II. And be it Enacted, That the Farmer or Farmers aforefaid shall give Bond with two sufficient Surcties to the Treasurer of the Province for the Time being, and his Succeffor in faid Office, in double the Sum which shall be given for the farming as aforefaid with Condition, that the Sum given be paid into the Province Treasury, for the Use of the Province in Quarterly Payments, from the Date of the faid Purchafe, which Bond the faid feveral Perfons to be appointed Commissioners as aforefaid, are hereby impowered to take, and the fame to lodge with the Treafurer aforefaid within Twenty Days after the faid Bond thall be executed, and the Treasurer in Case of Failure or Neglect of Payment on the part of the Farmer or Farmers aforefaid, at the Times therein limitted, shall put the faid Bond in Suit in Manner as is directed for the Recovery of the Debts payable to the Province, and the feveral Perfons appointed Commissioners as aforefaid, fhall render an Account of their Proceedings touching the fame to the General Affembly, in the first Week of their Session next after the fame fliall have been carried into Execution.

III. And be it alfo Enacted, That the Perfons fo farming the faid Duties may fubfitute and appoint one or more Deputy or Deputies under them upon Oath to collect and receive the fame, and the faid Deputy or Deputies shall have, use and exercife, all fuch Powers and Authorities, as are given by this Act to the Farmers for enabling them to collect the Duties aforefaid, and for detecting and profecuting Offenders.

IV. And be it further Enacted, That the Farmers aforefaid or their Deputies shall be liable to account for and pay the Drawbacks, to which any of the faid Articles aforementioned are subject within the Term of farming aforefaid, on the Exporters producing proper Certificates and complying in every Respect with the Rules prescribed by the Laws in that Case made and provided. W * and the Time of the Return of Writts, fix d and prefcribed by an Act made in the Sixth Year of his prejent Majesty's *** Reign, intitled An Act for preferibing the Forms of Writts and the Manner of iffuing the fame, hatb been found inconvenient. For Remedy whereof:

in the Courts at Halifax.

I. Be it Enected, by the Lieutenant-Governor, Council and Manner and Times Affembly, That the Plaintiff in any Action or Suit exceeding the Sum of Twenty Pounds, commenced in the Courts at Halifax, shall be at Liberty to file his Declaration any Time within three Days, after the First Day of the Term to which the Writ shall be returnable : Provided, the Defendant or his Attorney, shall be also within the faid three Days ferved with a Copy of faid Declaration, if the Defendant shall live within Twenty Miles of Halifax, and if at a greater Diftance the copy of faid Declaration shall be ferved at any time within Six Days of the faid First Day of the Term.

Manuer & Times for filing Declaracions in all other Courts.

I. And be it also Enacted, That in all other Courts in the Province, the Plaintiff in any Suit commenced in fuch Court (Exceeding the Sum of Twenty Pounds) shall be at Liberty to file his Declaration at any time within Four Days of the First Day of the Term or Setting of the Court at which the Writ shall be returnable, provided alfo, that the Defendant or his Attorney, shall be ferved with a Copy thereof within faid Four Days.
