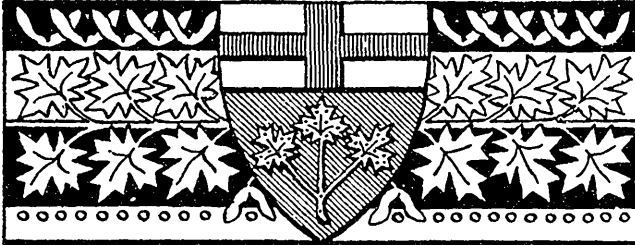

Armorial in Ontario.

IT is probable that there are in Ontario more persons, proportionately to the population, entitled to bear arms than in any other part of her Majesty's dominions. A statement which may be understood when it is considered that this province was largely settled by retired military and naval officers, and by the younger sons of families of established position. According to heraldic rule, applicable to most of such cases, the arms borne by such persons should be "differenced," that is, should undergo some change by which the cadet family settled in this province should be heraldically distinguishable from the parent family. There are some cases—two of which occur in the present number of this journal—where families have divided up into numerous and widely scattered branches, in which conformity to the rule is especially desirable.

It is unfortunate that there is no way in Canada by which arms may be registered and proper differences assigned. Applications to the Heraldic authorities in London, Edinburgh and Dublin, though in some respects easy enough, are beset with obstacles which not many Canadians care to encounter, and which appear to us to be of a very unnecessary character, and not at all in accordance with proper heraldic principles.

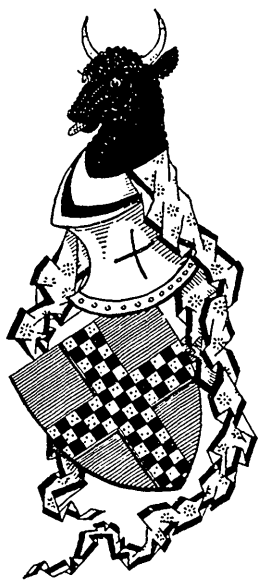
PEERS OF THE UNITED STATES.—It will come as a surprise, perhaps even as a shock, to most people to learn that there is a real House of Lords in the United States. It is situated in the State of New Jersey, and its members, although citizens of the United States, are, at the same time, vassals of her Majesty. Charles II. gave to his brother James the land which is now New Jersey, and James in his turn gave the land to twelve of his friends, with a deed of grant creating them and their descendants Lords. The Lords meet twice every year in Perth Amboy, in a little two-roomed house erected on the site of the first meeting house, which was erected in 1686. They are summoned by a crier with bell, dressed after the manner of a befeater. His summons begins with the usual "Hear ye, hear ye, hear ye—all manner of men, to whom these presents do come, that in pursuance of his Majesty King Charles," etc. The Lords, who have been in waiting in the outer room, then proceed to the inner or council chamber, where their deliberations are presided over by the Lord President.

For the genealogist it may almost be said that there is no surprise in any unexpected information which may come to him, and although the above may be very difficult to believe, the fact is that we have been assured of the active existence in the United States of organizations of a non-republican sort, not very much less surprising than a Nova-Cæsarean "House of Lords" would be.

AMONG those who followed William the Conqueror into England, was Thurstin the Fleming (Thurstinus Flandrensis), son of Rolf, who held lands in several counties, including Hereford. His wife's name was Agnes. Their son, Sir Eustace, Lord of Whitney, (in Co. Hereford), living in 1086, was the progenitor of the family of De Whitney, which continued there for many generations.

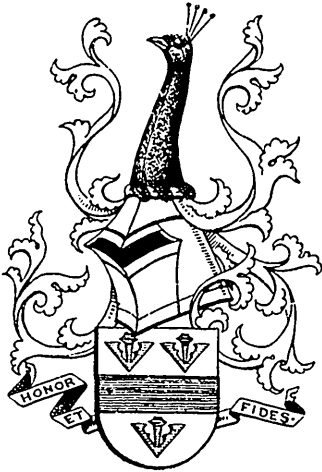

Tisdale, OF CHARLOTTEVILLE, U. S. A.



THE Tisdales were a family of some antiquity, said to have been originally Welsh and subsequently of Co. Lancaster, Eng., one of whom emigrated to America, and settled at Freetown, Mass. His grandson was a shipbuilder in extensive business, whose son

Ephraim Tisdale, b. 10 Feby. 1745, d. 1818, a shipmaster, having adhered to the Crown in the revol-

ution, seems to have been subjected to the treatment usually accorded to Loyalists, and it is recorded of him that in 1775 he fled from home, and went to New York. "During the war, while on a voyage to St. Augustine, Florida, he abandoned his vessel at sea to avoid capture, and gained the shore in safety, and though nearly destitute of money he made an overland journey to New York, a distance by the route he traversed, of 1,500 miles." In 1783 he went to New Brunswick, where he held public appointments, both military and civil; removed to Upper Canada in 1808 (where his son Lot had settled ten years previously), and settled in the township of Charlotteville, near Vittoria. He m. at Fairford, N.Y. 19 May 1767 Ruth Strange, b. 6 April 1748, who had emigrated from Scotland, and had issue, viz. :
