An Act to leave the selection of the County Town of Lincoln to the option of the Rate-payers residing within the same.

WHEREAS the Municipal Council of the County of Lincoln have by their petition prayed that an Act might be passed to enable the Municipal Electors of the said County to change the place for the County Town of the said County, and it is expedient to grant the prayer of the said petition; Therefore Her Majesty, &c., enacts as follows:

Preamble.

I. It shall and may be lawful for the Municipal Council of the County of Lincoln either themselves to change the place for the County Town of the said County, or to submit such change for the decision of the Municipal Electors of the said County, by a By-Law determining in what manner the votes of the said Electors shall be taken; and in either case a majority of votes of the Municipal Council or of the Electors, as the case may be, shall be decisive; and the said County Council are hereby authorized to carry such decision into effect, and to adopt and pass such By-Laws and take such measures as they may deem expedient to procure the necessary County Buildings at such place as the said Council or Electors may select for such County Town.

The County Council may choose, or leave the electors to choose, a new County Town.

II. This Act shall be deemed a Public Act.
