Explanatory note / Avant-propos

This bibliography continues the volume published under the same title in April 1989. It does not incorporate the material contained in that volume. Most of the works cited here are in the collection of the Departmental Library at External Affairs and International Trade Canada, and most were published between March 1989 and May 1990.

The cited works are classified by format (books, documents, databases etc.) as delineated in the table of contents. The 'Articles' section was sub-divided by topic due to its length. Articles considered relevant to two categories have been mentioned in both.

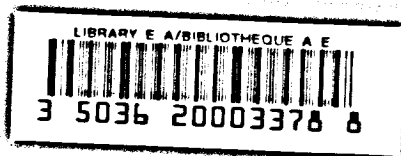
