## An Act to incorporate the Village of Mitchell, in the County of Perth.

THEREAS the inhabitants of the Village of Mitchell in the County Preamble. of Perth, have by their Petition represented, that from the rapid increase of the population of the said Village, it has become necessary to confer upon it corporate powers, and prayed that it may be incorporated b accordingly; and it is desirable to grant the prayer of the said Petition: Therefore, Her Majesty, &c., enacts as follows:

I. From and after the passing of this Act, the inhabitants of the said Mitchell in-Village of Mitchell shall be a body corporate apart from the Townships of a Village. Lozan and Fullarton, in which the said Village is situate; and as such 10 shall have perpetual succession and a Common Scal, with such powers and privileges as are now or shall hereafter be conferred on Incorporated Villages in Upper Canada, and the powers of such Corporation shall be exercised by, through and in the name of the Municipality of the Village of Mitchell.

15 II. The said Village shall comprise and consist of the lots and pareels Boundaries of of land, included within the following boundaries, that is to say: On the the Village. north, the concession road between the 2nd and 3rd concession of the Township of Logan, commencing at lot number 11 and ending at lot number 20. both inclusive of the said Township: on the east, the side Road between 10 lots numbers 20 and 21 in the Township of Fullarton, north, 30° east, and the side road between lots numbers 10 and 11 of the said Township of Logan; on the south the concession road between the 2nd and 3rd concession of the Township of Fullarton, south, 60° east, commencing at lot 21 and ending at lot 30 of the said Township; and on the west the boundary line be-25 tween the said Township of Fullarton and the Township of Hibbert, north 30° east, and the side road between lots numbers, 20 and 21 of the said Township of Logan.

III. Immediately after the passing of this Act it shall be lawful for the Returning offi-Governor of this Province to appoint a Returning Officer for the said election. 30 Village of Mitchell, which Returning Officer shall appoint the time and place for holding the first Election in the said Village, of which appointment the said Returning Officer shall give notice in a newspaper published in the said Village, or if there be no newspaper published there. then by notices posted in at least three conspicuous places in the said 85 Village, ten days before the said Election.

IV. The duties of the said Returning Officer, and the qualifications of His duties. the voters and the persons elected as Councillors at such first Election, of voters. shall be as prescribed by law with respect to Townships in Upper Canada.

Copies of the proper part of collectors' Rolls to be furnished to Returning Officer.

V. The Collectors or Township Clerks of the Townships of Logan and Fullarton, or other person having the legal custody of the Collector's Rolls of those Townships, for the year of our Lord one thousand eight hundred and fifty-six, shall furnish to the Returning Officer on demand made by him for the same, a true copy of such Rolls so far as the same 5 relate to voters resident in the said Village, and so far as such Rolls contain the names of the male freeholders and householders rated upon such Rolls in respect of real property lying within such limits, the amount of the assessed value of such real property for which they shall be respectively rated on such Rolls, which copy shall be verified on oath, 10 or as is now required by law.

His oath of Office.

VI. The said Returning Officer, before holding the said Election. shall take the oath or affirmation now required by law to be taken by Returning Officers for Incorporated Villages in Upper Canada.

Subsequent as in other places.

VII. Elections for Councillors for the said Village of Mitchell, after the 15 elections to be year one thousand eight hundred and fifty seven, shall be held in conformity with the provisions of law applying to Incorporated Villages in Upper Canada.

Oaths of office, &c.

VIII. The several persons who shall be elected or appointed under this Act, shall take the same oaths of office and of qualification now 20 prescribed by law.

Number and powers of Councillors, &c.

IX. The number of Councillors to be elected under this Act shall be five, and they shall be organized as a Council in the same manner as in Villages incorporated under the provisions of the Upper Canada Municipal Acts, and have, use, and exercise the same powers and privileges as 25 in the said Incorporated Villages.

Provisions as to existing Township debts.

X. From and after the passing of this Act, the said Village shall cease to form part of the said Townships of Logan and Fullarton, and shall, to all intents and purposes form a separate and Independent Municipality, with all the privileges and rights of an Incorporated Village in Upper 30 Canada; but nothing herein contained, shall affect or be construed to affect any taxes imposed for the payment of any debts contracted by the Townships of Logan and Fullarton aforesaid, but the said Village of Mitchell shall be liable to pay to the Treasurers of the Townships of Logan and Fullarton respectively aforesaid, in each and every year until 35 any such debt be fully discharged, the same amount which was collected within the said described limits of the said Village towards the payment of such debt for the year 1856, and the same shall be a debt against the said Village.

New Township Councillor to be elected in place of any one residing in Mitchell.

XI. Any Councillor elected to serve in the Township Councils of the 40 said Townships of Logan and Fullarton respectively for the present year, and residing within the above prescribed limits of the said Village, shall immediately on the passing of this Act, cease to be such Councillor, and the duly qualified electors of the said Townships of Logan and Fullarton respectively, not included in the said limits, shall thereupon 45 proceed to elect a new Councillor or Councillors, as the case may be, to serve in the Councils of the said Townships respectively, for the remainder of the year, as in the case of death or resignation provided for by the Municipal laws of Upper Canada.

XII. The Officers of the said Councils of the Townships of Logan As to taxes in Mitchell for and Fullarton, shall not proceed to collect any rate or assessment im- 1857. posed by the said Councils for the present year, within the limits of the said Village, but the amount which may be required for the purposes of 5 the said Village within the present year, shall be based on the assessment of the Township assessor or assessors for the present year, and shall be collected by the Officers to be appointed by the said Village Councillors for that purpose: Provided always, that nothing herein con- Proviso as to tained shall affect any school section or school rate for the present year, &c. 10 nor the right of any school section to any money already set apart for school purposes: And provided further, that the said Village of Mitchell, Proviso as to shall be entitled to recover from the said Townshipsof Logan and Fullarton share of U. C. Municipalirespectively, such share of all money apportioned to such Townships from ties Fund. the Upper Canada Municipalities Fund, prior to the passing of this Act, 15 as shall bear the same proportion to the whole sum so poportioned to the said Townships, as the number of the rate-payers resident within the limits of the said Village as shewn by the Collector's Rolls of 1856, bears to the whole number of rate payers of the said Townships.

XIII. The Clerks of the said Townships shall, and they are hereby re- Requisite por-20 spectively required to furnish to the Clerk to be appointed by the Council tion of assessof the said Village, on demand made by him therefor, true copies of the ment rolls to be furnished Assessment Rolls for the present year, so far as the same shall contain for Mitchell. the rateable property assessed within the same Village, and the names of the owners thereof.

XIV. The expenses of any assessment imposed for the present year, As to expenso far as the same shall relate to assessments made within the limits of ses of assessthe said Village, and the expenses of furnishing any documents, or copies 1857, &c. of papers or writings, by the Clerks or other officers of the Councils of the said Townships respectively, hereinbefore referred to or required to 30 be furnished, shall be borne and paid by the said Village Council to the said Township Councils or otherwise, as the said Township Councils shall require.

XV. This Act shall be deemed a public Act.
