

CONSTITUTION AND BY-LAWS

1. The Club shall be called The St. Michael's Tennis Club.
2. The Club shall consist of the Senior Branch, whose membership fee shall be \$3.00, and whose membership shall not exceed fifty; and the Junior Branch whose membership fee shall be \$1.00. Only those having a fully paid-up Senior membership card will be entitled to vote on club affairs. The age limit of the members of the Junior Branch shall not exceed 18 years, and they shall have no vote in the affairs of the Club, and will be admitted to the courts on all week days until 6 o'clock and on all holidays and Saturdays until one o'clock.
3. The officers of the Club shall consist of a President, Vice-

President, Secretary - Treasurer; an Executive Committee of seven members including the President, Vice - President and Secretary-Treasurer, who shall be ex-officio members; a Social Committee consisting of five members, three ladies and two gentlemen; and a tournament committee which shall consist of three members.

4. The duties of the President shall be to preside at all meetings of the Club and Executive Committee; decide all rules of order; enforce by-laws; sign all bills and countersign all checks.

5. The duties of the Vice-President shall be to assist the President in the discharge of his duties and perform same in the absence of the President.

6. The duties of the Secretary Treasurer shall be to keep an accurate account of the proceedings of all the meetings of the Club; keep a correct list of the members of the club and their residences; conduct all corres-

pondence of the Club; receive all membership fees, but pay no bills without sanction of Executive Committee. His books shall be open for examination at any meeting by any paid-up member. He shall deposit all money of the Club in a bank and pay all bills with checks.

7. The duties of the Executive Committee shall be to keep the courts in condition; be responsible for the general upkeep of the Club; open the courts at the beginning and close them at the end of each season, and if necessary at any time for repairs; it shall have power to establish a waiting list with limited privileges; elect honorary members, and receive and pass upon applications for membership after the limit of fifty has been reached. Three members present at any meeting of the Executive Committee shall constitute a quorum, and the absence of a member of the Executive Committee from two consecutive meetings without

giving sufficient reason to the Secretary - Treasurer, will be deemed a resignation of that member.

8. The duties of the Social Committee shall be to provide refreshments for all tournaments at home, and arrange socials at its discretion.

9. The duties of the Tournament Committee shall be to select all tournament players and arrange for all tournaments.

10. Membership fees are to be paid in advance. In case fees are not paid within a month after opening, the delinquents shall be notified that their fees are overdue, and also if same are not paid within six weeks from opening, said delinquent's name shall be struck off the membership roll. All new applications for membership shall be accompanied by membership fee.

11. Players must wear tennis shoes on the courts.

12. Visitors shall be accom-

odated on week-day afternoons, excepting Saturday and holidays, on one court in presence of members of the Junior Club, and on both courts in absence of members of the Junior Club.

13. The east court shall be reserved for ladies playing exclusively, on Tuesday evening and the west court on Thursday evening of each week, and vice versa for men.

14. Every paid - up member shall receive a card and receipt for his membership from the Secretary-Treasurer.

15. All members must have in their possession two good balls when coming on to the courts to play.

16. No playing shall be allowed on the courts on Sundays or Church holidays.

17. Spaulding's rules shall apply on the courts.
