An Act to amend the Act concerning the erection and division of Parishes, and the building and repairing of Churches, Parsonage Houses, and Church-yards, and Fabrique Meetings.

HER Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

The first Paragraph of section twenty-two of chapter eighteen of the Consolidated Statutes for Lower Canada, intituled, "An Act concerning the erection and division of Parishes, and the building and repairing of Churches, Parsonage Houses, and Churchyards, and Fabrique meetings" is repealed, and the following is substituted therefor and shall be inserted in the place thereof:

1. As soon as the Commissioners have made an order approving the election of the trustees, and authorizing them to make an assessment and to levy the sums assessed, the trustees shall proceed to draw up an Act of assessment, which shall comprise a specification of the work to be done and a detailed estimate of the expenses, known and unforeseen, which they deem necessary for the construction or repairs in question, and also a correct statement of all the lands and other immovable property situate in the said parish or mission, (excepting Church property and buildings occupied as educational establishments, with the land on which they are erected or which may be attached to or form part of such establishments, and which are not liable to such assessment) shewing the extent and value of each lot, and the name of the real or supposed owner, and the proportionate sum of money (and the quantity of materials, if any) which they have assessed on each lot, towards the necessary expenses of such construction or repairs."
