

QUESTION IV.

What Ministers have died since the last Conference?

# ANSWER.

1. CHARLES GASKIN, who last Conference, through ill health requested to become a Supernumerary, gradually declined under the fatal disease Consumption, until 10th March, when he finished his earthly career, in the 33rd year of his age, and the eighth year of his ministry. His sufferings, for some time previous to his death, were great—which, no doubt, had an influence on his Christian enjoyment: but, as he drew near the end of life, the Lord dispersed every cloud, and enabled him to pass through death triumphant home.

2. THOMAS GAETZ—who was born at Musquodoboit Harbor, Nova Scotia, on the 5th of Oct., 1831. He was thoughtful and studious when a child; and at the age of twelve years was soundly converted to God. Very soon after his conversion he felt a strong desire for the salvation of sinners; and feeling that he was called of God to preach the Gospel, he was at an early age engaged as a Local Preacher; but desiring to devote himself fully to the work of God, he became a candidate for the ministry among us in the year 1851 : since which time he laboured with acceptance and success in Nova Scotia, Prince Edward Island, and Newfoundland.

In the Grand Bank Circuit his labors were greatly owned of God. His name is, and long will be, a household word. He never spared himself, but often laboured beyond his strength—such was his anxiety to do good. He was appointed by the last Conference to the Old Perlican Circuit. Immediately on his arrival he commenced his labour with great zeal—yea, intense ardor—and although with this people so short a time, yet he was endeared to them—greatly beloved by them—and his death was deeply lamented. When told he could not possibly recover without some speedy alteration, he exclaimed, "Well, my peace is made with God." His last words were, "Jesus is all love!" after which he fell asleep in Christ, on the 24th of October, 1860, in the 29th year of his age, and the 10th year of his ministry.

2. That this Conference, fully concurring in the opinion that the establishment of a proper Provincial University, distinct from all teaching institutions, to be the sole source of university honors and degrees, upon the plan) essentially, of the London University in England, and the Queen's University in Ireland, would be of great and permanent advantage to the cause of liberal education, gladly complies with the request of the Board of Trustees of the Mount Allison Wesleyan Academy, and appoints the Rev. the President of the Conference and the Rev. the Secretary of the same, with the Superintendent of the Fredericton Circuit, to act with the Executive Committee of the Academy, as a joint Committee, to bring the matter under the notice and consideration of the Government and Legislature of the Province of New Brunswick, in such a way as shall seem best calculated to secure the establishment of such an institution.

3. That the Conference is convinced that, in the event of a failure in the effort to secure the establishment of such an institution as is contemplated in the second resolution, it will be then expedient to fall back upon the Act of the Legislature which authorizes the organization of a College proper at Mount Allison, upon certain conditions, which, it is believed, can be fulfilled without involving the necessity of any general appeal throughout the Circuits for additional funds.

4. That in the opinion of the Conference the establishment of a College will give additional stability and influence to the C. F. Allison Theological Professorship, and that it should operate as a stimulus rather than a hindrance to the completion of the Endowment Fund for this Professorship.

#### THEOLOGICAL INSTITUTION.

#### QUESTION XIV.

What are the Resolutions of the Conference respecting the Toeological Institution ?

1. That the Conference records its appreciation of the services rendered by the Rev. C. DeWolfe, A. M., to the students of theology at Sackville during the past year, and being:

deeply impressed with the importance of continuing and strengthening the existing arrangements for the training of candidates for our ministry, hereby directs that his name appear in the list of stations as Theological Professor.

2. That the student probationers for our ministry shall be placed under the entire control and government of the Theological Professor for the ensuing year, who shall provide for their comfort, superintend their studies, and exercise over their moral and religious conduct a constant care.

3. That the Professor of Theology and the Treasurer of the Endowment Fund be a Committee to adopt such measures as may be necessary for collecting in unpaid subscriptions, and for obtaining further subscriptions to the funds, so as that the sum originally contemplated of \$20,000, for the establishment and sustentiation of the Charles F. Allison Professorship of Theology, may be realized at the earliest possible period.

4. That the students who may be placed under the charge of the Theological Professor by the Conference, during two or more years, shall be allowed one of such years as a part of their probation.

5. That the Theological Professor, the Principals of the two branches of the institution, and the Superintendents of the Sackville, Point de Bute and Amherst Circuits, be a Committee to arrange and submit to the Conference at its next session suitable courses of study for the young men under theological training, and for probationers upon Circuits, upon which they may be examined at our Annual District Meetings.

# MISCELLANEOUS RESOLUTIONS.

#### I .--- DEATH OF THOMAS FARMER, ESQ.

The Conference of Eastern British America having heard with unfeigned regret of the decease of the late Thomas Farmer, Esq., of London, who for so long a time occupied the post of one of the General Treasurers of the Wesleyan Missionary Society, and by his princely munificence so largely sustained the cause so dear to us, and of such vast importance to the world, would express their sincere sympathy with the Wesleyan Church generally, and with the esteemed members of his bereaved family, in this providential removal of our late highly-esteemed Brother to a better world, with the earnest hope that other princes of our Israel may be raised up in his place of trust thus rendered vacant by his death.

#### II.-THE CANADIAN DELEGATION.

# THE PASTORAL ADDRESS.

### TO THE MEMBERS OF THE WESLEYAN METHODIST CHURCH OF EASTERN BRITISH AMERICA.

# DEARLY BELOVED BRETHREN :

PROVIDENTIALLY permitted again to assemble ourselves together for Conferential deliberation on all matters pertaining to the well-being of our Church, we eagerly and joyfully hasten to renew, in our collective capacity, our pastoral intercourse with you. Deep and abiding is our sympathy with all that concerns you. A thousand tendrils and ties unite our interests with yours. We share with you the same spiritual baptism, and the same pure scriptural creed; we walk the courts of the same sanctuaries, and fall prostrate together before the same altars. Our voices blend in the gushing raptures of the same holy song, and our memories of the garden, the cross, and the tomb, melt and mingle in the same sacramental joy. Side by side with you we fight the good fight of faith-hand in hand with you we traverse the great and terrible deserts, or ford the deep dark waters, which lie between us and the promised land. Our trials are similar. our triumphs are mutual, we pity and pray with you in the darkened chamber where your loved ones suffer ; we tearfully mourn with you on the brink of the fast-filling graves where your sainted-ones slumber. We live for God and you. Gladly do we avail ourselves of this opportunity collectively to say, what we trust by our sympathy and labors individually to prove, that we love you in Christ Jesus, and that your prosperity and happiness lie near to our hearts.

Our Conferential session this year has been unusually interesting. Questions of much importance to the advancement of the cause of God among us, have occupied our attention. A refreshing spirit of candor and frankness—a free, genial interchange of thought and sentiment, have marked the discussions, through which our deliberations have been guided to definite conclusions. The religious services held during our session have been spiritual, edifying, and stimulating, in a high degree; in some instances, they have been distinguished by unusual power from above, and the richest unction of the Holy Ghost.

Two members of our body, while yet in their early manhood, for whom a long career of usefulness might have been expected, have been removed from us, since last we met, by a death peaceful and triumphant. By their removal from the vineyard of the Lord, we feel ourselves imperatively admonished to work with increased faithfulness and diligence while it is called to-day.

Some of our Circuits have been, during the year, blessed with very gracious revivals of religion, in which many precious souls have found the pearl of great price. We are enabled to report a nett addition of 330 to our membership, and 1,553 on trial; and the general state of our work is highly encouraging. Yet, for how much more glorious manifestations of Divine power—for how much wider an extension of Christ's blessed cause are we not commanded to pray and toil, and privileged to hope and believe! May the Lord speedily make you a hundred fold more than you are.

Judged by tests thus supplied, Methodism, among her Christian sisters stands pre-eminent-unrivalled, as well for her success in winning men to Christ as for training them for the enjoyment of His presence in heaven. Let us see to it, dear brethren, that we both prize and profit by our peerless religious advantages. We affectionately exhort you ever to remember the relation which time bears to eternity. In your affluence and in your poverty-in your prosperity and in your adversity-in your cares, anxieties and disappointments-in your pleasures, your joys, your successes-amid all the many checquered scenes that give character and variety to life, oh ! keep it in your memory, bright and fresh, that no acquisition is a gain to you that deadens the fervor of your love to God; and that no deprivation can be a loss to you if it leaves your title to the heavenly inheritance unweakened, and your meetness for its enjoyment undiminished. Let the toil and weariness, the strife and sorrow of this world that passeth away, render more dear to you the love of Jesus and the hope of heaven. Ye know your calling, Brethren, its lofty aims, its glowing incentives, its blissful rewards! To glorify God, to know the Saviour, to diffuse the sweet fragrance of His exalted name, is your heaven-appointed work. To be washed in the all-cleansing blood, to be assimilated to the Divine image, to hold uninterrupted fellowship through the Spirit with the Father and the Son, to be filled with all the fullness of God, is your bloodbought privilege, ratified by a covenant well ordered and sure.

We beseech you to walk worthy of your high vocation. Allow no talent to be misused or unused; no promised blessing to remain untasted; no duty to continue undischarged. Live in God. Live for God.

But while your principal work, and your primal solicitude should ever be to fulfil your own obligations to God, and to make your own calling and election sure, how claimant and imperious is the demand upon you, in behalf of a race perishing in its misery for lack of truth and grace ! Its wail of anguish is gone out through all the earth, and there is no speech nor language where their piercing cry is not heard.

Your response to this appeal will be limited neither by color, nor clime, nor tongue. Your efforts to bless will be conditioned only by your power and by your opportunity. Where your labor cannot be expended, your sympathy will go; where your example cannot shine, there the benefits procurable to your effectual fervent prayer will descend. Your supplications, prayers, and intercessions will be made for all men : for this is good and acceptable in the sight of God our Saviour, who gave himself a ransom for all. Nevertheless, in the sphere more immediately accessible to you in your own land, in your own Church, in your own families, your great opportunities for usefulness will be found; and here your evangelistic labors and holy living and earnest prayers may all combine to render your success both certain and large. Strive, we beseech you, to maintain all the general institutions of our Church in the greatest possible efficiency, and all the local means of grace among you in a state of the greatest possible spirituality and vigor. Where co-operation is needed, give it unstintingly. Where your individual effort is required, put it forth cheerfully and manfully. For doing good, Methodism is not more distinguished by its power and facility in combined movements, than by its freedom of bindividual action. With an ecclesiastical system better adapted than any other on earth at once to conquer and consolidate, to secure world-wide expansion and internal development of the highest type of Christian excellence, let us perform our respective parts with intelligence, and courage, and faith.

Let no frowardness of temper, no obstinacy of born again. will, no moral insensibility by which any of them may be characterized, induce you to doubt the practicability of this great change, or lead you to abate one jot of heart or hope in laboring for its accomplishment. To this end, let the soft and winning allurements of the Christian Mother, with her gentle speech and melting tears, and loving smile, attemper the stern authority of the Christian Father. For this result, let the flame on the domestic altar never burn low, and the light of a holy parental example never grow dim. Beneath the mingled fires of divine and human affection, let your anxious hearts unceasingly exhale their prayers to the skies. Avail yourselves wisely of the aid which the Sabbath sanctuary and the Sabbath-school present for your acceptance. Recognise their proper value, and fully embrace their proffered benefits. We entreat you, moreover, to train your children carefully to an intelligent appreciation of our wise and admirable economy, our beautiful and Scriptural Theology, and our glorious and providential mission to the world. In faithfully and successfully discharging these high duties, you will, at the same time, be conferring lasting benefits upon your children, and rendering most valuable service to the Church of your choice and love. You will be greatly assisted in this necessary work, if with provident liberality you procure for your families a sufficient supply of that sound, healthful, noble Wesleyan literature, which our Book-Room at Halifax, still under the management of our estermed and active Brother, Rey, C. Churchill, A. M., can bountifully furnish. Not less helpful to you, or less beneficial to our Church will it be, to introduce the Provincial Wesleyan into all your families, that the current events which bring sadness. solicitude or joy, to our denomination, may be familiar as household words around your firesides.

You will be gratified to learn that the Theological Institute at Sackville, designed to aid in the preparation of our young Ministerial Candidates for the better discharge of their sacred duties, has won for itself an incipient success, in the hands of our gifted brother, Rev. C. DeWolfe, A. M., upon whose prelections, during the year, quite a number of young men, prosecuting their literary studies in the Sackville Academy, have been in attendance. The Rev. C. DeWolfe

is re-appointed Theological Professor this year, and will enter upon his important functions with auspicious omens. We commend this enterprise to your sympathy and prayers. We trust, notwithstanding the pressure of these disastrous times, that the endowment of this Professorship will be speedily and satisfactorily completed.

You will also be delighted to know that our Academical Institutions at Sackville have enjoyed a year of decided prosperity. They have been very largely patronised, and have never been in a more healthful and vigorous condition than during the past year. Great and growing is our obligation to these most excellent Institutions. We exult in their efficiency and deservedly high character; and we cordially, confidently and earnestly recommend them to your undivided patronage. But, deeply as we are indebted to those Institutions, for the benefits they have conferred on our country and our Church; and grateful as we have felt, and increasingly feel for their success, many of us have long been convinced that the welfare of our Church imperatively demands an extension of the educational facilities of the Male Branch at Mt. Allison, in order that the young men of our communion. desirous of obtaining a thorough Collegiate Education, or might easily be induced to seek it to our and their lasting advantage, may be able to obtain this precious boon from our hands, under those religious safeguards which we deem indispensable to Christian Collegiate Education. Three years ago this Conference recorded its judgment in favor of elevating the educational status of Sackville Academy, and approved a plan adapted to secure this desirable result. Subsequently it was deemed expedient to postpone action in this direction for a time, and to combine our energies in the establishment of a Theological Professorship. Now, however, after lengthened and most careful deliberation, we have unanimously resolved that we ought no longer to delay such action in this matter, as may be provident and practicable, tending to meet the educational necessity which we feel to exist. We earnestly implore a continuance of that divine favour which has smiled upon all our educational enterprises hitherto.

# ADDRESS

### CONFERENCE OF THE WESLEYAN METHODIST CHURCH OF EASTERN BRITISH AMERICA,

#### TO THE BRITISH CONFERENCE.

### REVEREND AND BELOVED FATHERS AND BRETHREN :

Being now assembled in our annual Conference, we have heard the Reply from your venerable body to our last Address, with unfeigned satisfaction, and with unmingled joy.

As the youngest sister of the great Conferential family, and having been favored with many proofs of parental solicitude and tender regard for our welfare, we still eling to you with all the ardour and fondness of youthful affection, and we trust that our future course, and steadfast fidelity to the great trust we have received, will ever justify that confidence which you now repose in us, and that nothing shall ever transpire to diminish that heart-felt joy and satisfaction with which we turn to the ancestral home of our beloved Methodism.

We have watched with peculiar interest the unceasing evidence of strength, of unity, of vitality, of Apostolic effort and of soul-saving power, which are exhibited in your midst. The great heart-throbbings of British Methodism send their pulsations of life through every part of our Provincial work, and their vibrations have stirred our hearts to deeper love and to holier zeal.

We sympathize with you in noble evangelistic enterprise, we magnify "the grace of our Lord Jesus Christ" which hath constrained you to enlarged effort; we admire the effectiveness of your agencies, we are strengthened by your example, we are honored in your triumphs, and we would endeavor in our own sphere "to walk by the some rule and to mind the same things."

"We have heard with our ears and our fathers have told us of the work done in their days and in the old time before them," and we are convinced that the ancient glory of Wesleyan Methodism hath not departed, but that men imbued with the same spirit as her venerable Founder still live to minister in her sanctuaries, to guide her deliberations, and to conduct her noble enterprises to triumphant success. Earnestly do we pray, and ardently hope, that she will continue faithful to her vocation, "renewing her youth like the eagle," nutil she fold within her boson those neglected masses which throng the towns and eities of the British Isles.

It is to us, at this time, when men of acknowled scholarship, and possessing the prestige of high ecclesiastical position, are found repudiating the distinctive teachings of the Christian faith, a matter of great joy that our system of evangelical doctrine is so well defined, and so firmly established. "If the foundations be destroyed what can the righteous do?"

We have endeavored to prove faithful to the trust which we have received in the preaching of "an unadulterated Gospel;" never can we compromise, or keep in the back-ground, the great central truths of our holy religion. "But God forbid that we should glory save in the Cross of our Lord Jesus Christ." Nor can we conscienciously yield to that pressing demand which is being made for sensational preaching.

of the Holy Spirit—in some cases hundreds of sinners have been convinced of sin, have come with agonized hearts and tearful eyes to the foot of the Cross, and have received the forgiveness of sins; some of whose names are already enrolled with us in Church fellowship, and others are candidates for the same relation. On account of commercial pressure which has been severely felt, and in some Circuits caused a great falling off in membership, we cannot report such a large numerical increase as we otherwise would do, yet we are grateful for the mercy of God so signally vouchsafed to us. "Our Gospel" has not been "in word only, but also in power, and in the Holy Ghost.

Our sphere of labor is enlarging—new doors are opening. The Macedonian cry comes to us from many a fine field, and from many a sparsely populated district within the bounds of our Conference. We are aware that our resources are limited, and that increased agencies will augment our responsibilities, but our love for the souls of these who ask from us the bread of life, our sympathy with the great purposes of the Divine Redeemer, and our faith in the mission of Methodism, urge us onward, even though for a time at an increased pecuniary sacrifice by those Ministers already engaged in the work.

The Lord of the Harvest is sending forth laborers for the whitened fields. Nine of our young men, who have honorably passed their probation, and who have "witnessed a good confession before many witnesses," have been consecrated to the full work of the Ministerial office, and sixteen young men have been received on trial as candidates for the ministry of our Church.

Being satisfied of the importance of an extensive theological training, as well as of mental culture, for the work of the Sacred Ministry, we have been actively engaged in the establishment of a Theological Institution, and have appointed the Rev. C. DeWolfe, A. M., one of our most accomplished scholars, and best theologians, as Professor of Theology.

Our Educational Institutions at Mount Allison have never, perhaps, stood so high in efficiency, in prosperity, or in acknowledged excellence, as at the present time. It has been unanimously resolved that, in addition to the Academic department, arrangements shall be made by increasing, the staff of Professors and otherwise, for conducting the Students through an entire course of Collegiate instruction.

We would endeavor to express to our Fathers and Brethrenour sense of the favor conferred upon us, as a youthful Connexion, at a critical period of our history, and when questions of momentous interest to our Church in these Colonies were awaiting decision, in the appointment of the Rev. W. B. Boyce to be President of our Conference. Mr. Boyce was not unknown to us; in connection with the Kaffir Missions, and the Australasian Conference, his name was familiar. But his ability in presiding over our deliberations, practical sagacity, clear insight into the most intricate details of business, and thorough acquaintance with every subject bearing upon our entire, economy, have exceeded our most sanguine anticipations.

We have also been favored with the presence of a deputation from our elder sister Conference in Canada, consisting of the Rev. Dr. Stinson, President, Rev. Richard Jones, Co-Delegate, and Rev. John Gemley, Secretary of the Canadian Conference. The presence of these honored Ministers of Christ has been a source of great encouragement to us. We have been delighted with their able and richly evangelical ministrations in the pulpit; we have greatly profited by their counsels and admonitions; while their narrations of early struggles, of rapid progress, of glorious triumphs, and of future prospects, have tended to confirm our confidence, and to deepen our conviction in the wisdom and excellence of our ecelesiastical system, and in the future destiny of Wesslevan Methodism.

We have great pleasure in requesting that the Rev. H. Pickard, D. D., to whose faithful labors, sound judgment, and high integrity of character, we are deeply indebted, may be President, and that the Rev. Charles DeWolfe, A. M., may be Co-Delegate, during the ensuing year.

Having been informed that our beloved President, the Rev. Mr. Boyce, cannot be in England in time to represent us, we request that the Rev. Wm. Arthur, A. M., be our representative at the British Conference.

We cannot refrain from expressing our deep sense of the loss sustained by you in the recent death of one of the Princes of our Israel—one whose connection with the
