SDC CONDEMNS STUDENT CONDUCT

In an emergency meeting last night the Student Disciplinary Committee condemned the student behavior exhibited at the *Red 'n' Black Party*, November 25th, 1961, at the Flame Restaurant.

On Tuesday November 28th, the Red 'n' Black Executive organized a meet-

ing at which the cast and crew voted in favour of a self-imposed levy of one dollar per person in order to meet the costs of the \$165.00 in damages.

Upon closer inspection of the Flame incident student infractions of a more serious nature were revealed. In the light of this new

evidence, and at the suggestion of the administration, the SDC decided to apprehend the more serious offenders.

Because of the difficulty in isolating specific offenders and in establishing concrete evidence the SDC will deal with only those cases in which definite

misdemeanors had been observed.

Some charges that were laid did not correspond with this decision and were dropped.

Those charges that did agree with this decision were dealt with and several others are pending further investigation.

SDC POSSESSES JUDICIAL POWERS

The Student Disciplinary Committee has been constitutionally endowed with such powers as deemed necessary for its ensuring that UNB students conduct themselves in a manner befitting that of a member of this institution.

In the light of recent infractions on the part of UNB students, in particular those occurring at the Red 'n' Black Party of November 25th, the SDC wishes to inform the entire UNB student community of its authority with regard to such behavior.

STUDENT DISCIPLINE COMMITTEE UNIVERSITY OF NEW BRUNSWICK CONSTITUTION

Article I

The disciplinary powers of the Student Body of the University of New Brunswick are hereby invested in a committee hereinafter known as the Student Discipline Committee. The Committee shall have jurisdiction over student conduct on University property, at all student functions, and over all cases handed to the Committee by the University Administration. All reports arising from incidents outside SDC jurisdiction shall be referred to the University President.

UNB STUDENTS IRRESPONSIBLE?



At the meeting discussion was held regarding future SDC policy on disciplinary action in an attempt to improve the effectiveness of this organization.

It was generally agreed that student conduct had deteriorated to such an extent that it required careful consideration with respect to disciplinary action. In this connection, the board put forth the following questions:

Will it become necessary for the University Administration to assume responsibility for supervising student functions?

Does student behavior, as witnessed at the Red 'n' Black Party imply that forthcoming events such as Winter Carnival be cancelled to prevent the recurrence of such behavior?

Can the students at UNB be trusted with the responsibility of their actions at student functions without 'outside' controls or will it be necessary that these events be policed?

Should SDC members be in attendance at major events to aid the Campus Police and the students in maintaining good conduct?

Should the Campus Police be required to attend such special functions as the Annual Red 'n' Black Party, the Hammerfest, faculty smokers, etc.?

Will it be possible to maintain conduct becoming to a student and responsible student action at future Red 'n' Blacks, Winter Carnivals and other similar student activities — or will it be necessary to CANCEL these events?

Only we the students can answer these questions. We make up the SRC, the SDC and the Campus Police. We organize and take part in the various student functions. We are responsible for our conduct both individually and collectively.

These questions and others will be discussed tonight at the weekly SRC meeting. The SDC, being primarily responsible for this extra edition of *The Brunswickan*, hopes to impart to all UNB students the seriousness of the preceding questions and to warn the students of the possible consequences.

All interested students are urged to attend tonight's meeting of the SRC at 7:00 p. m. in the Tartan Room of the Memorial Student Centre, where your views and opinions will be taken into consideration.
