A Message came from His Excellency the Governor, requiring the Attendance of the House in the Council-Chamber; accordingly Mr. Speaker, with the House, attended His Excellency, and being return'd, Mr. Speaker reported, That his Excellency was pleas'd to make the following Speech to both Houses : House met.

' *Gentlemen of the COUNCIL and HOUSE of*  
' *ASSEMBLY.*

' YOUR meeting at this Time being necessary, and the Season of the Year convenient, I make no doubt that the Result of your Deliberations will produce those Advantages and Benefits, which our present Condition and Circumstances require. His Excellency's  
Speech.

' I am satisfied that it would be needless to recommend to your Attention the Provincial Revenues; an Object of so much Concern cannot fail of having its due Weight with you. And I trust that the Means you will provide for supplying the Deficiencies, will be as proper and effectual, as the State and Condition of the Province  
' will

‘ will admit of. But among the several Matters  
 ‘ which demand your serious Consideration, none,  
 ‘ Gentlemen, is of more Importance, than to make  
 ‘ some Provision, whereby a Scarcity of Corn and  
 ‘ other Seed, in the most urgent Season, may be  
 ‘ prevented or supplied; such an Evil, altho’ not  
 ‘ uncommon, is not without Remedy; and to pro-  
 ‘ vide that Remedy, and effectually apply it, will  
 ‘ be a Precaution of such Wisdom and Prudence,  
 ‘ as will not only be much to your Advantage and  
 ‘ Profit, but will give you Credit and Reputation.

‘ I shall direct the proper Officers to lay before  
 ‘ you such Papers as are necessary for your Inspec-  
 ‘ tion; and I will communicate to you by Message,  
 ‘ such other Matters as may, during the Session, oc-  
 ‘ cur for your Consideration.

‘ I recommend to you, Gentlemen, Unanimity  
 ‘ and Dispatch, and assure you of my most earnest  
 ‘ Desire to forward and perfect every Measure,  
 ‘ which can tend to your Advantage, Welfare, and  
 ‘ Prosperity.’

*Order’d*, That Mr. *Hinschelwood* and Mr. *Bren-  
 zton* do prepare an Address in Answer to his Excel-  
 lency’s Speech.

*The humble ADDRESS of the HOUSE of ASSEMBLY.*

*May it please your Excellency,*

**W**E His Majesty's dutiful and loyal Subjects, the Representatives for this Province, now met in General Assembly, return your Excellency our Thanks for your Speech from the Chair, and for calling us together at a Season of the Year which will best admit of our Deliberations on the present State and Circumstances of the Province, from which we hope with your Excellency, to derive all possible Benefit and Advantage.

We

We are sensible of the Urgency of applying our first Attention to the Provincial Funds, an Object we cannot fail to have much at Heart, whilst we contemplate it as the Basis upon which the Growth and Prosperity of this Province so greatly depend, and your Excellency may be assured we shall leave no Resource unattempted to make good the Deficiencies of the Revenues, to the utmost of our power and Abilities.

We heartily concur with your Excellency in Sentiment upon the Importance of adopting some Method to prevent the Scarcity of Corn, and other Seed Grain in the Country, at that Season when they are most needful; and shall exert our best Endeavours to discover and apply some effectual Remedy to an Evil which if not timely guarded against, must produce consequences of the most distressing Nature to the Husbandry of the Province.

To promote Unanimity and Dispatch in our Proceedings, we beg leave to assure your Excellency shall be our earnest Study; and we are particularly perswaded of your Excellency's Zeal and Desire to forward and perfect every Measure for the Public Welfare. On this Occasion we are sincerely happy in expressing to your Excellency our great Satisfaction in seeing the Roads in the Interior parts of this Province, and about the Capital under your Excellency's active and prudent Conduct, so greatly improved, from which we cannot but foresee the Advantages that must mutually be felt by the Inhabitants of the Town and Country, in an easier and safer Communication with each other than heretofore.

A Letter from *Richard Cumberland, Esq;* dated London, the *5th April*, 1769, directed to Mr. *Speaker*, was read, setting forth, that he readily accepts the Appointment of this House as Agent to the Province.

Petition from the Commissioners of Sewers for *Horton*.

A Petition from the Subscribers, Commissioners of Sewers for the Township of *Horton*, was presented to the House and read, setting forth, that whereas a very considerable Part of the Dyked Lands in said Township are owned or held by absentees or non-resident Proprietors, who neither by themselves, their Attorneys, Agents or Factors appear to pay the frequent Charges and Expences of making and repairing the Dykes, and that the Petitioners meet with great Difficulty in Leasing the Lands of such Non-residents for defraying those Charges according to the present Powers given by the Acts of this Province, as no Person will appear to take a Lease of such deficient Lands, unless for a very long Term, by which means the Petitioners have it not in their Power to pay off the Charges already arisen or which may arise for such Labour, to the great Damage of the Persons who perform the said Labour; and praying that the Legislature of the Province will take the said Matter into Consideration, and afford the Petitioners Relief therein.

Upon

Upon Consideration of which, *Resolved*, that a Bill be prepared for the Purposes contain'd in the Prayer of the said Petition.
