
I am encouraged by the impressive worldwide total activity results of the Export and Investment Promotion Program as reflected in the July-September quarterly report. A number of individual missions have devoted considerable effort to refine their figures so that they are an increasingly realistic representation of workload results and progress. Several have done so despite difficult operating conditions, mostly of a workload nature.

Almost all of your Export and Investment Promotion Plans have been received in Ottawa and are currently being verified in the geographic bureaux. The next step will be to create a data base from the plans from which upwards of 23 standard reports will be available to form the basis of consultations with OGD's, provinces and national trade associations. Data entry will be completed by Christmas and the consultative process will be undertaken during January-February 1987. During the consultations on mission plans, the department's objective is to harmonize your plans with OGD's (to ensure they accommodate their many perspectives as well as possible) and to achieve similar synthesis with the provinces and the private sector to which the Government is committed in the continual development of a trade strategy for Canada.

Following the consultations, any significant changes will be incorporated into the plans which will be communicated to you as your agreed plan for the next fiscal year. The new Trade Tracking System Report forms which you received with your planning kits, will come into use April 1, 1987 to coincide with your new program year.

During FY 87/88 your Bureau will receive, based upon the new Tracking Report, a quarterly report comparing your progress and results with the work program you had outlined in your plan. They will also receive workload analyses based on your tracking reports. I am confident that this system will sharpen the department's ability to keep abreast of developments in a more disciplined fashion and to monitor developing situations which suggest resource reallocations may be warranted. The planning and tracking systems do not take the place of good management. They are intended to provide some of the tools to produce better management of the trade program.

Your mission plans are in the process of forming the most detailed and comprehensive storehouse of data on world markets we have ever had. We will be able to supply clients of the department with information on your territory, region, or on a world basis either sectorally, geographically or from a specific product, sector or project point of view. Perhaps most importantly, we will be able to identify our priorities quickly and with considerable precision; a key requirement when resources are becoming scarcer.

Je trouve encourageants les excellents résultats du Programme de promotion des exportations et des investissements en ce qui a trait à l'ensemble des activités dans le monde, tels qu'ils apparaissent dans le rapport trimestriel pour la période de juillet à septembre. Certaines missions ont déployé des efforts considérables pour fournir des chiffres plus précis, si bien que l'on peut maintenant se faire une idée plus juste de la charge de travail, des résultats obtenus et des progrès accomplis. Plusieurs missions y sont parvenues en dépit de conditions de travail difficiles, dues essentiellement à la nature des activités.


Presque tous les plans de promotion des exportations et des investissements sont parvenus à Ottawa et sont actuellement vérifiés par les directions générales géographiques. La prochaine étape consiste à établir une base de données tirées des plans, à partir de laquelle 23 rapports uniformisés au moins seront produits pour servir de base aux consultations avec les autres ministères, les provinces et les associations professionnelles nationales. L'entrée des données sera terminée avant Noël et le processus consultatif débutera en janvier ou février 1987. Au cours des consultations sur les plans des missions, l'objectif du Ministère est d'harmoniser vos plans avec ceux des autres ministères (pour s'assurer qu'ils couvrent le plus grand nombre possible d'aspects) et pour parvenir à une synthèse similaire avec les provinces et le secteur privé, avec lesquels le gouvernement s'est engagé à collaborer de manière suivie à l'élaboration d'une stratégie commerciale pour le Canada.

À l'issue des consultations, les changements majeurs seront incorporés aux plans qui vous seront communiqués et qui constitueront votre plan approuvé pour le prochain exercice financier. Les nouveaux formulaires de rapport du système de suivi des résultats commerciaux, que vous avez reçus avec votre trousse d'information sur la planification, entreront en vigueur le 1^{er} avril 1987 de façon à coïncider avec la nouvelle année du programme.

Au cours de l'exercice 1987-1988, votre direction générale recevra un rapport trimestriel établi d'après le nouveau système de suivi, dans lequel vos activités en cours et vos résultats seront comparés avec le programme de travail que vous aviez présenté dans votre plan. La direction générale recevra également des analyses de la charge de travail fondées sur vos rapports de suivi. Je suis certain que ce système permettra d'accroître la capacité du Ministère de se tenir au courant des développements d'une façon plus ordonnée et de contrôler l'évolution de situations pouvant justifier une réaffectation des ressources. Les

systèmes de planification et de suivi ne remplacent pas une bonne gestion. Ils ont pour but de fournir quelques-uns des outils qui permettent de mieux gérer le programme du commerce.

Les plans des missions sont en passe de former l'ensemble de données le plus complet et le plus détaillé sur les marchés mondiaux que nous ayons jamais eu. Nous serons en mesure de fournir aux clients du Ministère des renseignements sur votre territoire, votre région ou sur l'ensemble des pays, que ce soit par secteur ou par région géographique, ou qu'ils portent sur un produit, un secteur ou un projet particuliers. Mais ce qui est peut-être le plus important, c'est que nous serons en mesure de définir nos priorités dans un délai très court et avec une très grande précision; il s'agit d'une exigence essentielle lorsque les ressources se font de plus en plus rares.

Trade Tracking System Guidelines

Some concern has been expressed about the use of confidential information provided in Business Influenced Reports submitted by posts as part of their quarterly report. The general policy is that the relevant bureau is asked for its concurrence before any particular Business Influenced information is included among "Highlights". In any particular case where a post might have asked to approve the release of especially sensitive information, such requests are carefully followed.

While it is important to include all business within a quarterly report, only those items in which a post has played a meaningful role will be used among "Highlights".

Additional effort is needed, particularly among larger trade development posts, to provide a level of "Business Influenced" reports commensurate with their resources. The present format of this report does not feature the quantity of Business Influenced reports of individual posts, nor their cumulative values. However, it is thought that such a review would more vividly reflect the variety and magnitude of post's relationship with the business community and may be incorporated into future reports.

Posts should continue to submit the list of names of Canadian business visitors as such information can be used to update Departmental data on exporters and serve as a reference for project recruitment.

Directives sur le système de suivi des résultats commerciaux

Certaines questions ont été soulevées concernant l'utilisation des renseignements confidentiels contenus dans les données sur les résultats commerciaux obtenus que les missions soumettent dans le cadre de leur rapport trimestriel. La politique générale à cet égard consiste à obtenir l'accord de la direction générale concernée avant d'inclure des renseignements particuliers sur les résultats commerciaux sous la rubrique "points saillants". Dans les cas particuliers où une mission a jugé utile de demander l'autorisation de divulguer des renseignements à caractère confidentiel, ces demandes sont examinées attentivement.

Bien qu'il soit important d'inclure toutes les activités dans chaque rapport trimestriel, seules les opérations pour lesquelles la mission a joué un rôle important doivent être inscrites à la rubrique "Points saillants".

Il convient de faire un effort particulier, notamment dans les missions où les activités commerciales sont plus importantes, pour transmettre des données sur les résultats commerciaux qui soient en proportion de leurs ressources. Le format actuel de ce type de rapports ne permet pas de faire ressortir le nombre de rapports sur les résultats commerciaux fournis par chaque mission, ni leur valeur cumulative. Toutefois, on estime que ce genre de recherches permet de donner une idée plus précise de la variété et de l'importance des relations qu'entretiennent les missions avec les milieux d'affaires, et qu'elles pourraient figurer dans les futurs rapports.

Les missions devraient continuer à dresser la liste des gens d'affaires canadiens en visite qui s'adressent à elles, car ces renseignements peuvent être utilisés pour mettre à jour les données du Ministère sur les exportateurs et servir de référence pour prendre les contacts nécessaires à un projet.

INTRODUCTION

This is the fourth quarterly report of Trade and Industrial Development Program results and activity. It covers the period of July through September 1986 and contains information drawn from the TID Program Tracking System. The report is based on the returns that were available up to November 17, 1986, from a total of eighty-six missions in all five major regions abroad.

This report encompasses the addition of Osaka as well as the recent reorganization of some geographic bureaux.

There are two main sections to this report:

Section I, immediately following, consists of six program results summaries; one for each major region and one for "All Regions", i.e., a global summary. Each page summarizes for its respective region: the business activity reported and highlights of that activity; key statistics on trade and investment enquiries; and the number of business visitors.

Section II, contains an "Activity Report" for each region, its respective sub-regions and posts. The format of these reports is identical throughout this section, regardless of the level of geographic aggregation. "Activity" on these reports is broken into TID program activity (items A-G) and activity relating to other mission programs (item H). For each activity there is an indication of the average time spent by Canada-based and locally-engaged trade program and non-trade program officers. There is also a "total time allocation" for each activity which should be read as an indicator of program officer person-years. Finally, each report indicates workload by activity.

INTRODUCTION

Le présent document constitue le quatrième rapport trimestriel des résultats et activités du Programme commercial. Il couvre la période de juillet à septembre 1986 et contient des renseignements tirés du Système de suivi des résultats commerciaux. Il a été établi d'après les rapports présentés, au 17 novembre 1986, par quatre-vingt-six missions réparties dans les cinq grandes régions du monde.

Ce rapport comprend également notre nouvelle mission à Osaka et reflète la ré-organisation de certaines directions géographiques.

Le rapport se divise en deux grandes sections:

La section I, qui suit, comprend les résumés des résultats de six programmes; soit un résumé pour chaque grande région et un pour "toutes les régions", c'est-à-dire un résumé mondial. Pour chaque région, le résumé présente les activités commerciales et leurs points saillants, des statistiques clés sur les demandes de renseignements relatives au commerce et aux investissements et le nombre de visites de gens d'affaires.

La section II renferme un "Rapport d'activités" pour chaque région et ses sous-régions et missions respectives. Dans toute cette section, tous les rapports sont présentés de la même façon, quel que soit le regroupement géographique effectué. Les "activités" sont subdivisées en activités du Programme commercial (article A à G) et activités se rapportant à d'autres programmes de la mission (article H). Pour chaque activité, on a indiqué le temps moyen consacré par les agents canadiens et les agents recrutés sur place chargés du programme commercial et d'autres programmes. il y a également pour chaque activité une rubrique "Total du temps consacré", qui doit être considéré comme un indice du nombre d'années-personnes relatif aux agents de programme.
