Grit Figuring Exploded.

How a Government who said they were "Only Fines on the Wheel" added to the Public Debt and Placed the Public Treasury!

Senator McPherson has just issued a public letter in which he deals with Grit figuring and puts the Grit figures in a way which is a masterly exposure of the insincerity and incapacity of the men who brought the country to the verge of bankruptcy, and should be read far and wide.

Referring to the ridiculous statement made in a Campaign Sheet recently issued by the Grits, which alleged that the Mackenzie Government added to the public debt the sum of \$884,662, Mr. Macpherson says—

"The writer of the Campaign Sheet asserts that the party which in office spent from Capital Account only \$684,662.

"I have drawn only this small amount from Capital Account—the millions which they expended in surveying and constructing the Canadian Pacific Railway and other works."

Every man in the country who reads this statement will know how absurdly untrue it is.

The expenditure of capital by the Mackenzie Government was not \$684,662, but \$42,811,202. Many will be surprised to learn that the portion that \$684,662 bears to \$42,811,202 is probably not far from the proportion of truth to fiction in the Campaign Sheet issued by the Opposition.

By referring to the public Accounts, it will be seen that the Mackenzie Government added to the public debt in 1877, \$75,728,641 and in 1878, 155,395,780

Showing an increase since Confederation of \$79,667,139
The net debt in 1873, was 99,848,461
And in 1878, 140,362,069

Increase by Mackenzie Government \$40,513,608

This proves that the increase by the Mackenzie Government exceeded \$40,000,000, being more than one half the total increase of debt since Confederation.

It is stated that these "five on the wheel" were in office LESS THAN FIVE YEARS, and they added to the public debt over \$60,000,000! There is a nice record for an economical Parliament. These are nice men to be charging their opponents with "extraneous" expenses! Extraneous! Indeed, every elector can figure for himself where this country would have been if a Grit Government had remained in power during the last five years of the Dominion at the rate of over EIGHT MILLIONS OF DOLLARS A YEAR!

But this was not all. The imbecility or the dishonesty of Cartwright has managed to abstract from the Dominion Treasury a nice penny to be added among the financial centres or head-centres on the other side of the water. Says the Hon. Mr. Macpherson—

"Then it must be remembered that while the Public Debt was swollen by the amount of Sir Richard Cartwright's extravagance, indeed, amounting to \$85,638,333, at their face or par value, and that while interest has to be paid thereon during the currency of the loan, the country received only as proceeds of these loans, 874 cents on the dollar, Sir Richard Cartwright having left in London, among bankers, &c., \$4,900,000 as their profits on the transactions."

Nearly FIVE MILLIONS OF DOLLARS "dropped" in only two transactions! Tell it in Gath—publish it not at Grit meetings! Here was a wonderful loss of money to the country, you! No wonder that some financial powers in England have attacked the present Government! No wonder that the cartwrights and the Grits were swept from office in 1878! Why, this man and his Party would have made the fortunes of half the brokers and bankers in London if they had only been kept in office. But WHAT WOULD HAVE BECOME OF CANADA! It is painful to pursue the subject further, but the mere statement of what was paid to brokers and bankers in England, and the losses this country has suffered by the Cartwright loans, as Mr. Macpherson had previously pointed out, would be enough to ruin any party or years of what was lost through Cartwright's loss of 1874 and 1876. The actual loss by these loans was therefore \$6,651,718.

With such facts as these patent to the public it requires a cheek of brass in a Grit candidate to stand forth and proclaim that the Mackenzie Government were models of financial ability, and that Cartwright was the ne plus ultra of a statesman.

We shall, doubtless, in this Dominion have many Governments before the St. John Globe of the future have succeeded in flying the Stars and Stripes over loyal British subjects. We shall have had many statesmen at the helm before the Blakes of the future can boast that they have severed the tie which binds us to the greatest Empire which has ever existed. But we shall probably never have a Government who wasted as wantonly the public treasure as the Mackenzie Government succeeded in doing; and we shall never have a Minister whose record will compare in mischievous results with the lamentable record of Sir Richard Cartwright.
