

An Act to confirm the Survey made by James Mackintosh, a Provincial Land Surveyor, of the Side Lines and Side Roads in the third, fourth, and fifth concessions of the Township of Beverly, under the authority of the Act 28 Victoria, cap. 100.

WHEREAS the Municipal Corporation of the Township of Beverly, Preamble. in the County of Wentworth, did, under the Act twenty-third Victoria, chapter one hundred, employ James Mackintosh, Esquire, a 23 V.c. 100. Provincial Land Surveyor, to define the precise position of the side lines

- 5 and side roads in the third, fourth and fifth concessions of the said Township of Beverly, as they, at the time of the passing of the said Act twentythird Victoria, chapter one hundred, then existed and were known, and to mark the same by permanent cut-stone monuments, properly marked and planted at the front and rear of the angles of the said third, fourth
- 10 and fifth concessions respectively, so that they might thereafter be deemed and taken as the undisputed boundaries of the same, and in order that the said Surveyor should deposit one copy of his plan and report of his survey in the Crown Lands Department, and another in the Registry Office for the said County of Wentworth; And whereas the said James
- 15 Mackintosh, as such Provincial Land Surveyor, did in all things duly comply with all the requisitions contained in the said Act, according to the true intent and meaning of the same, and did define the precise position of the said side lines and side roads in the several concessions hereinbefore mentioned, as they at the time of the passing of the said
- 20 Act existed and were known, and did duly mark the same by permanent cut-stone monuments, properly marked, and did plant the same at the front and rear of the angles of the said third, fourth and fifth concessions respectively, and did duly deposit one copy of his report and plan thereof in the Crown Lands Department, and another copy thereof
- 25 in the Registry Office for the said County of Wentworth, as required by the said Act: Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:---
- 1. The said survey and the report and plan thereof so made, and the The said sur-30 stone monuments so marked and planted at the front and rear of the vey and angles of the said third, fourth and fifth concessions of the said Town-boundary stands conship of Beverly, by the said James Mackintosh, are hereby confirmed, firmed. and the said monuments shall be deemed and taken to be the undisputed boundaries of the said side lines and side roads in the said third, fourth 35 and fifth concessions of the said Township of Beverly, respectively.

2. This Act shall be deemed a Public Act.
