HEREAS it is expedient to consoli-Preamble.

III And be it enacted, That the number of the said Courts in each District shall at no 5 time he less than three, nor more than nine; and that there shall be one Division Court held in each City and District Town, and that a Court shall be holden under this Act once in two months in every such Division, 10 and that it shall and may be lawful for the Judge of the said Court to fix and appoint the times and the places within such Divisions, when and at which such Courts shall be holden, and in like manner from time to 15 time to alter the same.

IV And be it enacted, That it shall and alter Divisons, may be lawful for the Justices of the Peace in each District now or hereafter to be elected in Upper Canada, from time to time, to alter 20 the number, limits and extent of such Divisions within their respective Districts, subject to the restrictions herein contained.

X. And be it enacted, That it shall be Clerk may ap-40 lawful for the Clerk of any such Division point a deputy Court (with the approval of the Judge there-ness, &c of,) to appoint from time to time, a Deputy to act for him in the office of Clerk of the Court,

at any time when he shall be prevented by illness or other unavoidable accident from acting in such office, and to remove such deputy at his pleasure; and such deputy during the time for which he shall be so appointed, shall have the like powers and privileges, and be subject to the like duties as if he were the Clerk of the Court for the time being; and the Clerk of the Court shall be civilly responsible for all the acts and omis- 10 sions of his Deputy.

And be it enacted, That the Treasurer of every District shall be the Receiver General of fees of the several Division Courts within his District; and every such Treasurer 15 shall be paid a per centage of pounds, on every hundred pounds of the gross produce of the fees of the Courts of which he is Receiver General; and every Judge shall be paid by a certain salary, the salary of a 20 Judge being in no case more than

XIX. And be it enacted, That in case of the death of any person during the time that he shall be holding the office of District Treamoneys in his surer or of Clerk of any Division Court, or after he shall have resigned or be removed 20 from such office, the Treasurer for the time being may, in his own proper name, or by his name and description of office, sue and recover from the executors or administrators of such person deceased, all such sums as 25 shall have been remaining in his hands, of money received under the authority of this Act by an action of debt in any Court of Record in this Province having competent jurisdiction—in which it shall be competent for the 30 plaintiff to declare that the deceased was indebted to the plaintiff for money had and received to his use for the purposes of this Act; and that the deceased died possessed of money had and received for the purposes of 35 this Act, whereby an action hath accrued to the plaintiff, to demand and have the same from such executors or administrators; and a like action may be brought against any executors or administrators of executors or ad- 40 ministrators; and in all such actions the defendant or defendants may plead in like manner, and avail themselves of the like matters in defence as in any action founded on simple contract of the original testator 45
