The report of the Grand Master was then read, as follows:

TO THE R. W. GRAND LODGE OF THE PROVINCE OF BRITISH COLUMBIA:

BROTHERS AND REPRESENTATIVES — By permission and blessing of the Supreme Grand Master we meet here to-day, being the Sixth Annual Communication of this R. W. Grand Lodge, to transact the business of the different Lodges in this Jurisdiction, and such other matters as may be brought before us in the interest and for the prosperity of our beloved Order.

My Brethren, another year has past and gone since our last Communication, and we should not forget to return thanks to the Almighty for his many blessings bestowed upon us, and for the continued prosperity of our Order in this Province. The past year has been one of great moment in our beloved Order, especially in this city. It is with deep regret that I have to record the demise of our worthy Brother J. P. Davies, Past Grand Master, who died very suddenly on the 20th of September last, and was buried on the following day. I therefore caused a notice to be placed on the bulletin board requesting the Grand Lodge to appear in a body to attend the funeral of our deceased Brother.

I have to congratulate the different Lodges in this city on the rapid strides they have made in erecting their new Hall, and I trust we may never hear the sound of an angry or unkind word within its walls.

You are aware of the legislation of the Grand Lodge of the United States, which at its last session changed its name to that of the Sovereign Grand Lodge; and also with regard to members who have been suspended for non-payment of dues, whose names are now to be kept in a separate book and to be called Dormant Odd Fellows. I hope at the next Communication of the Sovereign Grand Lodge this law will be repealed, as in my opinion it is of no benefit to the Order generally, and will only induce unworthy members to try and be reinstated into their different Lodges, as it only requires a majority vote to be reinstated. I therefore would recommend you to take such action as you may deem fit with regard to the readmission of such members. My official acts during the year, as follows:

March 17, I issued a Proclamation to all the Lodges in the Jurisdiction to celebrate the Sixtieth Anniversary on the 26th or 28th of April according as they might choose.

With the R. W. Grand Officers I visited the Lodges in this City officially on the following dates: April 11, Victoria Lodge, No. 1; April 16, Columbia Lodge, No. 2; April 17, Dominion Lodge, No. 4.

April 28, Laid the Corner Stone of the new Hall on Douglas Street, to be erected by the three Lodges in this City, with appropriate ceremony.

July 2, Installed the Officers of Columbia Lodge, No. 2.

July 3, Installed the Officers of Dominion Lodge, No. 4.

July 7, Installed the Officers of Victoria Lodge, No. 1.

July 8, Accompanied by the R. W. Grand Officers, I proceeded to New Westminster and installed the Officers of New Westminster Lodge, No. 3. The Brethren there received us in their usual kind manner. I found them working harmoniously together for the good of the Order.

September 8, With the R. W. Grand Officers visited Victoria Lodge, No. 1, officially. An initiation taking place the same evening the Grand Officers were kindly invited to exemplify the work by initiating the candidate. The invitation was accepted, and the Grand Officers performed the initiatory ceremony.

October 6, Granted a dispensation to Black Diamond Lodge, No. 5, to hold a ball and supper and to appear in Regalia at the same under the usual restrictions.

October 10, Proceeded to Nanaimo accompanied by the R. W. Grand Officers. We were kindly received by the Brethren and entertained during our stay.

October 11, Dedicated the Hall built by Black Diamond Lodge on their own property, which is a credit to such a young Lodge, and will no doubt prove a profitable investment. Here we found the Order in a healthy condition and working well.

January 5, 1880, Installed the Officers of Victoria Lodge, No. 1, into their respective chairs.

January 7, Myself and the Deputy Grand Master being unable to attend, the Officers of Columbia Lodge, No. 2, were installed by the R. W. Grand Secretary.

January 8, Installed the Officers of Dominion Lodge, No. 4.

January 31, Received a communication from Eureka Lodge, No. 13, Dakota Territory, appealing for aid to assist them in rebuilding their Hall. Taking into consideration all the circumstances I did not deem it advisable to forward the communication to the subordinate Lodges.

Also the same date a communication from the Grand Lodge of Florida, appealing for aid in favor of erecting a home for the proper treatment of unfortunate Brothers who might visit their Jurisdiction, which I forwarded to the different Lodges in this Jurisdiction.

I have received encouraging reports from the District Deputies of No. 1 and 2 Districts which are submitted, and regret very much that no report has reached me from District Deputy Norris of No. 3 District.

The decision of Bro. Todd, District Deputy of No. 1, which is given in his report, I approve.

The decision given by Bro. Trew, of District No. 2, which you will find in his report, does not properly answer the question put to him by New Westminster Lodge, No. 3. A widow or family of a deceased Brother being entitled to the funeral benefits to be paid by the Lodge at his death, if no expense is incurred. (See White's Digest, Sections 196 and 197.)

In conclusion, I take this opportunity of thanking the Officers who have worked so willingly and faithfully with me through the year. Also to the Brothers throughout the Jurisdiction for the many courtesies extended to us while visiting the different Lodges. I hope that perfect harmony may prevail through all our deliberations, and that our acts may prove to be for the welfare of the Brothers in this Jurisdiction.

The returns from Subordinates show a gain of 13 in membership.

The new law passed the Sovereign Grand Lodge regarding dormant members, has brought a return from Subordinate Lodges in this Province of 122, who now stand under that denomination, but I feel convinced that the names of several persons returned in that list, who left the country many years ago, are in all probability dead, for all trace of their whereabouts has been lost.

I received during recess appeal papers in the matter of John Bennett against the action of Dominion Lodge, No. 4, which I handed to the Chairman of Committee on Appeals.

I also received an Amendment to By-Laws of Black Diamond Lodge, No. 5, which I handed to Chairman of Committee on Laws of Subordinates.

I have to call your attention to the tax due Sovereign Grand Lodge. One year was omitted, but since then a year has passed, and we stand as owing \$75, which I have no authority to pay, and I would ask that some action be taken in the matter.

I received a Circular from Grand Lodge of Missouri regarding a revision of the Ritual of the Degrees, which I attach hereto, for any action you may feel inclined to take.

I also received a few days ago a letter from the R. W. Grand Representative of Ontario, which I also place before you for action.

These are the only communications received that require any action by the Grand Lodge. All the other correspondence has been attended to.

Whereas, the practical experience of years has demonstrated the fact that the five Subordinate Degrees of the Order fail in attractiveness to the membership generally, as is evidenced by the meagre attendance at Degree meetings, and the want of interest in the Degree work by most of those who have received the Degrees; and

Whereas, it is believed that a proper revision of the lectures and ritual of the Degrees, and their reduction from five to three, retaining the present unwritten portion of them, but varied in form, style and matter, would be more impressive, attractive and effective; therefore, be it

Resolved, That the Grand Lodge of Missouri is in favor of a revision of the Subordinate Degrees, and their reduction in number from five to three Degrees, and that our R. W. Grand Representatives are requested to advocate and vote for the same in the Grand Lodge of the I. O. O. F.

Rep. Grant submitted the following amendment to the preamble and resolution, which was accepted by P. G. Sire Veitch:

That the Grand Lodge of Missouri is also in favor of such change as will have the work in the Subordinate Lodges done in the highest Subordinate Degree.

Report read from Committee on Appeals, as follows:

TO THE R. W. GRAND LODGE OF BRITISH COLUMBIA:

VICTORIA, February 9th, 1880.

APPEAL OF BRO. J. BENNETT, OF DOMINION LODGE, No. 4, against the action of Dominion Lodge, No. 4, on charges preferred against him by Bro. M. J. Goode, P. G. of Dominion Lodge, No. 4, for conduct unbecoming an Odd Fellow, by attempting four times in the month of November, 1878, to defraud W. P. Sayward and several others, named in the indictment:

A committee of five Brothers of Dominion Lodge was appointed and proceeded to the trial of Bro. Bennett upon said charges.

Bro. Bennett was found guilty of the charge, and expelled the Lodge; from which action Bro. Bennett appeals on the following grounds:

1. That evidence was allowed, by the Committee who tried the case, of charges not specified in the complaint.
2. That the verdict of the Committee was contrary to the weight of evidence.

3. That the document alleged to be a copy of a statement made by one to the Official Assignee was ex parte evidence, and should not have been received. See White's Digest p. 389.

4. That the evidence was not taken in accordance with the provisions of Sec. 4, Art. 7, of the Constitution, and the record of the proceedings does not show that the witnesses, if members of the Order, gave their evidence on the honor of an Odd Fellow, or if not members, on oath or affirmation.

5. That evidence was rejected, tendered on my behalf, to show animus of prosecution.

6. That the vote on the penalty was illegally taken, as all the different orders of punishment being before the Lodge at the same time the order for expulsion was kept open for several ballots. On the first ballot a majority did not vote for expulsion, and not until several ballots were taken was majority vote for expulsion obtained. See White's Digest, 648.

After reviewing the case we find—

1. That Mr. D. McNaughton gave evidence on an offence alleged to have been committed about Feb. 25th, 1879, which was three months subsequent to the date of the offence with which he (the Appellant) was charged.

2. The documents before your Committee do not show if Mr. McNaughton is a member of the Order, or if an oath or obligation of any sort was administered to him before receiving his evidence. The same objection in the case of all the other witnesses. See Constitution Sub. Lodge, Sec. 4.

3. That the other witnesses do not appear to have any complaint against Bro. Bennett.

4. Your Committee agree with the Appellant that a person charged with an offence should not be compelled to criminate himself, and that ex parte statements should not be taken except in support or confirmation of other evidence.

5. Bro. Bennett had an opportunity, we presume, of objecting at the time to the appointing of a new member on the Trial Committee, of which he should have availed himself.

6. That the ballot was illegally taken, as penalty of expulsion ought to have been dropped after the first ballot. If as stated by the Appellant, we have nothing to show on the documents.

Your Committee would therefore recommend that the appeal be sustained.

Grand Lodge of Missouri, which states "that a revision of the Subordinate Degrees and their reduction from five to three degrees, would be more impressive, attractive and effective"; also, that "the work in the Subordinate Lodges be done in the highest Subordinate Degree"; and further, "that a careful consideration of this important matter" is asked of this R. W. Grand Lodge. Your Committee having carefully examined the subject contained in the Circular, submit the following:

"Resolved, That this R. W. Grand Lodge fully agree with the resolutions as contained in the Circular from the R. W. Grand Lodge of Missouri, dated St. Louis, Sept 1st, 1879, and in the event of this Grand Lodge not being represented at the next session of the Sovereign Grand Lodge, it would be pleased to have the R. W. Grand Representative from Missouri to state that the Grand Lodge of British Columbia are in favor of the proposed changes.

has been for years a vexed question in the Order, and that the Sovereign Grand Lodge has from time to time postponed legislation on this subject, we are of opinion that the notice of motion of Rep. Hayward, of No. 1, that the addenda to Sec. 2, Article 4, of the Constitution of Subordinates, be adopted, viz:

"Provided alway that such benefits shall not exceed the rate of \$10 per week for each dollar of monthly contributions, and provided always that no Lodge shall continue to pay the above rates of benefits for a longer period than six months continuous sickness, after which time it shall not exceed the sum of seven dollars and fifty cents for each dollar of monthly contribution. And farther, that after the expiration of twelve months continuous sickness no Lodge shall pay greater benefits than at the rate of \$5.00 per week for each dollar of monthly contribution."

With the following added thereto:

For members not having the Searlet Degree the benefits shall not exceed the rate of \$6.00 per week for the first six months, \$4.50 per week for the next six months, and after which \$3.00 per week during term of sickness, for each dollar of monthly contribution.

In all cases where a sick member has received any benefits, and by reason of the recovery of his health ceased to receive such benefits, he shall not be entitled to recommence the receipt of full benefits until he has been able to resume his business or occupation for six months, commencing from the day of his ceasing to receive benefits; but if he fall sick within that time he shall be placed in the same position as when he ceased to receive benefits and be paid the same benefits as he was then receiving; but when six months shall have elapsed after his restoration, if he fall sick he shall receive his full benefits.

Benefits shall not commence until after a Brother has been sick one week.

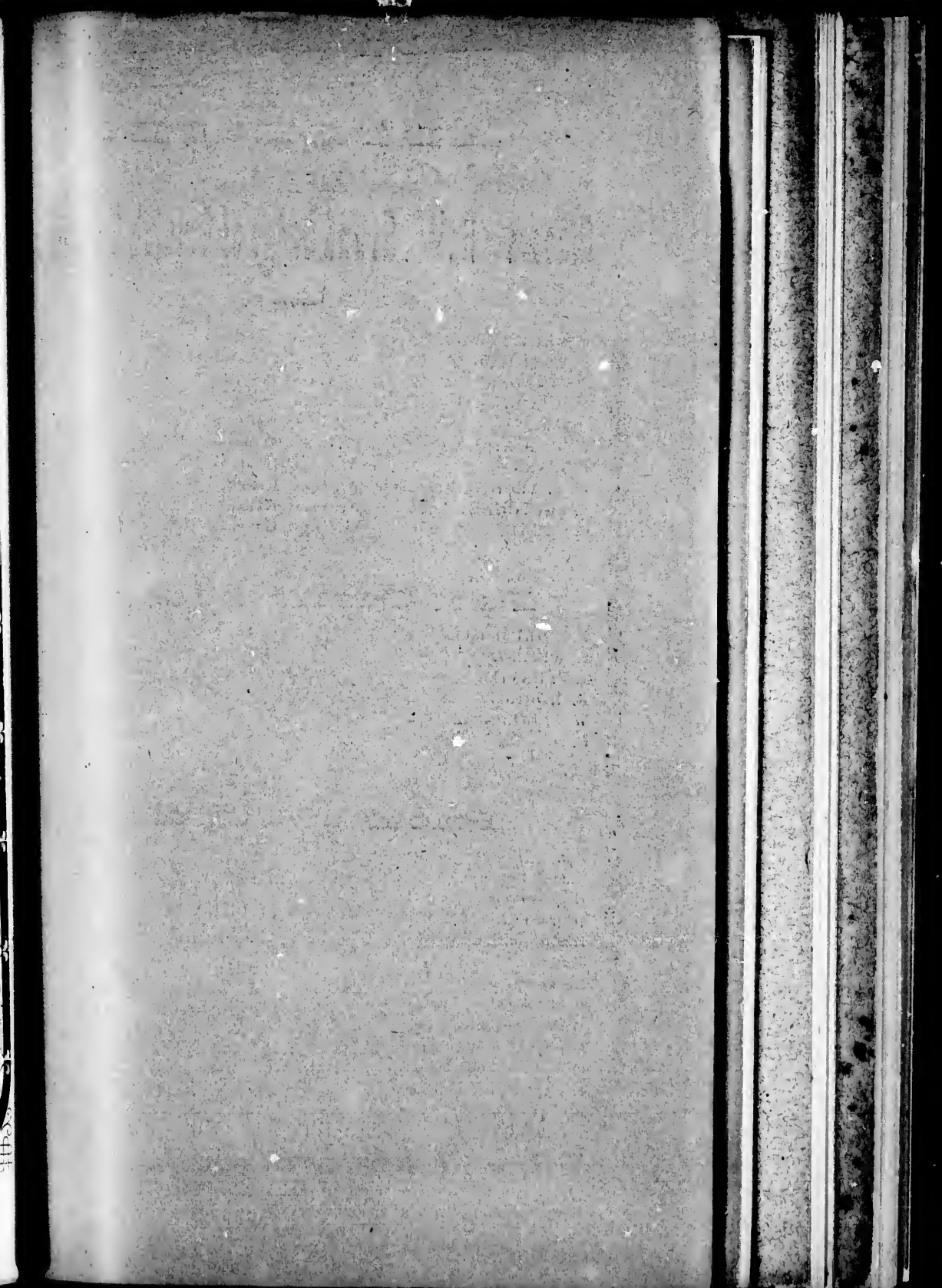
