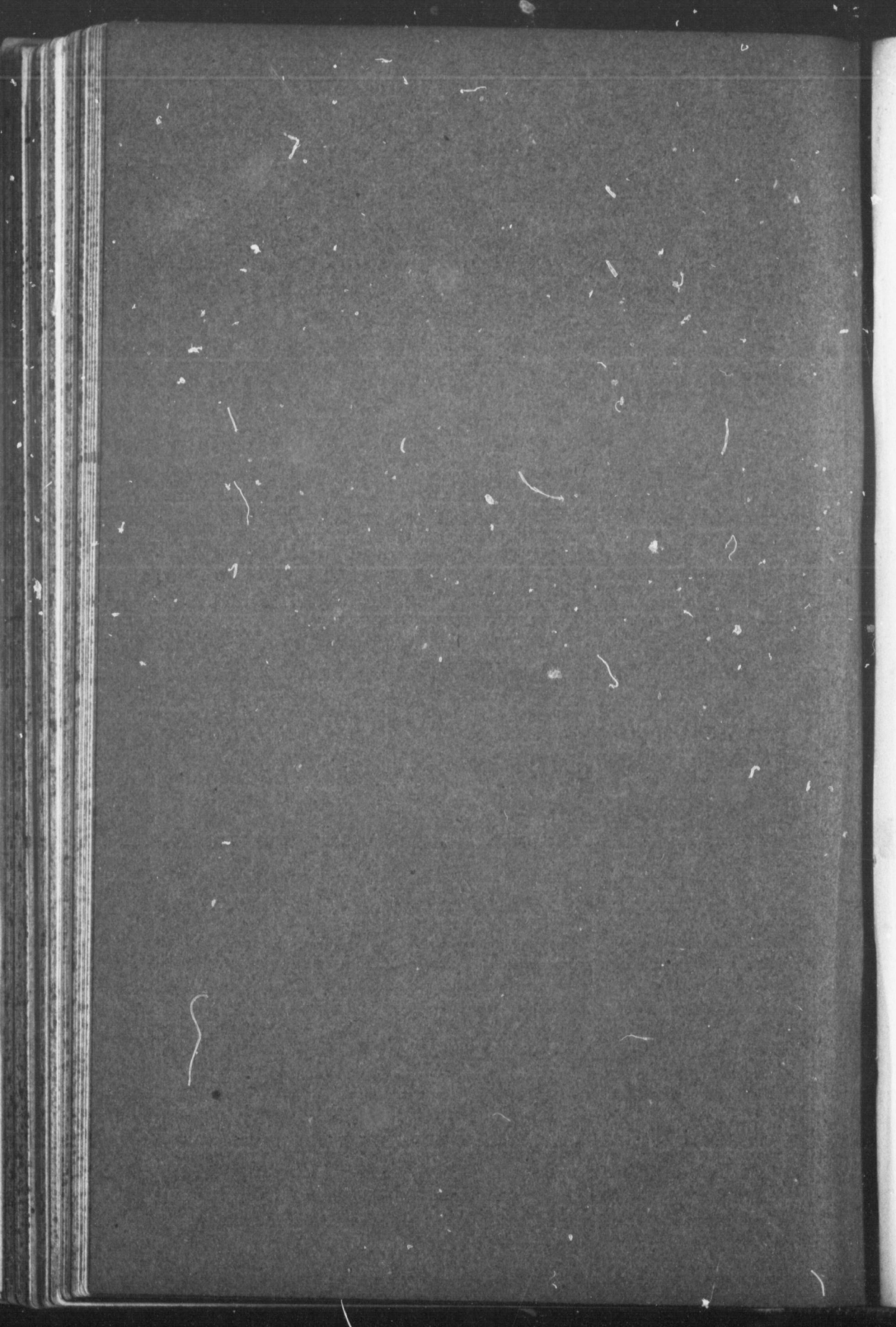

## REPORT.

---

The Managers of the Toronto House of Industry have much pleasure in presenting this their annual Report to the patrons and friends of the institution.

It is but too apparent that much destitution prevails in this city during the present season, and that the charity of the benevolent is highly taxed in giving relief to deserving applicants. The number seeking relief from this charity increases yearly, and the funds at the disposal of the committee are barely sufficient to grant the required aid.

In the last Annual Report allusion was made to a change therein proposed and since carried into effect, for distributing to out door recipients coal instead of wood for fuel. The change has been found to be efficient, in as much as the coal gives more comfort than wood in heating the houses of the unfortunate, and is more economical and less expensive for the institution.

It would appear that the public were not altogether aware that a soup kitchen for the daily dis-

tribution of soup in connection with the house was in existence at the beginning of the season ; there has been one for the past three years, and donations of that nutritious beverage given to a large number of poor families. This mode of relief has been attended with the most beneficial effects and is much appreciated by the recipients. The managers have much pleasure in reporting that since the last annual meeting warm and cold baths with shower baths have been constructed in the house for the use of the inmates ; the use of them has been attended with the most beneficial effects.

The managers cannot too strongly urge upon their patrons and the public in general the necessity of refusing to give to those vagarants who may apply to them in the streets or at the private residences of the charitable. As this institution is established for the express purpose of assisting the destitute and deserving poor in our midst, it is desired that all such applicants be sent to the house, where they would, upon its being ascertained that they were deserving, receive a donation of coal, bread, and soup. If such a proposal could be carried into effect it would give the managers an opportunity of ascertaining the exact number of the destitute poor in the city and might lead to procuring employment for those able and willing to work for and assist themselves.

There is a committee of three gentlemen from amongst the trustees and managers who meet twice a week, viz., on Tuesday and Friday in each week throughout the year, to inquire into the case of each applicant, and on being satisfied of the necessities of the case of each applicant, grant the required aid during the winter season. Whilst application is being made for a grant of fuel, the time of such committee is so taken up, that the labours of the day are frequently extended from nine in the morning till five o'clock in the afternoon, which, being a labour of love, is most cheerfully given by the gentlemen comprising the committees and entered into with much earnestness by several of the managers, who not only attend at their own appointed time, but act for those whose business and other engagements prevent them from giving that attention they would wish, and which at this time is urgently required.

Besides the weekly committees there are also ward visitors whose particular care is to visit the applicants at their houses. The labours of those gentlemen have been attended in many instances with the most beneficial effects, many who are unwilling to apply for relief have been found out and assisted, whilst many imposters have been detected, and that which has been obtained by craft has been stopped and bestowed upon the more deserving but



less urgent. The weekly committees having ascertained that men well able to work if inclined have applied for wood or fuel, resolved that in such cases they would require such persons to saw as much wood as was asked for, and where compliance was refused the relief sought for should not be granted. In some cases the applicant has refused to comply with the request of the committee, in which case relief was reluctantly refused.

The funds at the disposal of the managers have hitherto been sufficient to provide for all reasonable calls made upon them for relief, but as there is a steady increase in the number of distressed applicants, they hope those who are desirous of relieving the distressed will not hesitate in sending their contributions to the superintendent.

Since the last annual meeting the managers have to deplore the loss by death of a highly respected and ever to be regretted member of the Board of Management, the Rev. Mr. Kennedy, a clergyman of the Church of England : as a member of the weekly committee and ward visitor he was always most regular and assiduous in his attendance, and in giving assistance to and inquiring into the cases of the necessitous. His loss will be felt by the poor and deplored by the community amongst whom he resided.

Herewith are submitted detailed accounts of the treasurer of this institution, (J. W. Brent, Esq.,)

shewing the receipts and expenditure for the past year. Also the superintendent's report of the number of persons relieved with the amount distributed to out-door recipients during the same period.

All of which it is hoped will prove satisfactory.
