The G.W.P. read his report as follows:-

G. W. P.'s REPORT.

REPRESENTATIVES AND BROTHERS,

In accordance with the arrangements made in our last Session at St. Andrews, in May last, I have the pleasure of meeting you on the banks of the far famed Ottawa, for the dispatch of such business as may be brought before us, connected with the welfare of our Order. I trust that the spirit of fraternal regard, which, on former occasions, so largely prevailed amongst us, will on this occasion, be poured out upon us in richer abundance; so that the object of our organization will be greatly advanced. You are aware the Quarter through which we passed is not usually characterised by much activity in the Temperance cause. The merchant and the husbandman being alike obliged to devote a more than ordinary share of their time and attention to their laudable callings, so that the most that can be expected is that we should maintain our ground. It must be gratifying to you to know that the Divisions, and especially those which have been recently formed, have been making rapid progress, -and are exerting a very marked and beneficial influence. both direct and indirect, in those neighbourhoods in which they are formed, as may be instanced, in conducting Agricultural Sales, and also on the raising of farming and domestic buildings, which are now conducted to a large extent without the aid of Alcoholic Drinks; and the same remark will apply to the abandonment of Ardent Spirits in the social intercourse of the people. Still there is a great work to be accomplished. The work of ruin and death is still going on. Domestic bliss and social comfort are in many families giving place to widows' tears and orphans' groans, produced by black Intemperance; and such we may expect will continue to be the case, and that it will ever increase, unless some-

thing stronger than Moral Suasion can be brought to bear upon this destructive vice. I trust, therefore, that we shall never relax our efforts, until we have brought the public sentiment to bear upon our Legislature in such a way as shall induce them to pass a Law that will put an end to the manufacture and sale of all intoxicating drinks as a beverage, and limiting their uses to medical and mechanical pur-It will be our duty to consider what further steps are necessary to secure this great object; amongst them we would suggest the propriety of a hearty co-operation with the movements of the Upper Canada Temperance Law League, or the taking of such steps by this Division as shall be necessary for the formation of an Independent League for Lower Canada; the initiative of which, I am happy to say, has been already taken by several of our Subordinate Divisions forming themselves into branches. It will be necessary also that we take into consideration the best means of obtaining an efficient Lecturer, during the present Fall and Winter, to visit our Divisions, and break up fresh ground under the direction of a committee appointed for that purpose: and that every means within our power be employed to get up Petitions to the Legislature, to sustain those valuable men, who have with such untiring zeal and ability ad vocated the MAINE LAW.

The Grand Scribe read his Report as follows:-

GRAND SCRIBE'S REPORT.

MONTREAL, August 9, 1853.

OFFICERS AND BROTHERS,

Owing to the short period that has elapsed since our

last meeting, nothing of importance has occurred, beyond the regular business of this office.

No new Charters have been granted since last meeting, but intimation has been received that Gatineau Division, instituted on February 12, 1853, has ceased to exist. The communication from the Deputy of that district informing me of the fact, I sent to the G. W. P. for his action in the matter.

I addressed a Circular to the Divisions in relation to the Resolution passed at last meeting, recommending the Divisions to raise a subscription of 1½d from each member for the purpose of employing a Lecturer during the coming winter, and the answers that have been received have all been favorable. I have placed the communications received in the hands of the Committee appointed to take action in this matter, and I have no doubt but they will report at this meeting.

I put myself in communication with the Committee appointed to present a memorial to the Legislature, praying for the extension of the Act of Incorporation of the Sons of Temperance of Canada West, to Canada East. The petitions were put into the hands of the Hon. W. Badgley, who undertook to see the matter carried through; but it appears nothing further was done in the matter by the Hon. gentleman than presenting them to the House. The Grand Division will therefore have to begin again, and appoint some one in Quebec, whose duty it will be to see the matter properly attended to during next Session of Parliament.

The printed proceedings of the last meeting of the National Division have not yet reached this office; and this is to be regretted, inasmuch as action was there taken, as I learn from reports in the papers at the time, of considerable

interest to subordinate Divisions. The new Ritual was adopted, and will be furnished to subordinate Divisions as early as practicable, and it is the general belief that this new Ritual will revive a new and enlarged interest throughout the Order.

It was also voted that the Installation of Officers might be performed in public where Divisions desired it.

The Constitution of subordinate Divisions was amended, so as to allow a reduction of the Initiation Fee to one dollar. These are the most important items, but as the proceedings must be here soon, copies will be sent immediately on their arrival to the different subordinate Divisions under our jurisdiction, when action can be taken by them.

The progress of our principles in the circumstances referred to, should stimulate the Members of this Grand Division as well as the entire Order, to renewed diligence in the prosecution of the great work to which they have been called.

We cordially concur with the views expressed by the G. W. P. both as to the reason and necessity that exists for the passing of a Law similar to that which received so much countenance at the last meeting of the Legislature, and that no effort should be spared to renew the application at the next meeting of the Legislature, and we should not rest satisfied with anything short of this measure.

Your Committee are of opinion that the formation of a Canadian Prohibitory Liquor Law League for Lower Canada, similar to the one now in operation in Upper Canada, should at once be established in Montreal, and that all Subordinate Divisions should do their utmost to establish branches in their respective localities.

Your Committee are glad to learn from the Report of the Grand Scribe, that the Divisions have so generously responded to the call of the Grand Division, in contributing to the fund for a Temperance Lecturer; for it must be to efforts of this kind, in connection with the circulation of correct information through the press, that we must mainly look for the means of leavening the public mind with our principles.

Your Committee are also of opinion, that positive measures should be adopted to obtain an Act of Incorporation for Lower Canada, either by the extension of the Act already in existence, or if need be, a new Act on our own account, at the first meeting of Parliament.

Your Committee would further suggest that this Grand Division, for the future, hold but two Sessions in the year, viz —an Annual and Semi-Annual Session.

Your Committee regret to observe that three Divisions have neglected to send their returns, which prevent the Grand Scribe from completing his return, and thereby depriving this Grand Division of the means of forming an estimate of the real numerical strength of the Order, and would suggest that in future the Deputies be instructed to enforce this part of their commissions without fail.

Your Committee are of opinion that it would materially tend to the advancement of the Order, if our G. W. P. be deputed to visit during the recess of this Grand Division, such Subordinate Divisions as he may deem requiring his more special attention, not only to correct errors, and give information, but also to encourage and strengthen the hands of the Brethren.

The Journals of last Session of the National Division have just come to hand, and so soon as this Session of our Grand Division is over, a copy will be sent to each Division under our jurisdiction.

I would direct your attention to the following action had by the National Division, in regard to matters forwarded from this Grand Division for their consideration:—

The Committee on the case of appeal of Bro. Cole from the decision of this Grand Division, reported as follows, and which was agreed to:—

Your Committee think, that a brother's becoming unable, by reason of insanity, to practice his calling in life, and earn his bread or attend to his affairs, entitles him to benefits, as fully as an inability proceeding from any other cause, and that his being provided for by the public in an Asylum, no more dis-entitles him to the benefits, than if he were provided for in a Poor House, or than if his private fortune were ever so ample, in either of which cases he could rightfully claim benefits.

The Committee on Constitutions, to whom was referred the Memorial of this Grand Division, praying the National Division to enact a Law that will entitle benefit members leaving one Division to the same privilege, immediately on depositing their cards in another Division,

REPORTED:

"That while they feel the importance of the subject submitted for their consideration by the memorialists, they are of opinion that it is a matter entirely within the jurisdiction of the several Subordinate Divisions, and with which the National Division should not interfere." This was agreed to.

REPORT:-

We have had under our review, the Report of the G. W. P. and G. S., and which we have given our best consideration.

From the Report of the G. W. P., it is gratifying to observe, that several new Divisions have been added to our number during the past year, while others have been strengthened and enlarged, and that the Order has exerted a healthful influence, on the still too prevalent drinking customs.

We cordially concur in the opinion expressed by our G. W. P., that our efforts as an Order, must be directed to the enlightening of the public mind, and the awakening of the public conscience; and that we must not cease our efforts by petition or otherwise, as our free and enlightened institutions will permit, until the temperance public have been rid of the all but intolerable burdens imposed upon them, by the prevailing drinking customs; and we must, in an especial manner, continue to demand our rights, in no uncertain sound, at the bar of our legislative halls, until these have been granted. Every occasion which calls for a review of this question only convinces us the more, that nothing short of the Maine Law, i. e. the prohibiting by law, of the

importation, manufacture and sale of intoxicating liquors as a beverage, will suffice to remove the terrible scourge of intemperance from this or any other land.

A powerful means for the attainment of our object will be, the infusion of more life and vigor into the Sub-Divisions, as well as the establishment of central and branch Leagues, whenever such can be accomplished without weakening other existing organizations which might be employed for the same purpose.

We singularize the League as a powerful means for the attainment of the object we seek, from the fact that all may unite in it, without reference to any specific pledge, except that of the good of our fellow men; thus embracing within its ample folds all men, whatever the peculiar views they may entertain, but which they may be willing to hold in abeyance for the time being, for the general good of the whole. And your Committee cannot resist giving expression to the conviction, that all well-directed efforts for the advancement of the temperance cause, tend not only to the temporal but to the spiritual interests of our brother man.

We take our leave of the G. W. P's. Report, deeply impressed with the genuine christian feeling with which it is imbued, and under the conviction, that if the duties of the office are always discharged in the same spirit, great good cannot fail to be the result.

The Report of the G. Resolved, 3.—That in order more fully to carry out the main object for which we are united,—viz., The suppression of intemperance, Divisions be earnestly solicited to diffuse information among the people generally, by distributing books and tracts at stated periods, particularly the tract on the Order of the Sons of Temperance, written by G. W. A. White, and published by this Grand Division, as from a perseverance in so doing, more than any other course of proceeding, may great results be anticipated, particularly if accompanied by personal solicitation; and this Grand Division would recommend the appointment of a Tract Committee in every Division to superintend this business.

Resolved, 4.—That in view of the benefits, moral, social, and pecuniary, arising from connection with the Order, Sons of Temperance individually, (and particularly those who have families,) are solicited to sustain the Temperance Press, by becoming subscribers to papers of established reputation, in order to keep alive their own zeal in the cause, and to train up their families in Temperance principles.
