Resolved, That Bros. G. A. Downey, G. E. Sturgis and William Millar be a Committee on the State of the Denomination.

The Corresponding Delegate to the Mass. Association, Rev. William Knollin, gave an interesting account of his visit to our brethren there. He had had a warm reception, and found that in the centres of culture emotional religion was still in vogue.

Rev. J. W. Freeman, who attended the Annual F. C. B. Conference, at Hampstead, N. B., last October, spoke of the harmony which prevailed in their deliberations, and of the Divine presence in all their meetings. They are encouraged by many young then coming into their ministry.

Rev. E. W. Porter, though not a delegate, felt at home with us. He referred to his earlier life and his interest in sur prosperity. The tide of travel and communication was opening Nova Scotia to an era of prosperity and the spiritual opportunities were grand ones. He spoke especially of the work done at Ocean Park by the Free Baptists.

Rev. M. P. Orser and Rev. Mr. Turner, of the Free Baptists of Maine, New Brunswick and Nova Scotia, spoke of their mission here, and asked permission to present the matter at another hour.

The report of the Prudential committee, commending the letter of Rev. G. M. Wilson, giving excuse for non-attendance, was adopted.

Resolved, To have a social meeting this evening, the Moderator presiding.

Resolved, That hereafter the election of Officers of this Conference be the order of business on the Saturday of the Annual Session at 10 a.m.; and that the Treasurer's report precede the Election of Officers.

Various communications having been considered by the Prudential committee, they reported the advisability of considering some of these in committee of the whole, as they contained charges against a member of the Conference. Others were read, and the letter of the Beaver River church, being one of them, was referred to the General Pastorate committee.

The report was adopted as amended; and brethren S. K. West, J. L. Smith, D. T. Porter, R. A-Sims, Albert Cook, Morris Forbes and Wm. Wilson were appointed as the Committee of Seven.

Adjourned until 9 a.m. Friday.

Conference opened Friday morning by singing and prayer. The roll was called and minutes of previous day read and confirmed.

Resolved, That all persons having accounts with this Conference, present them as soon as possible.

Resolved, To pay the bill of expenses of the corresponding delegate to the Mass. Association, \$11.80.

Resolved, That the Nominating committee be instructed to name the Treasurer of this Conference as the Treasurer of each of the various societies of this Conference.

The Secretary of the Home Mission Society then read the report of that society with financial statement.

Resolved, To go into Committee of the whole, to consider the report of the Committee of Seven. 3 p.m. Friday.

The committee rose at 10-30 a.m. Saturday, and reported progress. The difficulties having been adjusted by the parties interested, the basis of settlement was accepted by a unanimous vote, and

Resolved, That the papers on the table containing the charges be destroyed.

Rev. A. G. Jones made a statement of the condition and prospects of the Halifax F. B. church, and appealed for council and help in securing a new church building.

Resolved, That the Moderator appoint a committee to confer with Bros. Jones and Wilson of Halifax.

Edwin Crowell, Wm. Millar and Adolphus Corning were appointed.

Bro. G. F. Francis was appointed as assistant clerk, pro tem.

Resolved, That the public meeting of the Education Society be this evening.

Adjourned until 8.30 a.m. Monday.

Conference resumed work at 8-30 a.m. Monday, Sept. 15. The Moderator in the chair. Minutes of previous session read and confirmed.

The Rev. M. P. Orser, of the Free Baptists of N. B., Maine and N. S., addressed the Conference requesting the Conference to establish a correspondence by delegation with that body, with a view to closer relations in the future. Moved and seconded, to grant their request. Moved and seconded, to refer the whole matter to the Executive of Conference. Carried.

That the Conference seek to raise this year the amount i. of \$300 required by the Home Mission Board.

That the pastor, deacons and, at least, two sisters ii. appointed for the purpose by each church, be in each church a committee to raise an amount equal to 10 cents per member for the whole membership of said church for the Home Mission Funds.

That the Home Mission Secretary may designate to iii. to each committee the time when such funds should be collected.

The Home Mission report was then adopted.

Rev. Wm. Millar then read the Obituary report.

Since God in His Providence has seen fit to remove from our midst, the REV. ALBERT SWIM, after a long and useful life in his Master's service, we would extend to the bereaved family our heart-felt sympathy, and thank God for such a life,

Woodworth who met so often in our yearly gatherings has been called away to his eternal reward. The church at Canning has been deprived in his death of a leading spirit, who shared the burdens of his brethren, and was con-stantly, actively engaged in the Master's cause. Deacon James Spinney, ci Lower Aryle, passed away to his heavenly home during the past year. He was a man of noble Christian character, and active in religious affairs until laid aside by old age and infirmity. He found the Saviour to be very precious to him in life and he died in the faith.

Rev. D. T. Porter presented resolutions on the denominational literature; and after considerable discussion in which special reference was made to the value of the S. S. Times in its own department the resolutions passed unanimously.

Resolved, That the Free Baptist Conference of Nova Scotia express its approval of the "Morning Star," "Religions Intelligencer," and "Missionary Helper," and recommend them as worthy of the favor and patronage of our people.

Resolved, To accept the invitation of the delegates of the Beaver River church, to convene with them in next Annual Session. Rev. J. L. Smith extended greetings and invitations of Lower Argyle church, if it should be necessary to have a special meeting in December.

Resolved, That the Clerk correspond with the churches of Queens county regarding a June Session of the Conference in that county.

A vote of hearty thanks was passed to Rev. Messrs. Twort and E. W. Porter for their efficient services during the Conference; also to the church and community for their hospitality and the choir for its valued assistance.

Resolved, That this evening we hold a Gospel Temperance meeting, conducted by Rev. W. M. Knollin, and that the Temperance report be read there. See Appendix G.

The Executive of Conference brought in the following resolutions upon matters referred to them :

a Resolved, That we are happy to learn that there is a prospect of securing the services of the Rev. E. W. Porter for the Beaver River pastorate; and that we recommend the Home Mission Board to appropriate one hundred dollars to supplement the amount which that pastorate may be able to raise for current expenses the coming year. Adopted.

b WHEREAS Rev. M. P. Orser, of the Free Baptists of N. B., Maine and N. S., h s made a visit to this Conference, steking corresput lence by delegation, with a view to more intimate relations in the future;

THEREFORE RESOLVED. That there are circumstances in the history of our denominaten which make it expedient to defer any correspondence by delegation for the present; while at the same time we are free to encourage any offers from their membership, who are resident in this Prevince; looking to their incorporation into the churches of the Free Baptist Conference of Nova Scotia. Adopted.

Resolved, That we are gratified to hear of the progress in the Advocate F. B. After due notice given by the Executive, the General Conference met in business session, at Glenwood, N. S., on Monday, November 4th, 1889, at 9 a.m. Twenty-two members of Conference present, the Moderator, Rev. W. C. Weston, in the chair. R. A. Sims, Esq., was appointed Assistant Moderator pro tem. The minutes, of Monday, September 16th, were read and approved. After a season of prayer, the report of the committee on Amenuments was read and adopted.

By this vote the constitution of the F. B. Conference of

Nova Scotia was changed to read thus :

ARTICLE II. This Conference shall consist of its own Elders and Licentiates, and Deacons and Delegates from the several churches of which it is composed. Each church shall have one delegate for every fifty members, but any church shall have one delegate, though its membership be not fifty.

ARTICLE III. The officers of this Conference shall be a Moderator and Assistant Moderator, a Clerk, a Corresponding Secretary, a Treasurer, and an Auditor, all to be chosen annually.

BY-LAW X was also amended by adding "The Corresponding Secretary shall receive the reports from the various churches, and report to the Conference on the first day of its Annual Session.

Instead of "Quarterly meetings of the said church" substitute, "Churches of the said Free Baptist Conference of Nova Scotia."

Rev. J. W. Freeman was elected as Corresponding Secretary. The books of the Y. and S. Quarterly Meeting with \$10.37, the funds in hand, were handed over by Rev. J. W. Freeman, the Q. M. Clerk, and a vote of thanks was given him for his services.

Resolved, That the bill of the delegate to the F. C. B. Conference, amounting to \$10.00, be paid.

Resolved, That we hold a session in Kings Co. next

June; the Executive to choose time and place. The report of Rev. S. K. West, delegate to the Maine Central Yearly Meeting, was received. Ordered that his bill

HOME MISSION SOCIETY REPORTS.

The work of denominational Home Missions is of that nature which loses nothing by just comparison with any other branch of Christian activity.

The fostering and development of churches in communities where population is increasing and the facilities of communication are assured, is the duty of the Christian church as pre-empting such ground against the dominion of the devil. The sympathies and convictions which lead godly people in such communities to seek the co-operation of a particular denomination in sustaining the means of grace may be regarded as a specific and divine call upon such a denomination for aid.

Having accepted such a mission and directed the evangelizing forces into such fields of work, it is still more necessary to continue the operations and to hold the fort. Good church generalship will not permit a recall of these forces while the destiny of souls depends on the continuance of the mission. The argument of St. Paul (i Cor. xii,) regarding the care of the weakef members of the body and the mutual dependence of all parts of the organization, is a beautiful illustration from nature, and is especially applicable to the Home Mission interests.

The needs of our brethren in sustaining the divinely appointed preaching of the Word; our need of intimate acquaintance with them in order that we may know Jesus the better; the prospects that the work may become strong and pay their debts gratefully to others as Paul did his to the Greeks and Barbarians in Christ's stead; all these urge the intelligent Christian to engage even at self-sacrifice in such blessed work.

The attempts of the F. B. H. M. Society in this respect arenow to be given. Your board considered a claim from the church at Riverdale which is weak financially, but affords a hopeful young community to the worker. Here much increase of contribution or permanent membership can hardly be expected, as the youth go from home quite early in life.

We also engaged the services of Rev. J. W. Freeman as a Home Missionary, leaving him as President of the Board much discretionary power as to place of labor. He spent a month at Kemptville in the last of 1889, and a large part of the present year in Kings Co. doing very effective work as indicated by God's favor in the conversion of souls and the invigoration of the churches. in part appeared in the "Religious Intelligencer."

The Yarmouth church having assumed independent pastoral relations, has urged no claim for Home Mission

funds since the spring of this year. Our interest in the work of Brother D. T. Porter and

the churches under his care has been shown by continuing the grant to them.

A guarantee was given to Brother Downey, laboring at Port Mouton, for his salary there, which was redeemed by

the Port Mouton church, without calling on our society. Beaver River pastorate was considered as historic

ground where the local efforts made to retain Brother Wilson must be supplemented to the extent of our power, and so sixty dollars was voted to assist them, of which fiftyfive have been paid. How much that grant was appreciated may be seen both in the letter of Beaver River church and

reports of work done in that pastorate. Regarding the work of Brother Freeman who spent one

month in Kemptville, and six months in Kings county, the accounts will show that the board has appropriated about one hundred dollars to supplement the amount received by him on his field of operation, at a salary of five hundred dollars per annum. For this amount we have drawn on our

The other appropriations amount to about one hundred capital account. and twenty-five dollars, which represents the amount raised

from churches which have not participated in the grants. The board, to do effective work, needs more money; and

an authorized, systematic appeal to our churches, would doubtless double the amount of present income, and prove a great blessing to our cause. We call upon all pastors and churches to respond in individual and united work to this end.

Especially should ministers and church officers be prominent in temperance work. As has been said by one, the name of Intemperance is Legion. It destroys the individual, soul and body, and blights the community. Its very aim and purpose is to destroy. Now, as all the moral interests of the individual and community are under the special care of the ministers and his church officers, certainly the local temperance societies should never have to complain that the work of these divine agents has been unfaithfully done. And not only through the local societies may these agents work, but much can be done by bringing to the notice of the people and emphasizing, by every means in their power, the temperance notes and items which are so frequently and, in many cases, so regularly appearing in our religious and secular papers.

Furthermore, not only Free Baptists but Christians everywhere should better appreciate the importance of securing men of sound temperance principles as legislators. It cannot be expected that drinking men, or men who assume temperance principles for the sake of votes, will make laws to suppress the traffic in strong drink.

But, above all, should we as Free Baptists see to it that children shall be rightly and faithfully instructed in regard to intemperance, Much can be done through faithful work in the home, not only by conscientiously avoiding to prescribe intoxicating drinks as medicine except by the advice of an honorable physician to bridge over a crisis, but also, by instilling into the young mind an abhorence for the very name of alcohol. Again, greater and still greater efforts should be made to secure temperance instruction in the common schools of our Province. Let us as Christians make haste to erase from the minds of our boys and girls the idea that somehow it is a manly or smart thing to drink and get drunk. This may be effectually accomplished when we teach them just what it means to take alcohol, the intoxicating principle of all strong drinks, into the system. Tell, explain, and illustrate to them the effect upon the muscles, the diges-

tion, the circulation and the working capacity of the body. Show them how it paralyzes the nervous system, weakens the will, and exposes its victim to temptation and disease. us aim to secure, at an early date, temperance instruction in all schools for scholars of every grade. Again, tem-Maine much good has been done in this way. perance lessons are too often entirely omitted in the Sabbath Here is an opportunity for Free Baptists to set a Much can be done for the children, also, Schools. better example. We here take through juvenile temperance organizations. the opportunity of recommending to our churches the forming of the society called the Juvenile Temperance Band, among The Ritual of this society was prepared by Rev. of winning the lation for the highest christian character in individual lives cannot be over-estimated.

Could the faith of the good Robert Raikes have foreseen the progress and extent of this work begun by him in such a humble way, surely the heart of the good man would have rejoiced that he should be the founder of an institution which was destined to be such a mighty factor in christianizing the human race.

Christ said to His disciples, "Search the scriptures, for in them ye think ye have eternal life and these are they which testify of me," and every christian knows that the highest success in the christian life depends largely upon a proper understanding of our relations to God and of His will concerning us; and these can only be attained by the study of His word.

Then. too, it is important that religious teaching should be begun early in life, as the young are more susceptible to the impress of truth, and before the heart has been hardened and the judgment perverted by a life of sin. And even mature minds and hearts, softened and governed by God's love, cannot afford to lose the great Messing to be derived by becoming more familiar with the teaching of the good book and by coming in contact with and cultivating an interest in the spiritual welfare of those outside their own home circles.

Were parents everywhere as earnest and attentive concerning the spiritual needs of their children as they should be, the Sunday School would perhaps not be such a necessity as it is; since unfortunately this is not the case, it becomes the duty of every person be he christian or otherwise, who desires the elevation of humanity (which can only be attained by the building up of the Redeemer's kingdom) to be engaged in this good work and seeking by importunate prayer and persistent effort to lead the young to Jesus, the children's best friend. Indeed we fail to see how any christian can be clear who refuses or wilfully neglects to find his or her place in this work, in which all, regardless of age or ability, may labor for the glory of God and the salvation of souls.

As to the best methods to be used in the work of the school we advise First that the Bible find a more prominent place in its exercises.

While we appreciate the assistance rendered by the various Lesson Helps available, especially our own Star Quarterly, yet we fear that the tendency is to use these to the neglect of the Bible, which cannot possibly result in the progress desired, as that can only be attained by studying different portions of God's word in connection with each other and by encouraging and cultivating habits of searching at the fountain head of truth for those gems, not rare it is true, but of priceless value to the believing heart.

Second only to giving the word of God the first place in our work, is the matter of prayer for, and a deep interest in, the welfare of our scholars. We must learn to love them; not only those who are naturally lovable and attentive to us, but as well those who are wayward and careless.

This can only be attained by keeping our own hearts filled with the spirit of the Blessed Saviour; and by continually seeking to realize that God is no respector of persons, and that His grace is able to make all what he desires them to be.

We need above all to have great faith in God and His promises, and to remember that our "labor cannot be in vain in the Lord."

Rev. F. W. Reeder having received a call, came to this Pastorate last December, and since that ime has been their Pastor. He has been, and is still, earnestly and zealously laboring on this Island. Last winter special meetings being held, great good was done. Twelve ware added to the Clarks Harbor church by baptism. Rev. George Sturgis, M.D., is also deeply interested in Christian work, and is Superintendent of a flourishing Sabbath school, connected with the church at the Harbor. The interest at Centreville is encouraging. At Newellton, the people have erected a new Meeting house. Upon the whole the cause of God is being built up on this Pastorate. That God may greatly bless minister and people is our prayer.

Pastorate No. 3, including Second Barrington, Bear Point, Shag Harbor and Woods Harbor churches. Pastor, Rev. Wm. Miller, is still engaged with the people of these churches. Regular services are held in Barrington Centre, and good is being done. Bear Point Church has suffered loss by the death of faithful workers, but they are not discouraged. At Shag Harbor the interest is good. At Woods Harbor the usual church work is being performed with a good prospect. It is well known that Bro. Miller is wide awake in attending to duty's call. All things considered, the outlook is favorable.

Pastorate No. 4, including Upper and Lower Pubnico, First and Second Argyle Churches. Rev. J. W. Freeman closed four years' pastoral labor with these churches, last January. Rev. J. L. Smith having received a call, accepted, and came to them in March last. We believe that through the providence of God our Brother has been directed back to his native Province. His ministrations to the people of his charge are highly appreciated. One was baptized, last November, in Lower Pubnico. At Central Argyle a new Meeting House is being erected. It is the intention to have it finished this fall. When it is finished there will be four good Meeting Houses on the Pastorate. It is to be regretted that on account of the unsatisfactory ownership of the Pubnico

Head House of worship it remains unrepaired. At First and Second Argyle Churches, prosperity is quite apparent.

Pastorate No. 5, including Tusket, Riverdale, Plymouth, Little River, and Brooklyn Churches. Rev. W. M. Knollin He preaches in all the places named on this At Tusket the conference and social meetings are is Pastor. not regularly kept up, but the preaching services are well Pastorate. attended and the harmony of the church members is good. A Sabbath School has been started with a library of seventy volumes, besides singing books, etc. Plymouth is doing very well. Last winter, in revival meetings, three were received into the church by baptism. Riverdale has complied with the offer of the church by baptism. Home Mission Society and now has regular preaching. Bro. Knollin has labored for some years with churches of the May the Lord greatly bless him and all concerned. Pastorate No. 6, including Yarmouth, Chebogue, and Pastorate.

Pastorate No. 6, including rarmound, characteristic Session Hill churches. Rev. C. F. Cooper continued in pastoral relations with all these churches until last April. Since that time, Yarmouth church, having become strong enough financially has undertaken the support of a pastor alone. Bro. Cooper still remains in Yarmouth and is zealously administering to them the word of life. The interest is good Five received by letter. Considering the location of this last named church, it is very important to this denomination. Let us all pray that God will greatly bless minister and people here. Bro. G. Wilson has preached some at Session Hill. Doubtless these last named churches will be placed in other

pastorates. Pastorate No. 7, including Beaver River and Sanford churches, and their branches; Cedar Lake and Short Beach. Rev. G. M. Wilson has had the pastoral charge of these churches. He has performed faithful work on this pastorate, the result of which will we trust, be reaped in the near future. Bro. What is wanted on this Pastorate now is a Pastor to work in harmony with our brethren and continue the good work. They have raised more financially than was thought, one year ago, for the support of the gospel, and the prospect for the future is still better. It must be the prayer of all our hearts that God will wonderfully bless all through this field of labor.

Pastorate No. 8, including Kemptville and Carleton Churches, and their branches—Rockingham, Forest Glen, etc. Licentiate E. S. Parker, who was with these churches at time of our last Yearly Conference, returned to school last November. In December last Rev. J. W. Freeman by direction of Home Mission Board paid them a visit and spent about a month, for the most part in Kemptville holding revival meetings and baptized four and united them to the church. Your secretary heard good words said in favor of Brother Parker's labor there. That he did much good among them was quite apparent. Bro. Parker returned to this Pastorate in May last and has been with them until recently. He is now attending school. Brother West has labored one quarter of his time at Forest Glen, and has also done good work in other parts of the Pastorate.

Pastorate No. 9, including the churches of Queens County. Last fall, Licentiate Geo. Downey moved his family to Port Medway, and since then has had the care of Port Medway, East Port Medway, and Port Mouton Churches. The interest in East Port Medway is good. At Port Medway, they feel quite encouraged and have a fair interest. Everything at Port Mouton is not so encouraging. We believe Bro. Downey has exerted himself to build up the cause of God here. We hope and pray with those deeply interested in the cause of God that these churches may have large ingatherings and thus be greatly blessed. (Caledonia) Harmony Church has had no regular preaching from a Pastor, but for about two or three months Bro. James Smith has been preaching to them and good has been done.

Pastorate No. 10, including the churches of Kings County: These churches had been without pastoral labor for some time. Under the direction of the Home Mission Society

Rev. J. W. Freeman went to their assistance last February. Twenty-eight At Halls Harbor there was a good revival. were received into the church by baptism and three by letter. He has spent all his time since, excepting the month of May with the churches of this last named county. One has been received into the Canning Church by baptism and two by letter. The prospect of this church is much better than it has been for a long time. The debt on Meeting House is about paid off. The prospect in the Black Rock Church is not good. Many are away. Out of a membership of over a hundred, you can count only on about thirty resident members, and many of these live some miles from House of Worship. There are very few resident members at Avonport, but we have some good members there. To sustain our interest in this county, they must have a settled Pastor. Rev. Joseph Cox has again settled at Canning on his farm. He has preached some in Halls Harbor, Centerville, etc., and has been very helpful.

Pastorate No. 11, including the churches of Cumberland county. This field of labor has the pastoral care of Rev. D. T. Porter. He preaches at Advocate Harbor, Port Greville, Apple River and other preaching stations. There appears to be an increase of interest. It is the purpose of the people at Advocate Harbor to have a House of Worship built soon. There is a good interest at Port Greville. Four were added to the church by baptism. Reports speak well of our Brother's work and of the prospect in Cumberland county. Let it be remembered that these churches have only been planted a short time ago.

Pastorate No. 12, Halifax church: Rev. Arthur G. Jones is Pastor. Report from church was made up, stating finances, &c., to December 31st, 1889. A good interest in Christian work and fellowship is reported. It has not been without great effort by those deeply interested, for years, to hold and build up the religious interest, connected with this denomination, in Halifax. The brethren are hopeful, and under the protection and favor of God, we may look for greater things. Three have been added to the church by baptism. It is to be hoped that Bro. Jones will be cheered in his work.

That Rev. W. C. Weston is very much interested in religious work of the Denomination, is well known.

THE BASIS OF UNION.

Between the Free Christian and Free Will Baptist Denominations of Nova Scotia, Nov. 29, 1866.

Many of the people of God, belonging to the Free Christian and Free Will Baptist denominations as they hitherto existed in this Province, believing their isolated condition to be detrimental to the prosperity of each, and to hinder the work of God among us, by retarding the development of the free element in this Province, resolved to labor for their consolidation. After several unsuccessful attempts to accomplish the work, believing it to be right, and for God's glory, relying upon Him for success, the work was again undertaken previously to the last General Conference of the Free Christian Baptists, held at Canning, Cornwallis, Sept. 15th, 16th, and 17th, 1866, when the following was proposed to the Free Will Baptist Quarterly Meeting as a

BASIS OF UNION.

1. That the Free Will Baptist churches of Nova Scotia dissolve their present organized connection with the Yearly Meeting of which they are now members, and that they and the Free Christian Baptist Churches of Nova Scotia unite in one Yearly Meeting under the name of the Nova Scotia onference of Free Baptists.

2. That we unite in one Denomination as we now exist ; the Ministers of each Body to retain their present standing in the new organization, and have full liberty to engage in any church from which they may have a call.

That we labor to consolidate and unite our churches, 3. when such consolidation is necessary, as fast as possible.

That any church have the liberty to receive and 4. employ a Minister of the Free Will Baptist Denomination, who is in good standing, with the understanding that if said Minister should be permanently employed, he shall unite with the Denomination.

At the last Quarterly Meeting_of the Free Will Baptists, held at Pubnico, Nov. 2nd, the proposed Basis was adopted.

It was then agreed by the Quarterly Meeting, with the consent and advice of the Delegates of the Free Christian Conference who were present; to call a Convention of delegates from the several Churches of the two Denominations, at Barrington, on Thursday, November 29th, for the purpose of Consolidation.

Agreeably to the above, the Convention was organized by appointing Deacon Thomas W. Wilson to the Chair. Prayer was then offered. Brother J. C. Smith was chosen Secretary.

The Chairman then made some very interesting and appropriate remarks; when Rev. E. G. Eaton moved, and Rev. J. I. Porter seconded, the following resolution :--

Resolved, that we, the Free Will Baptists, and Free Christian Baptists, in the Province of Nova Sectia, do now form ourselves into a Yearly Meeting, to be known by the name of the Free Baptist Conference of Nova Scotia.

This was passed unanimously.

is Province, two\religious communities, known respectively as the "Free Will Baptists" and the "Free Christian Baptists" of Nova Scotia, did call a Convention of Delegates from the several churches of such two Denominations at Barrington, in the County of Shelburne, on Thursday the twenty-ninth day of November, A. D., 1865, who then and there unanimously formed themselves into an association, by the name of the "Free Baptist Conference of Nova Scotia."

And Whereas this religious community now exists, governed by rules made by the said Conterence, composed of all the ordained Elders, Licentiates, and Deacons of the said church in Nova Scotia; and the business of such Conference is presided over by a Moderator elected annually from the ordained Elders;

And Whereas such Conference is possessed of considerable property, real and personal;

And Whereas parcels of land have been conveyed in trust for such Conference, and Meeting Houses have been built thereon, and serious inconveniences have arisen in the holding and transmission of such lands, and the management of their property, from the difficulty of appointing new Trustees on the occurrence of vacancies, and it is believed that the incorporation of such Conference and the several churches respectively, would greatly simplify the management of their temporal concerns and advance the several benevolent and religious objects of the said church, and promote its spiritual interests :

Be it therefore enacted by the Governor, Council, and Assembly, as follows :

1. Elders C. Knowles, A. Swim, D. Oram, W. C. Weston, S. K. West, J. I. Porter, E. Sullivan, C. Cann, W. M. Knollin, T. H. Crowell, W. Downey, B. Minard, Z. Churchill, J. Lowden, C. Cushing, sen., B. Banks, B. Covell, J. Newell, T. Pitman, G. Bower, D. Porter, W. Sollows, S. Crowell, J. Robbins, E. Crowell, L. Minard, C. Cushing, jun., P. Smith, S. W. Nickerson, A. E. Gayton,

A. Pitman, S. Hamilton, J. Trefry, D. P. Corning, M. McGray, J. Kenny, E. W. Perry, A. McGray, W. Sims, A. Robbins, T. Brown, E. Perry and others, now constituting "The Free Baptist Conference of Nova Scotia," their associates and successors shall, be a body politic and corporate, by the name of the Free Baptist Conference of Nova Scotia, and may purchase, receive and hold grants of real and personal estate, and sell, assign, mortgage, lease, or otherwise dispose of the same, and receive the rent and profits, for the use of such Conference and Churches, according to the intention of the donors, and may appoint officers for the management of any funds, institutions and objects connected with such Conference and Church, and may regulate the mode of constituting and government of such Conference.

2. The first meeting of the Corporation shall be held at Port Medway, in Queen's County, on Thursday, the eighth day of September next. When the Corporation shall be deemed organized, thirteen members shall be a quorum for the transaction of business; but any less number may adjourn.

3. The Trustees of every Meeting House in connection with such Conference shall be a body politic and corporate, by the name of "The Trustees of the Free Baptist Church of ——," according to the particular designation thereof, at pleasure, with power to hold and receive real and personal estate, add may mortgage, sell, assign and convey the same, and make such By-Laws as may be necessary, and exercise all the corporate powers conferred by law for the purpose of managing the temporal affairs of such Meeting House.

4. Every conveyance grant, bequest, devise or gift of any lands, goods, chattels, or real or personal estate, whatever, that may have been made to any Free-Will Baptist or Free Christian Baptist Society or Body, or may hereafter be made to any Free Baptist Society or Body other than Trustees of any Meeting house organized by or consituted under the authority of "The Free Baptist Conference of Nova Scotia Confer fully i bequea proper authori Equity otherw proceee mas sp grantor such gi finally such ru 5.

5. All property or estate, real or personal, to which any Society or Body in connection with such Conference, other than Trustees of any Meeting House constituted under the authority of the said Conference, shall be entitled in any way, shall be held by such Conference for the benefit of and in trust for any such Society or Body, and the Conference shall by such rules as they shall from time to time make, define the mode of investing the same and accounting therefor.

6. The Conference may invest any money they may have from time to time, either in Government securities or the security on Bond of any Corporation, or on Bond and Mortgage.

7. Every church may annually, at such time as the Conference shall prescribe, elect any number not less than three nor exceeding five Trustees, being members of such church, who shall continue in office for one year or until others are elected in their stead.

8. Every male of the age of twenty-one years or upwards, being a communicant of such church, or a regular attendant at the worship in the Meeting House where such church is organized, who contributes towards the funds of the church, such sum as the Conference shall prescribe, shall be entitled to vote at the election of Trustees.

9. Every Board of Trustees incorporated under the authority of this Act shall exercise their powers and privileges according to the usages and rules prescribed by the Conference, but not less than three Trustees shall form a quorum for the transaction of business, and no By-Law shall be made repugnant to Law.

10. All lands conveyed in trust to the late Free-Will Baptists, or late Free-Christian Baptists, and buildings erected thereon, shall be subject to the provisions of this Act whenever a Board of Trustees to manage the same is elected in the manner herein prescribed, provided always that this provision shall not interfere with the right of the Conference to the exclusive control to any land conveyed to such Conference.

11. No conveyance, gift, or bequest made to the Free Baptist church shall be deemed to be made to "The Free Baptist Conference of Nova Scotia," unless such Conference is expressly named in the instrument of transfer.

12. The annual revenue derived from the rent of lands held by such Conference shall not exceed twenty thousand dollars, nor of any Board of Trustees two thousand dollars.

Constitution of the Free Baptist Conference of Nova Scotia.

ARTICLE I.

This yearly meeting shall be known as the Free Baptist Conference of Nova Scotia.

ARTICLE II.

This Conference shall consist of its own Elders and Licentiates and Deacons and delegates from the several churches of which it is compresed. Each church shall have one delegate for every fifty weat members, but any church shall have one delegate though its memcomposed

ARTICLE III.

The officers of this Conference shall be a Moderator and Assistant Moderator, a Clerk, a Corresponding Secretary, a Treasurer and an Auditor, all to be chosen annually.

ARTICLE IV.

Any church which holds the doctrines and agrees to conform to the usages of the Free Baptist denomination, may at any time, on application, by a vote of the Conference become a member thereof.

ARTICLE V.

This Conference shall have power to discipline the churches of which it is composed, and to exclude them for disorderly walk if labor proves unsuccessful, but in no case to reverse their decisions nor interfere with any of their internal regulations.

ARTICLE VI.

The Annual Session of this Conference shall be held on the / 395 second Thursday in September, commencing at 10 o'clock a. m., at which time it shall be the duty of the churches of which the Conference is composed to represent themselves by delegates, and report their standing, prespects and statistics by letter; and at which time the Conference shall transact such business, not repugnant to this constitution, nor to the usages of the denomination, as in their judgment may forward the cause of Christ, and the interests of the churches within the limits of the Conference.

ARTICLE VII

Thirteen members shall constitute a quorum for business; a less number may adjourn.

ARTICLE VIII.

No minister of this Conference shall be allowed to engage, labor, or in anywise exercise the functions of his office in any community in which there is a Free Baptist Church, between which, and said minister there is any difficulty or trial existing until said difficulty or trial shall have been removed ; provided always that this article shall not be so construed as to conflict with the Basis as adopted by this body.

ARTICLE IX.

All questions before this Conference shall be decided by a majority vote.

ARTICLE X.

No Licentiate shall be ordained to the work of the ministry until examined and approved of by this Conference.

ARTICLE XI.

This Conference shall have power to adopt any Regulations or By-Laws not inconsistent with this Constitution, which may be deemed essential to the farther regulation of its sessions.

ARTICLE, XII.

A special meeting of this Conference may be called by the Clerk at the request of three Elders and two Lay brethren by giving three weeks notice in the "Religious Intelligencer" and the "Morning Star."

ARTICLE XIII.

This Constitution may be altered or amended by a vote of the Conference at any Session, notice of such intended alteration having been duly given and recorded at any previous Session.

BY-LAWS.

ARTICLE I.

Each session and adjourned sitting of this Conference, shall be opened and closed by priver

ARTICLE II.

After the opening of each session of this Conference, a Prudential Committee shall be appointed, whose duty it shall be to examine all questions coming before the Conference, and decide whether they should be introduced or not.

ARTICLE III.

This Conference may hold correspondence by Delegates or otherwise with other religious bodies as it may deem advisable.

ARTICLE IV.

This Conference shall sit with open doors except when it may go into Committee of the whole.

ARTICLE V.

Any person not a member of this Conference may be allowed to take part in its discussions by obtaining permission of the Conference.

ARTICLE VI.

It shall be the duty of the members of this Conference to be present at the time appointed for the sitting, and any one wishing to retire while the Conference is in sitting, shall first obtain leave of the Moderator.

ARTICLE VII.

It shall be the duty of the Moderator to appoint the time of opening and closing of all the meetings; to preserve order; and to conduct all business before the Conference to a speedy and proper result.

ARTICLE VIII.

The Moderator and Prudential Committee shall have charge of the Meetings for Worship during the session of the Conference, and appoint Brethren to preach in them, if expedient.

ARTICLE IX.

The Clerk shall keep a true and faithful record of all Meetings, and business transacted in them, and furnish a copy of the same for publication, when required.

ARTICLE X.

The Corresponding Secretary shall receive the reports from the various churches, and report to the Conference on the first day of its Annual Session.

ARTICLE XI.

The Treasurer shall receive all money forwarded or paid to him for this Conference; shall pay to the order of the Conference such sums as may be drawn for; and shall render at each Annual Meeting a just and proper account of all money received and paid-including from whom amount received, and to whom paid.

ARTICLE XII.

Every member wishing to speak in Conference, shall first address the Moderator, thus :- Brother Moderator.

ARTICLE XIII.

No person shall be allowed to speak more than ten minutes at any one time, nor more than twice on any subject without leave of Conference.

ARTICLE 'XIV.

No debate shall be allowed on any motion, except the same be submitted in writing, and seconded by a Member of Conference.

ARTICLE XV.

Each Male Member of the Denomination shall be requested to contribute annually a sum not less than twenty-five cents, and each Female not less than ten cents into the Conference Fund.

ARTICLE XVI.

The Constitution and By-Laws of this Conference shall be read at the commencement of each Session.

A Treatise on the Faith of the Free Baptists of Nova Scotia.

ARTICLE I.

Being and Attributes of God.

The Scriptures teach that there is only one true and living God, who is a spirit, self-existent, eternal, immutable, omnipresent, omniscient, omnipotent, independent, good, wise, holy, just, and merciful; the Creator, Preserver, Governor of the Universe; the Redeemer, Saviour, Sanctifier, and Judge of men; and the only proper object of divine worship. The mode of his existence, however, is a subject far above the understanding of man. Finite beings beings cannot comprehend him.

ARTICLE II.

Creation, Primitive State of Man, and his Fall.

SECTION I. CREATION-1. Of the World.-God created the world, and all things that it contains, for his own pleasure and glory, and the enjoyment of his creatures.

2. Of the Angels. - The angels were created by God to glorify him, and obey his commandments. Those who have kept their first estate, he employs in ministering blessings to the heirs of Salvation, and in executing his judgments upon

3. Of Man .--- God created man, consisting of a corporeal body, and a thinking, rational soul. He was made in the similitude of God to glorify his Maker.

SECTION II .- PRIMITIVE STATE OF MAN AND HIS FALL. -Our first parents, in their original state of probation, were perfectly righteous; but in consequence of the first transgression, the nature of their descendants is so unholy, that none by virtue of any natural goodness can become the holy children of God; but they are all dependent for salvation upon the redemption effected through the blood of Christ; and upon being created anew unto holiness through the operation of the Spirit; both of which are freely provided for every

Ghost is in reality God, and one with the Father in all divine perfections. It has also been shown that Jesus Christ is God, one in essence with the Father. Then in essence these three, the Father, Son, and Holy Ghost, are one.

ARTICLE V.

Atonement and Mediation of Christ.

1. Atonement.—As sin cannot be pardoned without a sacrifice, and the blood of beasts could never actually wash away sin, Christ gave his life a sacrifice for the sins of the world, and thus made salvation possible for all men.

2. Mediation of Christ.—Our Lord, not only died for our sins, but he arose for our justification, and ascended to heaven, where as Mediator between God and man, he will make intercession for us till the final judgment.

ARTICLE VI.

The Gospel Call.

By virtue of the atonement, which is designed to counteract the effects of the fall, man is placed in a salvable state; the grace of God, the influences of the Holy Spirit, and the invitations of the Gospel are given to all men, and by these they receive power to repent and obey all the requirements of the Gospel. We mean only to say, that salvation for all men is possible, for though in its provision it is free and absolute, yet in its application it is expressly conditional. Salvation, then, being freely provided, and man being capable, through grace, of obtaining it, if he perish whom can he blame but himself?

ARTICLE VII.

Repentance.

The repentance which the Gospel requires is a deep conviction, a penitential sorrow, an open confession, a decided hatred, and an entire forsaking of all sin. This repentance God has enjoined on all men, and without it in this life, the sinner must perish eternally.

ARTICLE VIII. Faith.

True faith is an assent of the mind to the great and fundamental truths of revelation; an act of the understanding in giving credit to the Gospel through the influence of the Holy Spirit, and a firm confidence and trust in the living God. The fruit of faith is obedience to the Gospel. The power to believe is the gift of God; but believing is an act of the creature. Repentance and faith are required as a condition of pardon.

ARTICLE IX.

Regeneration.

As God is a holy Being, and heaven a holy place, man must be regenerated before he can enter a state of happiness. This change is a renovation of the soul by the grace and Spirit of God whereby the penitent sinner receives new life, becomes a child of God, and is enabled to perform spiritual service. It is called being born again, born of the Spirit &c.

ARTICLE. X.

Perseverance.

As the regenerate are placed in a state of trial during this life, their future obedience is not determined. Consequently their eternal salvation is depending on their abiding in Christ; it is therefore their duty and privilege to be steadfast in the truth, to grow in grace, persevere in holiness, and made their election sure.

ARTICLE XI. The Church.

A Christian Church is an assembly of persons who believe in Christ and worship the true God, agreeably to his word. In a more general sense it signifies the whole body of real Christians throughout the world. The Church being the body of Christ, none but the regenerate, who obey the Gospel, are its real members. who believe b his word. bdy of real mg the body Gospel, are a particular d faith, and SECTION 1.—OFFICERS OF THE CHURCH.—The officers in the primitive church were apostles, bishops, and deacons. The apostles were the special *Witnesses* of the works and sayings of Christ, and of course this office ceased when their work was accomplished. The *Gifts* perpetuated in the Church are evangelists, pastors, teachers, helps and governments. These, however, do not appear to be distinct officers, but they imply different kinds of duties, which are performed by bishops or elders, deacons and others.

1. Bishops are overseers, who have the charge of souls -to instruct and to rule them by the Word. They are called Elders, and they perform the duties of pastors, teachers, and evangelists. The qualifications required in a candidate for the office, are as follows :-- 'He must be guiltless and be the husband of but one wife. He must be watchful, prudent, and have the regular exercise of cool, dispassionate reason. His conduct and manners must be decent, orderly and grave. He must be a lover of hospitality and good men; ready to communicate and able to teach. He must be temperate; not quarrelsome ; nor desirous of base gain. He must govern his family well; he must not be a novice, but experienced in the things of God, and have a character not justly liable to reproach. He must be especially called of God to the work, adhere closely to the doctrine of Christ, and be ordained by the laying on of hands.

The duties of an Elder or Bishop are, 1. To be an example to the flock in all things. To preach the word, baptize, and administer the Lord's Supper. He should assist in ordaining elders and deacons, and according to his ability, do the work of an evangelist, and make full proof of his ministry.

2. A Deacon is a regular or stated servant of the church. For the qualifications required in a candidate for this office, see 1 Tim. iii. 8, 12. Acts vi. 1-3.

Duties of a Deacon.-1. He should attend to the temporal wants of the poor members of the church.

2. As the design of his appointment was that the ministry might be freed from temporal care, the inference naturally follows that it is his duty to see that *their* wants also are

supplied. 3. There being no other officer in the church to superintend its *temporal affairs*, it is inferred from the nature of his office that the deacon should attend to all the concerns essential to its prosperity, which do not devolve on an Elder. 4. From the important nature of his qualifications, it has been considered his duty to take the lead of religious meetings in the absence of the minister.

SECTION II.—ORDINANCES OF THE CHURCH.—The following ordinances or institutions of the church were appointed by Christ, and are obligatory on the church :—

1. Christian Baptism.—This is the immersion of believers in water, in the name of the Father, Son, and Holy Ghost, in which are represented their death to the world, the washing of their souls from the pollutions of sin, their resurrection to newness of life, the burial and resurrection of Christ, their resurrection at the last day, and their engagement to serve God.

2. The Lord's Supper is designed to commemorate the sufferings of Christ, and to represent, in the use of bread and wine, the communion which saints have with him, and with each other. Every true believer in Christ, being a member of his body, and a part of his visible church, has not only a right to partake of his body and his blood in the communion, but is under obligation thus to commemorate his death.

SECTION 111.—DUTIES OF THE CHURCH.—The duty of the Church is that obligation which the revelation of God enjoins upon it collectively, or as individuals, for the manifestation of his manifold wisdom, the perfecting of the saints, and the conversion of the world. In this obligation are included the observance of the ten commandments, entire obedience to the influences of the Spirit, to the institutions of the Gospel and to all the instructions and precepts of the Scriptures. Among the latter are the following particular requirements : Christian fellowship, secret and family prayer, domestic and social duties, watchfulness, administering to the necessities of the poor and afflicted, the support of those that preach the Gospel, and the exercise of church discipline. ARTICLE XII.

Death.

The bodies of men, being subject to the calamities of the fall, all have died, all will die, except Enoch, Elijah, and the Saints that will be on earth at the last day. But the soul, spirit, or the immaterial part, survives the dissolution of the body, and immediately after death enters a state of happiness or misery.

ARTICLE XIII.

The Resurrection.

As the transgression of Adam secured temporal death to all his posterity, so the obedience and resurrection of Jesus Christ iender it certain that the bodies of all men will be raised from the dead. The saints will be raised in the likeness of Christ; but the wicked will awake unto shame and everlasting contempt.

ARTICLE XIV.

The General Judgment.

As men do not receive the due reward of all their deeds in this life, there will be a general judgment, when time and man's probation will close forever. Then all men will be judged according to their works; the righteous will enter into eternal life, and the wicked will go into a state of endless punishment.

We agree to attend, to the utmost of our power, the Sabhath, Conference, Prayer, and other Meetings of the In every Conference Meeting we attend, we will report ourselves to the Church, and in no meeting will we wilfully grieve the Holy Spirit of God; we will labor for the prosperity of the Church and its upbuilding in the most holy faith--not forsaking it in adversity, but bear each other's

burdens, and so fulfil the law of Christ. We will attend to the ordinance of the Lord's Supper as we may have opportunity, or as it may be administered

by those over us in the Lord. We will not use intoxicating drinks ourselves, nor allow them to be used in our families, nor furnish them for persons in our employment except for medical, chemical or mechanical We will not buy nor sell these articles, nor give our influence for the traffic in them, only for the purposes above named.

We will walk circumspectly towards those who are without, that the cause of God may not be reproached on our account; and will strive to promote those enterprises which have for their object its advancement—among which are Sabbath Schools, Bible Societies, Missions, and Education.

And may the God of Peace sanctify us wholly, and preserve us blameless to the coming of our Lord Jesus Christ; to join the glorified around the throne of God, in ascribing blessing, and honor, and glory, and power, unto Him that sitteth on the throne, and unto the Lamb for ever and ever.

We agree to the annexed usages as guiding to the faith in doctrine, and our practice in Church Government

Church Usages.

Section I.

This church shall be known as the "Free Baptist church," in connection with the Free Baptist Conference of Nova Scotia

Section II.

The leading doctrines held by this church are those set forth in the Treatise of Faith, as published in A. D. 1866, by the Free Baptist Conference of Nova Scotia, which we consider in harmony with God's Word.

Section III.

All the affairs of this church shall be under the decision of church meetings publicly convened. At all church meetings the Pastor shall preside, and in case of not having a Pastor, the Senior Deacon.

68 Section IV.

The officers of this church shall be :--1. A Paster, to be chosen by the church. 2. Deacons, similarly elected. 3. Helps may be chosen annually to assist the Deacons and Pastor in their duties. 5. A Clerk, whose duty it is to keep a good and faithful record of the church.

Section V.

The Pastor, Deacons, Helps and Clerk, may meet quarterly, or oftener, if necessary, to arrange and digest any business to be brought before a church meeting, and for other purposes when expedient.

Section VI.

All business of this church shall be done by a majority vote, except the reception of members, which shall be unanimous.

Section VII.

Any church may receive the transient labors of any Minister belonging to the Free Will Baptists of the United States of America, or the Free Christian Baptists of New Brunswick, who is in good standing in his own denomination; and if requested by a legal vote of the church, shall have full liberty to administer the ordinances and give the right hand of fellowship therein.

Section VIII.

This church admits to full fellowship only such as give satisfactory evidence of being born of God, and are immersed; but admits to communion and equal privileges in worship all who love our Lord Jesus Christ in sincerity and truth.

Section IX.

Cases of discipline, after private admonition and counsel by the Pastor or some other officer of the church, shall be brought before the Officers' Meeting for consideration; but sentence or suspension from church privileges or excommunication shall be the act of the church meeting only.

Section X.

This church shall meet at least once in every month for Christian conference; at which time it shall be the duty of

Any member in good standing, removing from the limits of the church to which he belongs, or wishing to unite with any other church, on application to the church, may receive a letter of commendation by a majority vote of the church.

Section XII.

Whatever mode for obtaining means to defray the expenditures of the church shall be deemed prudent by legal vote thereof, the members shall co-operate in—all contributing as God prospers them.

Section XIII.

The Covenant and Church Usages shall be read in church conference at least once in three months.

Section XIV.

The church may adopt any rule not contrary to God's Word, which may be necessary for their interests.

In view of the benefits secured by the Pastorate System and our desire to preserve it intact;

Therefore be it enacted by this Conference, that]any minister who shall in any way act prejudicially to the best interests of the Pastorate System, as recommended and adopted by this body, shall be the subject of discipline for such an act;

And be it further enacted, That any church that shall violate, by any action, the rules regulating this Pastorate System, shall also be liable to the discipline of the Quarterly Meeting to which it belongs, unless both as regards ministers and churches, consent has been given to take such action in accordance with vote of Quarterly Meeting to which said churches and ministers belong.

ARTICLE II.

Its object shall be to promote union and harmony in feeling and unanimity of doctrine among its members, and to consider any question of discipline or adopt any mode of operation for the assistance or benefit of its members, that may be deemed proper by a majority at any regular meeting.

ARTICLE III.

Formula for Marriage.

Divine Revelation, my friends, has declared Marriage to be honorable in all. It is an institution of God, established in the time of man's innocency, ere he had yet been banished from Paradise. It was given in wisdom and in kindness, for the benefit of the race, to increase human happiness, to repress irregular affections, to support social order, and to provide that through well-ordered families, truth and holiness might be transmitted from one age to another. It lies at the basis of all human society, and all governments and laws are built upon the household relations.

From the history of our blessed Saviour, we learn that that he honored a Marriage festival with his presence, and wrought there the beginning of his miracles; and by the Holy Spirit speaking in His Apostle, he has selected the relation thus formed, as an apt emblem of the union that exists between himself and the church. A union thus consecrated, should therefore be undertaken not thoughtlessly and ineverently, but discreetly, advisedly, and in the fear of God, and with a due regard to the purposes for which matrimony was at first ordained.

And now, as in the sight of God, the Searcher of hearts, and as you will answer it on that day when the secrets of all hearts shall be made manifest, I charge you to declare, if there be any cause which should prevent your lawful union.

ADDRESS RESUMED.

As the ties now to be assumed should be sundered only by death, it becomes you to consider well the duties enjoined upon you as husband and wife. If duly remembered, and faithfully discharged, they will smooth the rugged pathway of life ; lightening, by dividing its sorrows, and heightening, by doubling its enjoyments; if neglected and violated, you

cannot escape misery and guilt. It is the duty of the husband to be the friend, counsel-

lor, and guardian of his wife; shielding her from danger, providing for her support, and cherishing for her a manly and unalterable affection; it being required by the word or God that husbands love their wives, even as Christ also loved the Church and gave himself for it.

It is the duty of the wife to be the friend, companion, and solace of her husband; reverencing and obeying him, putting on the ornament of a meek and quiet spirit, which is in the sight of God of great price; it being commanded by Scripture, that as the Church is subject unto Christ, so should wives be to their own husbands in every thing.

It is the duty of both to cherish and ever to manifest mutual affection ; to preserve an inviolable fidelity ; to delight each in the society of the other; to cultivate a just sense of their respective duties; to train wisely all who may, in their household, be brought under their influence; to remember that in interest and reputation, as in affection, they are to be henceforth one and indivisible ; and to see to it that what God hath joined together, man put not asunder.

The legal marriage of two persons involves mutual consent, publicly expressed, before a duly authorized minister of the Gospel, of this province, who publicly pronounces them man and wife.
