An Act further to amend the Acts relating to the Niagara District Bank.

WHEREAS the President and Directors of the Niagara District Bank ^{Preamble.} have by their Petition prayed that the Capital Stock of the said Bank may be limited to the sum of Four Hundred Thousand Dollars; and that the time for subscribing and paying up the balance still unsubscribed and unpaid, may be extended for two years longer, and it is expedient to grant the prayer of the said petition: Therefore Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

1. For and notwithstanding any thing contained in the several Acts <sup>Time for pay-
ing up capital</sup> 10 of the Parliament of this Province relating to the said Bank, the sum ^{extended.} still required to be subscribed and paid up in order to raise the paid up capital of the said Bank to Four Hundred Thousand Dollars, shall be subscribed for and paid up within two years from and after the passing of this Act, on pain of forfeiture of the privileges granted by the said Acts.
- 15 2. For and notwithstanding any thing in the said Acts or any of <sup>Capital lim-
ited.</sup> them contained to the contrary, the capital stock of the said Bank shall be and the same is hereby limited to the said sum of Four Hundred Thousand Dollars.
- 20 3. So much of the said Acts or any or either of them as may be inconsistent with, or repugnant to the provisions of this Act, shall be and <sup>Inconsistent
enactments
repealed.</sup> is hereby repealed.
- 25 4. The said Acts as amended by this Act shall be and remain in force ^{Acts amende^d} until the first day of June, which will be in the year of our Lord, one <sup>continued to
1st June, 1870.</sup> thousand eight hundred and seventy, and from that time until the end of the next session of the Parliament of this Province, and no longer.
5. This Act shall be a Public Act. ^{Public Act.}
