




CHEMICAL CATHODES

The first television sets were built around vacuum tubes. These tubes had a filament which heated a metal cathode. The cathode emitted electrons which were accelerated by an electric field. The electrons hit a phosphorescent screen, creating a bright spot of light. This spot could be moved across the screen to form an image. However, the vacuum tubes were expensive and fragile. They also required a lot of power to heat the filament.

In the early 1950s, researchers began to look for alternatives to vacuum tubes. One promising idea was to use a chemical cathode instead of a metal cathode.

Chemical Cathodes

A chemical cathode is a material that can emit electrons without being heated. This makes it much more efficient than a metal cathode. It also allows for smaller, lighter, and more durable television sets.

However, there are some disadvantages to using a chemical cathode.

One disadvantage is that the cathode needs to be replaced after a few years of use.

Another disadvantage is that the cathode is less efficient at emitting electrons than a metal cathode.
