"Where copies of the list have been sent to the secretary or secretary-treasurer of a school board instead of to the head teacher of a public or separate school, such secretary or secretary-treasurer shall act in the place of the head teacher, and shall post up one copy of the list on the door of every school house under the control of the board, R.S.O., 1937, c. 7, s. 10.
