DIPLOMATIC APPOINTMENTS

The Secretary of State for External Affairs, the Honourable Barbara McDougall, announces the following diplomatic appointments:

Mr. L. Michael Berry, as High Commissioner to the Commonwealth of Australia, with concurrent accreditation to Papua New Guinea, Solomon Islands and the Republic of Vanuatu.

Mr. Berry (BA Honours [Economics and Political Science], McGill University, 1961; Graduate Studies in International Relations, McGill University, 1963) joined the Department of Finance in 1961. In Ottawa, he has served as Director General, Economic Policy Bureau, and as Director General, Asia Pacific South Bureau. He has served abroad in Berlin, London and as High Commissioner to Singapore. 1988, he was appointed Ambassador and Permanent Representative to the Organization for Economic Co-operation and Development in Paris. Mr. Berry is married to Linda Kathleen Randal and they have three children. Mr. Berry replaces Mr. R. Allen Kilpatrick.

Mr. Raymond A.J. Chrétien, born in Shawinigan, Quebec, Ambassador to the Kingdom of Belgium.

Mr. Chrétien (BA, Joliette Seminary, 1962; LLL, Laval University, 1965; admitted to the Quebec Bar in 1966) joined the Department of External Affairs in 1966. He has served abroad in New York, Beirut, Paris and as Ambassador in Kinshasa from 1978 to 1981 and in Mexico from 1985 to 1988. In Ottawa, he served as Director, Industry, Investment and Competition Policy Division, Assistant Under-Secretary of State for Manufacturing Industries, Technology and Transport Bureau, and as Inspector General of the Department from 1983 to 1985. Since 1988, he has been the Associate Under-Secretary of State. Mr. Chrétien is married to Kay Rousseau and they have two children. Mr. Chrétien is replacing Mr. Jacques Asselin.

Mr. Reginald H. Dorrett, born in Saskatoon, as Consul General in Los Angeles, United States of America.

Mr. Dorrett (BA [Science and Economics], University of Saskatoon, 1953; Certificate [Public Administration], Regina College, 1957; Certificate [Business Administration], Regina College, 1958) joined the Department of Industry, Trade and Commerce in 1964, following several years with the Province of Saskatchewan and the City of Regina in industrial development. He has served abroad in Düsseldorf, Jakarta and Tokyo. From 1983 to 1986, he was Ambassador in Manila and from 1986 to 1988, he served as Ambassador in In Ottawa, Mr. Dorrett has worked as Director of Operations, Trade Commissioner Service, in the Department of Industry, Trade and Commerce and as Secretary to the Interdepartmental Committee on External Relations. he became Director General, International Marketing Policy Group, and in 1982 he was named Assistant Under-Secretary of State, International Marketing Policy, Planning and Evaluation, at the Department of External Affairs. 1988, Mr. Dorrett has been Assistant Deputy Minister, International Trade Development, and was recently named Chief Trade Commissioner. He is married to Isabelle Jean McMillan and they have three children.

Mr. Bernard Dussault, born in Montreal, as Ambassador to the Republic of Haiti.

Mr. Dussault (BA, University of Montreal, 1963; BComm, University of Sherbrooke, 1966; MComm, University of Sherbrooke, 1967) joined the Trade Commissioner Service in June 1967. He has served abroad in Accra, Buffalo, Paris, Berne and as Ambassador to the Gabonese Republic. In Ottawa, he has served as Special Assistant to the Minister of Industry and Commerce and was a Co-ordinator on the team for liberalizing Canadian-American trade relations. Also, in Montreal, he worked as Director General, International Trade Development. Since September 1988, he has been the Director, African Trade Division, at the Department of External Affairs. Mr. Dussault is married to Marie-Thérèse Lefebvre and they have three children. Mr. Dussault replaces Mr. Pierre Giguère.

Mr. Fredrik S. Eaton, O.C., born in Toronto, as High Commissioner to the United Kingdom of Great Britain and Northern Ireland.

Mr. Eaton (BA, University of New Brunswick, 1962; LLD, University of New Brunswick, 1983) joined The T. Eaton Co. Limited in 1962 and served in a variety of positions in Victoria, Toronto and Great Britain. He was appointed

Director, The T. Eaton Co. Limited, in 1967 and President and Director, Eaton's of Canada Limited, in 1969. In 1977, he was appointed Chairman, President and Chief Executive Officer, The T. Eaton Co. Limited. Since 1988, Mr. Eaton has been Chairman, The T. Eaton Co. Limited. In 1990, Mr. Eaton was appointed an Officer of the Order of Canada. He is married to Catherine Howard Martin and they have a son and a daughter. Mr. Eaton replaces the Honourable Donald S. Macdonald.

Mr. Ewan N. Hare, born in Southport, England, as High Commissioner to the Federal Republic of Nigeria, with concurrent accreditation to Sierra Leone.

Mr. Hare (BA [Political Science and History], Earlham University, 1961; Graduate Diploma in Public Administration, Carleton University, 1964) joined the Department of Finance in 1961. In Ottawa, he has held a variety of posts, including Director General of the United Nations Program at the Canadian International Development Agency (CIDA) and Director of the Africa Trade Development Division at the Department of External Affairs. In 1988, he was appointed Director General, Industrial Co-operation Division, CIDA. He has served abroad in Malaysia, Ghana and as Ambassador to the Republic of Zaïre. Mr. Hare is married to Raina Ho and they have three children. Mr. Hare replaces Mr. Robert L. Elliott.

Mr. Jean-Pierre Juneau, born in Quebec City, as Ambassador to the Kingdom of Spain.

Mr. Juneau (BA, Collège des Jésuites, 1965; Specialist in Political Science, Laval University, 1968; MA [Political Science-International Relations], Laval University, 1969) joined the Department of External Affairs in June 1969. He has served abroad in the Permanent Mission of Canada to the United Nations in New York, in Havana, Washington and as Minister-Counsellor in Paris. In Ottawa, he has served as Assignment Officer, Personnel, and as Assistant Director, Latin America Division. He has been Director General for the Western Europe Bureau at the Department of External Affairs since August 1988. Mr. Juneau is married to Emitza Escobar-Jurado and they have two children. Mr. Juneau replaces Ms. Julie Loranger.

Mr. Ronald S. MacLean, born in Camrose, Alberta, as Ambassador to the Kingdom of Denmark.

Mr. MacLean (BSc, BEd, University of Alberta, 1950; Graduate Studies, University of Alberta, 1952; MA, Fletcher School of

Law and Diplomacy, 1955) joined the Department of External Affairs in 1956. In Ottawa, he worked as Director General, International Energy Relations Branch at the Department of Energy, Mines and Resources. He has served abroad in New Delhi, Paris, Tokyo, as Ambassador and Permanent Representative to the Organization for Economic Co-operation and Development in Paris and as Ambassador to Brazil. Since 1986, he has been Ambassador to South Africa. Mr. MacLean is married to Beverley Jean MacLean and they have three children. Mr. MacLean replaces Ms. Dorothy J. Armstrong.

Mrs. Patricia M. Marsden-Dole, born in Edmonton, as High Commissioner to the United Republic of Tanzania, with concurrent accreditation to Mauritius and Seychelles and as Ambassador to the Democratic Republic of Madagascar.

Mrs. Marsden-Dole (BA, University of British Columbia, 1967; Post Graduate Diploma, College of Europe, Bruges, Belgium, 1968) joined the Trade Commissioner Service in 1969. In Ottawa, she has worked as Deputy Director (Japan), Pacific Trade Development Division, and as Director, Resources and Commodity Trade Policy Division. She has served abroad in New Delhi, London, Sydney and Cleveland. In 1989, she was appointed Deputy High Commissioner to India. Mrs. Marsden-Dole is married to Paul Dole and they have two children. Mrs. Marsden-Dole replaces Mr. J. David L. Rose.

Mr. Aubrey L. Morantz, born in Winnipeg, as High Commissioner to the Republic of Zambia, with concurrent accreditation to the Republic of Malawi.

He has served abroad in New York, London, San José and as Counsellor and Consul in Geneva. Mr. Rochon is married to Carol Ann Rochon and they have three children. Mr. Rochon replaces Mr. Clayton G. Bullis.

Mr. Gordon S. Smith, born in Montreal, as Head of Mission, Ambassador to the European Communities in Brussels.

Mr. Smith (BA, McGill University, 1962; PhD [Political Science], Massachusetts Institute of Technology, 1966) joined the Public Service in 1966, serving with the Department of External Affairs in Ottawa and with the Canadian Delegation to NATO in Brussels. Since returning from Brussels in 1990, Mr. Smith has served as the Secretary to the Cabinet for Federal-Provincial Relations and as Senior Advisor, Privy Council Office. He is married to Lise Grace Lacroix and they have four children. Mr. Smith is replacing Mr. Daniel Molgat.
