


A copy of the Memorandum complete which is to be read with and form part of this Prospectus is printed at the end hereof, giving signatories and their holding in classification of shares.

The Company adopts Table A, which provides that the qualification of a Director shall be the holding of at least one share. See Regulations Amending Table

The Directors may not proceed to allotment unless 500 shares are applied for.

The Vendor of the property is Dr. Frank Hall. The consideration to be paid him is \$26,000.

Ten per cent. cash is to be paid as commission for subscribing or agreeing to subscribe to the debentures and shares respectively.

The preliminary expense is estimated at \$1,500.

There is no consideration to the promoter, and there is no material contract.

W. Curtis Sampson, Victoria, B.C., is the Auditor of the Company appointed until the annual meeting in the year 1911.

The Directors have no interest in the promotion of or in the property proposed to be acquired by the Company.

The right of voting at meetings of the Company is, a vote a share.

Dear Sirs:—

As per instructions received from you we have inspected Burleith Lodge and the property that belongs to same, viz.: 22 lots.

This house was formerly owned by Mr. James Dunsmuir as a residence and was sold by auction recently by a syndicate who had acquired this and adjoining property, to Dr. Frank Hall for the sum of \$21,000. He has since spent on the property between \$3,000 and \$4,000, and as you state has now given you an option on the property for 60 days from this date at \$26,000.

Our valuation of the property is as follows:

Two waterfront lots fronting on Victoria Arm, \$2,500 each, \$5,000; 20 inside lots of an average valuation of \$600 each, \$12,000. We base our valuation of this property on the fact that we have sold and owned nearly 100 lots in this vicinity and have sold within the past week inside lots on McPherson Avenue, an adjoining street in a locality not quite as good, for \$1,000 each. We also owned and sold the adjoining waterfront property to Burleith consisting of about 4 acres, good, for \$1,000 each.

The House. The building originally cost, we are informed by the people who are in a position to know, \$70,000, and the house is in a good state of repair and magnificently finished. We would consider the house worth as a Hotel and Boarding House proposition at least \$30,000; any necessary changes can be done at a moderate cost.

Taken as a whole, however, we would consider that the proposition is worth more money as the situation for a high class hotel and boarding house is ideal. The Oak Bay Hotel is the only place of a similar character in the vicinity of the City and it is so crowded at all times that people have to book at least two months ahead to get accommodation. The boating and bathing at Burleith is the finest on the Coast as the water is protected and safe and the water is warm, as the tide runs in so far before it gets there.

It is conveniently situated in the centre of the City, the Gorge car running past the property via the Craigflower Road, which is the main thoroughfare from the rural districts of Metchosin, Goldstream, etc.

If this place is run on a proper plan, we think it can be filled with a high class trade the year round.



THE "COMPANIES ACT"
MEMORANDUM OF ASSOCIATION
of the
**Burleith Mansions,
Limited**

1. The name of the Company is "Burleith Mansions, Limited."
2. The Registered Office of the Company will be in the City of Victoria, Province of British Columbia.
3. The objects for which the Company is established are:—
 - (1) To purchase of Dr. Frank Hall the residence and adjacent area consisting of five acres more or less of Mr. James Dunsmuir acquired by Dr. Frank Hall, and now under option of sale dated the 24th day of August, 1910, to Messrs. Bond & Clark, Trustees for this Company, and to carry into effect the said agreement.
 - (2) To reconstruct, remodel, enlarge, alter and construct additional buildings upon the said area and to furnish and equip the same;
 - (3) To carry on the business of a private unlicensed hotel with board and lodging accommodation and all other accommodation usually given in unlicensed hotels, boarding houses and restaurants, and to carry on with such business the business of a bathing establishment with laundries, dressing-rooms, reading, writing and newspaper rooms, libraries, grounds and other places of amusement, recreation, sport, entertainment and instruction of all kinds;
 - (4) To establish, maintain and conduct an unlicensed Club of a non-political character (unlicensed for the sale of liquor) for the recreation of members of the Company and their friends, and to use and operate the buildings of the Company as and for a Club House and other convenience and generally to afford to members and their friends all the usual privileges, advantages and conveniences of accommodation of a Club;
 - (5) To carry on any other business which may seem to the Company capable of being conveniently carried on in connection with the above or calculated directly or indirectly to enhance the value of and to render profitable any of the Company's property or rights;
 - (6) To acquire and undertake the whole or any part of the business, property and liabilities of any person or persons (whether dead or alive) or possessed of property suitable for the purposes of this Company;

- (7) To enter into any arrangements with any Municipal, local or other authority that may seem conducive to the Company's objects or any of them, and to obtain from any such authority any rights, privileges and concessions which the Company may think it desirable to obtain, and to carry out, exercise and comply with any such arrangements, rights, privileges and concessions;
- (8) Generally to purchase, take on lease or in exchange, or otherwise acquire any real and personal property, and any rights or privileges which the Company may think necessary or convenient for the purposes of its business, and to construct, maintain and alter any buildings, erections, garden or ground embellishment and plantings, or works necessary or convenient for the purposes of the Company;
- (9) To invest and deal with the moneys of the Company not immediately required in such manner as from time to time may be determined;
- (10) To lend money to such persons and on such terms as may seem expedient and particularly to customers and others having dealings with the Company, and to guarantee the performance of contracts by any such persons;
- (11) To borrow or raise money for any purpose of the Company and to secure the payment of same and interest in such manner as the Company shall think fit, and in particular by the issue of debentures or debenture stock perpetual or otherwise charged upon all or any of the Company's property, both present and future, including its uncalled capital and to purchase, redeem or pay for any such securities;
- (12) To remunerate any person or Company for services rendered or to be rendered in placing or assisting to place, or guaranteeing the placing of any of the shares of the Company's capital, or any debenture, debenture stock or other securities of the Company, or in or about the formation or promotion of the Company or conduct of its business;
- (13) To draw, i.e., accept, endorse, discount, execute and issue promissory notes, bills of exchange, bills of lading, warrants, debentures and other negotiable or transferable instruments;
- (14) To adopt such means of making known the operations of the Company as may seem expedient, and in particular by advertising in the Press, by circulars, by purchase and exhibition of works of art or interest, by publication of books and periodicals, and by granting prizes, rewards and donations;
- (15) To sell, improve, manage, develop, exchange, lease, mortgage, dispose of, turn to account or otherwise deal with all or any part of the property and rights of the Company;
- (16) To do all or any of the above things as principals, agents, directors, trustees or otherwise, and by or through trustees, agents or otherwise, and either alone or in conjunction with the others;
- (17) To do all such other things as are incidental or conducive to the attainment of the above objects;

(18) To accumulate funds and to admit any person or persons to participate in the profits or assets of the Company;

(19) To distribute any of the assets for the time being of the Company among the members in kind, and to stipulate for and obtain for the members or any of them any of the rights, privileges or options;

(20) To acquire by surrender or otherwise the whole or any part of the interest of any member of the Company therein;

(21) To assign to any member or class of member any preferential, special or qualified rights or privileges over or as compared with any other members as regards participation in profits or assets and as regards voting and as regards winding up, or otherwise howsoever;

(22) To purchase or otherwise acquire on such terms or in such manner as the regulations of the Company from time to time provide in shares in the Company's capital;

(23) To distribute any of the property of the Company in specie among the members.

4. The liability of the members is limited.

5. The share capital of the Company is One hundred thousand dollars, divided into ten thousand shares of ten dollars each.

Any of the shares in the capital, original or increased, may be issued with any preferential, special or qualified rights or conditions as regards dividends, capital, voting or otherwise attached thereto.









SIDE ELEVATION.

ADDITIONS - DWELLINGS - VICTORIA D.C.






Grand Floor Plan

Architectural Drawing



SECOND FLOOR PLAN.





As will be seen by the annexed printed report, which is to be taken as part of this Prospectus, it has been estimated that there exists a profitable business enterprise in acquiring the late residence of Mr. James Dinsmuir standing on about five acres of land with water frontage on Victoria Arm, and converting the same to provide suitable accommodation for guests and to operate a private unlicensed hotel to be conducted on the lines of a private unlicensed hotel or restaurant combined with some of the advantages of a private Club.
