The Prayer Meeting services were evidently enjoyed by all who regularly attended them, and the Session hope that more this year will partake of this fountain of fellowship and prayer in the midst of the week.

The addition to our number of two new members, Messrs McLeod and Woodley will enable us to exercise a more efficient oversight of you all.

We go forward in good hope that this year shall bring to us as a congregation seasons of refreshing from the presence of the Lord, enabling us to seek with all our heart the things which are Jesus Christ's.

Annual Congregational Meeting.

Held 11th Jan'y '93.

Mr. J. K. Macdonald, president, presided at the meeting, which, owing to the severity of the weather was but poorly attended.

The meeting was opened by the Pastor, reading the scriptures and offering prayer.

The Secretary read the minutes of last annual meeting, which were duly confirmed.

The annual report of the Board of Managers for the year 1892 was then read and laid on the table.

The Treasurer read the financial report and entered into full and lucid explanations of the monetary affairs of the Church, after which Mr. Wm. Greig moved, seconded by Mr. Russell that the report of the Managers be received, adopted, and printed. In amendment, Mr. T. J. Rutherford moved, seconded by Mr. J. Phymister, that the recommendation of the Board granting \$50 per annum and two special collections in aid of the Sabbath School be amended to read, that a grant of \$100 per annum be given to the Sabbath School.

In amendment to the amendment, Mr. M. Hutchinson moved, seconded by Mr. T. Brady, that no specified sum be granted to the Sunday School and no special collections be taken up, but that instead, the Secretary open a subscription list to defray the Sabbath School expenses.

On a vote being taken the amendment was carried, and the Report of the Board as amended was adopted.

SEVENTH ANNUAL

Report of the Board of Managers.

To the Members and Adherents of Melville Church:—

The Board of Management of Melville Church beg herewith to submit to the Congregation the Seventh Annual Report in reference to the secular affairs of the Church.

Another year of our labours has ended, and we are again permitted by a gracious Providence to assemble in council to review the past and plan for the future, and in doing so it is to be hoped that the wisest councils may prevail and your deliberations guided by heavenly wisdom which will insure their being of lasting benefit to our beloved Church.

The Treasurer's statement which is now before you shows an increase of \$215 in ordinary revenue over last year, but this has been counter-balanced by an increased expenditure, your Board had to meet the cost of fitting up the Church with electric light, and in addition have had to provide for alterations to the choir platform, &c., in all amounting to \$320; towards this sum special contributions of \$136.50 have been received, leaving a deficiency of about \$175.00 to be met which we would recommend being raised by special subscriptions.

In connection with the revenues of the Church, we regret to report a falling off in the number of contributors to the ordinary

revenue, but we trust this condition of affairs will not continue very long, and that a gratifying increase will soon be apparent.

In regard to the Debt Fund, we are sorry to say this Special Fund has not been more generally supported, your Board had expected that at least \$1.000 per annum would be raised to wipe off the debt on the church property, while only about \$500 has been contributed during the past year towards that object. Since the last Annual meeting the Electric Lighting of the Church as promised in last year's report, is now an accomplished fact, and we have no doubt the Congregation fully appreciate the advantage of the new light over gas.

The Sabbath School having applied to your Board for an increased grant towards its expenses, we recommend that in addition to the \$50 granted per annum two special collections be taken up during the year in aid of the funds of the Sabbath School.

MISSION BAND.—The Mission Band continues its labors of love in clothing the destitute. A slight change has been made during the year in regard to its management. In place of electing officers from among the lady teachers, the children now choose them from among themselves, the whole being placed in charge of a lady superintendent.

Annual Report of the Melville Church Young People's Society of Christian Endeavor.

In presenting this our third annual report, we have to look back over a year, during which we hope a good deal of quiet work has been done in our midst, "For Christ and the Church."

Our roll shows at the close of this year, 33 active, and 11 associate members.

The weekly prayer meetings have been well attended during the year. Two union prayer meetings have been held with the Cote St. Antoine Methodist C. E. Society, both of which we trust, were stimulating and helpful to both societies.

The Charitable Committee has given assistance to several parties who were in need of help and sympathy, and has also provided clothing for a pupil in the Mackay Institute.

The Missionary Committee has carried on the regular weekly collections for Foreign Missions, and has also adopted a similar system for Home Missions, which in all amounted to \$51.95.

During the year this committee has also collected numbers of Sunday School, Missionary, and Illustrated Papers and Magazines, and distributed them to different mission fields.

The work of the Flower Committee is noticeable to all, the pulpit has been supplied with flowers every Sabbath. Flowers have also been sent, not only to the sick among the members of the Society and Church, but also to the sick in the hospital.

The other committees have attended faithfully to their several duties as occasions demanded.

Our Society's delegation to the New York convention was notably large, no less than 15 members having attended that wonderful gathering last July, these members gave full reports of the work of that convention to the Society, on their return.

One of the most pleasant features we have to record, is the fact, that five of our young people have left the associate membership ranks, have joined the Church, and have thus come out on the Master's side.
