



A CANADIAN MICROSCOPE. - We copy the following, with great pleasure, from the Kingston British Whig of the 12th ult. :- "Mr Smith, watchmaker, has, at the expense of much labor and money, completed a very powerful oxy-hydrogen microscope, the first eyer made in Canada; which magnifies the object upwards of ten million times. At a private exhibition at the Lambton House, a variety of insects and other minute objects were submitted to the powers of the microscope, and the result was truly surprising and wonderful. A fly's wing was rendered so enormous, that only a very small portion of it could be contained on the large screen, and its minute and delicate structure was beautifully developed.






