

An Act to enable the Provincial Government to dispose of claims against certain Companies for Loans made to them under the authority of certain Acts of the Parliament of Upper Canada.

WHEREAS the Government of this Province, or that Presuble. of the Province of Upper Canada, hath at divers times, under the authority of Acts of the Legislature of Upper Canada, advanced or paid sums of money to or

- 5 for Companies incorporated for the purpose of constructing canals, railroads, harbors, roads and other works and improvements of a public nature in Upper Canada, and such sums or part thereof, or the interest thereon or part thereof, remain due to the Province, and it is expedient to
- 10 authorize the Provincial Government to dispose of the claim of the Province for any such sum as aforesaid, to any party who may be willing to purchase the same, and upon such terms as may be agreed upon between the Government and such party: Be it therefore enact-
- 15 ed. &c. ;---

That it shall be lawful for the Governor in Council, by Governor in any Order in Council to be made for that purpose, to as- assign claims sign, transfer and convey to any Municipal Corporation, against Com-Incorporated Company or other party, who may agree to 20 purchase the same, the claim of the Province for any sum

- of money due from any company or party, and arising out of any such advance or payment as is mentioned in the preamble to this Act, on such conditions and with such clauses, provisions and limitations as shall be mentioned in
- 25 such Order in Council, including the undertaking of any third party to become surety for the due payment of the consideration money, and the faithful performance of any conditions therein mentioned; and any such Order in Council shall transfer to and vest in the party therein
- 30 named for that purpose, all the rights of the Crown in and to the debt or claim thereby intended to be transferred, and shall have effect according to the tenor thereof, as if the clauses, conditions and provisions thereof were inserted in this Act: and a copy of the Canada Gazette containing Evidence of
- 35 any such Order in Council or any copy of such Order cer- such transfer. tified by the Provincial Secretary, shall be evidence thereof. and the consent and agreement of all the parties named therein, shall be presumed unless disputed by such parties. and if disputed, shall be proved by any copy of such Or-

panies.
