### THE CANADIAN KENNEL CLUB.

A full report of the formation of the above will be found in another column. That it was much needed is a fact no "doggy" man can deny, and we trust it may meet with the support it deserves and the success to which its promoters ate entitled.

A few words of criticism from us may not come amiss. We have had considerable experience in kindred societies, and trust any remarks we make may be taken in the spirit in which they are uttered, namely, a friendly one. In article 6 of the Constitution we find, in our opinion, the first error, no member of any board should be elected at any time but at a full (annual or other) meeting of the Club. It is always a safe rule to give every member a voice in all matters of importance. If needs were a vote on any particular subject could be taken by mail. Articles 8 and o are certainly wise, though that point in Article 8 referring to notice at previous meeting may result in the delay for a year of any desirable change, if no meeting other than annual meeting be held.

Section 1, Article 1 of the By-laws one of the best bitches we have had of leaves entirely too much power in the hands of the President. We say this with, of course, no personal feeling. All accounts should be signed or initialed by the President or Secretary and handed to the Treasurer for paymen (we don't like the joint position of Sec.-Treas.) and all books at the end of the year placed in the hands of properly-elected Auditors (two) for their examination and approval.

> Article 5. Here to our mind lies the gravest error of all. Why! gentlemen, you leave your fate entirely in the hands of the Executive Committee. They have actual power to alter, amend or, in fact, entirely suspend the By-laws of the Ciub, surely this is not right.

> We would respectfully advise the re-consideration of these matters.

### OUR ILLUSTRATION.

We reproduce this month from the English Stock-Keeper a portrait of the Field Spaniel, Moonstone. Appended are our contemporary's remarks.

The Field Spaniel Moonstone, it will be remembered, at Richmond the other week, won first prize in his class, the Medal for best Spaniel, and a valuable Silver Cup presented by Sir Whittaker Ellis, Bart, M. P., for best dog in the show. Moonstone has only been exhibited on one other occasion, viz., at Burhley; when he was about six months old, where, in a class of fortyfive, he won first prize. He was bred by his owner, Mr. Theo. Marples, and is by Sterling, (20,636), out of Moonlight, (22,585); his dam was also bred by Mr. Marples, being by Lord Bute. (14,229); out of Old Midnight, (18,697) Sterling is by a brother of Solus.

Moonstone is now just over a year old, and is probably the longest, the lowe i, the flattest-coated, and heaviestboned Field Spaniel on the bench. He is a good-sized dog, and combines in a remarkable degree substance with quality. His head is above an average one, and his ears almost phenomenal in their low carriage and length. carries his stern low, and for a dog of such length he has great symmetry: and we are informed by Mr. Marples that he is a very active dog in the field.

### COCKER SPANIELS.

(COMMUNICATED.)

We have chosen this breed for our illustration in the first issue of the KENNEL GAZETTE for several reasons. First and principally because they are very popular in Canada, and because in the breeding of Cocker and Field Spaniels Canada stands almost a-head, as may be seen by a perusal of the prize lists of the principal Bench Shows both here and in the U. S.

A large number are now bred in Canada, there being at least six prominent extensive breeders we think of in this locality, who breed and sell large numbers every year, many going to the U.S. There are also many amateurs, who have taken up this useful and attractive little dog; the result of which is they are probably the most popular dog in Canada at the present time, and we trink deservedly so, for either at his natural work in the field, on the street as a companion and friend, or at home as the favorite house dog, and pet of the children, he is ever the same bright, active, intelligent little fellow, and attracts universal admiration. As a sporting dog for bird shooting in field or cover, we think he stands unrivalled in keen intelligence and untiring energy.

To those who are not sportsmen, either from inclination or want of time, he is a faithful companion, ever active, obedient and sagacious.

We remember many instances of his almost human intelligence, which we may embody in a future article. direct the attention of our readers to our cut of "Moonstone," which is a good type of the modern. Cocker. will be seen he possesses very strong characteristics, that he differs from the old style Cocker will be apparent to all who have a knowledge of the breed, but as to whether he is superior in all the qualities which the Cocker is supposed to possess, we shall not just now venture an opinion, as this has been a much-vexed question. We shall be pleased to have the view of our Canadian fanciers on the subject, if they are sufficiently interested.

### CONSTITUTION.

CANADIAN KENNEL CLUB OF CANADA.

- 1. This club shall be known as the
- 2. The object of the club shall be to promote the breeding of thoroughbred dogs in Canada, to protect the interests of owners as well as breeders, to formulate rules for the Government of Dog Shows and competitions, and to recommend suitable judges for the same.
- 3. The officers of the club shall consist of Honorary President, 1st Vice-President, four Vice Presidents, Secretary-Treasurer and an Executive Committee of eight members, to be elected at the annual meeting.
- 4. The annual meeting shall be held at such a time and place as shall be decided at the previous meeting.

A special meeting shall be called at the request of ten members of the club or may at any time be called by order of the Executive Committee.

- 5. Applications for membership shall be proposed and seconded in writing to the Secretary and passed by the Executive Committee; one black ball to suspend the election until the next meeting of the Executive Committee.
- 6. The Executive Committee shall have power to fill vacancies on the Committee until the next annual meeting.
- 7. The annual dues to be \$2.00 payable in advance.
- 8. No alterations can be made in the Constitution or in the governing rules, as adopted by this club, except by a two-thirds majority of the vote cast at the annual meeting or special meeting of the club, and notice of any such proposed change must be given at the previous meeting.
- 9. The Executive Committee shall have full power by a two-thirds vote, to suspend or expel any members, and the President, or First Vice-President when

members so suspended or expelled shall have no claim against the club, or be allowed to enter into any competition held under the rules of this club. Such members shall have the right of appeal to the club from the action of the Executive Committee at the aunual meeting or at any special meeting, provided notice of appeal has been given.

BY-LAWS.

Article 1. Duties of Officers: President.

Section 1.—The President shall preside at all meetings of the Executive Committee whenever in his judgment he may deem it necessary, he shall submit a report of the work done during the ; ast year at the annual meeting. First Vice-President.

· Section 2.—The First Vice-President shall perform all the duties of the President in his absence.

### Secretary-Treasurer.

Section 3.—The Secretary Treasurer shall keep the minutes of each meeting of the Executive Committee and of the club, conduct the correspondence, and have charge of and be responsible for all the books and papers of the Executive Committee. He shall collect and have charge of all moneys belonging to the club, shall pay all bills when properly approved, and submit a report thereof to the Executive Committee at every meeting. He shall keep a book containing a list of the members with their addresses, which book shall, at all reasonable times, be open for the inspection of members in good standing.

Article 2: Section 1.—The meetings of the Executive Committee shall be called by the Secretary at the request of three members of the committee or by order of the President, and two weeks' notice of such meeting shall be given to every member of the committee. Section 2.—At all meetings of the Executive Committee four members shall constitute a quorum.

Article 3: Payment of bills.

All bills shall be presented to the

Article 5: Amendments, etc.

These by-laws may be altered, amended, or suspended at any meeting of the Executive Committee by a single majority vote, provided two weeks' notice shall have been given to every member of the Executive Committee of the proposed alteration, amendment or suspension. In the absence of such notice, a two-thirds vote of the members present shall be required.
