SIR,—I have the honour to hand you a report dealing with one hundred (100) samples of lime-juice, collected officially by our inspectors from May to September of this year.

The last report upon this article was dated July 1913, and had regard to collections made in the earlier part of that year. It is published as Bulletin No. 262. Of thirty samples therein reported only five meet the requirements of departmental standards as published in Circular G 947. These standards, originally legalized, 13th March, 1911, have been challenged in two respects. It is claimed that commercial lime-juice, of guaranteed genuineness, does not always contain 10 per cent of its weight of solids; also, that limits for optical activity should be extended to read from $+0.5^{\circ}$ to -1.0° of the Soleil Ventzke Scale.

In order to determine the facts, application was made to importers and refiners for certified samples of raw and clarified lime-juice, and the firms of L. Rose & Co., London, England, the National Drug and Chemical Company, of Canada, and Lymans, Limited, of Montreal, were kind enough to furnish me with nine samples under affidavit of genuineness. These gave the following analytical results:—

Nos. 1, 2 and 3, represent the article as manufactured by the National Drug and Chemical Company, Nos. 4 and 5 are the crude and the refined juice as furnished by L. Rose and Company, Nos. 6, 7, and 8 are West Indian lime-juice, as imported by the National Drug and Chemical Company, No. 9 is raw limejuice as imported by Lymans, Limited, from Dominica, B.W.I.

It would appear from the above that the process of refining, which is asserted to consist merely of filtration, with, in most cases the addition of a minute quantity of benzoate of soda, or other preservative, effects but little change in the total solids; has no effect upon reduction of the citric acid content, and is chiefly evidenced by the removal of traces of materials which increase the laevo-rotatory character of the raw juice.

Four samples of raw lime-juice, received by me from the port of Halifax in 1902, and believed to represent importations of that year although not vouched for by affidavit, gave the following results:—

In a letter dated 31st October, 1913, Inspectors Ogston and Moore, Analytical Chemists, London, England, comment upon our standards for lime-juice as follows: "The citric acid figure is correct but the total solids figure is fixed too high. We find the total solids to be between 8.50 and 9.00 per cent."

The British Pharmacopoeia does not furnish any standards for Lime-Juice, but defines lemon juice (*Succus limonis*) as follows:—

"The freshly expressed juice of the ripe fruit of *Citrus Medica*, Linn., var. *Limonius*, Hook, fil. Specific gravity 1.030 to 1.040; citric acid 7 to 8 per cent. Ash not more than 3 per cent."

The United States Pharmacopoeia defines Lemon juice in similar terms.

Leach, "Food Inspection Analysis," 2nd Edition, p. 925, states that both varieties of the genus *Citrus* are used indiscriminately for furnishing commercial lime-juice.

In this connection I am favoured with the following letter from the Government Botanist at the Port-of-Spain, Trinidad:—

DEPARTMENT OF AGRICULTURE,
PORT-OF-SPAIN, TRINIDAD, March 9, 1914.

DEAR SIR,—I have recently received a copy of *Bulletin 262* of the Laboratory of the Inland Revenue Department, Canada, dealing with lime fruit juice, and in it I noticed that lime-juice is defined as "the fresh fruit juice obtained from lime fruit (*Citrus Limetta*)."

The lime-juice with which you are dealing is, I understand, the ordinary lime-juice of commerce, of which the West Indies are the largest producers. This lime-juice, is, however not obtained from *Citrus Limetta*, but from *Citrus Medica* var. *acida*. There was formerly confusion between the two plants but this was cleared up as indicated by the following extract from the *Bulletin of the Royal Gardens, Kew*, for 1894, page 113:—

"One of the most distinct species of *Citrus* is *C. Medica*, which includes the citron, lemon, and the limes. Of the limes there are sweet and sour limes, characterized, according to Roxburgh, by small pinkish flowers, usually four petals, and a perfectly spherical fruit, having a thin skin of a lively yellow colour and pale acid juice. Sir Joseph Hooker states that the word lime is promiscuously applied to fruits very different in character, especially in British India, where the sweet limes of various forms are universally spoken of under that name.

"The sour lime, although probably introduced from the East Indies, has made its second home in the West Indies, where, indeed, is its present principal area of systematic cultivation. The history of the sour lime is given by Sir Joseph Hooker in the *Botanical Magazine*, tab. 6745. It was first described by Rumph (*Hortus Amboinensis*, 11, p. 107, tab. 29), in 1750, under the name of *Limonellus*, alias *Limotenus*, or thin-skinned lemon. *C. Limonellus* is also described by Miquel, who says it is cultivated everywhere in the Dutch East Indies. The same plant is well-figured by Wight as *C. Limetta*, Risso (*Icones*, t. 958), who says it is wild in the Nilgiris. In the West Indies, McFadyen very clearly described it as *Citrus Lima*, 'a thorny shrub with ovated leaves, pentamerous white flowers, small nearly globose, yellow fruit, with thin skin, and an abundance of pure acid juice; it is naturalized in Jamaica, forming strong fences.' Brandis (*Forest Flora*, Ind., p. 52), rightly places the sour lime of India as a variety of *Citrus Medica*, L.; other authors refer the sour or West Indian lime to *C. Limetta*, Risso, its nearest European representative, but this latter differs in its sweet juice. The botanical position of the West Indian lime as an acid variety of *Citrus Medica*, L. is now established. This small acid lime seems confined to tropical and sub-tropical zones. It does not appear to flourish in Southern Europe, and as already stated, its present headquarters under cultivation are in the West Indies, where in the islands of Montserrat, Dominica and Jamaica it is commercially utilized for the production of lime-juice and essential oil."

You will have botanical authorities accessible whom you will be able to consult, and if they confirm this view, I would suggest that the official Canadian definition of lime-juice should be altered accordingly.

In the light of the evidence furnished herewith, it will be necessary to amend present standards for lime-juice, as these appear in Circular No. G 947, as follows:—

Lime-Juice, Lime Fruit Juice is the freshly expressed juice of the ripe fruit of Citrus (various species); and has a specific gravity at 20° C, not less than 1.030 and not greater than 1.040, and contains not less than eight (8) per cent of solids and not less than (7) per cent of free citric acid. Its optical activity (rotatory power to polarized light) lies between the limits of +0.5° and -1.0° of the Soleil Ventzke Scale, when observed in a column of 200 mm. in length, at 20° C.

The samples herein reported have been judged by these standards and indicate as follows:

Eight samples contain sugar (or glucose) in more than traces. When the presence of sugar is acknowledged upon the label, or the article is offered under a name which informs the purchaser in accord with the facts, no fraud is committed. When sold as lime-juice, the addition of sugar, glucose, or anything else, constitutes adulteration. Details of these samples are as below:—

In the absence of any standards for, or legal definition of lime-juice cordial, it is impossible to charge adulteration in the cases of any samples sold under this name. At the same time, it is worthy of note that numbers 2134, 51988 and 61933 contain less than half their volume of lime-juice.

No. 61526, being sold as lime-juice, must be regarded as adulterated.

In a strict sense, 16 samples which are found below standard in solids, although containing 7 per cent of citric acid; as well as 16 other samples which are below the standard of 7 per cent citric acid, must be regarded as adulterated under the Act.

Inasmuch, however, as this is the first general inspection under these standards, I would respectfully suggest leniency in these cases.

Preservatives, chiefly benzoic or salicylic acid, are in no case present in dangerous amount. It is to be noted that, under the terms of an Order in Council of 4th April of this year, the presence of preservatives must be declared on the label; and benzoic acid must not exceed 1 part in 1,000 parts, nor salicylic acid, 1 part in 5,000 parts of the food material.

I would further recommend publication of this report as Bulletin No. 295.
