JUDICIAL NEWS

Important decision arising out of the

Election cases decided.

Judge Hodgson delivered at Charlottetown on the 5th inst., two important judgments that will be of interest all over Canada. The Patriot newspaper published a charge that an elector named Henry, an elder in the Presbyterian Church, had personated another man at the late elections. Henry sued for libel. It seems that his name was misprinted "Hyde" on the voters' list, printed at Ottawa. This mistake was discovered before the lists were issued to the deputy returning officers, and Judge Reddin corrected it to Henry. Marking the alteration with his initials. But the lists in the hands of the Liberal agents were unchanged. It was upon this that the charge was made. The jury gave a verdict for the plaintiff. The Judge justified Judge Reddin in making the alteration, declaring that not only was he right in having done so, but that the Supreme Court would, if necessary, have compelled him to have done so by mandamus.
