BILL.

An Act to amend the Act for the better Assignment of Dower in Upper Canada.

In amendment of the Act for the better assignment of Dower in Upper Canada ; Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows :

1. That the fourth sub-section of the fifth section of the said Act be repealed, and the following sub-section substituted therefor, and be a lien with right of distress.
read as the sub-section hereby repealed : 4.—“ Such annuity shall be a lien upon the entire of the said land, or apportioned upon a part on the several parts thereof, in such manner and amounts as the said Commissioners or a majority of them shall think just, and shall be recoverable in such payments as the said Commissioners shall direct by distress in the same manner as rent, in addition to the usual personal remedy against the owner of the land. And if arrears of Dower are claimed, the Commissioners shall assess such arrears, and apportion the same, if they deem it proper, in the same way as such annuity.
- 15 2. That the sixteenth section of the said Act be repealed. Provided always, that this Act shall not apply to any action commenced on or before the first day of July, in the year of our Lord one thousand eight hundred and sixty-four.
