



The 35th annual meeting of the congregation (and the 26th of Dr. Cochrane's pastorate) was held on Wednesday evening Feb. 8th, in the lecture room of the church.

Dr. Cochrane presided and there was an encouraging attendance of the various active workers and members present. After devotional exercises and a brief review of the past year.

Mr. Thomas McLean presented the report of the Session giving particulars regarding the church membership and making special mention of the increased attendance at the prayer meetings and the success following the ministrations of their esteemed pastor. The Treasurer's statement was read by Mr. Wm. Grant, fully explaining the receipts and disbursements during the past year, both in connection with the ordinary expenditure, and the special fund collected for basement improvements.

Mr. James A. Wallace, Secretary Board of Management, presented their report for the past year.

Mr. W. N. Hossie read the report of the Sabbath School Association referring to the basement improvements and the proposed alterations in the Balfour St. School.

The report of the Missionary Association was read by Mr. James A. Wallace showing a total of \$1862.20 collected for missions and colleges, and also the report of the Women's Home Mission Society, stating that during the year they had raised \$155 for North West Missions.

Mr. Alex McWillie read the report of the Mission Band showing that \$53.61 had been devoted to Foreign Missions during the year.

In the necessary absence of Mr. Robert Henry, Mr. James A. Wallace presented the report of the Musical Committee calling attention to the appointment of Miss McCormack to the vacancy created by Mrs. Vanderlip's resignation and complementing the organist and choir on the acceptable musical service rendered. The reading of reports being now concluded it was moved by Mr. E. Jonathan seconded by Mr. Thos. Bishop and unanimously carried: That in view of the encouraging reports presented the congregation express its gratitude to Almighty God for the measure of success that has attended the ministrations of the Sanctuary during the past year, and the labours of the Sunday School teachers and those engaged in mission work, further that the sincere thanks of the congregation are due, and are hereby tendered the office bearers of the church, elders, Board of Management, Sabbath School Teachers and various Missionary Societies and also the choir of the church, for their continued efforts to promote the cause of Christ in this community, and that the several reports be now adopted and printed for circulation among the members and adherents of the congregation. Messrs Thos. Watt and A. N. Ogilvie were re-appointed auditors, and the retiring managers Messrs J. K. Osborne, Dr. Philip and Wm. Grant re-elected. The following ladies were appointed a committee to look after the poor of the congregation, under the name of the "Ladies Benevolent Society of Zion Church." Mrs. Welding, Convener, Mrs. John T. Wallace, Miss Beatrice Cleghorn, Mrs. Robertson and Mrs. Salmond.

The Musical Committee was re-appointed, the name of Mr. Charles Duncan being added. The selection of tunes for vocal worship was criticised and it was the feeling of the meeting that in future the older and better known were to be used in preference to others.

THIRTY-FIFTH ANNUAL REPORT

OF

THE BOARD OF MANAGEMENT.

As customary our report commences with a statement of cash received, and controllable by the managers: Last year the total amount received was \$4,396.88; from pew rents \$2,982.31; ordinary collections, \$1,384.57; average, \$26.62; supplementary, \$30; this year the income from above sources is \$4,363.84; from pew rents, \$2,892.78; collections, \$1,471.06; average, \$28.29; a decrease of \$90 in pew rents, but an increase of \$86.44 in the year's collection. The slight decrease in pew rents is accounted for by the fact, that last year's larger return is in great part due to the collection of long standing arrears.

The marked increase in the number of applicants for pews,to which we had the pleasure of calling attention last year, still continues. Now, there are only 28 scattered sittings left in the area of the church. This is very satisfactory, excepting to those who are desirous of obtaining the best pews in the church, forgetful that others who hold them are just as anxious to retain them.

Although the sittings left are but few the income realized is not as large as it should be, as about \$450, due Feb. 7, remains unpaid. This, of course, is a heavy drag and prevents the annual reduction of the church debt. If those in arrears would kindly remember that quarterly payments of pew rent are much easier settled, than yearly, this difficulty would be largely obviated.

As the Treasurer's statement and that of the Basement Committee give full particulars of the recent alterations in the Basement it is hardly necessary to call attention to them here.

The Managers retiring by rotation are Messrs. J. K. Osborne, Wm. Grant and Dr. Philip all of whom are eligible for re-election.

The action of the Annual Meeting a year ago, appointing a Special Committee to provide better heating apparatus, and modernize the Lecture and School rooms, has been crowned with success. The old heaters have been replaced by modern coal furnaces, placed where the pipes do not obstruct the light; the walls and ceilings calsomined and neatly decorated; sixty-two new settees and fifty chairs, with improved gas fixtures, a superior black board and a new library case, the whole costing a little over

\$600. The Balfour Street School, too, so long over-crowded, benefitted by the liberality of the congregation, so that on the opening spring, the work of extending its building will be proceeded with.

It is confidently trusted that any balance necessary to complete the whole will be promptly supplied, and render the building sufficient for the large and increasing number that attend.

Owing to the expense incurred in these long desired improvements, no special appeal has been made the past year for funds to provide the necessary school requisites, the cost of these have been drawn from the ordinary Sabbath day offerings, which formerly have been solely applied to Missions, but during the current year it is hoped we may resume the old plan of applying the whole of the school offerings to mission purposes.
