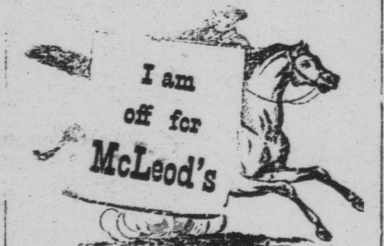

LATE FATHER MURPHY
FUNERAL SERVICE AT MAISONNEUVE.
The little Parish Church at Maisonneuve was crowded recently by a devout congregation anxious to pay the last tribute of respect to Rev. Father Laurence Murphy. There were not many men in the congregation, comparatively speaking, and these for whose preservation Father Murphy had labored in the gold cure, were conspicuous by their absence from his funeral. The church was completely darkened, the only light being obtained from the tapers burning on the altar, and around the bier on the catafalque lay the casket containing all that was mortal of the late priest, covered by a black pall with a large white cross, and surmounted by the bierette, stole and other emblems of the priesthood.

NEW BRUNSWICK LUMBER AT LIVERPOOL.
Farnworth & Jardine's wood circular for the last month states of the English importations: "Of N. B. spruce there has been import of 2,273 standards against 2,551 standards in the corresponding month last year, and deliveries have been fairly satisfactory. Stocks are moderate, and although there is no change in value to report, sales are now more difficult to effect for forward delivery. Birch—Of logs the imports, which consist of shipments by steam from St. John, has been large, the deliveries have been disappointing and prices are low; the stock is too heavy. Of planed and small parcel has been imported; there has been a small enquiry but prices are low; the stock is reduced." The timber tonnage from this port since January is given as 9,704, against 7,194 for 1896 and 5,401 in 1895.

Editorial Notes.

War has been declared between Greece and Turkey, in spite of the powers, to their lasting disgrace, endeavoring to force Greece from renegeing the attack on the bloody Turkey and to prevent the accession of Crete to Greece as the people of that country desire. British subjects all over the world consider their country's honor has been disgraced in this manner, and by its protection of the bloody Turkey who should have long ago been wiped out of existence as a nation.

The St. John Telegraph on Monday says:

Greece and Turkey are at war: that is the startling announcement that will be read in every newspaper in Europe and America today. So much for the good work done by the concert of the powers, which has been looked upon as so essential to the peace of Europe that to preserve it the good name of Great Britain has been dragged in the dust, and a great Christian nation has been made the accomplice of the bloody and murderous Turk. What the outcome of all this will be no one can venture to predict, but it is surely time for the British Government to reconsider its position, and to withdraw from the concert of the powers.

There is not a great power in Europe that would lift a hand to preserve the British empire from destruction, and in allying herself with Germany and Russia for the coercion of Greece and Crete our mother land has been merely doing into the hands of her bitterest enemies. The sooner this state of the situation dawns upon the mind of Lord Salisbury the better it will be for the good name and welfare of Great Britain.

Postal Affairs.

Postal matters seem to be run very loosely as regards prompt connection, and we are thereby compelled to apologise to our subscribers for the non-receipt of this Advocate when it ought to reach them. Sometimes we are unable to get to the post office early enough to get our bags into the post office before eight o'clock, and then according to the absurd reading of the postal regulations made by the former Postmaster General, our papers are delayed from being placed on board the postal car on the express but must lie over until the next day, a delay of about 24 hours in one direction and 24 in the other. For upwards of twenty years we could send our mails up to the station and have them put on board the postal car for despatch to destination, which has now been stopped. The much red tape about such a system of delay to suit either publisher or public.

Even when the mails are placed in the post office in time there is no surety that they will go right along to each destination without undue delay caused by the carelessness or ignorance of the postal clerks. Last week our bag of Advocates for Chatham was placed in the post office before the mails were closed, Mr. Wilson, the postmaster, having given us a little extra time, some ten minutes, and yet they did not reach Chatham until Thursday, probably having been taken to Moncton and then brought back. The might probably say that the reason was the new Quebec postal clerks who have been foisted on to this division only that it is no new thing for our mails (even when posted in time) to be delayed a day in transit. Not many weeks ago the writer was in Halifax, and the Advocates which had been mailed in good time on Tuesday night did not reach there until Thursday afternoon instead of Wednesday afternoon.

In Formal Session.

The Fredericton Gleaser of April 15th says:—

The Local Government are holding their first formal meeting of the April session this afternoon. Several informal conferences were held yesterday, when decisions were practically arrived at on some matters of local interest.

The provincial programme for the celebration of the sixtieth anniversary of the Queen's reign will be considered, if the Carleton delegation who are pressing the claims of Mr. J. Allan Dibble for a seat in the Cabinet, will give the Executive an opportunity to do so.

It is not likely that the Act establishing a Commissioner for Agriculture in the Government will be proclaimed at present. It is believed that nothing will be done in this direction until other changes are announced. The rumor is renewed that Chief Commissioner Emerson is likely to accept a lucrative office in the Intercolonial railway service. It is not stated what the position is, but the Chief's friends say that it has been settled that Mr. Emerson is to be well paid for, for Mr. Wilson, who is a Commissioner for the salary that is in it, says that the position of Superintendent of the I. C. R. does not call for the services of a man of railroad experience. Coming from a position of sensible notions or ideas this might be taken to mean that Mr. Emerson is to get Mr. Pottinger's office; but there seems to be no doubt that Mr. Emerson will remain to be satisfied with a place less important than the superintendency of a railway system. Mr. Emerson would probably jump at the store department. It is not to be understood that Mr. Emerson is tired of politics. He will withdraw for the reason that circumstances have forced him into a secondary place. In short, he will not follow Mr. Tweedie, who it appears, is to be Mr. Mitchell's successor. When Mr. Mitchell has made up his mind to retire from the Premiership, the office on the I. C. R. will probably be ready for Mr. Emerson to step into. But the new act will likely be proclaimed and the reconstruction of the local executive will be of course follow.

In order to heat a house all that is necessary is to open the warm air compartment reflecting the heat over the room while closing that hot air compartment confine the heat in the range instead of the house.
