An Act to amend the Act of Lower Canada, passed in the fourth year of the Reign of His Majesty King William IV., intituled "An Act to autho-" rise the establishment of Mutual Fire Insurance "Companies," and the Act of the said Province passed in the sixth year of the same Reign, intituled "An Act to continue for a limited time, and " to amend a certain Act therein mentioned rela-"tive to the establishment of Mutual Fire Assur-" ance Companies."

WHEREAS it is expedient to amend the Act of Lower Canada Preamble. passed in the fourth year of the Reign of His late Majesty William the Fourth, intituled An Act to authorize the establishment of Mutual Fire Insurance Companies, and the Act of the said Province 5 passed in the sixth year of the same Reign, intituled An Act to continue for a limited time, and to amend a certain Act therein mentioned, relative to the establishment of Mutual Fire Assurance Companies; Therefore Her Majesty, &c., enacts as follows:-

I. It shall be lawful, hereafter, for the freeholders, and other persons Company may 10 residing within the limits of any town or city in Lower Canada, con-be formed in cities and taining a population exceeding five thousand souls, according to the towns of 5000 then last census, to establish a Mutual Fire Insurance Company, for souls. insuring property situated within the limits of such town or city only, and not elsewhere, with the same effect to all intents and purposes as if 15 the said Company had been established for the said town or city, under and in virtue of the said Acts, or either of them, the provisions of which shall apply to any Company to be established in virtue of this Act, in so far only as they are not inconsistent with the provisions thereof.

20 II. Every Mutual Fire Insurance Company established in virtue Company to hereof in any town or city in Lower Canada, shall be a body politic, be a corporation.

and shall be, in law, called and known as the Mutual Fire Insurance Company of the town or city for which it shall have been established.

The legal year for the business of any such Mutual Fire Insurance Company, established in any town or city in Lower Canada, in virtue of this Act, shall begin on the first of October in each year, and expire on the first of October of the year following; and the annual meeting for the election of Directors shall be held on the second Mon- 5 day of October in each year, or on the day following, if it be a holiday, and at such hour as may be fixed by the Directors.

V. From and after the passing of this Act, all and every the provisions of the Acts cited in the preamble to this Act, which are modified, nies under this or are inconsistent with the provisions thereof, shall be, and they are 10 hereby repealed, in so far as they may relate to Mutual Fire Insurance Companies for towns and cities, but not as regards any other Company established in virtue of the two Acts aforesaid; with respect to which said Companies all and every the provisions of the said two Acts shall remain in force as though this Act had not been passed. 15
