An Act to continue and confirm the separation between the Municipality of St. Julie de Somerset and St. Calixte de Somerset.

An Act to continue and confirm the separation of the Municipality of St. Julie de Somerset from St. Calixte de Somerset.

WHEREAS the north east part of the Township of Somerset in the County of Megantic, hath long been separated for Municipal purposes from the remainder of the said Township, and hath elected a Council for the same : And whereas doubts exist respecting the validity of such separation and election which it is expedient to remove ; Therefore Her Majesty, &c., enacts as follows :

I. The lots numbers one to thirteén, all inclusive, in the first ten ranges of the said Township, shall continue separated from the remainder thereof as a local Municipality, under the name of the Municipality of the Township of North East Somerset, and the Council elected for the said north east part under the name of the Council of St. Julie de Somerset, shall be held to have been and shall continue to be the lawful Council thereof to all intents and purposes, as if the said lots and ranges had been constituted a local Municipality by the "Lower Canada Municipal and Road Act of 1855."

II. All acts of the said Council heretofore had and done under the aforesaid name, shall be held to be good and valid whether the same relate to the internal government of the said Municipality or to the borrowing of money under the Consolidated Municipal Loan Fund Act.

III. All elections for the said east part, whether Parliamentary or other, shall be held at St. Julie de Somerset.

IV. This Act shall be deemed a public Act.
