QUARTERLY SESSION.

DIVISION ROOM, NEW GLASGOW. Tuesday, April 22, 1873.

The Grand Division opened in due form at 3 o'clock, p. m., the G. W. P. in the chair.

At roll call there were present: J. F. L. Parsons, G. W. P.; P. Monaghan, G. Scribe; H. A. Taylor, G. Treas.; Samuel Mc-Naughton, G. Chap.; Peter A. McGregor, G. Con.; Hugh Fraser, G. Sent.

Absent: Robt. Boak, G. W. A.; Rev. G. O. Huestis, P.G.W.P. Bro. John McLearn was appointed G. W. A., and David Marshall, P. G. W. P., pro tem.

The G. W. P. addressed the Grand Division and declared the Session open for business.

On motion of Bro. R. P. Fraser, seconded by the G. Treasurer. it was agreed that lady visitors and members of subordinate divisions be admitted to the sittings of this Session, on being vouched for and obligated.

The Grand Conductor announced representatives in waiting for initiation.

On motion of the Grand Treasurer it was agreed that representatives in waiting be obligated by the P. G. W. P.

The Grand Conductor announced that a public meeting would be held this evening by New Glasgow Division; also that a public meeting would be held at Albion Mines to-morrow evening, and invited the Grand Division to attend both. On motion the invitation was accepted.

On motion it was agreed that members of the Grand Division a car in Regalia at public meeting to be held this evening.

On motion of P. G. W. P. Marshall, Bros. M. H. Smith, D. Marshall and Harvey Graham were appointed to co-operate with the Committee of Albion Mines Division in making arrangements for public meeting to be held to-morrow evening.

Read communication from New Glasgow Division, suggesting action on part of G. D. and Templar organizations in preparing a Prohibitory Liquor Bill. Referred to Communications.

Read Communication from Chebucto Division in reference to formation of a Temperance and Prohibitory League, in compliance with request of Ontario and Quebec Leagues published in The Abstainer of April 16th. Referred to Committee on Communications.

The following Report was read and referred to Committee on State of the Order:

To the Grand Worthy Patriarch and Members of the Grand Division of N. S. WORTHY BROTHERS.—The Agency Committee appointed at the Annual Session, have pleasure in Reporting that the work entrusted to them has been very successfully prosecuted. It was with much gratification that your committee found the person who was to be by them employed had been chosen to

fill the most honorable position in the gift of the Grand Division; - by which circumstance the Agent and Lecturer's labours were made much more effec-Atual than they otherwise could have been. The Grand Worthy Patriarch, who in his official position could speak with authority, has been found well qualified in other ways to influence the Brotherhood; and the result of his labours has been most satisfactory.

Your Committee present no account at present, as what they purposed is as yet but partially accomplished; but any inquiries made of the Grand Scribe concerning Receipts and Expenditure relative to the Agency, will be by that Officer courteously answered, as well as any bearing on contemplated action

between this time and the holding of the Annual Session.

Your Committee would however respectfully urge the importance of contributions from the Subordinate Divisions, and individuals who are friends of the cause to the Agency Fund; in order that this most effectual mode of operation may be followed and extended during the next Autumn and Winter, and continuously after that time.

Referred to Committee on State of the Order. The Grand Scribe presented the following report:

To the Grand Division Sons of Temperance of Nova Scotia:

WORTHY BROTHERS,-To the Giver of all good the members of our association owe a debt of gratitude for the privilege granted us of meeting in quarterly Session at New Glasgow on this day—the Twenty-Fifth Anniversary

of the organization of this Grand Division.

Twenty-five years ago—on April 22, 1848—this body was formally instituted at Yarmouth, by Philip S. White—then the Most Worthy Patriarch of the National Division of the United States.

At the organization sic subordinate Divisions were represented by twelve brothers, viz:-

Acadia, No. 1, Fitz-William Redding, John Tooker, Samuel Flint. Central, No. 2, Edward B. Bingay, James Starr, John Crowley.

Providence, No. 3, Thomas Hilton, Charles W. Kelley. Milton, No. 4, Wm. Burrill, James B. Dane.

Concord, No. 5, James Cose.

Chebogue, No. 17, A. M. Gidney.

All these Divisions were located in Yarmouth township, except No. 5, of

Barrington.

The first staff of officers whose term expired in the October fol owing-Grand Divisions at that time being required to hold their Annual Sessions in that month—comprised the following named brothers:

Of the Divisions but three are now working-Central, Milton and Concord. Of the members who attended the first meeting, so far as I can ascertain, but four are now members of the Order, viz: Bros. Burrill (now senior P. G. W. P. in the jurisdiction), Flint, Gidney and Dane. I am not aware how many of them are living, I am certain of the death of but one-J.mes Starr.

It would be gratifying to us if to-day we had the presence of a constitutional quorum of the first dozen to assist us in transacting the business of this Session. A quarter of a century is a long period for such an organization as ours to be actively engaged in its chosen work. We who are present regret that we have none of the brothers named to work with us to-day. Yet when another quarter of a century rolls round, how many of the brethren now in this room will be permitted to assist in celebrating the Jubilee of the Grand While we hope that many of us may be spared to join in that celebration, it may be that others will fill our places. Should such be the case, let it be our fervent wish that, while our successors cannot be more earnest in the work than we are, they may be more successful in advancing its interests.

Want of sufficient time, and incompleteness of returns-consecutivelyfrom Subordinate Divisions, have prevented me from preparing some statistics, and gleaning from the records of the past information which might prove

interesting to you.

It may not be out of place to name here the brethren who have held the two chief offices in this Grand Division during the twenty-five years. I give the date on which they were installed. Those whose names are in capitals are living: those in italics are dead:

Of these thirty-three are fiving; thirteen are dead. The other two having removed from the Province, I am not certain if they are living. Three have filled the office of G.W.P. twice each. Thirty became members of the National Division. Four of those living have left the Order.

At the time t is Grand Division was formed, fourteen Divisions were in

existence; since then 328 Divisions have been chartered (one of which did not

work after being organized.) We have now the names of about 150 Divisions on the Roll, 130 of them supposed to be in fair working order.

Having given so much space to an item or two of the history of this body, . the remainder of this report must be as brief as I can possibly make it.

It is pleasing to know that the Order is more active than it has been for the last two or three years. While I have to report the dissolution of Lake Echo Division, in Halifax County, and the suspension of work by Noble, Victoria Mines, Barratt, Star of Promise, Granite Rock, Granite, and two or three others (with an exception or two all inactive for the past six or seven months), it is gratifying to know that new ones are being instituted.

As to the state of the Order in the jurisdiction, the G W. P., from a personal knowledge, is in a position to give a more correct statement of its position than I can from the few reports and returns to hand. I cannot embody the statistics of the quarter in this report, but will append them thereto before

the Journal is placed in the printer's hands.

The Grand Worthy Patriarch has been continued in the field since the last quarterly session as Agent and Lecturer. From reports received it is evident that he has proved himself acceptable to the Order in such parts of the Province as he has been enabled to visit. We require no better evidence of the necessity of having an Agent constantly employed, and the good results sure to follow from his labors. Is is of importance therefore that liberal contributions should flow into the Agency fund.

It is with feelings of deep sorrow I have to announce the death of a member of this Grand Division. Bro. Henry B, Mitchell, of Chester, P. W.P. of Phænix Division No. 115, died after a severe illness of about six weeks, on March 12th, in the 40th year of his age. The removal of Brother Mitchell is a loss, not only to our Order but to the temperance cause. He was a true temperance men, and never lost an opportunity of advocating-with tongue and pen—the interests of the reform in which this and other organizations are engaged. At an early age he connected himself with Chester Division No. 32; on 31st October, 1855 he became a member of this Grand Division; and on 28th October, 1858, was installed into the office of Grand Sentinel.

I have also to announce the death of P.W.P. Henry McDonald of Gay's River, who was also an earnest Son of Temperance. He was initiated into this G.D., 27th October, 1864. It was through his exertions that a new Division was organized at Milford, Hants County, in November last. Brother McDonald died after a severe but brief illness on 18th March, at the age of 36 years. At the time of his death he held the official position of D.G.W.P.

New Glasgow, April 23, 1873.

Grand Worthy Patriarch and Brothers,-

Your Committee on the State of the Crder beg leave to report that they have examined the several reports submitted to them, and have been much encouraged by the facts brought under review. We know that our Grand Worthy Patriarch will cheerfully allow his excellent report, so full of labors and withal so unpretentious, to take the second place in our consideration, while Your Committee claim room for the children of the Bands of Hope and the boys merging into manhood of the Sections of Cadets. The Standing Committee on Juvenile Temperance Organizations report from flourishing Bands of Hope and from Sections of Cadets as the available force in this section of the temperance army. We hail their existence and healthful vigor as proof that our principles have become more and more firmly fixed in the homes of Nova Scotia, and especially deep down in the hearts of our earnest temperance workers.

Your Committee are well aware that exertions are made in advocacy of our principles in some localities in Sabbath Schools. But although such efforts may be made, and if made must, we doubt not, be attended with blessings to all concerned; still Your Committee cannot help urging this Grand Division to use all legitimate means to increase the number of Bands of Hope and Sections of Cadets, or otherwise provide that all the children and youth of our land may be permanently enlisted on the side of Total Abstinence, and that

our Agent be instructed to attend specially to that duty.

Your Committee hail with joy the fact that mainly through the labors of the Grand Worthy Patriarch ten new Divisions have been instituted during the past quarter.

Those Divisions will form a fitting monument to the highly-appreciated ser-

vices of our chief officer, more enduring in character than the paragraphs of Your Committee or the heartfelt expressions of a grateful brotherhood.

It is indeed matter of congratulation as well as the reason of our success during the quarter, that the Agent of this Grand Division and the Grand Worthy Patriarch were united so happily in one person. We fain hope that the

profitable union may continue.

The Agency Committee deserve the thanks of this Grand Division for their labors during the autumn and winter. We hope that continued success will crown their exertions, so that labors so auspiciously begun and so vigorously pursued under their fostering care—by their indefatigable Agent our G. W. P. —may result in a more abundant harvest.

Whereas, this Grand Division has on more than one occasion acknowledged the desirability of extending Juvenile Temperance Organizations,-

And whereas, it is contemplated to organize a Grand Section of Cadets for the Province with a view to bring this association more immediately under the control of this Grand Division,-

And whereas, funds are necessary to carry out the object contemplated in

organizing said Grand Section,—
Therefore Resolved, That this Grand Division will be prepared to aid the Committee on Juvenile Organization as far as practicable in establishing a Grand Section of Cadets of Temperance for the Province of Nova Scotia,—all items of finance to be subject to the approval of the Executive Officers of this Grand Division; the sum required to be considered as a loan, and not to exceed fifty dollars (850) for the first year.

Passed.

The Committee on Communications reported as follows:

... Your Committee beg leave to report that they are gratified to find that the Brethren throughout the Province are becoming more alive on the grand subject of Temperance; that there is an increasing anxiety to secure the safety of the young by the organization of Sections of Cadets of Temperance and other Juvenile Temperance societies; that there is an increasing desire for the more compact organization and co-operation of temperance bodies, and they recommend the formation of a Provincial Temperance and Prohibitory League, having the same organization, objects and aims as those now in operation in Ontario and Quebec.

Your Committee would further recommend, in accordance with a resolution from New Glasgow Division, the appointment of a Committee to act conjointly with similar Committees from other Temperance organizations for the purpose of drafting a Phrohibitory Liquor League Bill for Nova Scotia and the Dominion at large; and that the same Committee be instructed to take the necessary steps towards the organization of Temperance and Prohibitory Leagues.

C. W. P.'S REPORT.

The Grand Scribe regrets that the Report of the G. W. P. does not appear in its proper place; it is as follows:

Division Room, New Glasgow, Tuesday 22nd April, 1873.

Officers and Brethren,—Twenty-five years ago to-day, on the 22nd April, 1848—a band of noble men assembled in the town of Yarmouth and organized this Grand Division of the Sons of Temperance. Without interruption our stated Quarterly and Annual meetings have been maintained. During this time the principles of Temperance have been spread abroad and the vigor of our Organization sustained and very largely increased.

In July, 1861, the Grand Division held a Session for the first time in this town; there was a second meeting here in July, 1871, and again we meet "to interchange the greetings of an exalted friendship" The Annual Session in October has always been held in Halifax, except the first in Yarmouth, and the quarterly Sessions—74 in number—have been distributed among the Countries of the countries of

The Grand Scribe in his report will furnish no doubt, interesting and valuable information respecting the growth of our Order, the labors and successes in the past, and the present standing and future prospects. Our fathers began the great work amid many discouragements and prophecies of failure, but, earnest men and true, they gave themselves to the cause of all mankind—determined, in spite of every obstacle, to labor for the right. Many of them have passed from earth, but were rewarded by participating in the manitold successes of the Cause before being called away. Others of the First Sons of Temperance are yet with us, earnest devoted workmen desirous of bearing their part still in the labors and success of our noble Order.

During the winter now drawing to a close, the cause of Temperance has advanced with lengthened strides. From almost every part of the Jurisdiction, cheering accounts of progress have been communicated to the Grand Officers and through the columns of the "Abstainer" and the general Press,

made known to the reading and thinking public of the land.

I beg to submit extracts of reports from District and Divisional Deputies s follows:—

W. C. Bill, P.G.W.A., writes of Kings County-

"I am happy to inform you that our beloved Order of Sons of Temperance in this County is more prosperous now than for some years past especially in the Eastern part of the County * * * Deputy Eagles of Gaspereax No. 333, reports a pleasing and prosperous state of the Temperance cause. Lake as well as some of the other older Divisions although not increasing in numbers rapidly, are exerting a wide-spread and healthful influence in their communities."

P.G.W.P. Longley in speaking of Annapolis says that in Olive Branch Division a good degree of interest is manifested. The attendance is good

and the Division is bringing some of the rumsellers to book for illegal selling. This Division is the only one with which he is intimately acquainted. Divisional Deputies have not reported to him, but from letters of various Deputies we learn that the work has been vigorously prosecuted in different parts.

Brother Blois D.G.W.P. for East Hants reports:

"The Cause is progressing in E. Hants. Bro. Alex. Dunbar reports Kellogg Division at Elmsdale prosperous; 15 initiated during past quarter, with bright prospects ahead. It has become respectable to be a Son of Temperance. The visit of the G. W. P. to East Hants has stirred the Temperance people up to their work. Vesper is flourishing—never so good since organized, 22 initiated the past Quarter."

Brother McLearn of Rawdon writes:

"Rechab Division, South Rawdon, weekly meetings well attended. No spirituous liquors retailed within nine miles. Community generally quite temperate. "Still-in-Time" at Mount Uniacke though small is diligent in attendance and work. "Hillsdale" a new Division organized with 17 Charter members is advancing notwithstanding some discouragements. "Ellershouse" also a new Division is progressing finely—weekly meetings well attended, no charges against any members—officers well posted up in their duties,—weekly additions. I visited all these Divisions several times last quarter. I also hear of "Brooklyn" progressing—recently resuscitated—and "Riversdale" at Avondale on the onward move. Upon the whole Temperance was never more healthy in Hants than at present."

From Lockeport the Deputy reports prosperity and the formation of a new Division at Brighton. He says: "We were much pleased with the visit of our esteemed G. W. P., I think he is a live G. Worthy. "Brighton" Division near our place will receive our aid and brotherly love. We continue to fight the foe whenever we see an appearance of his approach—No liquor is allowed

to be sold within many miles of us."

I have noticed that our Temperance friends in the Legislature have failed to accomplish very great reform in the Laws, but we must hope for the good time coming.

Our veteran Bro. Smith of Windsor states among other things:

"Avon" is progressing in regard to members—but we need more energy in Temperance matters. We are glad to hear of the prosperity of our Order more especially in our own communities. May God bless the labors of our energetic G. W. P.

From Digby Bro. Taylor reports:

"Union" Division is I am happy to say looking more hopeful—more interest being manifested in the meetings and additions to our numbers.

Bro. Manning of Bridgewater, informs the Grand Scribe:

"We are having more interesting meetings of late and initiations every night. The G. W. P. has been the means of reviving the Temperance cause among us. I think he is admirably adapted for the work he is engaged in.—The different Temperance organizations are forming theuselves into a Prohibition League for the purpose of stamping out the sale of Liquor."

Bro. Walter Larkin of Pubnico speaks of "Sailors Guide" Division:

"Our weekly meetings have been quite interesting; the cause of Temperance has been highly esteemed and I trust it will ever be until all mankind

shall be clear of the evils of intemperance."

From Port LaTour Bro. Christie reports:

"I am happy to inform you that "Montrose" Division is working well—
Bro. Parsons G. W. P. has given new life and energy to all the Divisions this way.

"Day Dawn promises to be a good working Division, and I think will soon include all the coloured people in the place—seven new ones joined the first night. The G. W. P. did a noble work when he organized that Division for there was some liquor sold on the sly, but the Division has put a stop to it.

From Horton Brother Elder writes:

"Maple Leaf" at Greenoch and "Friendly" in Wolfville, new Divisions are doing well and bid fair to be useful. There has been quite a revival of the Temperance work since the meeting of the Grand Division, and I am in hopes it will hold on and do good."

Bro. Raud of Wolfville recently organized a fine new Division "Evangeline" at Lower Horton with thirty-nine charter members. Wolfville Division

is flourishing this winter.

"Rising Sun" Division of Middle Musquodoboit is reported by Brother

Francis Layton as rising still higher in numbers and influence.

Brother Gibbons speaks encouragingly of the cause at Hubbard's Cove and Fox Point. In that locality it was expected the Society would go down, but instead of that a second Division has been formed, and the two are now

strengthening each other and fighting the common foe.

The five City Divisions and Richmond Division have had interesting meetings public and private during the quarter. The good done during the winter by the Temperance Organizations of Halifax compares favorably with that of any preceding year, and gives us encouragement to look at the no distant future when the respectability will be taken away from the drinking customs

in the metropolis.

During the Quarter it has been my privilege to visit twenty-four Divisions; many of these visits were made before or after public Temperance meetings, but none the less interesting and enthusiastic on that account. Forty-three public meetings were held during the Quarter, and twenty-three previously—making a total of 66. Some of these were under the auspices of Lodges of British and Independent Templars—from the members of which I received most kindly welcome and to whom I conveyed the greetings and good will of the members of this Grand Division and the Subordinate Divisions. The collections in favor of the Agency Fund have been very good—a complete list will be published in an early No. of the "Abstainer" My tour thus far has included the counties of Hants, Kings, Lunenburg, Halifax, Queens and Shelburne—and the distance travelled, nearly 1200 miles.

In different parts of the Province people are forming Prohibition Leagues—banding together irrespective of party or name determined to put down and stamp out the illicit sale of Liquors in their midst. The organization is simple and can be very effective. Each member pledges a sum of money—the amount is left to his own option—and also pledges to sustain the Committee

in prosecuting the work.

The League meets—chooses officers and an active Committee Information is procured, prosecutions are carried forward and success crowns the efforts. Men addicted to strong drink are at liberty to contribute to the funds of the Society and thus aid in the work, whereby their greatest enemy may be put

beyond their reach.

It seems to me that County and Provincial Prohibition Leagues can best be rendered secure and successful by laying the foundation in the shape of Prohibition Leagues in our Villages and Towns. We could then stand secure and win such victories as would soon make our Province sober, prosperous and happy.

A felt want as an amendment to our License law is the power (already conceded in principle by being granted to proclaimed Gold Districts), to destroy

the liquor kept for illicit sale.

The principle is acknowledged in all other commercial transactions.—Putrid fish or meat exposed for sale is destroyed and the vender fined as well. Unlawful weapons are confiscated and the bearers fined or imprisoned.—Poisonous substances exposed for indiscriminate sale are seized and the owners severely punished. Every active power for evil to the human race seems to be most strictly dealt with by our Laws, except the most pernicious poison of all—Alcohol—and the principle is acknowledged in respect of that also by the power conferred in proclaimed Gold Districts.

What we need and must have is the general acknowledgment of this principle throughout the land by substituting the words—"any Polling District where no licenses are granted"—for the words "any proclaimed Gold District."

The State of Maine found it very difficult to enforce their Laws against the vending of strong drink even though they had heavy fines and imprisonment until they adopted the short, effective and common sense Law—The Liquon must be destroyed. There are a score of places in Nova Scotia now that would be freed from the curse of run in less than one year after the passing of that slight verbal amendment.

If all the Temperance organizations in the Land will unitedly ask for the destruction clause to be inserted in the Law, our Legislature dare not refuse the request, at least they would not refuse it after the next general appeal to

the country.

Our Public meetings and agitations for reform must be contained and increased; and moral sussion must never be laid aside. Our motto must ever

be-" Every agency in its place and all well worked."

It is with sorrow and deep regret I have to record the departure by death during the quarter of several of our dear brethren of the Order. Friend after friend departs. The memory of their friendship is sweet. The good they did still lives; may it influence us all to nobler aspirations and to the performance of better deeds.
