Surveyor-General Mitchell gives notice of the sale of angling licenses in the last Gazette as follows:—

The right of fishing (with the rod only) in front of the ungranted Crown Lands, on the unincorporated river, with reference to the sale of public angling, at this office, on Wednesday, the 20th day of June next, at the lowest price, subject to the regulations to be made known as the time of sale.

Respective main River, from Todd Brook up to Mouth of Kegwick.

Keegwick River.

Unaspiguch River.

Patapedia River.

Jacques River.

Northwest Miramichi River and Devil's Half-Acre.

Maple of the localities may be seen on application at the Crown Land office.

We understand that the right of angling on the river named will be sold for one year only, an arrangement that is judicious on the part of the Government, though it may not be entirely satisfactory to those who wish to secure the privileges offered.

We observe that the Telegraph takes it for granted that the Crown Lands privileges are the attractive ones on our rivers, but, while the fishing is enjoyable, they are excelled, so far as this County is concerned, by those of private property. The leasing of such privileges as the Local Government still retains is, however, a movement in the right direction. It is one of the advantages to the Province to be realized from the late political change at Fredericton, for although the Provincial Government in power since Confederation may have known that the Dominion Fisheries Department had no right whatever to issue angling licenses above tide-water, it permitted the practical confusion of our inland waters by the federal authorities for more than fifteen years. There are politicians who defend that the Provincial Government should always maintain a kind of partnership with that at Ottawa, as against the friendly independence which should exist and it is one of the advantages in favor of the latter view that the present Government takes prompt action in asserting its rights. Friends of the late local Government urged in vain that it should—as the chief riparian proprietor—contend against the confusion of its fishing rights by the Department at Ottawa and it is discreditable to the Attorney-General, from Mr. Wetmore in '87 down to Mr. Hanington in '82, that they never officially protested against the invasion of provincial rights by the Ottawa authorities, but allowed private riparian proprietors to bear the expense of settling a question in which the Province was as much interested as all others combined. The fact, however, that the late local Government was as much a department or dependent of the Dominion Government as the Constitution of the Province permits it, to explain why it allowed provincial rights to be invaded by those who were practically its masters.

The Surveyor-General—after the long-continued neglect of this interest by his predecessors—will find it no easy undertaking to "organize" the rivers under his control, but the latter will benefit other riparian proprietors even though the provincial Government should sell few privileges and, therefore, realize but a small income from the proposed sale. Hereafter a longer leasing system will probably be adopted, while the question of public lands fronting on good fishing privileges will be considered.

Another Pacific Scandal!

An Ottawa press despatch of June 1st, says:—

Buffalo Courier.—The session of the Canadian Parliament which has just closed has shown in a marked manner the tendencies toward centralization prevailing in the Dominion. The present Confederation of the North American Provinces is not yet sixteen years old, and the central Government already undertakes to do things which few persons in this country would think of entrusting to the Government at Washington. At the last session of the Ottawa Parliament a law for the regulation of the liquor traffic for the whole Dominion was enacted. From our point of view such legislation seems foolish, even if the Act of the British Parliament which is the constitution of Canada has empowered the Dominion Parliament to make laws of this kind. In our federal constitution powers are vested in Congress which are now dormant, though the General Government has been in existence nearly a hundred years. Respect for state rights in this country grows greater than it is now after the Republican party has been expelled from power, and it is even to be feared that that party in opposition will adopt extreme views of the extent of State rights and the limitations of federal power. Against the centralizing tendencies of the Dominion Government the Toronto Globe utters words of warning. The Globe points out that between the Canadian Province there are greater differences in point of race, religion, and social and political customs than there are between the several States of our Union. Situated as the Canadians are they cannot build up a "strong" central government at the expense of State or Provincial rights without undermining their confederation and preparing the way for its early dissolution.

There is a report that Mrs. Langtry is to be married to Mr. Gebhardt as soon as a legal divorce can be obtained on the ground of abandonment on the part of her husband, Mr. Langtry. Mrs. Langtry, is now staying at Albemarle, and a reporter to-day handed her a slip containing the latest report affecting her most private and confidential life. 
