Editorial Notes.

Judging from appearances the Liberal Government has made up its mind to continue to subsidize mail steamers running to a foreign port, and thus continue to use Canadian money to build up Portland as the winter port of Canada against the interest of the several ports open throughout the year. St. John, by a factious opposition to the late government because it could not get everything in the way of subsidies irrespective of the right of other ports, compassed the election of two supporters of the Liberal party, and they have no influence even as a protest against the continuance of a policy which the former government had decided should be abolished and Canadian money used only to build up Canadian ports. St. John must be proud of it of such representatives.

In the Meadow Brook murder case the inquest is proceeding day by day. The little girl is thought to be recovering and it is possible her evidence may form an important link against the murderer. John Sullivan, against whom there are grave suspicions of having been the murderer, is at present under arrest in Calais, Me., awaiting extradition proceedings to transfer him to the custody of Canadian legal authorities.

The Montreal Sugar refinery was partially destroyed by fire on Sunday evening last. The boiler room, office, warehouse and barrel factory were not burned. The portion burned was insured for \$140,000, all except \$7,700 being held by United States companies. It is stated that the refinery will be rebuilt.

Festivities.

The members of the Liberal club here are at loggerheads with one another about the way matters are conducted at the club, several of which exist within its borders. At a meeting held one evening last week there was a serious set-to among the Melville portion of the happy family and those were exchanged. ## Newcastle Field Battery.

The 12th Newcastle Field Battery went into camp on Monday, under command of Captain R. L. Maltby, to perform their twelve days drill in camp. Their camp is pitched, as it was last year, in the property known as the Fortune property at the upper end of the town, and is known as Camp Fortune. This has for many years been the firing point for the gun practice, the target being moored on the Northwest branch, giving a range of one thousand yards.

The men marched into camp on Monday morning, pitched their tents and got dinner and in the afternoon brought down the guns.

## Post Office Irregularities Examination.

The examination into the charges preferred against John Fish, late postmaster of Newcastle, was held on Thursday morning at the Court House in Newcastle before Justice Viner. Meddie P. Smith being sworn testified as follows:

My full name is Meredith P. Smith, I am commonly known as Meddie P. Smith, I am manager of a barber shop. I have been so engaged since the first of April. I used to be a clerk in the Newcastle post office. I became a post office clerk on the 1st of March, 1894, and continued until the afternoon of June 9th, 1895. Mr. John Fish, the accused, was postmaster in the Newcastle post office when I was clerk there. [Book shown to witness.] I identify this book as the record of register letters kept at the Newcastle post office for delivery. [Witness' attention is drawn to the entry in the book of a letter purporting to have been mailed at St. Louis de Kent under date March 9, 1896, addressed P. Hennessy, number 523 with the words "error on, on," and the name "P. Hennessy" in the column of delivery address, "Not long after, Mollie Hennessy came up into the office. In reply to Sir Charles Tupper, Hon. Mr. Davies said the government had the Chignecto Marine railway matter under consideration. The house adjourned at 10 o'clock. No business of consequence was transacted to-day.

OTTAWA, Sept. 17.—The routine proceedings in the house to-day were varied by an incident that will make glad the hearts of the militia boys now in camp. The gentleman usher of the black rod knocked on the door of the commons and summoned Her Majesty's faithful commons to the senate chamber, where Mr. Speaker Elgar, standing at the bar, presided. Sir Henry Stong, the acting governor general, with a bill authorizing Her Majesty to expend some \$400,000 on behalf of the militia of Canada. Divested of all its "pomp and circumstance" this ceremony simply means that the money for the pay of the camp is now at the disposal of the government and may be paid at once.

Prior to this Sir Adolphe Caron had called attention to a paragraph in La Presse, which related to a visit now being paid to Rome by Abbe Proulx, a priest from a village in the province of Quebec. The telegram from Mr. Laurier to the Abbe. The telegram was in French, and it is surprising that two translations. One is: "Everything is ready. Be here." The other is: "Everything is ready; come!" Sir Adolphe desired to know if the telegram had been sent. Mr. Laurier was very guarded in his reply, but he admitted the authenticity of the telegram. ## BEAT THE RECORD.

GLENN FALLS, N. Y., Sept. 11.—A perfect day and a fast track drew 8,000 people to the Glen Falls race track yesterday afternoon. The match race between John R. Gentry and Star Pointer was of the closest and most exciting order. Gentry won the second heat in 2:01, breaking the world's pace record. They got away in the first with Star Pointer at the pole. He led to the home stretch, when Gentry slowly forged ahead and won the first heat by a nose. Time by quarters: 21.1, 1:03, 1:35, 2:01. In the second heat the horses went around the track neck and neck, with the precision of machines, neither gaining nor losing. Just before reaching the wire Gentry made a magnificent start and went under the wire a neck ahead, amid wild enthusiasm. The time by quarters was: 31, 1:02, 1:32 and 2:01, the last half and quarter being the fastest ever recorded. It was officially announced that the world's record has been broken. Star Pointer in this heat gained more on his previous record than did Gentry. Gentry won the third easily by a length. Time, 2:00. The race was for a \$200 purse. The Breeders' association of this place offered \$5,000 extra if the world's record was broken. At Terre Haute Robert J. made 2:01 1/2 against time.
