The Sheriff shall, immediately, upon the receipt of his copies, cause one of them to be posted up in a conspicuous place in the Court House; the Clerk of the Peace, upon receipt of his copies, shall cause one of them to be posted up in a conspicuous place, in his office; every Public or separate School Head Master or Mistress shall, in like manner, post up one of his or her copies on the door of the School House; and every Postmaster shall post up one of his copies in his Post Office.
