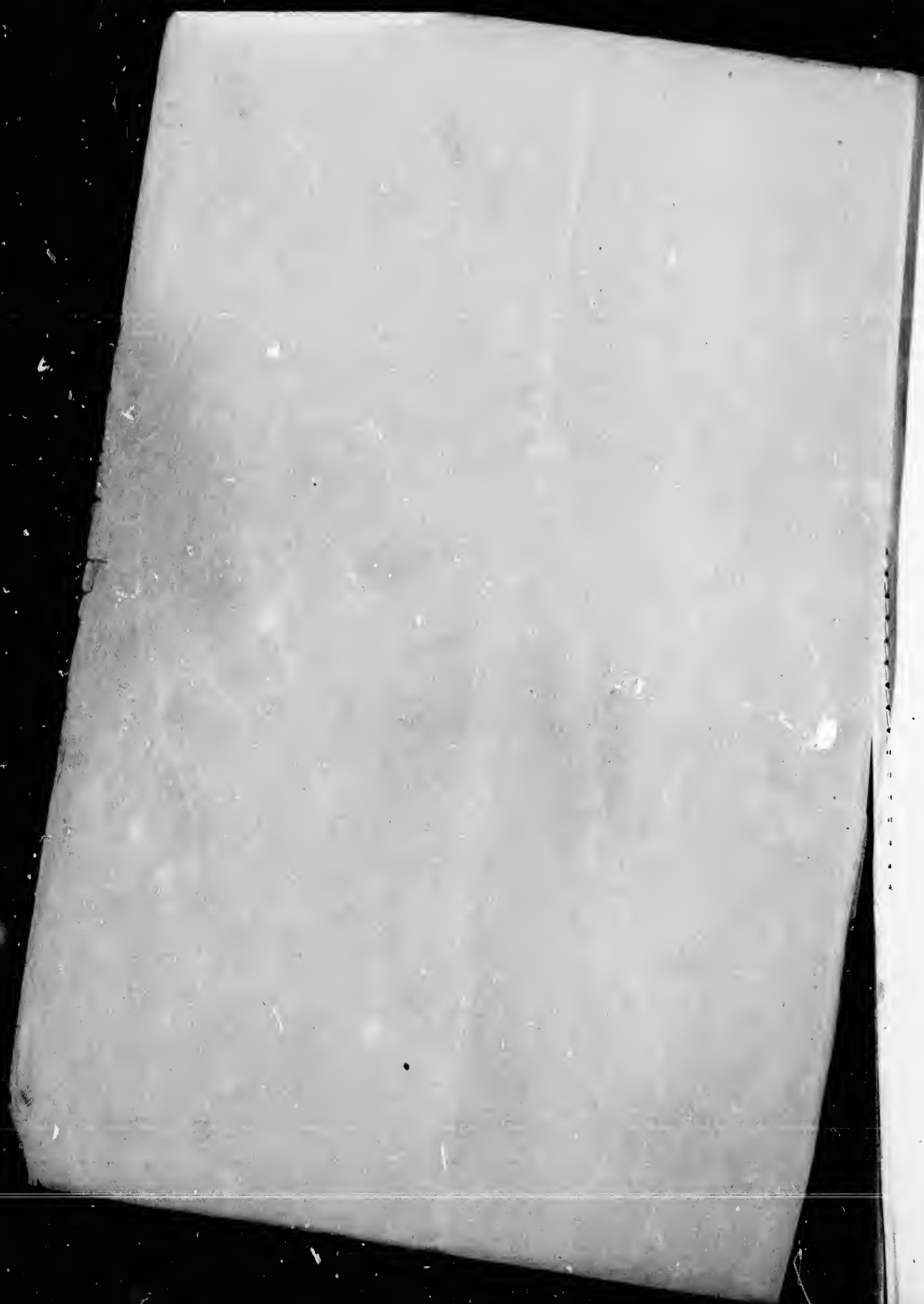


INSTRUCTIONS.
