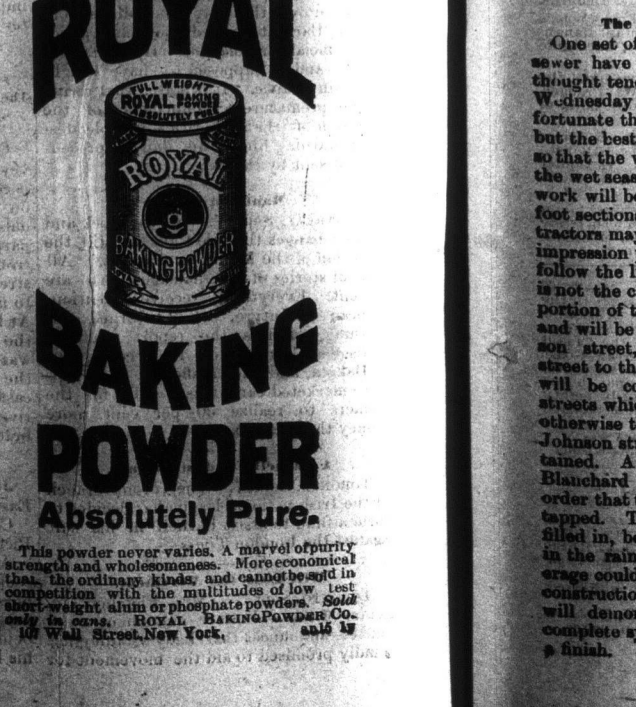

Prof. Proctor, the Celebrated Astronomer, Falls a Victim to Yellow Fever at New York.

Further Ravages of Yellow Fever at Jacksonville—The Death Rate Increasing Daily.

The Fisheries Question Discussed in the Senate—An Aged Lady Banned to Death.

Death of Prof. Proctor, Astronomer.

New York, Sept. 12.—Prof. Richard A. Proctor, astronomer, died at the Willard Parker hospital in this city early this morning from yellow fever. He arrived here from Oakland, Fla., where he has an observatory, on Monday, and was immediately prostrated with the disease, which the best doctors unhesitatingly pronounced to be yellow fever. It was not until the disease was really yellow fever, but that doubts were removed when this patient died of its effects. The professor had engaged a passage for Europe, intending to start on Monday, but he was still at Oakland, where no case of yellow fever is reported.
