



And finally, we ask thee to bless and prosper our beloved Order, wherever it exists; may its influence be like the morning, scattering light and bliss everywhere over our wide earth. And in case you should be expelled or voluntarily withdraw from this Order, you will consider the obligation to keep the secrets of this Order still binding. You also promise that, should any books, papers, or other property belonging to this Order, be entrusted to your keeping, you will faithfully preserve the same, and deliver them up when legally called upon to do so. To all of which you pledge your sacred honor.
