

MIDNIGHT FIRE ALARM And the Horrible Awakening of Over

a Hundred Guests.

pletely destroyed by fire and a large number of people were burned and suffocated in the ruins.

The Hotel Royal was built more than 25 years ago. The house was the home of many persons in the theatrical profession and was patronized chiefly by transients for the night, that class which keeps late hours in the upper part of the tenderloin district.

The fire broke out shortly after three o'clock this morning, and spread with fear-ful rapidity, the flames soon enveloping the entire building and outting off all means of escape for the guests rooming in the upper stories of the building.

The origin of the fire is unknown. It stated in the basement near the elevator shaft, which was located in the middle of the building.

The fire department arrived within a few minutes after the alarm was given by an engineer on the elevated railroad, but meanwhile the most heartrending and sickening seenes were being enacted.

The horror-atricken crowd that had quickly gathered in the streets about the doomed buildings saw men and women, clad only in their night clothes, jump from the upper stories and fall upon the stone flagging of the sidewalks, crushed to death or seriously injured.

WHAT EYE-WITNESSES SAW.

Eye-witnesses tell of the appearance at the upper windows of terror-stricken men and women who, unable to find escape, fell to back overcome by the smoke and flames. Every window of the building seemed filled with men, women and children, crying out pitcously for those below to save them. Many of those were certainly burned to death.

The fire escapes in the rear of the building afforded a means of escape for some, whilst the fire ropes provided in all the rooms were utilized by many male guests in the reaching the streets.

According to the most reliable reports there were about 150 people all told, aleeping in the hotel last night. How many of these were lost may not be assertained for several days.

Nearly every room of the 124 rooms which the hotel had on its five floors was occupied last night by guests, both permanent and transient; in fact all rooms save four had been taken at 1 o'clock in the morning when Richard Mears, the proprietor, at 3.05 o'clock Mears and his wife, who occupied a room on the third floor forty feet from the stircase, were avoused and found

Emineat Threat Surgeon blee of a Bronehial Attack.

A London cable says: Sir Morrell Mackenzie, the distinguished physician, whose serious illness with bronghitis was announced a few days ago, died to-day. Sir Morrell Mackenzie was born in Leytonstone, Essex, in 1837, and was educated at the London Hospital Medical College and in Paris and Vienna. He was the author of numerous publications on laryngological subjects, and in particular of a systematic treatise in two volumes on "Diseases of the Throat and Nose," which is acknowledged to be a standard work. Dr. Mackenzie was also the author of monograms on diphtheria and hay fever and of an article on "Specialism in Medicine," which appeared in the "Fortinghtly Review" in 1885, and which exoited considerable attention. Dr. Mackenzie was attendance on Frederick III., German Emperor, during the latter's last illness and was knighted in 1887. He published in 1886 "The Fatal Illness of Frederick the Noble." At the close of that year he resigned his connection with the College of Physicians. In 1889 he contributed to the "Contemporory Review" some essays entitled "The Voice in Singing and Speaking."
