CENTRAL BOARD OF AGRICULTURE.

MEETINGS OF EXECUTIVE COMMITTEE.

Speaker's Room, Jan. 30th, 1880.

The Executive Committee met this morning at 10 o'clock in the Province Building. Present—Colonel Laurie, President; Mayor Longworth, of Truro; Mr. C. F. Eaton, Cornwallis; P10f. Lawson, Secretary. The Secretary laid on the table a letter from Mr. David Matheson, Pictou, stating that he was detained by court business and could not reach Halifax till to-morrow.

On the suggestion of Mayor Longworth, the Committee arranged to meet the delegates from the Colchester Exhibition Committee on Tuesday morning, 3rd February, at 1 o'clock.

The following gentlemen appeared before the Committee as a delegation from the King's County Exhibition Committee, viz: J. W. Barss, Wolfville; Dr. C. C. Hamilton, Canard; L. DeV. Chipman, Kentville. Mr. Chipman represented the views of the King's County Committee, and the grounds upon which they claimed the Exhibition of 1880 in a written statement prepared by them, which he read to the meeting.

The President pointed out that the Executive Committee were hardly as yet in a position to deal with the matter of choice of site for the Exhibition of 1880, but were glad to hear the views of the delegation.

The meeting was then addressed fully by Mr. Barss, the Chairman of the delegation, Dr. Hamilton and Mr. Chipman, who urged the importance of having the Exhibition in the County.

Moved by Mr. Longworth, seconded by Mr. Eaton, and resolved that the address of the King's county Committee be allowed to lie on the able, and its consideration taken up along with the offers and communications from other bodies.

February 3rd, 1880.

Mr. L. D. V. Chipman, one of the delegates from the Kings County Committee, also attended, and was heard by the Executive Committee in reference to the claims of King's.

Moved by Mr. Longworth, seconded by Mr. Eaton, and resolved that the full consideration of the matter of choice of site for the Povincial Exhibition of 1880 be deferred till to-morrow (Wednesday), when there will be a larger attendance of the Executive Committee.

With reference to an application from Clyde River Society for grant for 1878, the Committee, after giving it full consideration, agreed to adhere to the former decision, the Society having failed to qualify in terms of the Act.

Moved by Mr. Longworth, seconded by Mr. Eaton, that the President and Secretary be requested to prepare the Annual Report of the Board to the Legislature. Passed.

Blank forms for registration of thoroughbred stock were submitted, and the Secretary was authorized to have them set in type for final examination at the next full meeting of the Board. No entries to be received except on the prescribed forms.

The subject of the Provincial Exhibition of 1880 was then taken up. The following offers were submitted :-

The first meeting of the Committee was held to-day, and an Executive of five, with a Secretary and Treasurer, were chosen as follows:—C. C. Hamilton, C. F. Eaton, Robt. W. Starr, Edward M. Jordan, George W. Fisher; William Eaton, Secretary; L. D. V. Chipman, Treasurer.

It was also resolved that a Committee be appointed to present before the Central Board the claims of King's County to the Exhibition.

Will you be kind enough to notify me when the Central Board will be in a position

to receive this delegation. I may be allowed to say that the Committee rely upon the good faith of the Central Board to grant the request now made, as the County was induced to incur the expense of pur-chasing grounds and erecting buildings, by the assurance, expressed or implied, that the Counties that thus qualified themselves should each in their turn enjoy the advantages connected with the holding of the Exhibition within their limits.

We would strongly bring before your Board the central location of the town of Truro, and its easy access by speedy means of transit from all parts of the Province. are so situated that to the many exhibitors of eastern Nova Scotia, the island of Cape Breton, the large farming Counties of Anti-gonish, Picton, Cumberland, Hants and Colchestor, we present the most convenient locality in the Province of approach, thereby naturally drawing to a Provincial Exhibition a larger and better class of agricultural exhibits than a less favored geographical locality could possibly do.

We have suitable grounds and buildings already approved by your Board and the Provincial Government for carrying out any Provincial Exhibition. These will be enlarged and improved, if we are successful

in this application.

4th. In the matter of entertaining the public who flock to our annual shows, we cannot be crowded, we have eight large hotels, capable of accommodating 600, while private boarding-houses and private residences will readily find room for the additional thousands that visit us-

5th. We would refer to our previous management of Provincial Exhibitions, and the little dissatisfaction that exhibitors have ever expressed with our arrangements in gen-

eral and in detail in 1876 and 1878. Similar satisfaction, we think, we can guarantee the public, it favored with the Exhibition of 1880.

STATEMENT BY DELEGATES FROM KING'S COUNTY.

The delegation from King's county respectfully submit for the consideration of the Central Board of Agriculture the following statements and reasons in support of their claim, that the next annual Provincial Exhibition should be held in the Exhibition Building at Kentville:

1. It was clearly the intention of the Legislature, no less than the policy of the Gov-ernment, that the Provincial Exhibitions should not be centralized in any one locality. In support of this view it is sufficient to quote cap. 37, sec. 10, sub-sec. 5, R. S., 4th series, which enacts that "In holding General Provincial Exhibitions due regard shall be had to the just claims of the several counties;" and cap. 13 of the Acts of 1875, which authorizes the Central Board to pay "any Agricultural Society, or other responsible body \$4,000 as a prize fund for an Agricultural and Industrial Exhibition to be held in any county selected by the Central Board." It cannot be contended that the selection of the same county, year after year, by the Central Board, will give effect to the spirit or intention of the Acts, or legitimately satisfy "the just claims of the several counties."

2. The Central Record itself is appropriately.

2. The Central Board itself is emphatically committed to the principle that such Exhibitions will best serve the public, and most fully accomplish the purposes for which they are intended, by being held periodically in different agricultural and industrial centres. In that report, dated 1st March, 1877, which may be referred to in N. S. Journals for that

year, appendix 8, page 3, it is stated:—
"They (the Central Board) are moreover encouraged by the marked success of the Annual Provincial Exhibition held in Truro, Oct. 1877. to look forward to the Annual Provincial Exhibitions in the counties as likely to exert a direct and powerfully beneficial influence in the development of the industry of the Province; to lead to rapid improvement in every department of agriculture, and te promote the comfort and prosperity and intelligence of the agricultural population."

3. Apart, however, from the legislation on the subject, or the report referred to, it is obvious that it is only by alternating the lo-calities in which the Exhibitions are held, that the objects and benefits of the institution can be reasonably expected to be realized. Such Exhibitions are in their very nature of a Provincial and not a mere local character. Their initial aim and object are to act and react beneficially over the whole country, instead of being confined to a limited area. They are intended to give a useful impetus to the various agricultural centres; to create a healthy rivalry in the different districts of the country, and to educate the people by

bringing directly under their observation the results obtained and progress made in agri-cultural developments and industrial pursuits. This can only be efficiently done by taking the Exhibitions periodically to the doors of the people. To centralize them permanently in any one place would seriously cripple their usefulness, and render them of little or no advantage to the great bulk of the agricul-tural population of the country, who can neither afford the time nor expense to undertake long journeys to visit them.

The experience of agriculturists in the mother country, where such Exhibitions are not of yesterday, demonstrates the soundness of the principle contended for. Agricultural Society's Exhibitions in England, and those of the Highland Agricultural Society in Scotland, are held annually in different parts of the country, East, West, South and North,—and, be it remarked, that not only are the richer districts visited, but the poorer districts as well, to the manifest advantage of all, and to the marked encouragement and development of agricultural in-dustry—in all its branches.

5. The experience in Nova Scotia is as yet

limited, but so far it is conclusively in favor of localized, as against centralized, Exhibitions. It is indisputable that, as regards agricultural exhibits, those shown at the Exhibitions held in Truro and Kentville were, in extent, variety and general excel-lence, considerably in advance of those shown at Halifax. On the other hand, it is conceded that exhibits of manufactured articles were more varied and complete at Halifax, which goes to prove the utility of holding Exhibitions occasionally, by turns, in indus-trial as well as in agricultural centres.

6. The deputation have thought it proper to refer to these points, and to establish the general principle that ought to regulate the selection of localities in which to hold the annual Exhibitions, because of late claims have been put forward in the city press and by certain influential persons, to have next and subsequent Exhibitions held in Halifax. Such a proposal is not merely at variance with the spirit of the legislation, the policy of the Government, and the deliberately expressed opinion of the Central Board on the pressed opinion of the Central Board on the subject, but is also opposed to both experi-ence and common sense, and if adopted would go far to nullify the objects sought to be attained.

be attained.

7. That the permanent establishment of the Exhibit as in Halifax will not be nearly so beneficia. r advantageous to the agriculturists of King's county and western Nova Scotia generally, as periodic Exhibitions held in their midst, is so obvious as scarce to require illustration. The deputation, however, submit for the information of the Central Record the following statistics: tral Board the following statistics:

passengers from this section of country. These 932 persons were carried at less than single fares from Yarmouth and all places up to Kentville, and from Kentville to Windsor at a single fare. Nor was there any detention or change of cars at Windsor, as had been the case for the preceding two years. It results, therefore, that with special inducements

in the way of fares, with railway communication all the way from Yarmouth, and with a removal of the annoying restrictions and change of ears at Windsor, the total number of persons who visited the Halifax Exhibition from western Nova Scotia, as berein defined, was only 932, of whom it is safe to say that not more than one-half represented " agriculre" pure and simple. 8. When the Exhibition was held at Kent-

ville in 1877 there were 5,218 passengers by rail alone who visited it, although at that time the Windsor and Annapolis Railway, smarting under the injustice of their eject-ment from the Windsor Branch, charged full fares over all portions of their line, and pas-sengers arriving at Windsor had to procure tickets and change cars. From Annapolis county—exclusive of large numbers who tra-

county—exclusive of large numbers who travelled with private conveyances from Wilmot and the eastern part of that county—there came by rail 530 persons to Kentville, against 221 who went to Halifax last year. In additional county—the county—there were the county—the county—t tion to upwards of 3,000 persons who came to

Kentville in vehicles from all quarters of the county, no less than 1,045 from King's county came by rail. The number who visited Hali-

fax from the county was a trifle under 500.

9. The fair deduction to be drawn from these facts and figures is that, to effect the maximum of benefit, and to attract and influence the bulk of the population, the Exhibi-tions must be held at the different agricultions must be field at the americal agricul-tural centres in different parts of the Province. King's county is wholly an agricultural county, and the 500 persons who visited the Halifax Exhibition last year from this county as against about 4,500 who visited the Kent-cill. Fishibition was the taken on fair inville Exhibition, may be taken as a fair in-dex of the influence these Exhibitions may be expected to exert upon the general agricultural population according as they are permanently located in one place—for instance Halifax—or periodically brought home, as it were, to the doors of the people. These figures are of themselves conclusive, and fur-

ther comment seems to be unnecessary.

10. While it is the object of this deputation to press upon the Central Board at this time the paramount claims of King's county to have the next Exhibition held at Kentville, they desire to say that they endorse the sentiments of the Board as expressed in their report above referred to, in the fullest manner. To be of general and Provincial benefit, the Exhibitions should, without doubt, be held alternately in different sections of the country. nearest the agricultural and industrial centres.
As yet, a large section of western Nova Scotin, represented roughly by Yarmouth, Shelburne and Queen's counties; of eastern Nova Scotia, represented by Picton, Antigonish and Gaysborough countres; and the whole of Cape Breton, have not participated as they should in the benefits to be derived as they should in the benefits to be derived from such Exhibitions. If these sections of country combine to purchase lands, erect buildings, and otherwise comply with the regulations and stipulations required by the Acts and Central Board, the people of King's county will be the first to hail with satisfaction such evidence of intelligent interest in the material progress and development of the country, and will raise no dissentient voice against the Exhibitions being held in regular rotation in the several localities selected by the people as most suitable for the nurnose. the people as most suitable for the purpose.

11. At the present time only three centres of agricultural and manufacturing industry have complied with the requirements of the

Statutes and the Central Board, viz., chester, Halifax and King's counties, with Exhibition Buldings respectively at Truro, Halifax and Kentville. The Exhibitions were held in 1876 at Truro for Colchester district; in 1878 at Truro for Colchester district; and in 1879 at 11.15 for Colchester district; and in 1879 at 11.15 for 11.15 trict; and in 1879 at Halifax for Halifax district. It will be seen that if it had not been that Halifax stepped in and complied been that riminal scepped in the subject, the Exhibition should, in order of rotation, have been held in Kentville last yerr. King's county at that time, representing western Nova Scotia, were pleased to see Halifax, tardily though it was, come to the front at furtherance of the general principle.

12. The delegation submit now, however, with the utmost confidence, that the section

of country they represent is entitled, not more in respect of legislative enactments, than of the inherent fairness and justice of the case, and the general benefits to be derived and aims to be attained, that they have a paramount and indisputable claim upon the General Conneil to locate the next Exhi-

bition in Kentville.

13. Independent of the general principle which, in the opinion of the delegation, it is the function and duty of the General Board to carry out, it is contended that, when King's county complied with the 'egislative enactments, and with the recommendations of the Board, by purchasing lands and creet-ing suitable buildings and conveniences at considerable expense, it is only fair and equit-able that these lands and buildings should be utilized for the purposes for which they were intended in regular rotation. The interence that this should be so is irresistible, and was indeed freely admitted by members of the Board to Mr. C. F. Eaton when he was urging the claims of King's county and arrang-ing to have the 1877 Exhibition held at A contrary assumption is at variance with the whole spirit and purpose of the legislation, would largely neutralize the beneficial results anticipated, and is directly hestile to the further extension of the principle, since no county or responsible body would undertake to recommend the expenditure of \$10,000 to \$15,000 of public money, and ask, and obtain and use donations from private citizens, in the mere expectation that only one Provincial Exhibition would be held at the site selected.

14. The delegation assert that, in view of all the circumstances of the case, King's Co. was induced to undertake onerous expenditures for land and buildings on the well grounded expectation that they should be periodically used for Provincial Exhibitions; and they authoritatively say that but for expectation, and with this end a view, the county would not have incurred the expendi-tures referred to. Therefore, the delegation, for themselves and the important interests they represent, protest emphatically against any interference with the well established principle that the Exhibitions should be held periodically in the several counties which have complied with the law and regulations, and creeted suitable permanent Exhibition

Buildings.

15. In the confident hope that the General Board, recognizing the legitimate rights and claims of western Nova Scotia, will select King's as the county in which the next Provincial Exhibition shall be held, the delega

tion are authorized to offer a prize list of \$5,500. If the decision of the General Board, however, is to be narrowed down and made to depend upon a question of \$500, more or less, then, in such case, the delgation will personally guarantee such additional \$500, so as to raise the prize list to \$6,000.

16. The delegation further state that facilities equal to those granted on the Intercolonial Rulway last year, will be granted for the transit of passengers and exhibits over the Windsor and Amapolis line, from Hahfax and from Annapolis. The delegation remark with satisfaction that the Dominion Government have restored the Windsor Branch under the lease to the W. & A. Railway, and have thus removed the burdens and restrictions from which the people of this section of country suffered so seriously, and which militated so adversely to the success of the last Exhibition held at Kentville.

17. The delegation further add that there are seven large and commodious hotels now in operation in Kentville, with whom arrangements have been made for a low uniform boarding charge per dicin. The lodging committie, guided by their past experience, will leave nothing undone to provide suitable and reasonable accommodation; and the running of morning and evening trains east and west of Kentville will enable visitors to go to and return from the neighbouring towns and villages, and thus obviate all danger of overcrowding or inconvenience at Kentville. In short, all the arrangements are in the hands of an able, competent and efficient committee, and are of a nature that cannot fail to make the Exhibition a success in every

respect.

18. Finally, the delegation rely that the Central Board, true to their function as a representative body, will give effect to the deliberate opinions and recommendations contained in their own report above quoted, and, by deciding that the next Exhibition shall be held in Kentville, satisfy the just and reasonable claims and expectations of the farmers and agricultural population of King's and Annapolis, and western Nova Scotia generally. If from any special or local mo-tives these claims are ignored, the delegation beg to represent that, in their opinion, a serious blow will be struck at the future success of Agricultural Exhibitions in the Province; and they fear that the sense of injustice will be so great and general that the agricul-turists of this district—not the least important in the country—will withdraw their counte-

nance and support from such Exhibitions.

"Resolved, That, having given very full consideration to the several applications for the Provincial Exhibition of 1880, and, whilst fully appreciating the public spirit shown by Halifax and Truro in making such liberal offers for the encouragement of agriculture, this Committee is of opinion that the interests of agriculture will be best served by holding the Exhibition of 1880 at Kentville, and accordingly accept the offer of the King's County Exhibition Committee."

Moved by Mr. Matheson, that the offer of the City Council of Halifax be accept-This motion was not seconded.

Mr. Longworth addressed the Committee. He said that Colchester has made very strong representations with a view to receive the Exhibition, chiefly on account of its central position, rendering it convenient not only for agriculturists of Picton, Cumberland, and other important Counties, but also for breeders of stock in New Branswick and the Western Provinces, who might desire to take part as in former years. At one time no Provin cial Exhibition was possible, except in the city where the wealth of the Province was centered. Matters are different now, since wealth has increased in the country and great improvement in agriculture has taken place. Last year's Exhibition having been held in the city, it is due to agriculturists to hold this year's in the country. He would prefer to have it in Colchester, but thinks it important not to alienate the western section or create antagonism in the city, but that all the Counties and the city should unite to render those Exhibitions really Provincial. He concluded by iving . " I do not think it would be for the interest of the Province at large to have the Exhibition at Halifax or even at Truco this year for the reasons stated, and therefore I second Mr. Eaton's resolution."

Mr. Matheson remarked that the selection of King's County would ignore the whole of his disiriet, Pictou, Antigonish and Guysborough. The votes of the

elicited by the Halifax Society, showed that Halifax was the most convenient place. It is true that Truro would be more convenient than Kentville for the Eastern Counties, but they prefer Halifax. The Halifax Exhibition was not so large in cattle as it should have been. This he attributed to farmers refraining from bringing to the city any animals or produce that were not of the very highest character. He thought the Board should not bind itself to any definite routine of places, but be free each year to accept the most advantageous offer, taking all things into account.

Mr. Eaton read a private letter from a member of the Board, Mr. C. E. Brown, Yarmouth, expressing his view that Halifax should not be selected for this year's Provincial Exhibition or any year's when another locality is ready to carry it out. The city is abundantly able to carry out an Exhibition from its own resources and gate money. Let her hotel keepers, merchants and wealthy men subscribe a prize fund or guarantee one. \$4,000 should be raised in the city society in an hour or two if the right men took it in hand, and let the Government grant go to the weaker counties.

Mr. Eaton's motion was then put by the Chairman and passed.



A FARMER in Halifax County has fayoured us with the following communication :- "In answer to Col. Laurie's invitation to the farmers to answer Mr. Boyd's questions on wheat raising, I give the following: We sow wheat as soon in the spring as the ground can be worked, ploughing in the spring, harrowing to lovel the land after sowing, rolling to make a firm seed bed. We sow wheat after potatoes and vegetable crops, mostly carrots and beets; it yielded the past season 56 bushels from two acres, measured exactly, 4 bushels sown. As for fog, it is hard to tell how much fog there is at River Bourgeois, there is always some here, but it don't seem to hurt the young wheat plants in the least. If this is of any use to print as an answer from Halifax County, you can print the whole or part as you like."

The Guardian, of Truro, reports that the machinery for Mr. McMullen's steam grist mill has arrived. A number of men are now at work fitting up the mill and machinery, which will probably be in operation by the end of this month. The engine (40 horse power) and machinery are from the Waterous Engine Co.'s works, Brantford, Ontario. Mr. Walter S. Fraser, of New Glasgow, who for several years ran the well-known grist mill at McLellan's Brook, near that town, is to be miller in the Truro steam Mr. McMullen advertizes for milk wheat.

THE Short Horn Bull Lord of Braemar, bred by the Earl of Dunmore, imported by the Board of Agriculture in 1876, and then purchased by the Bridgetown Agricultural Society, has been sold to Prof. Lawson, and is now at Lucyfield Farm. He weighs 1950 lbs., and is in even better condition than when first bought in 1876. It is evident that the members of the Bridgetown Society know how to care for a bull, and do not go on the principle of taking out of him the last pound of flesh.

WE are glad to hear that the Ellesmere pigs are sustaining their high reputation. A correspondent in Cape Breton writes: "One of the pigs which we purchased at Oakfield, August, 1878, was killed a month ago and weighed 592 lbs. The largest one of the lot is still alive. They all turned out well."
