 SEVERAL ASSOCIATIONS.

PREVENT us, O Lord, in all our doings with Thy most gracious favour, and further us with Thy continual help; that in all our works, begun, continued, and ended in Thee, we may glorify Thy Holy Name; and finally, by Thy mercy, obtain everlasting life; through Jesus Christ our Lord. *Amen.*

O merciful God, who hast made all men, and hatest nothing that thou hast made, nor wouldest the death of a sinner, but rather that he should be converted and live; Have mercy upon all Jews, Turks, Infidels, and Heretics, and take from them all ignorance, hardness of heart, and contempt of Thy word; and so fetch them home, blessed Lord, to Thy flock, that they may be saved among the remnant of the true Israelites, and be made one fold under one Shepherd. Prosper, O Lord, the labors of those Societies of the Church in the land of our Fathers, which thou hast deigned to use in the promotion of this object, and which have nourished the Church in the Colonies; and bless in like manner with Thy Holy Spirit and Providential succour the Society in whose cause we are now met, and the undertakings which we have now in hand. "Prosper thou the work of our hands upon us; O prosper thou our handy work," for the sake, and through the merits of the same Thy Son Jesus Christ our Lord, who liveth and reigneth with Thee and the Holy Ghost, one God, world without end. *Amen.*

Our Father, which art in Heaven, Hallowed be Thy name. Thy Kingdom come. Thy will be done in earth, As it is in Heaven. Give us this day our daily bread. And forgive us our trespasses. As we forgive them that trespass against us. And lead us not into temptation; But deliver us from evil: For thine is the kingdom, The power and the glory, For ever and ever. *Amen.*

## GENERAL BY-LAWS.

### ART. I.

His Excellency the Governor General, if a Member of the Church of England, shall be requested to become Patron of the Society.

The President of the Society shall be the Lord Bishop of Quebec, or Bishop administering the Diocese, and the Vice-Presidents shall consist of such Chairmen of the different District Associations, hereinafter provided for, as are Members of the Corporation, and such other persons as shall be nominated at the general annual meeting of the Society, from among the Members of the Corporation.

The President shall have the custody of the Seal of the Society.

### ART. II.

#### OF THE TREASURER.

The Treasurer shall receive all subscriptions, donations, rents, issues and profits payable to the Society, for which purpose a paid collector or collectors may be employed.

Such monies shall be deposited in such Bank or Banks as shall be from time to time indicated, or approved of, by the Central Board.

No money shall be paid by the Treasurer without the authority of a resolution of the Central Board, certified by the Secretary, expressing the name of the person to whom, and the purpose for which, the money is to be paid.

The Treasurer shall also have the custody of all deeds, bonds, securities, and other documents relating to the property of the Society, which after registration shall be deposited in one of the approved Banks, unless otherwise specially ordered by the Central Board, and shall submit his accounts at the stated periodical meetings of the Board.

### ART. III.

#### OF THE SECRETARY.

The Secretary shall keep the minutes of all the proceedings of the Society, as well as of the Central Board, and shall be subject to the direction and control of the Central Board in all his duties and proceedings. He shall be allowed a salary and travelling expenses under the direction of the Central Board, and may appoint an assistant, subject to the control and approval of the Board, provided that such appointment shall entail no additional burden upon the Society.

The Treasurer, the Secretary, the Auditors, and other necessary Officers of the Society, shall be appointed by the Central Board. These appointments shall not be for any specified period, but may be cancelled at the pleasure of the Central Board.

### ART. IV.

#### OF MEETINGS OF THE SOCIETY.

The Society shall meet at Quebec twice on the second Wednesday in January of each year. Firstly, on the morning of that day, for the election of the Clergy-Trust Committee, and of the Vice-Presidents, and Central Board, and for general business. Secondly, in the evening, for the public celebration of its Anniversary: whereof not less than fifteen days notice shall be given by the Secretary, in at least one of the leading newspapers of Quebec, and elsewhere, as may seem to him expedient. A special meeting of the Society may be called at any time by the President, or in his absence from the Diocese, or in the event of a vacancy in the See, by two of the Vice-Presidents, and ten other Members of the Society, by a written order to the Secretary, who shall notify the same in the manner hereinbefore provided in respect of the annual meetings.

## ART. V.

## OF THE CORPORATION.

All Members of the Church of England, subscribing ten shillings per annum, shall be capable of being elected Members of the Corporation. But no person shall enjoy any of the privileges of Membership, whose subscription is more than one year in arrear. The annual subscriptions shall be considered due on the first day of January in each year.

Members of the Church of England giving a contribution in one sum of twelve pounds ten shillings shall be eligible as Life Members.

Contributors and subscribers may limit and direct any portion, not exceeding one-half of their contributions and subscriptions, to be applied under direction of the Central Board, to any one of the five objects specified in the Constitution of the Society.

## ART. VI.

## OF THE CENTRAL BOARD

There shall be a Central Board for the management of the general business of the Society, consisting of the President, the Vice-Presidents, and other Officers of the Society, all Clergymen licensed within the Diocese, and the Wardens of every Church or Chapel of the United Church of England and Ireland within the same, being Members of the Corporation, and of such others as shall be chosen annually at the general meeting of the Society from among the Members of the Corporation.

The Central Board shall meet eight times a year: viz. On the Thursday next after the Annual Meeting; the second Thursday in February and March; the second Wednesday after Easter and Ascension Day; the second Wednesday in September and November; and the last Wednesday in December, except when that day shall be Christmas-Day, in which case the meeting shall be held upon the preceding day. At this last meeting the discussion of the Annual Report shall be the first order of the day.

Special meetings may be called by the President, or in his absence from the Diocese, or in the event of a vacancy in the See, by two of the Vice-Presidents, and four Members of the Board; and not less than seven Members present at any meeting shall form a quorum. When a sufficient number of Members to form a quorum shall not assemble on the regular day of meeting, the members present shall have power to adjourn to another day, and so on *toties quoties*, until a quorum shall be found; and business shall and may then be proceeded with. It is one of the rules of the Central Board that no application for a grant of money shall be entertained, unless such application shall have reached the hands of the Secretary a fortnight at least before the next ensuing meeting of the Board.

The Central Board shall have authority to make such rules as may be necessary for the government of its own affairs, provided that none of them be contrary to, or inconsistent with, the spirit of the Constitution or By-laws of the Society.

The Central Board shall be held to be accountable to the Corporation, and shall report to the annual meeting a general statement of its proceedings, and of all moneys received and expended during the preceding year, submitting at the same time a list of Officers for the year then commencing.

The Central Board shall make no grant of money for the benefit of any Parish or Mission unless the subscriptions for the preceding year from such Parish or Mission shall have reached the hands of the Treasurer of the Society.

No portion of the Society's funds shall be employed in augmenting the stipends of officiating clergymen, in supporting schools, or in erecting Churches or Parsonage Houses, within the limits of the City of Quebec.

## ARTICLE VII.

## OF DISTRICT ASSOCIATIONS.

In connexion and correspondence with the Central Board, there shall be formed District Associations, except in the City of Quebec and the Baillieues thereof, to be composed of the Clergy, and all other Members of the Society resident within the bounds of such Districts, a contribution of five shillings per annum constituting Membership of such District Associations. The District Associations, except as hereinbefore excepted, shall continue as heretofore settled by the Central Board of the Society, before its incorporation, until otherwise hereafter determined by the Central Board.

The Senior Clergyman holding a Pastoral charge within such bounds, and being a Member of such Association, shall, *ex-officio* be Chairman thereof. They may have a Vice-chairman, Secretary, and Treasurer, and shall meet at such places as they may themselves determine; at one of which meetings the Officers shall be appointed, and a report of the proceedings of the year read.

The District Associations shall have authority to make rules for the government of their own affairs, provided such rules be not contrary to, or inconsistent with, the Constitution or By-laws of the Society. They shall report annually to the Central Board, at least one month before the annual general meeting of the Society, and at such other times as the Secretary, on behalf of the Board, shall require, a statement of their proceedings, and a detailed account of the moneys received and expended by them during the year.

One-half of all the moneys paid into the hands of the Treasurers of the District Associations, respectively, and not specially appropriated by the contributors, as provided for by Article V. shall be transmitted to the Treasurer of the Society, to be at the disposal of the Central Board, and the remaining half of all such collections shall, when required, be expended within the Parish or District in which they have been made, for such objects only as are specified in the Constitution of this Society. All moneys, remaining unappropriated at the general annual meeting of the District Association, shall be forthwith transmitted to the Treasurer of the Society, to be at the disposal of the Central Board.

## ARTICLE VIII.

## OF SUB-COMMITTEES OF THE SOCIETY.

For the more effectually carrying out the designs of this Society, the Clergyman and Churchwardens in every Parish and Missionary Station, and the Minister and Wardens of every Chapelry within the Diocese, shall be a Sub-Committee of the Society in correspondence with the District Association within whose bounds such Parish or Missionary Station is situated, or in Quebec with the Central Board, through the Secretary of the Society. This Committee shall meet as often, and at such periods, as they themselves shall decide to be most convenient, inviting the co-operation of all the Parishioners in their deliberations and designs. They shall collect subscriptions and donations from the Members of the Church in such manner as they shall deem most effective, and endeavour, by every means in their power, to augment the resources of the Society. All moneys raised by such Sub-Committees shall be remitted to the Treasurer of the District Association, or to the Treasurer of the Society, where such moneys shall have been raised within the City and Baillieues of Quebec.

## ARTICLE IX.

## OF SERMONS.

One sermon at least shall be preached during the year within the limits of each Parish, Station or Chapelry, on such Sunday as the Bishop shall appoint, in favor of one or more of the objects of the Society, and a collection shall then be made in aid thereof, the proceeds of which shall forthwith be remitted to the Treasurer of the Society. Any Parish, Station or Chapelry in which such sermons shall not have been preached, shall not be considered entitled to any grant or benefit from the Society until a sermon shall have been so preached.

## ARTICLE X.

## OF THE LAY COMMITTEE OF THE SOCIETY.

A Lay Committee, consisting of not less than thirteen members, shall be chosen at the first meeting of the Central Board after the annual meeting of the Society, from among the members of the Corporation. Three members shall form a quorum, and they shall have power to fill up any vacancy or vacancies which may arise within their own body, and shall be governed by the constitution, rules and regulations adopted and in force before the incorporation of the Society, until the same shall be altered by the Committee or by the Society at the general meeting.

The proceedings of the Lay Committee shall be subject to the sanction of the Bishop of the Diocese. The Clerical and other members of the Central Board may attend at any of the general meetings of the Committee, and may propose and discuss matters therein, but shall have no vote. The committee shall report their proceedings to the Central Board at their stated meetings.

The objects of this Committee shall be:

*First.*—The placing the Clergymen, now resident, and doing duty in the Province, upon a just footing as regards the sufficiency and permanency of their incomes.

*Secondly.*—The providing for the permanent and adequate support of an increased number of clergymen, so that, with the least possible delay, the members of the Church, in every portion of the Diocese, may have the means of access to a Church within a practicable distance.

*Thirdly.*—The building, in every place where it may be required, a church of stone or brick, upon a well considered plan as to dimensions, external form, and internal arrangement, keeping in view the probability of its requiring enlargement.

*Fourthly.*—The building, in a good situation, convenient to the Church, a comfortable Parsonage of brick or stone, the plan of which should be carefully considered, with reference to size and internal arrangement, and should admit of additions being made, with the sanction of the Bishop.

*Fifthly.*—The insuring such Churches or Parsonages against losses by fire.

*Sixthly.*—The procuring an adequate and permanent support for all the institutions, authorities and functionaries, suitable and appertaining to the establishment of the Church of England in this Diocese.

*Seventhly.*—The investing all life subscriptions, unless so far as the application of these may be otherwise limited by the Contributors, in a permanent and accumulating fund, of which the interest only shall be applied to the general purposes of the Society.

*Eighthly.*—The encouraging the formation of a Local Endowment Fund, at every station or place having a Church or Clergyman, by Special Contributions, or by setting apart a portion of the pew rents, to form an ac-



accumulating fund, until the net income shall in each case amount to fifty pounds per annum; for the more effectual promotion of which object the Society will engage, whenever such fund shall be formed and shall amount to one hundred pounds, invested in bank stock, or other public securities, to add thereto an amount not exceeding one hundred pounds, provided always that such investment shall stand in the name of the President of the Society.

*Ninthly.*—The management and the superintendence of all lands belonging to the Society.

#### ARTICLE XI.

All meetings of the Society, of the Central Board, and of District Associations, shall be opened by the following prayers—(*see any of the Society's Reports*),—or such others as the Bishop may appoint.

No alteration or amendment in the Constitution or By laws of the Society shall be made unless such alteration or amendment shall be proposed at one and adopted at another General Meeting of the Society, provided that not less than one month intervene between the two meetings, and that the object of the Meetings be stated in the advertisement by which they are called.

At all meetings of the Society, of the Central Board, or of Committees, the Chairman, in case of an equality of votes, shall have a double or casting vote.

#### ARTICLE XII.

Whereas some Members of the Church, who are not unmindful of the great spiritual wants of their own neighborhood, still feel constrained in pious gratitude for the blessings they enjoy, to allot something, however small, from the means with which a Gracious Providence has blessed them, towards the spread of the glorious Gospel among the nations, which still sit in darkness; the Society will gladly receive and forward to the Society for the Propagation of the Gospel, the Church Missionary Society, or the London Society for promoting Christianity among the Jews, whatever sums may be given for the conversion and instruction of the Heathen or the Jews.



## CENTRAL BOARD.

STATED MEETING, JULY 9TH, 1856.

Resolved: That it be an instruction to the Treasurer, when transmitting the amount of any grant of money, made by this Society, to any Parish or Mission in the Diocese, to require a Receipt, signed jointly by the Incumbent of such Parish or Mission, and one or both of the Churchwardens.

STATED MEETING, OCTOBER 8TH, 1856.

Resolved: That in all cases where grants of money (other than personal) are made by the Church Society, it shall be the duty of the person to whom such grants shall be paid, to furnish within three months afterwards regular Vouchers of the expenditure of such sums, to be submitted to the Board.

## ANNUAL REPORT FOR 1857.

---

In their Report, presented to the Society last year, the Central Board referred to the importance of making provision for an extension of the Missionary operations of the Society, as an object standing prominently forth, occupying indeed the foremost place, among those for which it was originally incorporated. Influenced by the same convictions, they have during the past year devoted much consideration to the subject. And it is with deep regret that they are compelled to acknowledge that they have as yet, from various causes, been enabled to effect but little towards the accomplishment of an end at once so desirable and important.

With a view to alleviate the pressure, which must necessarily follow the withdrawal of assistance by the S. P. G., and which would be felt more heavily, perhaps, by the Diocese of Quebec than by any other, your Board have forwarded a memorial to the Venerable Society upon the subject, setting forth the true condition and resources of the Church in this Diocese, and respectfully soliciting its sanction to the establishment of a commutator of her present claims upon the Society, on a basis similar to that adopted by the Provincial Government in the case of the Clergy Reserves: an arrangement which, if acceded to, would have the effect of securing in permanence to the Church at least a moiety of her present income.

To four Missions, viz: Pointe Levi, Frampton, New Ireland, and Stoneham, which, having fallen under the operation of the Society's Rule, have experienced different rates of reduction in respect of income, your Board have made temporary grants, equivalent to the existing deficiencies: in order that the Clergymen so

circumstanced might not be involved in difficulties by the sudden withdrawal of a considerable portion of their salaries; and in the hope that their respective congregations, understanding even at the eleventh hour the necessity of greater and more sustained exertions on their parts, might be led to render a more efficient support to the Church, which they profess to venerate and love, than hitherto they have been found to do. In this hope, your Board state, with deep regret, that they have been disappointed. Their liberality has not been met in a kindred spirit by the people. Their earnest appeals have failed to elicit any sufficiently encouraging response.

The great difficulty—however painful it may be, and even humiliating, to place such a statement upon record—the great difficulty which your Board have to contend with, not merely in the instances referred to, but throughout the Diocese at large, is the lukewarmness and indifference of the people themselves. They are willing enough, nay, apparently most desirous to have Clergymen resident amongst them, and to have Churches built, and Schools established: but they are not, as a body, found equally willing to assist in the accomplishment of such objects, either out of their abundance, or, like the Churches of Macedonia, out of “their deep poverty.” They cheerfully covenant to pay a certain sum to their Minister, or to raise a specified amount for the Church Society; but, in a vast majority of instances, such covenants, if not actually repudiated, are suffered to rest unfulfilled.

To this subject your Board have devoted much and painful consideration: and they have arrived, after mature deliberation, at the conclusion that, under the existing circumstances of the Church in this Diocese, it will be absolutely and unavoidably necessary to withdraw the assistance of the Society from all such Missions as shall be found, upon due investigation, to

An idea has been entertained by some, (which your Board consider it right to submit to you), that many of the difficulties which they have to contend with, might be met by the employment of a Travelling Agent, whose time could be devoted wholly to the advancement of the various objects of the Society: whose duty it should be to visit the several Missions periodically; to ascertain, as far as practicable, their resources; to organize local Associations; and, submitting to the people a plain unvarnished statement of the actual condition of the Church in this Diocese, the dependence of her very existence, humanly speaking, upon the zealous and sustained exertions of her children, to urge upon them, in God's name, the duty of placing in a position at least above that of actual privation and want, those who "minister to them in holy things," of furthering the cause of Education, as the handmaid of Religion, and of building up and maintaining the houses of God in the land.

Amidst the coldness and indifference on the part of many, which your Board have referred to, in language strong perhaps, but, in their estimation, amply justified by circumstances, it is cheering to have it in their power to report the following instances of timely liberality on the part of members of the Church. And they would add their humble and earnest prayer that many others, influenced by such examples, may be led to minister thus to her necessities—that, their devout affections being stirred up, they may by the Spirit of the Lord be moved to "go and do likewise."

Mr. Pozer, Seigneur of Aubert Galleon, County of Beauce, has lately made a free gift of 120 Acres of land; for the purpose of constituting a Glebe for the Clergyman, and of affording a site for a Church, and a Burial-ground.

The Rev. S. S. Wood, Rector of Three Rivers, has addressed a letter to the Bishop of the Diocese, dated September 3rd, 1857, from which the following is an extract:—"Having purchased a Farm, I have determined, if it please God to allow me so to do, to devote " a full tenth, or 18 acres, of cleared land to His service, " and in aid of the endowment and establishment of " the Church and Parish in Upper Durham."

Although, perhaps, a matter not strictly coming under the cognizance of your Board, yet as being one of importance in itself, and of interest to the Diocese, they beg leave to express the sentiments of satisfaction which they entertain, at being enabled to state that a Clergyman, the Rev. W. L. Thompson, has recently been sent from England, under the auspices of the " Colonial Church and School Society;" a Society which has already rendered much valuable assistance to the cause of Education in this Diocese: and that that gentleman has been licensed to the charge of Stanstead, a station of much importance, and which has long been unavoidably left destitute of the regular ministrations of the Church.

During the past year five individuals only have become Life-members of the Society, viz: Mrs. G. R. Mountain, (England), Miss Cockell, Hon. Edward Hale, Rev. Professor Thompson, and R. Wainwright, Esq. James Sealey, Esq., already a Life-member, has liberally presented to the Society a second subscription of £12 10s.

And here, with feelings of deep and sincere regret, your Board would record the untimely death, (untimely, at least in human estimation), of one of the Life-members of the Society, Mr. James Maclaren, who perished in common with so many others, on the occasion of the loss of the Steamer, " Montreal," June 26th, 1857: one of the most zealous and devoted members of the Church in this Diocese; ever amongst the foremost in

## MISSIONARY LABOR.

### GROSSE ISLE.

THE Rev. J. Torrance, having been appointed by the Lord Bishop to the Chaplaincy of the Quarantine Station, Grosse Isle, proceeded thither, June 2nd, and continued in charge until the end of August. He was succeeded, September 6th, by the Rev. Mr. Chapman, of Dudswell. Mr. Chapman remained in discharge of the duties of Chaplain until October 12th. The number of sick in Hospital during the season amounted to 417: of whom 378 were Protestants.

Neither of the above-named gentlemen has furnished any Report of matters connected with the discharge of duty at the Quarantine Station: but in a letter to the Secretary, Mr. Chapman expresses himself as quoted below; in reference, it is presumed, to the German and Norwegian Emigrants—of the latter of whom, especially, the numbers have largely increased of late years:

"I do not know that I could say anything more useful than to drop a hint of the urgent necessity of securing the services of a Clergyman for the Quarantine Station; who could hold intercourse with the poor Emigrant in his native tongue: a want which I severely felt in my own individual case. It may be deemed presumptuous in me to say any thing at all about the subject; as I have no doubt it is a subject of grave consideration both with the Lord Bishop and



" the Society, since the character of the Emigration

#### SAGUENAY AND CHICOUTIMI DISTRICTS.

On the 9th of September the Rev. E. G. W. Ross, of  
 Rivière du Loup, proceeded by direction of the Lord  
 Bishop, on a Missionary visit to the Saguenay and Chi-  
 coutimi Districts.

At Grande Baie, which he reached on the morning  
 of the 10th, he remained as the guest of Mr. Blair for  
 six days: during which period he held four public  
 Services, and visited the various families in the neigh-  
 bourhood, catechizing the junior members of the little  
 flock, and distributing approved religious publications.  
 The largest congregation that Mr. Ross was privileged  
 to address here consisted of twenty persons: with  
 reference to which he remarks, that the number of  
 Protestants at Grande Baie has diminished by five, in  
 consequence of removal to other localities, since his  
 visit to the Settlement last year.

On the 16th, Mr. Ross proceeded to Rivière du Mou-  
 lin, fifteen miles higher up the Saguenay; where, as  
 usual, he was hospitably received by David Price, Esq.,  
 M.P.P. Here he employed himself in visiting the  
 various Protestant families, French and English, in the  
 vicinity, distributing Tracts, &c., as opportunity of-  
 fered.

On the 18th, he visited Chicoutimi and Gladfield  
 Farm. Having passed the night at the place last men-  
 tioned, he proceeded next morning, at an early hour,  
 by boat three miles farther up the Saguenay, to Terre-  
 rompue, the residence of Mr. McLeod, the oldest Pro-  
 testant settler in the District. Having held religious  
 Service here, he returned in the evening to Rivière du  
 Moulin: where, on the day following, (Sunday), he  
 celebrated Divine Service, morning and afternoon, at  
 the residence of Mr. Price. On these two occasions

the congregations were much smaller than had been customary, owing to the extreme wetness of the weather, and the distance, (ten or twelve miles)—at which many of those, ordinarily attendant, reside.

On the 26th, Mr. Ross sailed from Rivière du Moulin, and on the evening of the same day arrived at Rivière du Loup, having omitted touching at L'Anse-a-l'Eau, as the only Protestants resident there were then absent. There are not at present any Protestants in residence at Rivière aux Canards; and only one at Petit Saguenay, whom Mr. Ross had seen some time previously at Rivière du Loup.

"In conclusion," the Missionary writes, "the Protestants in the Saguenay and Chicoutimi Districts are so few and far between, that there seems to be but little probability, at present, of their being able to build a place of worship, or to have a resident Clergyman. However, it is gratifying to find that they are in general very attentive to the ministrations of any Protestant Clergyman who may visit them.

"May the incorruptible seed of the Word of God; now sown, sink deep in all our hearts, and bring forth fruit an hundred-fold, to the praise and glory of God; our Creator, and Sanctifier, and Redeemer!"

#### HEREFORD.

During the Spring and Summer several visits have been paid, by direction of the Lord Bishop, to Hereford and some of the parts adjacent, by the Rev. H. G. Burrage, of Hatley, acting as Travelling Missionary of the Society. Hereford lies upon the frontier, and is distant from Hatley about 35 miles.

From the journal kept by Mr. Burrage the following extracts are presented:—

"Sunday, March 29th.—Performed Service in the School-House. Found a congregation assembled, from 40 to 50 persons. After service I was requested

" by many to repeat my visits. It was very pleasing to  
 " see the strong desire manifested by the people to  
 " obtain the ministrations of the Church among them.  
 " On this occasion, and on my former visit, the con-  
 " gregation was very attentive during the whole of the  
 " service, and showed much willingness to conform in  
 " every respect to our mode of worship. Evidently  
 " they feel the want of religious instruction very  
 " keenly: being, as they themselves remarked, sheep  
 " without a shepherd. The Travelling Missionaries of  
 " the Church seem to have made a favorable impression  
 " upon the minds of the people. I believe this to be  
 " the reason why they preferred to make an effort to  
 " obtain the services of a Church of England Minis-  
 " ter before looking elsewhere."

Under the date of Sunday, July 26th, Mr. Burrage  
 thus writes:—

" Started in good time for Hall's Stream, distant  
 " about eight miles from Hereford. On my arrival  
 " found a large number of persons within the School-  
 " house: probably 80 individuals. There were a few  
 " who made the responses, and the Psalms were very  
 " well sung. After dinner, retraced our steps, and  
 " reached the School-house, near Mr. Workman's, in  
 " good time. At the appointed hour there was a very  
 " large congregation, more than could conveniently find  
 " room within the building: fully one hundred persons  
 " were present. After the 2nd Lesson, I baptized three  
 " children, brought in from the State of Vermont for  
 " that purpose. The Township of Hereford borders  
 " immediately on Vermont, in the United States; and  
 " the School-house, in which I held service, was scarcely  
 " a mile from the Province Line. Seldom have I seen  
 " a more attentive and devout congregation than on  
 " this occasion. It is encouraging to find that the more  
 " frequent the visits, the more they are appreciated.

" On this Sunday I preached twice, baptized three children, and travelled fifty miles.

" It was my intention to have continued these visits during the summer at stated intervals. But it pleased God that it should be otherwise ordered. And thus the remainder of the summer unavoidably passed away, without my being able to go to Hereford. It is my intention, however, (D.V.) to endeavour to continue my visits through the winter."

#### RIVER DAVID.

With reference to the Mission at River David, the Secretary has received the following communication from Rev. J. DeMouilpied, employed by the Society to perform occasional Sunday Services at that Station:

" I have performed Divine Service there once a month, since my appointment at Sorel in June last. The distance from Sorel is 18 miles; and had it not been for that distance, I should have had much pleasure in attending there more frequently. The service is held in Mrs. Wurtele's house, where the few surrounding Protestant families meet me regularly every first Sunday in the month.

" My knowledge of French has given me several opportunities, without travelling out of my way, of addressing many Roman Catholics in their own language. On one occasion, at a funeral, the child of a Canadian mother was attended to the cemetery by about sixty Canadians, who seemed to be surprised, and well pleased, at hearing me read in their own tongue, the beautiful Burial Service of our Church. On another occasion, I officiated at a marriage, the bride being a Roman Catholic, and a large number of French Canadians were present. At the particular request of the friends, I performed the Service in French, much to their subsequently expressed satisfaction. In this way I trust that, openings being

"afforded by Divine Providence, my knowledge of the French language may be turned to profitable account, and the Scriptural services of our Apostolic Church become well and favourably known to the surrounding French Roman Catholic population."

DANVILLE, &C.

This field of labour, occupied last year by the Rev. Mr. Lloyd, under the auspices of the Church Society, has been transferred to the charge of another Clergyman, whose salary is provided for from a different source. In consequence of this circumstance, your Board may perhaps be considered as stepping somewhat beyond their proper province, in making any reference to this particular locality. Yet, as considerable prominence was given in last Report to the subject of Missionary labour in Danville and its neighbourhood, they are unwilling to omit all mention of a district, which they are disposed, for various reasons, to look upon as one of much importance, and of very encouraging promise.

Upon this subject, then, your Board beg leave to report that, in the Autumn of 1856, the Rev. A. Balfour, Missionary at Kingsey, was directed by the Lord Bishop to transfer his pastoral attention from Upper Durham, (now in charge of Rev. S. S. Wood) to the village of Danville, and the parts adjacent.

Besides Kingsey and Danville, which are about 14 miles apart, and which were served every Sunday, Mr. Balfour had services also in the Sproul Settlement, Warwick, Tinwick, and occasionally at a station in the rear of Shipton.—"These duties," the Missionary states, "commonly occupied five days, (including Sunday) out of the seven; and rarely allowed him the opportunity of returning home, until the week might be called finished. During his winter journeyings the Missionary suffered much from exposure to intense cold, having often to travel by night. This field of labor,"

he proceeds to say, "is large, interesting, and in several localities important. The distance directly travelled from the Parsonage at Kingsey through the above settlements was, on each tour during the winter months, about 54 miles."

The Sproul Settlement, (sometimes called "Cassidy's") is distant from Kingsey about nine miles. "This Settlement," the Missionary observes, "has always received more or less attention from the Mission of Kingsey; and most of the rising generation have been baptized by our Ministers. Still there exists here but little sympathy with the Church.

"The Missionary of Kingsey had here regular services for some time, on alternate Sundays, in the afternoon. But, judging from the genius of the people that nothing permanent could be effected here, he transferred his Sunday Services to the village of Danville: but has not entirely abandoned the post, as he has found the people generally willing at least to hear him."

Danville is a rapidly increasing village, near the Railroad Station, about 14 miles from Kingsey. The inhabitants of it, and of the neighbourhood, are chiefly Americans, belonging to the Congregational denomination. There are also several individuals of the Methodist persuasion, and some Roman Catholics. The Adventists also have here a Chapel, where regular Sabbath services are held. In the village itself there are resident but few members of the Church of England; but many scattered families of our communion dwell within a distance of five miles around. "At first," Mr. Balfour writes, "our congregations were small, and our prospects discouraging. Beginning with only six, our congregation has, however, extended to over seventy. It has assumed a sort of steadiness; and, as a general rule, in favorable weather numbers about fifty families countenances. About the period of Easter the

“ Sacrament of the Lord's Supper was administered to eight or nine communicants.

“ A pleasing instance of this people's humanity and liberality was shown to the Missionary, by their sympathizing with him in his journeying on horse-back, while the Thermometer ranged  $90^{\circ}$ , and their consequent efforts to ease his labour by purchasing for him a waggon at a cost of £10.”

Of Tinwick Station, which is about nine miles from Danville, and twenty-three from Kingsey, Mr. Balfour says :—“ This is a most interesting little community of Protestants, and well attached Church people. Did space permit, the Missionary could plead earnestly, if not eloquently, for these neglected members of our household. He does for them what he can, at the expense of much exposure and toil.”

As illustrative of the spirit actuating the inhabitants of Tinwick generally, he relates that on one occasion, having met with unexpected cause of delay, he did not reach the settlement till after darkness had set in : “ He called at the first house in the Settlement, the inmates not yet having retired to rest ; and informed them that it was his intention to have prayers at the School-house, at 7 o'clock on the following morning ; requesting them to do what they could to make it known. He rode on a few miles further to the house of Mr. Ewing. All the lights in the Settlement were now extinguished. Soon, however, this hospitable family were all up again, ministering to his wants : and, having assigned to him the best bed in the house, all was soon quiet again. Although there was no other notice given of the intended Service than that mentioned above, at an early hour next morning the people were seen wending their way to the School-house, which was filled with a congregation, old and young, of some sixty persons.”

Warwick, a Station of the Grand Trunk Rail-road, where there are a few Protestants resident, was visited several times during winter by Mr. Balfour. It was his intention to have repeated his visits in the course of the ensuing summer: but, from a combination of various circumstances, he was unable to carry his design into effect; and felt reluctantly compelled to defer its execution until the return of winter.

Mr. Balfour directs especial attention to this wide field of labour, in which he has been employed; which he represents as calling for the immediate exertions of the friends of the Church.

With reference to the Settlement in the Township of Shipton, he thus writes: "This Settlement, (or rather, two: lying contiguous, without any communication by road) is about six miles from the Parsonage, and has received the occasional attention of the Missionary at Kingsey. There are several families belonging to the Church here; and sometimes the School-house presents a large and attentive congregation."

Mr. Balfour's concluding observations are these:—"The Missionary has presented this detailed Report of his Mission, hoping that it may excite the exertions of the Church Society in this direction: and that a work, in which he is 'zealously affected,' but physically unable to bear, may be adequately provided for as soon as possible."

The Rev. M. M. Fothergill, of St. Augustine's College, Canterbury, recently ordained at Lennoxville, has been appointed by the Lord Bishop as Travelling Missionary: and for the present winter has had his sphere of labor assigned him in the Eastern Townships. From an early period in September until November 15th, the date of his admission to Holy Orders, Mr. Fothergill had acted as Lay-reader and Catechist, in the employment of the Society, in the Mission of Bury and the adjoining one of Dudswell.



Mr. Magill, late Student of Bishop's College, Lennoxville, was also employed, temporarily, during the summer months, as Lay-reader in the St. Francis District, under the superintendence of the Rev. Dr. Falloon, of Melbourne.

Before proceeding to enlarge on other topics, your Board deem it not inappropriate to mention here that, in addition to the four Missions which, as already stated, have received a very considerable amount of aid towards making good the deficiencies of income, caused by reductions which have taken place in the salaries of their respective Ministers, they have also contributed largely (more largely than perhaps could justly have been expected from them), to the support of the Missionary in charge of Bourg-Louis and Portneuf. In this they have been actuated by the deep reluctance which they felt towards leaving a district, so extensive, destitute both of pastoral supervision and of public ordinances; as must have been the case, had they withheld their aid: and influenced by the hope that the inhabitants, however backward hitherto, may yet be led to entertain a higher appreciation of their Christian privileges, and to exhibit a more willing spirit in giving of their worldly substance for the maintenance of the services of the sanctuary.

#### EDUCATION.

On the subject of Education the Rev. Mr. Kemp, of Bury, thus writes: "A School has been established at Robinson, under the 'Colonial Church and School Society.' Mr. Best took charge on the 1st of June, and commenced with twenty scholars: which have since increased to nearly sixty. The subjects taught are, Reading, Writing, Arithmetic, History, Geography, and Linear Drawing. The School is opened by singing and prayer, and a Scripture Lesson: and the whole of the instruction is based upon Religion. The

The Rev. Mr. Emery, of New Ireland, states: " There  
" are three Government Schools in my Mission, with  
" Churchmen for School-masters: and I hope, before  
" long, to have two more in the same position. We  
" have established a Mechanics' Institute and Library  
" at Maple-Grove, from which I look for my people to  
" derive great benefit. Government has made us a  
" grant of £50."

The Rev. Mr. Woolrich, of Stoneham, after referring  
to other matters of parochial interest, thus forcibly  
expresses himself on the subject of the necessity of  
Schools, as indispensable auxiliaries to the labours of  
the Clergyman: " I cannot, however, forget that, in  
" common with most of our Country Missions, mine  
" labours under the most serious disadvantage, the evil  
" of which it would be almost impossible to exagger-  
" rate—the want of good Day-schools. It is hopeless  
" to expect that one Clergyman, in a large and scat-  
" tered district, will ever be able to effect much per-  
" manent good amongst his people, until some measures  
" be taken to provide their children with a thoroughly  
" good and useful education. And this can only be  
" accomplished by placing in our country schools  
" teachers of approved character and attainments. I  
" rejoice therefore to be enabled to state, that my  
" representations on this important subject have been  
" met in a spirit of much liberality and courtesy by the  
" 'Colonial Church and School Society,' who have  
" intimated to me their intention of doubling the an-  
" nual grant, that has now been made for some years to  
" this Mission.

" I have also to mention that through the aid of your Society, and of the Society for Promoting Christian Knowledge, I have recently laid the foundation of a Parish Library: and from the short time that it has been in operation, I have reason to anticipate the happiest results."

With reference to the Schools in the Portneuf and Bourg-Louis Mission, the following Report has been received from the Rev. S. Briggs:—

" My Schools at Bourg-Louis appear to have produced good effects upon the parents as well as upon the children. I do not regret the labour and expense which they have caused me; for I feel more and more convinced that I have taken the right step in the right direction. I have made provision for the instruction of 160 children; and we have not far from that number in daily attendance. There was one School-room already built, I have finished a second, and a third is in progress.

" I take the opportunity of thanking the Church Society, for the aid afforded me; for without such assistance I could have effected little. I have also to thank the Colonial Church and School Society for a grant of £7 10s. per annum, made to each of the three Schools. And I trust that, ere long, the Societies will have the satisfaction of learning that their grants have been laid out to good purpose."

With regard to the School at Pine River, in the Mission of Valcartier, it is stated that it had suffered some interruption in the course of its operations during the autumn, but that it was re-opened on the 1st November, and has been regularly attended by 24 children. In addition to the usual branches of instruction, " the Church Catechism is taught on every Friday evening, and Scripture lessons are given on Mondays, Wednesdays, and Thursdays." In a letter to the Rev. E. C. Parkin, the Incumbent, the Teacher states

that it is his intention to open, on the first Monday of the new year, an adult evening class, which promises to be well attended.

While referring to the subject of Education, it affords the Central Board much gratification to be enabled to state, that a communication has been received by them from the Principal of Bishop's College, inviting their co-operation in a proposed plan for the admission of the Sons of the Clergy, officiating in this Diocese, at a rate reduced considerably below the ordinary scale of charges, into the Grammar School recently opened at Lennoxville: an Institution established under circumstances which, they are led to believe, are highly favorable, and afford a promise of extended usefulness.

The substance of this communication has received the most serious consideration of your Board: convinced as they are, that there is scarcely a privation which presses more heavily upon the Clergy in this country, than that (which is so lamentably common), of being unable, through deficiency of means, to afford their children an education suitable to the position, which they may naturally expect to occupy in after life.

## GRATUITIES

A gratuity of £10 (for 1856) has, as in previous years, been paid to such Clergymen as, under the resolution of the Board, became entitled to it; and a similar gratuity for the present year is now in process of payment on the same conditions. But it is to be regretted that, in several Missions, the Congregations have not met in a liberal spirit the desire of the Board to aid them in increasing the scanty incomes of their Clergymen; inasmuch as, instead of providing the sum of £10, stipulated for *in addition* to all other just demands upon them, they have made the necessity of so doing an excuse for diminishing, and in some instances altogether withholding, their contributions towards that Parent Society, whose cause should be looked upon as their own.

If, therefore, the gratuity is to be continued, it is evident that there exists an absolute necessity for such a modification of the conditions on which it is granted, as will insure a compliance with the spirit, as well as the letter, of the intentions, which gave rise to this effort on the part of the Board to place the rural Clergy upon a somewhat improved footing in respect of income.

## DEPOSITORY.

During the twelve months ending December 31st, 1857, the Sales at the Depository have amounted to the sum of £37 7s. 1½d. Among the Books sold have been, Bibles, 47; New Testaments, 25; and Books of Common Prayer, 100.

New Testaments, 6; Books of Common Prayer, 55; and Tracts to amount of £15 3s.

The Committee have also granted to various Clergymen in the rural districts, for sale at ordinary, or reduced rates, the following: Bibles, 48; Books of Common Prayer, 55.

A large, and valuable, assortment of Books has, as usual, been received from the Society for Promoting Christian Knowledge. But your Board are still obliged reluctantly to report that the Institution languishes: and to express their regret that such continued apathy respecting it should be found to exist among the country Missions; notwithstanding that, (as stated in last year's Report) it is the Country Missions that share beyond comparison most largely in the benefits which it affords. The Institution is, in fact, sustained by the City of Quebec alone.

Your Board may here be permitted to mention that they have purchased, and received from England, a large number of copies of a publication entitled, "The duty of giving away a stated proportion of our Income;" which they propose transmitting to the several Clergymen, for distribution in the various Parishes and Missions of the Diocese. They have adopted this course in the hope that the members of the Church, weighing well and honestly the convincing arguments put forward in that little work, may, by God's grace, be led to take a wider and more Christian view of the obligations and responsibilities attaching to their condition here below; may, by the same, power be enabled to prove themselves faithful and just stewards of the things committed to their charge; and may know it to be, not their duty only, but their high privilege, to be permitted of the Lord to "honour him with their substance, and with the first-fruits of all their increase!"

# ST. FRANCIS DISTRICT ASSOCIATION.

The St. Francis District Association held its Annual Meeting, being its fourteenth Anniversary, at Sherbrooke, on Tuesday, September 29th. The meeting was attended by the Secretary of the Church Society. The chair was taken by the Rev. Dr. Nicolls, Principal of Bishop's College, Lennoxville, who opened the proceedings by an interesting and very appropriate introductory address. Addresses were also delivered by the Rev. Professor Thompson, Rev. J. Kemp, Rev. A. Balfour, Rev. A. A. Allen, R. W. Heneker, Esq., Agent B. and A. Land Company, R. D. Morkill, Esq., Treasurer of the District Association, Jas. Jones, Esq., Student, Bishop's College, and the Rev. Dr. Percy, Secretary of the Church Society.

The Missionary at Sherbrooke, Rev. C. P. Reid, in a communication to the Secretary of the Church Society thus writes:—

“ From this Mission there is but little more to report than the ordinary routine of parish work. You will, however, I am sure, be happy to observe that, notwithstanding the very large amount that has, during the past year, been contributed in this Parish for local objects, the subscription list for the Church Society shews a small increase.

“ The debt which has hitherto been on our Burial-ground, and which had through the accumulation of interest, notwithstanding payments made from time to time, as parish funds admitted, increased to up-

wards of £60, has during this past year been paid off in full, by a special subscription. To the Burial-ground a considerable addition has been made through the liberality of the British and American Land Company. The debt also on the Church edifice has been reduced to £30, and will soon be paid in full."

The Rev. A. A. Allen, Missionary in charge of Compton and Waterville, after mentioning in grateful terms a valuable gift presented to him by the Compton Congregation proceeds to say:—

"In consequence of our many local wants, together with the payment of the Clergyman's salary, and the further demands upon the congregation, necessary to secure the gratuity to their Minister, I have not the courage to start any direct contribution to the Church Society. Let it, however, be borne in mind that the people pay their Clergyman's salary with a perseverance and regularity before unknown in this quarter: then some allowance may be made for the non-appearance of a long list of subscribers in the Society's Report.

"Of Waterville Congregation I have little or nothing to say. There, as here, the collections go towards liquidating debts, &c. Nothing is given towards the Clergyman's support."

The Rev. Professor Thompson, Officiating Minister of St. George's, Lennoxville, has forwarded the following Report:—

"I have not, as yet, been able fully to call in the subscriptions of our people in Lennoxville. The amount already paid, or promised, a little exceeds £20. The total will probably reach £23 or £24: being somewhat in advance of last year. The best spirit in co-operating with the Society has been shewn; and very few instances occurred of members of the Church declining to subscribe to its funds."

The Missionary at Eaton, Rev. J. Dalziel, thus writes :—

“ In the good providence of God I am still enabled  
“ to labour in the good cause, in the ordinary appointed  
“ way ; endeavouring, although in much weakness, to  
“ sow the precious seed of the glorious Gospel of  
“ Christ.” \* \* \* \* \* “ In my own case,  
“ while there is much to discourage, there is also much  
“ to encourage, as it regards the influence of the Gospel  
“ on the place generally. And although there are not so  
“ many fruits of ministerial usefulness as I could wish  
“ to see ; yet, there are as many as could be reasonably  
“ expected, from the peculiar circumstances of the  
“ Mission. We have good congregations, and also  
“ much attention to a preached Gospel.”

From the Rev. J. Kemp, Missionary at Bury, the following Report has been received:—

“ I regret that I cannot say much of a very encouraging character, as to the deep hold that the Church Society has taken in the minds of the people. Although the services of the Church are fairly attended, (that is, the congregations are not less than usual), and the people generally attentive and devout during the celebration of Divine Service, yet when it comes to giving, and especially giving to the Church Society, there is a sad want of the practically carrying out of one of the most important principles of the Gospel, namely, the solemn obligation on the part of those who hear the Word, to give of their worldly substance for the purpose of either directly, or indirectly, sustaining those who minister in holy things. There seems to be a sort of feeling, that when they have been tolerably regular in their attendance upon the services of the Church, they have done pretty much all that is required of them : and as for giving any thing, or at most but the merest trifle, it is altogether out of the question. And it is to be feared that things

"will not materially improve in this respect, so long as  
 "they can have the services of the Church, whether  
 "they give or not."

After enumerating the various Sunday services held  
 in the Mission, viz:—at the village of Robinson every  
 Sunday morning, at St. Thomas Church, on the Vic-  
 toria Road, once a fortnight, at St. John's Church, on  
 the Dudswell Road, once a month, and at Lingwick,  
 and another station, also monthly, Mr. Kemp proceeds  
 to say:—

"Mr. W. R. Best, the Master of the Colonial Church  
 "and School Society's School at Bury, has been  
 "licensed as a Catechist and Lay-Reader: who, with  
 "Mr. J. Martin, has rendered good service in supply-  
 "ing my place, when at Lingwick, and holding  
 "service occasionally at one or other of the outer  
 "Churches.

"Another service or two which I have held, will be  
 "regarded doubtless with some special attention. A  
 "number of Norwegian settlers have come in this sum-  
 "mer, who were temporarily located near the village.  
 "I called upon them; and invited them to a special  
 "service, in which I endeavoured to shew them the  
 "interest I felt in their spiritual welfare, and that I  
 "wished to do them good. I found that the Epistles  
 "and Gospels for the several Sundays in the year were  
 "the same as our own. And from this I endeavored  
 "to shew them the similarity of the two Churches in  
 "all essential points: which seemed to give them much  
 "pleasure. I have endeavoured to pick up a little of  
 "the Norsque language: at least sufficient to enable  
 "me to read the Lord's Prayer, the Collect, Epistle,  
 "and Gospel, in their own tongue: which appeared to  
 "afford them much gratification. Mr. Tambs, a native  
 "Norwegian, who speaks good English, acted as inter-  
 "preter of my address. I have only been able to hold  
 "two of these services: and I do not know whether I

" can continue them; as the people are now scattered,  
 " and located on lands several miles apart from each  
 " other. More are expected next year, when I hope to  
 " form a Mission to them."

The Rev. T. S. Chapman, Missionary at Dudswell, after referring to various difficulties in the way of raising contributions in aid of the Society, writes to the Secretary as follows:—

" I am still diligently, in person, circulating the Society's Subscription List, and urging its claims to the utmost of my ability."

From the Rev. W. L. Thompson, recently appointed to the Mission of Stanstead, the Secretary has received a communication, from which the following is an extract:—

" You are aware that Stanstead is a new Mission; not more than six months established: and consequently cannot be expected to be, as yet, in good working condition. The average congregation, when I came the Mission, was about 20. Now, thank God, it is 120. These, of course, are not all to be looked upon as Church people; but we hope may eventually become so.

" The Congregation contribute a considerable portion towards my salary, and the entire amount of our present Church expenditure. In consequence of our increased numbers, and the discomfort we experience in the 'upper room,' that we now occupy as our place of worship, earnest efforts have been made for the erection of a Church.

" Nor have these efforts been in vain. A site for the proposed edifice has been purchased, the foundation sunk, and a considerable quantity of stone drawn to the spot, ready for commencing operations in the spring. The building will be of stone: and it is estimated that, when completed, it will cost £550. Of this sum £300 have been subscribed by the people

 " beautiful Church Service. All circumstances, indeed,  
 " considered, I have faith to believe that in a few years  
 " there will be a large congregation of Episcopalians in  
 " Stanstead. There is in this locality, and in the neigh-  
 " bourhood around, a mass of mind, as yet unformed in  
 " spiritual matters, that I have good reason to hope  
 " may be moulded so as to become conformed to our  
 " Scriptural Church."

#### MEGANTIC DISTRICT ASSOCIATION.

The annual meeting of the Megantic District Association was held at Pointe Levi on Thursday, January 22nd. The chair was taken by the Rev. W. King, of St. Sylvester, Chairman of the District. The Report having been read by the Rev. C. P. Emery, of New Ireland, Secretary of the Association, the meeting, which was tolerably well attended, was addressed by the Rev. Messrs. Mountain, Robertson, Roe, Jones, Plees, Carry, and the Secretary of the Church Society: and by Messrs. Sample, Amiraux, and Chapman.

The Rev. J. H. Jenkins, of Frampton, has addressed a communication to the Secretary; from which the following is an extract:—

" Your visit last winter, and the stirring addresses  
 " made by yourself and the other members, lay and  
 " clerical, who took part in the proceedings, did much  
 " to create an interest in the work of the Society, and  
 " to stir us all up to greater activity in the good cause.

" Our list of subscribers is, as you see, nearly four times  
 " as large as it was last year. But there is still ample  
 " room for improvement. And I hope that, before very  
 " long, every head of a family in the Mission will be  
 " enlisted in the cause of the Church Society."

The Rev. Mr. Ross, of Rivière-du-Loup, en bas expresses his grateful feelings for two donations, received by him: one from the summer visitors to Cacouna, and the other from the Protestant residents at Grande Baie, District of Saguenay; the former amounting to £21 15s., and the latter to £4 2s. 6d.

He reports that an excellent melodeon was presented last summer by Miss Mountain, Miss Walker, and other ladies, to the Church at Rivière-du-Loup. For which he states that the congregation are very thankful, and desire that their grateful acknowledgments should find a place in the Society's Report.

The Rev. Mr. Emery, of New Ireland, writes thus in a communication to the Secretary:—

" I am happy to inform you that the amount, (including collections after Sermons), raised in behalf  
 " of the Society, somewhat exceeds £17 this year;  
 " being more than double the amount contributed last  
 " year. \* \* \* \* \*

" During the past year I have presented to the Bishop  
 " for confirmation 59 persons, varying in age from 14  
 " to 53 years. Of these I am happy to state that 50  
 " have become communicants.

" With respect to the subscriptions for the Clergy-  
 " man's stipend, I suppose you have been duly informed  
 " by the Church-wardens. I need not, therefore, enter  
 " upon a statement of the dilatory and unsatisfactory  
 " manner in which the people pay in their subscrip-  
 " tions for this purpose. I shall only add their excuse:

From Leeds, after reference to other matters, the Rev. R. Short thus writes:—

“The contributions of the people are small; and generally in kind, rated at high prices. From the congregation at Lambie’s Mills, although I am obliged to keep a horse for their service, I have received for the present year only five dollars and a half. I may lastly remark that I pay a Lay-reader five shillings for each service he performs, when the state of my impaired health forbids personal attendance.”

The Rev. W. M. Ross, of Drummondville, in a letter addressed to the Secretary of the Society, thus expresses himself with reference to his Mission:—

“The smallness of the amount remitted (£5 16s 6d.) is a cause for regret; more especially since I had encouraged a hope that the collections for the current year would have exhibited a marked increase. The failure of our expectations necessarily forces back upon us the reflection that the present is essentially ‘a day of small things.’

“ With respect to Lower Durham, but little can be  
 “ said. The people, (some few attached members ex-  
 “ cepted) exhibit a very mediocre appreciation of  
 “ Church privileges, and they are content to dwell in  
 “ ‘ ceiled houses,’ while the house of God remains in an  
 “ unfinished state. I hope to form a Parochial Asso-  
 “ ciation in this part of my Mission, (as likewise in  
 “ Drummondville) so soon as the progress of our local  
 “ enterprise will allow of it; and thereby excite the  
 “ people to greater earnestness and zeal in the cause of  
 “ Gospel truth. At present they contribute nothing,  
 “ in money or kind, either to the funds of the Society,  
 “ or to the Clergyman’s stipend.

“ Let us hope that the time may soon arrive, when  
 “ these, and other lukewarm members of our Zion, will  
 “ be led to recognize the many claims of the Diocesan  
 “ Church Society upon their countenance and support;  
 “ and may be led in consequence, to give freely of their  
 “ substance, as they ‘ have freely received.’ ”

From Rivière-du-Loup, en haut, the Rev. W. C.  
 Merrick thus writes :—

“ During the last year we have succeeded in erecting  
 “ a very neat steeple on the Church at Rivière-du-Loup :  
 “ which will have the effect of adding more of an eccle-  
 “ siastical appearance to the little Church ; a characte-  
 “ ristic which deserves especial attention, when our  
 “ places of worship are situated in the midst of the  
 “ French population of the Province.

“ The congregation gratefully acknowledges a grant  
 “ of £20 from the S. P. C. K., through the Lord Bishop;  
 “ which proved a very efficient aid in carrying out the  
 “ work.

“ The Hunter’s-town Lumbering Company are about  
 “ to erect extensive saw-mills near the village of Ri-  
 “ vière-du-Loup : a circumstance which offers the pros-  
 “ pect of an early accession to the very small number  
 “ of Protestants at present in the Mission. And a hope

"is in consequence entertained, that the important objects contemplated by the Church Society, will meet an increased attention and support."

The Rev. F. A. Smith, of Three Rivers, after expressing his regret at a falling off, resulting from various causes, in the subscription list, proceeds to say:—

"Through the indefatigable and praise-worthy exertions of one of the ladies of the congregation, our Church has been supplied with an excellent Organ. The ladies have also established a Sewing Society: by means of which they have already realized about £150, as the commencement of an Endowment Fund for the Church at Three Rivers. This amount, I believe, they intend intrusting to the care of the Church Society, in the hope that it may be managed to the best advantage."

"It is with great satisfaction that I am enabled to inform you that my people have hitherto faithfully and ungrudgingly fulfilled the condition required of them by the Lord Bishop on my appointment to this charge, by levying annually the sum of £25 towards the maintenance of the Incumbent."

"Together with this satisfactory proof of appreciation of Church privileges, it is with much thankfulness that I feel myself able to add others of higher

"import—the decrease of open immorality; the more  
 "religious observance of the Lord's Day; the larger,  
 "more regular, and more devout attendance on the  
 "public means of grace—especially at the celebration  
 "of the Holy Communion. At Stoneham, out of  
 "seventeen families, members of the Church, fifty were  
 "permitted to communicate at Easter. And at the  
 "Confirmation held by the Bishop in the month of  
 "March last, thirty candidates were admitted to that  
 "holy rite: all of whom have since communicated;  
 "and many of them with unfailing punctuality, and  
 "apparent devotion."

The Rev. E. C. Parkin, in reference to the new Church in process of erection in his Mission, thus writes:—

"Our neat Gothic Church, after the model kindly  
 "provided for me by the Bishop of Fredericton, has  
 "progressed favorably: and would have been roofed  
 "in, had the mason fulfilled his contract, by complet-  
 "ing the stone-work in time. The erection of such an  
 "edifice has been a great undertaking for Valcartier.  
 "Yet notwithstanding the constant call upon my people

## MEETINGS

ATTENDED BY THE SECRETARY OF THE SOCIETY.

January 22nd.—The Secretary attended the Annual Meeting of the Megantic District Association, held at Pointe Levi. The chair was taken, after the celebration of Divine Service, by the Rev. W. King, of St. Sylvester, Chairman of the District: who having opened the proceedings at considerable length, by an able and lucid exposition of the important objects of the meeting, afterwards called upon the Rev. C. P. Emery, District Secretary, to read the Report. Upon the conclusion of which, the meeting, which proved one of no ordinary interest, was addressed by several speakers, clerical and lay.

March 10th.—The Secretary proceeded by appointment to St. Gilos: where he found a goodly number assembled. After Divine Service, (which was celebrated previous to every meeting) a meeting of a highly interesting description was held.

In the afternoon a meeting, well attended, was held at St. Sylvester.

March 11th.—A meeting was held at Leeds. Some error had occurred with regard to this appointment: in consequence of which there was but a thin attendance.

March 12th.—Proceeded to the Church at Inverness. But few present: from same cause as at Leeds.

March 13th.—Meeting at New Ireland. A large attendance. And many fair promises of greater exertions in the Church's cause were made.

March 25th.—The Secretary left Quebec, accompanied by the Rev. A. J. Woolrich, for Frampton West: where they were hospitably received by Mr. Ross.

On the following day a meeting was held in the Church: the Lord Bishop, (who was on a tour of confirmation, accompanied by his Chaplain, the Rev. A. W. Mountair), took the chair.—Meeting well attended

—and Addresses were delivered by Rev. J. Carry, Rev. A. W. Mountain, Rev. J. H. Jenkins, and the Secretary.

In the afternoon a meeting was held in the Church of Frampton East. This meeting, although a mistake had occurred with regard to the hour at which it was to be held, was also very well attended. The chair was taken by the Rev. J. H. Jenkins, the Bishop having been obliged to return to Quebec immediately after the meeting at West Frampton.

The speakers on this occasion were ably reinforced by the Rev. A. J. Woolrich, of Stoneham, and Wm. Henderson, Esq. of Frampton. At the hospitable mansion of which latter gentleman the Secretary and his travelling companion were most cordially and kindly entertained.

At each of these meetings a considerable amount of interest in the Church's cause appeared to be experienced on the part of the people. And that it was no mere passing, impulsive feeling, easily lighted up, and as easily extinguished, seems in some measure to be established by the fact, that the subscription lists for 1857 very largely exceed those for the preceding year.

Sept. 29.—The Annual Meeting of the St. Francis District Association, held at Sherbrooke, was attended by the Secretary of the Society, as already mentioned in a previous portion of the Report.

#### STATED MEETING, NOVEMBER 11TH.

Secretary reported that in pursuance of Resolution of Board (September 9th) he had given instructions for preparation of Deed for transfer of Glebe lot in Upper Ireland. But that certain difficulties had arisen, which would probably retard for a time the accomplishment of the object.

Treasurer of Clergy Trust Fund reported that he had visited Montreal, and received from T. B. Anderson, Esq., all monies, &c., belonging to Quebec Bishopric Endowment Fund.

The Report of the Finance Committee having been presented, the following grants were made:—

£10, towards completion of Church at Upper Durham; provided Article IX. of By-laws, having reference to annual Sermons, has been complied with.

An addition made to Salary of Rev. J. Carry, of Pointe Levi, for six months from October 1st, 1857, at the rate of £50 Sterling per annum.

Secretary directed to inform Church-wardens of Pointe Levi and New Liverpool that the Board will make no further grant towards the maintenance of the Mission, until it is made to appear that the Congregations have contributed as much as can reasonably be expected.

£5, to School at Standon, Mission of Frampton.

£20, towards Outfit for Travelling Missionary.

A communication from the Principal of Bishop's College, Lennoxville, relative to proposed admission of sons of Clergymen, at reduced rate, into Grammar School in connexion with College, having been read, it was

Resolved: That the Society do contribute a sum of £10 annually towards the expenses of the Board and Tuition of every Clergyman's son admitted at the reduced rate: provided, (as suggested by Dr. Nicolls), that the number of pupils so admitted do not exceed one-fourth of the whole number of resident Scholars; and that it be understood that the words, "one-fourth," refer to the whole number of pupils admitted from this Diocese.

The standing annual grant for Missionary purposes was increased by sum of £10, in order that Salary of Travelling Missionary might be raised to amount of £150 per annum.

Rev. Mr. Roe and Mr. Scott, with the Secretary, were appointed to arrange for transmitting to the several parishes and missions copies of pamphlet, "The duty of giving away stated proportion of Income."

Rev. Mr. Mountain, Mr. Scott, and Mr. Andrew, appointed as a Committee to assist the Secretary in drawing up Annual Report.

Or,

For and towards the encouragement of education, and the support of Day Schools and Sunday Schools in the said Diocese of Quebec, in conformity with the principles of the United Church of England and Ireland.

Or,

For and towards a Fund for assisting persons preparing for the Ministry of the Gospel in the United Church of England and Ireland within the said Diocese of Quebec.

Or,

For and towards a Fund for circulating, in the said Diocese of Quebec, the Holy Scriptures, the Book of Common Prayer of the United Church of England and Ireland, and the Books and Tracts approved by the said Church Society for circulation within the said Diocese of Quebec.

Or,

As an aid towards the erection, endowment, and maintenance of Churches according to the establishment of the United Church of England and Ireland within the Diocese of Quebec,—the erection and maintenance of Parsonage House,—the setting apart of Burial grounds and Churchyards, and the endowment and support of Parsonages and Rectories, according to the said Establishment within the said Diocese.

### III. *A Devise of Real Estate for the general purposes of the Society.*

I give and devise unto the "Church Society of the Diocese of Quebec," incorporated by a Statute of the Province of Canada, passed in the seventh year of the Reign of Her Majesty QUEEN VICTORIA, all and singular, &c. (Describe the Real Estate clearly.) To have and to hold the said, &c., unto the said Church Society of the Diocese of Quebec, and their successors, for ever; upon trust to hold and apply the same, and the rents, issues and profits thereof to and for the uses and purposes of the said Church Society, as specified in the said Act of Incorporation, and none other, and under the provisions of the aforesaid Act of Incorporation of the said Church Society.
