HOLLENBERG'S ROACH

THEIR STORES IN COULT
The Evidence in the Ponton Case Yesterday At
Cobourg Was Hard Against the Prisoner.

Holden Repeated His Former Evidence, and Roach Gave a Recital
Which Was Precisely in the Same Line--The Court Was
Crowded and the Interest Intense.

Cobourg, Sept. 20.—(Special.)—"Surprise" was written all over today's proceedings when John T. Roach was called by the Crown. Everyone was significantly turned into a question mark. The defence did not expect anything, for W. G. Wilson, counsel for Roach for the past two months, said Roach had continually protested his innocence, but Lawyer Preston of Napawa had a card up his sleeve all morning, and suggestion of this nature was communicated to the World when Mr. Preston said he had been chosen by Roach as his counsel. No doubt the argument that prevailed with Roach was that Mackie had stood and as a result got ten years. The evidence was as strong against Roach as against Mackie. What better result could Roach expect? Hence Roach became a Crown witness out and out, qualified to receive the usual clemency in such cases. No one would be surprised if he got off altogether. It is true that immediately after this trial he will be indicted in Cobourg. The case will soon be disposed of.

Still Another Surprise.
There was still another surprise when the Crown told the defence that it did not intend to call Pare as a witness. The defence claim this action is a sign of weakness on the part of the Crown, for the defence claim to have found twenty-five separate and distinct contradictions in Pare's evidence. The defence claim Pare is not called because these contradictions would destroy the strength, if there was any strength, of his testimony. On the other hand, the Crown thinks the wind has been taken out of the sails of the defence, for not a little of the evidence to be put in by the latter was to refute Pare's story. It was evident from Mr. Pare's testimony that the examination of Holden and Roach that he was paying the way to a sweeping charge of contradiction to all three star Crown witnesses. The withdrawal of Pare very considerably shortens the duration of the trial.

Holden's Story.
The Crown's case will be closed to-morrow at noon. The chief evidence to be produced will be concerning Pare's finances at the time of the robbery. Holden in his evidence this morning said that Ponton had told him in August that he had short in his cash \$100 for about a week, and thought it might be better to-morrow morning the specification book of the bank will be put in to show that this was correct. The question arises, How could Holden know such a piece of inner bank history if someone else had not told him, and of course everyone knows where the signboard of the Crown points.

Ponton's Financial Condition.
The Crown bases much of its case upon the financial condition of Ponton at the time of the robbery. It is claimed he had \$10 in urgent debt at that time and had no visible means of meeting his liabilities. This is considered a very unsatisfactory statement to say the least. The statement that he received his O. I. without the consent of the inspector, and in fact, against his express order, is claimed as another straw blowing the same way.

The matter of the musty bills also comes to-morrow morning. Money deposited by Mrs. Wray of Napawa will be traced to Miss "Bonnie" Hunter, and thence to Hope McGinnis of Belleville. It is said these bills have been traced from Montreal, from Hastings and, from Brighton, to all comes back to Hope McGinnis. The inference is that McGinnis was a friend of Ponton and so on in the usual Crown custom.

Mackie Has Changed.
It is a fact that Mackie has changed considerably in his views since the last trial. From a reliable source The World was informed that Mackie had made overtures to the Crown in the hope that he might be allowed to become a Crown witness and reap what benefit would possibly occur. The reason that would prevail with the Crown against accepting such overtures is that Mackie has already on oath made a statement denying complicity in the robbery. For him to renege this statement would be to stultify him, and in no way increase the dignity of the Crown's case. In spite of this it would not be a surprise, and would certainly be in line with the Crown's action to-day if Mackie were put upon the stand to-morrow morning. The defence would not say to-night that they intend to call Mackie. Nor will they deny it. On the other side the Crown, asked point blank, refused to make a statement. The night closed with the query, Will Mackie confess even as did Roach? The case of the defence will not be finished before Friday night. It is the intention of the counsel to present only witnesses whose respectability and reliability were above parley.

This is not the reason when the umbrella man, who once figured in the case, will appear. Nor will Shap Baldwin have a chance to win the court with her snuff. Billy Ponton will be put in the box in his own defence, and certainly if a handsome, clear, red, vigorous boy, looking the picture of innocence, should be able to "take good" testimony Billy is the boy.

Speculation a Rife.
Speculation as to the verdict the jury will bring in may be premature, but it is rife. A disagreement, if not an acquittal, is spoken of. In case of that it is likely the case will never come up again, for the Government is in no humor to have a new trial, having already spent an enormous amount of money. A peculiar incident oc-

THE ASSISTING OF IMMIGRANTS

Demanded by the Workingmen as Represented by the Trades Congress.

REGARDING UNION LABEL

No Effort Made to Enforce the Law Therein.

THE CONGRESS DEMANDED LEGISLATION

Denounced as Being in the Interests of the Capitalists, Who Want Cheap Labor.

THE CROWN OPENED.

Holden's Evidence Was the Feature of the Morning Sitting--Interest Growing.

Cobourg, Sept. 20.—The second day of the Ponton trial opened cool, cloudy and depressing. Additional strangers are in town and one can recognize the steadily growing interest in the case.

The prisoner William Mackie was brought from Kingston penitentiary to-day to give evidence for Ponton, and Holden was brought down to the court house from the jail here.

The cross-examination of Mr. Baines elicited nothing significant. He said that in May, before the burglary, he was warned that an attempt was made to rob the bank, but the men who came to do it got drunk and separated.

A number of witnesses were called who swore that they saw Pare, Holden, Roach and Mackie together about Napawa, the three former as tramps.

William Burke, inspector of police, Boston, Mass., swore that he arrested Holden there and rescued the unsmiled bills shown in court yesterday. Mrs. Holden was putting them into the fire.

Holden's Evidence.
The first real sensation of the trial occurred when the prisoner William Henry Holden was called by the Crown. Mr. Oeler told him that he was at liberty to give evidence, but was not bound to do so. No one to look at Holden would imagine him to be a professional burglar.

He looks more like a prosperous business man. He is of stout build, a man of full habit, wearing a full iron grey beard. He stood erect in the witness box, leaning his arm upon the rail and emphasizing his evidence with right hand gestures. He spoke slowly to the point, using no unnecessary language, his story holding the undivided attention of the crowd. He recounted minutely the story he told at the former trial, and which was then printed. His evidence directly involved Ponton with himself, Roach and Mackie. He described the various efforts made to get at the money.

A Dog Frightened Him.
One time they were frightened out of the bank by the yelping of a dog below. The dog was returned for a council meeting, and returned in an ordinary way, and that quieted the dog, which was unused to the stealthy movements of midnight marauders. In order to get the combination it was decided by the conspirators to attack the letter-keeper and compel him to yield the figures. This was not done, because too many were about. Then they tried to get up a fictitious appointment with young ladies, and also a bicycle ride, when the letter-keeper was to be gagged and bound. But these schemes failed, and then Holden said he was going out of it.

Must Be a Professional Job.
The men agreed that "the job" must be done as if by burglars. After several futile attempts the party became discouraged, and Ponton said: "I'm in it, and I'm in it to stay."

Holden next told how Pare came into the case; then an attempt was made to blackmail Ponton, and Holden objected. The making of an impression of the key by Ponton, the appearance of Ponton's room, and the final successful attack upon the bank and safe were described by the witness.

Coming to the day of the successful robbery Holden described how he himself, Pare and Mackie did it. Wednesday night Ponton told them there was \$17,000 in the bank, Thursday night \$18,000, and they wanted more, and found it Friday night. The three met in Ponton's room at 9:30 with Ponton present. At midnight they began work, and how it was done was dramatically described by Holden. Pare opened the safe, pulled out the money, packed it in a bag, and then shut and locked the safe; all this time Ponton was in his own room and Mackie was sent outside, connected with his pals by a string, so that he could give notice of danger. The money was taken to Ponton's room, Holden keeping \$2000 in his pocket.

Division of the Spoil.
The most fascinating part of Holden's story was his account of the division of the money in Ponton's room. He said the one bundle of \$5000 was given to Ponton; he was to have that no matter how much was taken. Ponton counted the rest and said: "It is more than I thought." Four piles were made. Each one contributed \$1000 for "Whale" Mackie, and enough to pay John Mackie for board. Ponton also got \$125 in a small package and had \$2000 in unguessed notes. The room was thoroughly "cleaned up." Holden even chewing bits of paper to destroy them. Ponton, looking at his bundle said: "I think I'll keep that."

"Go and Plant It."
"Don't have it on you; go and plant it," said Holden. The latter took it and hurried out.

DROWN WILL NOT BE THOUGHT NAPPING

There is Outward Calm in England But Military Are Working Hard.

ACTIVITY AT WOOLWICH

Lord Wolsley, Sir Evelyn Wood and Mr. Chamberlain in Conclave at War Office.

NEWS MUST NOT BE GIVEN OUT

Kruger Will Recede No Further--Waiting Free State's Move--Harcourt Denounces Both.

London, Sept. 20.—Despite all outward show of calm, Great Britain is in practically the same condition as was the United States a few weeks before the opening of the war with Spain. Beneath the crust of diplomatic reserve the military officials are working night and day, preparing for the signs which begin hostilities, whether that comes or not.

Will Not Be Caught Napping.
England is not going to be caught napping any more than the Transvaal. While Lord Salisbury is only at home in Hatfield House, Mr. Chamberlain is buried in work at the Colonial Office, and double forces at the Royal Arsenal and dockyards are straining every nerve to equip and transport troops to the Cape. Many have set down for certain that Great Britain will do nothing to precipitate matters, and the Colonial office is far from admitting that the case is hopeless.

The report that Great Britain has demanded the dismantlement of the forts at Johannesburg, and the Cape, is a very real indication in the opinion of the Burgers, the Colonial office to-day would not be contented to let the Transvaal do as it pleased, although it is much desired.

War Department Working Hard.
Meanwhile the Marquis of Lansdowne, Secretary of State for War, who returned this morning from Johannesburg, has had long conferences with Gen. Lord Uxbridge Worsley, held marches with Gen. Lord Evelyn Wood, adjutant general to the forces, and the activity at headquarters is reflected in the contract supply and transport departments.

The structure of the transport department for the expedition to-day with little doubt was witnessed by a large and enthusiastic crowd.

At Woolwich activity increases daily, especially the Ordnance department, where Maxim guns, Lyddite shells, ballou equipment, gas, and other munitions, and the activity at headquarters is reflected in the contract supply and transport departments.

While rumors of the reassembling of Parliament are current, the fact is recalled that in the original war in South Africa, British declared war first and then assembled Parliament. 

WILFUL MURDER CHARGED. The Love with this Country. He Chopped up Furniture.

Thomas Blake of Smith's Falls Will Have to Stand Trial for His Life

BECAUSE OF THE DEATH OF HIS WIFE

The Woman Was Found Dead in the Home of the Couple, the Body Badly Bruised.

Smith's Falls, Ont., Sept. 20.—The adjourned inquest on the body of Ann Blake opened this afternoon before Dr. McCallum, coroner. E. G. Malak, county attorney, was present on behalf of the Crown and Mr. J. P. Barter of Perth, appeared for the prisoner Blake. The evidence went to show that Blake, his wife and Henry McGrath, spent Saturday evening and night in drinking; that the Blake household was usually quiet and peaceful, except when liquor was present, when one of the witnesses described it as "a scene of fighting, and the victor the one who was least intoxicated."

Blake confessed to having given his wife a good pounding on Saturday evening, alleging that she was molesting him with a knife. He confessed to at least three different parties who held out no inducement for him to do so. The jury retired at 9 p.m., to consider their verdict, which they brought in at 11 p.m. They returned a verdict of wilful murder against Blake, who is forthwith arraigned before the magistrate, and committed to Perth to stand his trial.
