TURKEY EXPECTED TO FORM REPUBLIC

Mustapha Kemal Pasha Likely Will Be First President, Is

Report.

Constantinople, Sept. 25.—The ques-tion of the form and name of the new Turkish state, which must be set-tled before Turkey is able to resume full diplomatic relations with the rest of the world is absorbing attention here and in Angora. It is virtually certain that Turkey will be declared a republic, the head of the Government being either a president or a chief of state, as in Poland. The first occupant of the exe-cutive office is expected to be Mus-tapha Kemal Pasha, who in a recent interview said that Turkey was al-ready a republic except in name and constitution, and might soon become even more democratic.





St. John's, Nfid., Sept. 25.—That the tragic death of Margarerite Lindsay, of Montreal, volunteer teacher at Cart-wright, Labrador, public school in Aug. 22, was due either to accident or to suicide, is the conclusion reached by the Newfoundland Department of Justice. Dublin, Sept. 25.—In consequence of representations by the United States customs authorities, who point out that the United States tariff act re-quires imports to be marked in Eng-lish, the Free State Government has notified Irish exporters to cease stamp-ing goods "Deanta in Eirin," and sub-stitute the English equivalent "Made in Ireland."
