





When the Liberals won in 1896 they were in the position of having been in power very little: the public service was largely of Con-servative appointment; the Liberals regarded it with great aversion; and there was much talk of general dis-missals. 


Monthly Report of Secretary Gives an Idea of Vast Amount of Work Done by
