BILL.

An Act to change the period for the annual meetings of Agricultural Societies in Lower Canada, and for other purposes.

WHEREAS the third week in January has been found to be an inconvenient period for the holding of the annual meetings of Agricultural Societies in Lower Canada: Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows : Preamble.

1. All the words after "to such electoral division," in the second paragraph of the eighty-seventh, and so much of the Seventy-ninth section of the "Act respecting the Bureau of Agriculture and Agricultural Societies" forming the thirty-second Chapter of the Consolidated Statutes of Canada, as provides that Agricultural Societies in Lower Canada shall hold their annual meetings in the third week of the month of January in each year, are hereby repealed. Part of Sec. 79 of C.S.O., cap. 32 repealed.

2. The said Societies shall hold their annual meetings at the time and place chosen for the exhibition: and when no exhibition shall take place, the said societies shall hold their annual meetings in the course of the month of November, in each year, in the manner prescribed in the said Act. Annual meeting to be held at the time and place of the Exhibition

3. At such meetings the said Societies may do any thing which by the said Act they are authorized to do at their annual meetings in January. What may be done at such meetings.

4. This Act shall form part of the said Act, which shall henceforth be read and construed as if the annual meetings of the said Societies were therein and thereby required to be held at the time and place chosen for the county exhibition. Act to form part of C.S. C., cap. 32.
