IT IS ORDERED, that the several Fees heretofore demanded and taken, at the Office of the Peace and Police-Office in this City, by the Clerks of the Peace and other Officers of this Court, be from and after, the 21st day of April next, (1830,) wholly discontinued; and, that instead thereof, the following be, and hereby are substituted; and the said Clerks of the Peace, and other Officers aforesaid, are required to conform to the same, and hereafter to demand and receive for the services herein under-mentioned, the following Fees, and none other, respectively, viz:—

EXTRACT from the Register of the GENERAL QUARTER SESSIONS, of the 18th January, 1827.

IT IS THEREUPON ORDERED, “at the suggestion of the Clerks of the Peace,” that henceforth the Clerks of the Peace, to prepare such Information and complaints, and issue such process thereon, as may be required by any Public Officer prosecuting such, for any offence which it may be his duty to bring under the cognizance of any Magistrate or Magistrates in Session or out of Session, without claiming, demanding, levying, or receiving from any such public officer any fee or reward, at any moment preceding the final Judgment on such proceedings, or any of them; and that the Clerks of the Peace do accordingly, henceforth, “await and abide the Judgment in all such cases.”

FOURTH.—In cases cognizable before a Justice of the Peace, in virtue of the Act 47 Geo. III. chap. 9,—commonly called the **Act relating to deserted Seamen, and for punishing those who harbour them.**

It being understood that in cases under this Act, of complaint against Seamen serving under one and the same set of articles, for breach of such articles or neglect of duty, all the Persons (if more than one,) complained of, at any one time, by any Master of a ship or vessel, or owner thereof, or other Person, are to be by the said Clerks of the Peace, included in one and the same deposition, and in one and the same Warrant.

To the Clerks of the Peace, for every such Warrant to apprehend, when the same is prepared by them, 0 2 6

It being understood, as aforesaid, that the Clerks of the Peace are to observe as a rule for their guidance, that all the Seamen, (if more than one,) complained of, at any one time, for any breach of the same articles, are to be included in one and the same Warrant.

For the conviction or acquittal, including the minute or Record thereof, 0 2 6

And if more than one person be convicted, then, to the said Clerks of the Peace, One Shilling for each name additional, specified in the Record of Conviction.

And to such Constable an extra allowance in case of extra trouble, to be taxed as provided by the 10th Section of the said Act, 47 Geo. III. chap. 9.

FIFTH.—In cases cognizable before the Justices of the Peace, against Tavern-Keepers, or against persons keeping houses or places of public entertainment, or retailing or vending Spirituous Liquors without Licence, contrary to the Acts 35 Geo. III. chap. 8, and the *Watch and Night-Light Acts*, (58 Geo. III. ch 2, and 3 Geo. IV. chap. 6,)—and generally in all cases where penalties are imposed by Acts, other than those herein above-mentioned.

To the Clerks of the Peace, the several Fees herein-before specified in the THIRD Article, for the several services therein mentioned, when performed by the said Clerks, and when not performed by them, then to the person performing the same.

That there be allowed to the Crier of this Court, and of the Hebdomadary and Special sittings of the Justices, at the Court-House, as follows, viz:—

On every Indictment, found by the Grand-Jury, 0 1 6
On the return of every original Summons, Plaintiff, or Subpoena, in Court, 0 0 6

The above is not to extend to any case, where the Defendant is in custody under a Warrant, nor to cases arising under the aforesaid Act, 47 Geo. III.


