On motion, the Report from the Grand Scribe E. was received and adopted.

SIXTH ANNUAL CONVOCATION, TORONTO, 1863. 201

The Grand Scribe E. read the rules and regulations for the government of Grand Chapter during the time of public business.

The following resolution to dispense with the reading of the minutes of proceedings of the Grand Chapter at the Annual Convocation, held at the City of London, on the 19th day of February, A.D., 1862, was submitted :

Moved by R. E. Comp. Marcellus Crombie, seconded by E. Comp. Charles D. Macdonnell, and resolved—

That whereas the Proceedings at the last Convocation have been printed, and the same having been forwarded to all the Chapters, the minutes be considered read, and the same be now confirmed.

The M.E.Z. read the following Address to the assembled Companions :

A D D R E S S .

*To the Most Excellent the Grand Chapter of  
Royal Arch Masons of Canada.*

COMPANIONS :

I concluded my last address to Grand Chapter by humbly praying the Great Jehovah to continue to this Province the high state of prosperity vouchsafed unto us, and to pour down upon this Grand Chapter, assembled in His holy name, the continual dew of His blessing, let us now bow in gratitude to the Great Giver of all good that our prayers have been found acceptable at the Throne of Grace, that we are once more permitted to assemble around our sacred altar in peace and harmony, that the prosperity of our Province has not only been continued but greatly enhanced, and that the Royal Craft in Canada is steadily improving.

Once more referring to my last address, it became,—entering upon a retrospect of occurrences of the year then passed,—my first and mournful duty to record the loss the Royal Craft had sustained

by the death of the Prince Consort, and to invite Grand Chapter to pass a humble address of condolence to Her Most Gracious Majesty; accordingly, an address was adopted by Grand Chapter and transmitted in due course. I am sure Grand Chapter will be much pleased to learn that the address was graciously received, as will appear from the following communications:

“SIR,—I have the honor to acknowledge the receipt of an address of condolence to Her Majesty the Queen, adopted by the Grand Chapter of Royal Arch Masons of Canada, and to acquaint you that I have transferred the same to the Secretary of His Excellency the Governor General, with a view to its being forwarded to the Rt. Hon. the Colonial Secretary.

“SIR,—I am directed by the Governor General to inform you that the Duke of Newcastle has laid before the Queen the address from the Royal Arch Masons of Canada, expressive of condolence with Her Majesty under Her recent bereavement, and has requested His Excellency to inform them that their sympathy was fully appreciated by Her Majesty.

Companions, it has pleased the Great Disposer of all things to temper the wind to the shorn lamb and to gladden the heart of our widowed Queen by the union of her eldest son, the heir apparent to the Crown, Albert Edward, Prince of Wales, to the beautiful,

the accomplished, the beloved Princess Alexandra—a match, not of diplomacy, but founded upon that most sure foundation of conjugal happiness, mutual love and esteem. Companions, let us again humbly approach the foot of the throne and assure our Queen that we are partakers of her joys as well as of her sorrows.

During the recess, the most amicable relations have continued to exist between the Supreme Grand Chapter of Canada and all Grand Chapters in correspondence with us. The threatened difficulty with the Grand Chapter of England with respect to a Warrant issued for a Chapter at the City of Ottawa, is seemingly disposed of, as I have not been advised of the working of any such Chapter.

The Reports of the Right Excellent the Grand Superintendents of the several Districts will afford further information concerning the working of our subordinate Chapters, and the review of Foreign Correspondence, kindly prepared by the R. Excellent the Grand J. Companion Curtis, will inform Grand Chapter of the position of the Royal Craft abroad.

On the first day of June, I granted a Dispensation for a new—“Tecumseh,” Chapter, at Stratford—which will be submitted to Grand Chapter for confirmation by Warrant.

The various resolutions adopted last meeting for the relief of our financial position have born good fruit, as will appear from the Treasurer’s report. Although, as yet this Grand Body cannot boast of a spare fund, it is at least satisfactory to know that the liabilities incurred in the formation of Grand Chapter and all current expenses, excepted only salary to Grand Scribe E., have been now liquidated.

The only notice of motion before this Council is by R. E. Companion Simpson,—as follows :

“When the Grand Lodge or any competent authority in the Craft shall suspend or expel any brother who is a Royal Arch Mason, the M.E.Z. shall immediately, on such suspension or expulsion being communicated to him by the Grand Lodge, direct the Grand Scribe E. to notify the subordinate Chapters of the suspension or expulsion, as the case may be, of the said Companion from his Arch Masonic functions.

I would recommend to grand Chapter the revision of the Constitution, aside of numerous alterations which seem to me imperative, and which I am prepared to submit to any Committee Grand Chapter may appoint to act in the premises. It must strike every Royal Arch Mason that the present Constitution is meagre in the extreme, and ought to contain a complete code of laws for the government of the Royal Craft in Canada, altogether distinct from the Constitution of Free and Accepted Masons, who, from time to time, make important amendments in their laws, wherein Grand Chapter cannot have a voice.

I am much pleased to find that subordinate Chapters continue to see the necessity of legislating by By-law. The code of the "Mount Moriah" Chapter, at St. Catharines, has been submitted for approval, and a copy thereof submitted to me. It does, indeed, much credit to the compilers, and is, besides, most tastefully got up. I have requested the Excellent Z. of the Chapter to lay a copy thereof before this Grand Chapter.

I am happy to say that my remarks at the last meeting of this Council anticipated the action of our Companions in the States, who, I have been assured, have made every effort to bring the differences between North and South to a satisfactory termination; that their efforts, under Providence, may be soon crowned with success is, I doubt not, the earnest wish of all Companions in Canada.

Much may be said, and is often expected to be said, in the annual address of the Head of the Craft to instruct Companions in the beauties of the Order. I hold, however, that such instruction appertains to private Chapters, and that the annual address of the Grand Z. should be a simple retrospect of occurrences during the recess, and information on all matters requiring the action of the Grand Body. It is then a source of congratulation that my address must of necessity be short. The occurrences of the recess just past may be wound up in the few words—"Peace and prosperity reigned within our sanctuaries;" and as to the future, the harmony of subordinate Chapters seems so complete as to call for but little legislation.

Grateful to the Grand Superintendents, the Officers of Grand Chapter, and the Grand Scribe E. in particular, for valuable assistance rendered to me, and to the Companions for the kindness and courtesy universally extended towards me, I now return the Sceptre, twice entrusted to my hands, to the Grand Chapter of Canada, with the assurance that I have endeavored to wear it faithfully, and if I have succeeded in so doing, my labors are well repaid.

I will thank the Companions to permit me now to retire to the ranks, and in a humbler sphere, to still use my exertions for the benefit of the Order in Canada.

Again, and always, I invoke the blessing of the Most High upon this Grand Chapter and upon every Companion of the Royal Craft, and may our labors thus commenced in order be continued in harmony and ended in peace.

It was on motion resolved,—

That the matters contained in the address of the M.E.Z. be referred to the following Special Committee, viz :—  
R.E. Comps. S. B. Harman, Marcellus Crombie, and E. Comp. E. J. Sisson, and to report thereon at an early day.

The following Reports from the Grand Superintendents of Districts were read :

#### R E P O R T.

*To the Most Excellent the Grand Council and Companions of the Grand Chapter of Royal Arch Masons.*

In accordance with the regulations of this Grand Chapter, I beg to submit the following report as Grand Superintendent for the Wilson District.

Having moved away from the District for which I was elected, I have not been able to pay that attention to the Chapters therein which I otherwise should have done.

I have on several occasions visited the "Oxford" Chapter, at Woodstock, and I am very glad to be able to state that it is in a prosperous condition, numbering twenty-six members, and working well. Of "Mount Horeb" Chapter, Brantford, I am unable to speak, not having visited it, which I very much regret. I wrote a letter to the Principal Z., asking for information as to the number of its members, and such other information on which the prosperity of Chapters generally depend, but I received no answer thereto, and therefore, I regret that I am unable to say anything regarding it.

Of "Ezra" Chapter, over which I had the honor to preside, until I removed from the District, although it is the youngest Chapter in the Wilson District, it was not behind "Oxford" Chapter when I left; and, from the well-known masonic zeal of my successor as 1st Principal Z., V. E. Comp. C.W. Matheson, I entertain no doubt that its progress will not be less than it was under me.

I received a telegram on the 5th inst., requesting me to come on that or the following day to Simcoe, for the purpose of installing the officers, but having appointed a Chapter meeting for the days named, (in "Tecumseh" Chapter, which has been established here since my removal to this place,) I regret that I was deprived of the pleasure of meeting my Companions in Simcoe on that occasion.

The masonic events in my District have been very few, and of such a nature as to be of little or no interest to capitular masonry.

I am unwilling to conclude this brief report without referring to the necessity of strictly enforcing the limits of jurisdiction which belong to each Chapter, and which, to my knowledge, have several times been infringed upon,

REPORT.

QUEBEC, 27th July, 1863.

*To the M. E. the Grand Chapter of R. A. Masons of Canada, in Annual Convocation assembled.*

In conformity with the regulations of Grand Chapter, I have the pleasure of submitting the following report of the proceedings and progress of R. A. Masonry in this District since the last Annual Convocation of Grand Chapter.

I am happy to say that the prosperity of "Stadacona" Chapter, No. 13, R. C., has been unparalleled in the history of Royal Arch Masonry in this District, during the past year, having added thirty-eight members to its list, by exaltations and otherwise, during this period. The punctual and large attendance of members at the convocations of the Chapter, and the able and effective manner in which the several officers discharge their respective duties, bear ample testimony to the zeal and energy exerted by R. E. Comp. Duncan, 1st P. Z., in all that relates to the well-being and prosperity of the Chapter. The number of Companions now on the muster roll of this Chapter would, under ordinary circumstances, justify the formation of an additional or second Chapter, under your jurisdiction in this District, but I have hitherto hesitated to recommend this course, owing to the circumstance of there being a Chapter holding under the English Registry in existence here, whose list of members heretofore exceeded that of "Stadacona" Chapter, and I am desirous of having the latter established in a good pecuniary position, prior to countenancing any dismemberment of its numerical strength by the erection of another Chapter, but I have no doubt such a measure will be eventually beneficially effected.

I regret to add that owing to the deep affliction with which it has pleased the great "I Am" to visit me within the past month, by the loss of a dear and elder brother—the late Mayor of Quebec—I will be unable to attend the approaching Convocation of Grand Chapter.

The whole, nevertheless, respectfully submitted.

## R E P O R T .

*To the Most Excellent John Charles Franck, Grand Z., and the Grand Chapter of Royal Arch Masons of Canada.* •

I have the honor to report on the condition of Royal Arch Masonry in the Central District during the term of my holding the office of Grand Superintendent.

I regret to state that, while Craft Masonry flourishes, the increase in the number of candidates for the Chapter Degrees is not in the same ratio as the initiations; and when it is considered that the Royal Arch is the completion of the Degree of Master Mason, one would naturally suppose that every brother should press onwards to the summit of Ancient Masonry, and thereby obtain that knowledge which had been lost. There does not exist the same interest in the working of the Chapter as we find in the Lodge. It is too often difficult to obtain the requisite number of Companions to open the Chapter, and at the best of times the attendance is small, considering the Chapter roll contains the names of so many members. The working constantly devolves on a few zealous members, and year after year do we find these Companions fulfilling the duties of the nominal officers. Can it be there is not sufficient zeal in the few new members who are yearly advanced to the active positions in the Chapter?

There is no doubt but that there is some remedy to cure the listlessness complained of and supply the want of zeal. It is well worth the consideration of your honorable body, and might be made the subject of reference to a special Committee. Great care should be evinced in granting a Charter to a second Chapter in one place; while one Chapter flourishes, the other languishes, and this too, is viewing it in the most favorable light. Often it occurs that both are barely supported, the funds are depressed, and the cause of Royal Arch Masonry materially injured.

I have paid official visits to three out of the five Chapters in this District, namely: The "Grenville" Chapter, No. 22, Prescott; the "Moir" Chapter, No. 7, Belleville, and the "Ancient Frontenac," No. 1, Kingston. The "Grenville" Chapter having received its Charter, I had the pleasure of consecrating and

installing its officers. I also performed the ceremony of consecration in the "Moria" Chapter, in December last. This Chapter has the best and most commodious hall of any Chapter in this District. In the foregoing ceremonies I was most ably assisted by the Excellent Principals and Companions.

I beg respectfully that my name be not submitted as a candidate for re-election, my professional avocations so fully occupy my time that I cannot devote that attention to the duties of Grand Superintendent which the office requires.

Before the last election and installation of officers of "Dorchester" Chapter, No. 17, the Companions requested a Dispensation authorizing the removal of the Chapter from this place to Waterloo, which I granted, being convinced the interests of the Chapter would be promoted thereby, since which time there have been several candidates exalted and there are other applications before it.

The number of Chapters, during the last year, remain the same—three.

My business has been such during the past year that I have not been able to visit any of the Chapters in this District but one. I

have the means of knowing that "Dorchester" and "Golden Rule" Chapters are in a flourishing condition. I am sorry to say that "Bedford District" Chapter, at Dunham, has made but little progress, the officers of that Chapter never having been able to confer the Royal Arch Degree.

There are a number of the Companions of that Chapter who, after having taken the lower Degrees, have been obliged to apply to "Dorchester" Chapter to have the Royal Arch Degree conferred.

In conclusion, I desire to return my sincere thanks to R. E. Comp. H. L. Robinson, P.G.S., for many acts of kindness and much valuable information, in my official capacity, during the past year.

The Grand Scribe E. read the following notice of motion given by E. Comp. W. W. Pringle, of "The Hiram" Chapter, No. 2, of an amendment to the Constitution, viz:

That Art. 6, for the government of subordinate Chapters, be amended by striking out the words—"unless he be an installed Master or Past Master of a regular Lodge nor."

The almost unanimous opinion of the members of Grand Chapter was adverse to the alteration being made, and the proposed amendment was withdrawn.

It was moved by M. E. Comp. T. Douglas Harington, seconded by E. Comp. James Jackson, and resolved,—

That whereas the present Constitution of the Grand Chapter of Canada enacts that no Honorary Jewel shall be worn therein that is not consistent with those Degrees recognized and acknowledged by the Grand Chapter, and whereas it is necessary to define those Degrees; therefore, it is declared that this Grand Chapter recognizes and acknowledges the E. A., F. C., and M. M. of the Craft Degrees; the Mark Master, Past Master, Most Excellent Master, and Royal Arch Degrees, and the Knights Templar and Knights of Malta; to obtain which two last Degrees, a Knight must be a Royal Arch Companion.

It was moved by R. E. Comp. S. B. Harman, seconded by M.E. Comp. T. Douglas Harington, and resolved,—

That R. E. the Grand Scribe E. be instructed to prepare, under the approval of the M.E. the G.Z., an address to all Chapters under this Grand Royal Arch Chapter, impressing upon them the importance as well as the duty that devolves upon the Representatives of Chapters of attending the deliberations of the Grand Body, with such statistics as to attendance and non-attendance hitherto, as will evince to the subordinate Chapters, the necessity of an improved attendance in future, to show a due respect for the Grand Chapter, and to advance the interests of the Royal Order in Canada, and that the Grand Superintendents be specially requested to bring the subject before the Chapters in their several Districts.

It was moved by R. E. Comp. S. B. Harman, seconded by R. E. Comp. Marcellus Crombie, and resolved,—

That until further notice the annual remuneration of the

Grand Scribe E. be fixed at three hundred dollars (\$300.00) per annum, and that all arrears be paid on the same scale.

The M. E. Z. appointed E. Comp. Edmund J. Sisson, Scrutineer, to collect the ballots for Grand Officers.

R. E. Comp. David Curtis, Chairman of Committee on Foreign Correspondence, submitted to the M. E. Z. the following Report, which was ordered to be printed with the proceedings of Grand Chapter :

#### REPORT ON FOREIGN CORRESPONDENCE.

*To the Grand Chapter of Royal Arch Masons of Canada.*

Your Committee on Foreign Correspondence in presenting to you a brief summary of the proceedings of eighteen Grand Chapters, the perusal of whose records has afforded them much *real* pleasure and satisfaction, have to regret that circumstances beyond their control have rendered it impossible for your Committee to give that attention to the subject which its magnitude and importance so eminently deserves. Hasty, however, and imperfect as the sketch must necessarily be, your Committee could not fail to observe, and they mention it with glowing satisfaction, that turn whithersoever they may, they perceive one prominent feature pervading Masonry throughout all its gradations, — a thorough conviction of the successful result which must inevitably ensue from its humanizing and benevolent teachings. Capitular Masonry, though at present overshadowed by the dark pall of internecine war in seventeen out of the eighteen jurisdictions, whose proceedings we are about so imperfectly to sketch, despairs not of its final triumph over the barbarity of human passions, and amidst the loud clangor of clashing arms, the horrid din of remorseless battle, and the maddening shouts of infuriated combatants, stands forth undismayed, clothed in those Godlike principles which have stood the test of centuries, and will, we trust, continue to gather strength and energy in their course

until that time shall arrive when all mankind shall acknowledge *her* influence.

Your Committee having their attention directed to jurisdictions all situated, except one (that of Scotland) in the heretofore United States of America, have to state that in consequence of the unholy and fratricidal war now raging there, Capitular Masonry is not at present making those wonted progressive strides so happily mentioned in former reports. There are however, jurisdictions surrounded and oppressed by a preponderating share of those calamities, and yet exhibiting such astounding symptoms of energy and vitality as to lead us to admire still more those ineffable and enduring principles upon which Masonry is founded.

It has grieved us to find in some instances R. A. Masons who have so far forgotten themselves and the principles of which they should be the exponents and vindicators, as to inveigh most virulently and in language unbecoming Masons, against those who have the misfortune to be arrayed in hostile arms against them.

The Chapter is dedicated to the God of peace, whose ineffable name should be so inscribed in characters of light upon the heart of each R. A. Mason, that the place of His sanctuary should not be contaminated, nor the fragrant essence of adoration issuing from the altars there erected, be polluted by the discussion of subjects *ever* at variance with the pure dictates of Masonry, whose salutary and benign influence has ever been directed in casting oil upon the troubled waters of human dissension, and in allaying the angry storm of man's untoward passions and violence.

The pretence for the introduction of this theme into the Chapter is, that Masonry and patriotism are so intimately connected, that when the standing column of national order and stability is in danger of being overturned, and the people have rushed to arms, no more suitable subject could be introduced into a Chapter, than the discussion of their sufferings, and a narration of their wrongs.

It should, however, be recollected that patriotism is a word of but local import, and that what may be deemed *sufferings* and *wrongs* on the one side, may, on the other, be considered justifiable acts of retaliation.

But Masonry, which has outlived the destruction of empires, the fall of dynasties, and the depopulation of entire nations, should not intermingle its lofty influence in the fierce and devastating siroccos of human violence, whose force, if left alone, would soon be spent.

Without troubling you with further reflection we, with *much diffidence*, present you with a short synopsis of the Proceedings of the following Grand Chapters.

#### SCOTLAND.

The proceedings of this Supreme Grand Chapter are from the 27th March, 1861, to 11th March, 1863, and relate entirely to matters of local interest.

The Grand Chapter of Canada received favorable attention and a vote of thanks for a copy of its Proceedings.

The Grand Scribe congratulates the Grand Chapter on its increased prosperity, six new Chapters having been established, and five dormant ones re-opened with a large increase of members.

#### CALIFORNIA.

The Ninth Annual Convocation of the Grand Chapter of this State was held at San Francisco, on the 8th day of May, 1863.

Twenty-one Chapters were represented.

The Grand Chapter was presided over by the Deputy G. H. P., in the absence of the G. H. P.

The Grand Secretary read the address of the G. H. P., which was well worthy of the individual holding that high position. He concludes a most eloquent and affecting allusion to the distressing calamity caused by the great overflowing of the river in certain parts of their State, in the following language: "But amidst all this calamity there were noble hearts and generous souls. Parts of our State pre-eminently stood forward as 'Good Samaritans' in the hour of need. The future annals of our young commonwealth will be inscribed in letters of living light with the record of those

generous impulses, those noble humanities which instigated and executed those deeds of benevolence and love; and proud indeed may we be, my Companions, to say that our brethren in that array of duty and philanthropy, were ever as they should be in the vanguard."

Alluding to the state of R. A. Masonry, he says:—"Never, I believe, since the organization of our Grand Chapter, has there been such an uninterrupted continuance of harmony and peace in the operations of our subordinate Chapters, no discord or confusion of any kind has occurred within my knowledge, and the applications to me, in my official capacity, for information or advice touching questions of practice in peculiar or difficult cases, have been extremely rare, so that I feel firmly and fully convinced, that, if the work performed during the past year, has not been as extensive as usual, still, that it has been 'good and true,' and that due care and caution have been maintained in the selection of material for our Masonic Temple."

The Committee on Foreign Correspondence reviewed in an able and impartial manner the Proceedings of sixteen Grand Chapters. Canada received flattering notice.

#### CONNECTICUT.

Convocation at New Haven the 13th day of May, 1862.

Twenty-one subordinate Chapters, and one thousand eight hundred and twenty-five members.

The G. H. P. delivered an able address in which he congratulates the Grand Chapter on the fair degree of prosperity attending the Order in his jurisdiction, and the unusual harmony prevailing therein. He adverted in a feeling manner to the demise of M.:E.: Wm. H. Jones, who was long a prominent Mason of that State.

The Committee on Foreign Correspondence presented a lengthy report reviewing the Proceedings of fourteen Grand Chapters, Canada included.

M.:E.: Nathan Dikeman, re-elected G. H. P.; R.: E.: E. G. Storer, G. Secretary.



## INDIANA.

Annual Convocation at the city of Lafayette 21st day of May, 1861.

Forty-seven subordinate Chapters, and one thousand five hundred and ninety members.

The G. H. P. delivered a lengthy and well written address, in which subjects of interest only to their Grand Chapter were ably discussed.

R.:E.: Thos. R. Austin, in his capacity as chairman of the Committee on Foreign Correspondence, reviewed the Proceedings of twenty-six Grand Chapters. Speaking of Canada, he gave expression to the following sentiments :—" We cordially greet our Companions of the Grand Chapter of Canada, and wish them prosperity and success."

M.:E.: George W. Porter, was re-elected G. H. P. ; R.:E.: Francis King, G. Secretary.

## IOWA.

The Eighth Annual Convocation was held at Keokuk, on the 31st May, 1862. M.:E.: Stewart Ellis, G. H. P., in his address regretted that a lack of interest existed in a majority of the Chapters in his jurisdiction, which he attributed to a want of a more thorough knowledge of the work, and lectures in the several degrees.

The Report on Foreign Correspondence is from the pen of Henry S. Jennings ; to evince the masonic spirit we make one extract—alluding to the unhappy position of their Country, he uses the following truly masonic language :—" Let us all restrain our passions and guard our words and actions, that nothing we may say or do as Royal Arch Masons, shall tend to widen or deepen the gulf now yawning between us. Let us do nothing as Masons to exasperate or wound the feelings of any Companion in any portion of the world." He impartially and fraternally reviewed the Proceedings of sixteen Grand Chapters, Canada making one of the number.

M.:E.: Caleb Lamb, was elected G.H.P. R.:E.: W. B. Langridge, Grand Secretary.

There are twenty-seven Chapters under this jurisdiction, and five hundred members.

KENTUCKY.

Convocation at Louisville on the 20th day of October, 1862.

The G.H.P. in a brief address alludes only to subjects of local importance, regretted that he could not congratulate Grand Chapter on the prosperity of the Order, which was languishing in consequence of the "civil war."

The G.H.P. laments the demise of two Companions, M.:E.: Thomas Ware and M.:E.: Henry Wingate.

The Report of the Committee on Foreign Correspondence is very brief, merely acknowledging the receipt of Proceedings of eleven Grand Chapters, our own included.

There are nineteen Chapters under this jurisdiction, and five hundred and ninety-three members.

M.:E.: Thos. Sadler, elected G.H.P. R.:E.: Philip Swigert, Grand Secretary.

LOUISIANA.

The Most Excellent Grand Chapter of Royal Arch Masons of this State was convened at the City of New Orleans the 11th day of February, 1862. The address of the G.H.P. is concise and to the point. We find nothing interesting to persons beyond that jurisdiction. The G.H.P. mourns the loss of Companions Thomas H. Lewis and Samuel G. Risk, both prominent Masons. The Committee on Foreign Correspondence made a verbal Report, having received Proceedings from four Grand Chapters only.

Twenty-five Chapters returned under this jurisdiction, and five hundred and ninety-six members.

## MARYLAND AND DISTRICT OF COLUMBIA.

Convocation at the City of Washington on the 11th Nov., 1861.

There were nineteen Chapters returned under this jurisdiction.

Companion E. L. Stevens on Foreign Correspondence, reviews very ably and at considerable length, the Proceedings of fifteen Grand Chapters, our own among the number, and although we make no extract, the report well repays a perusal.

## MAINE.

The Grand Royal Arch Chapter of Maine assembled in Annual Convocation in the City of Portland on the 5th day of May, 1862.

The address of the G.H.P., though purely of a local character, exhibits Royal Arch Masonry in a favorable condition in this State. Returns, twelve Chapters and seven hundred and five members.

The Committee on Foreign Correspondence made a voluminous Report, critically and fraternally examining the Proceedings of eighteen Grand Chapters, among which, Canada receives special, enlarged and kindly attention. Your Committee regret that time would not allow them to examine this Report more minutely, as they feel assured that had they been able to do so, they would have been richly rewarded, as the name of CYRIL PEARL at the head of the Committee is a good guarantee that the work is well done.

## MICHIGAN.

The Fourteenth Annual Convocation of this Grand Chapter, was held at the City of Detroit, on the 12th day of January, 1863.

In the Annual address, the G. H. P. congratulates Grand Chapter on the prosperity of Royal Arch Masonry throughout the State. He alludes to nothing of importance beyond the limits of his jurisdiction.

## SIXTH ANNUAL CONVOCATION, TORONTO, 1863. 227

There are twenty-seven Chapters returned, and one thousand three hundred and thirty-one members.

Companion J. Eastman Johnson, from the Committee on Foreign Correspondence, insists upon the expediency of a re-examination of the question of affiliation with the Grand Chapter of Canada, as English Royal Arch Masons, who have not received the Degrees of M. M., P. M. and M. E. M., are admitted as visitors to our Chapters.

## Supreme Grand Royal Arch Chapter of Scotland,

SCRIBE'S CHAMBERS, 50, GEORGE-STREET,

EDINBURGH, 13th April, 1863.

M. E. Sir and Comp.,—At a meeting of the Supreme Grand Royal Arch Chapter of Scotland, held on 17th December last, it was found necessary to suspend four Chapters, and thirteen Companions of the Order resident in Glasgow, for insubordination and disobedience to the Supreme Chapter.

It appears that these thirteen suspended Companions formed themselves into what they were pleased to term a "General Grand Royal Arch Chapter for Scotland and the Colonies;" and having prevailed upon a number of members of the suspended Chapters to join them, they commenced issuing charters and working the Royal Arch degrees. This having been reported to the Supreme Chapter, that body, at a special meeting held on the 6th inst., expelled from the Order of Royal Arch Freemasons the brethren whose names are contained in the annexed list.

I am directed by the Supreme Chapter to communicate the sentence passed upon these brethren to all Chapters and Mark Master Lodges holding of the Supreme Chapter, in order that they may prohibit and Discharge their members, in all time coming, from holding any communication with any of them on the subject of Royal Arch Masonry, or from admitting into their Chapters or Lodges any of these expelled brethren, or any one exalted, in, or belonging to, any of the spurious Chapters established by them.

I am also directed to intimate this to all sister Grand Chapters, and to request that the usual publicity may be given to it among their daughter Chapters, in order that these Chapters may not through ignorance, communicate with spurious Chapters and expelled brethren.

And, lastly, I am directed to intimate this to the Royal Order of Scotland, the Chapter General of the Religious and Military Order of the Temple, and the Supreme Council of the 33rd and last degree of the Ancient and Accepted Scottish Rite, in order that these bodies may adopt such measures as regards those of the expelled brethren who may be members of them, as they see fit,

I have, accordingly, in terms of these directions, sent you this notice, which I have to request you will lay before your first meeting.

On motion, the report of the Grand Scribe E. on Representatives, was received and adopted.

A number of visiting Companions being in attendance, the M. E. Z. granted permission for their admittance.

The Grand Scribe E. read the rules and regulations for the government of the Grand Chapter during public business.

It was moved by R.E. Comp. Richard Pope, seconded by V.E. Comp. Alexander Duncan, and resolved—

That inasmuch as the proceedings of the Regular Convocation of Grand Chapter, held at the city of Toronto, on the 11th day of August, A. D., 1863, have been printed, and copies thereof sent to the subordinate Chapters, the minutes be considered as read, and the same confirmed.

The M. E. Z. read the following address to the assembled Companions :

*To the Most Excellent the Grand Chapter of  
Royal Arch Masons of Canada.*

COMPANIONS :

For the first time since the Craft of Canada has been established in its present independent and honorable position in the Masonic world, one of its Sovereign Bodies meets in this most interesting, historical, and hospitable City of Quebec, and I am well pleased to be the Presiding Officer to proclaim a welcome to each and every Companion now visiting it, and express the hope that the visit may result in pleasure and satisfaction, and that gratifying reminiscences may arise in after times when it happens to be talked over.

We are now assembled to hold our Seventh Annual Convocation, and especially are we bound, as recipients of God's bounty and mercy, to take this opportunity of acknowledging our deep debt of gratitude, and offer our earnest thanks to Him for our



prosperous condition, for sparing us to meet again together, and for the many blessings he has been pleased to confer upon us.

I must ask your indulgence for my present address. I still feel the effects of illness, chiefly brought on by excessive heat, and much Masonic labor, gone through at the recent meeting of Grand Lodge at Hamilton, and in consequence I am unable, as I had intended, to enter fully into various subjects of interest appertaining to capitular Freemasonry, and which I wished to make mention of. I must, therefore, leave to your united counsel the inauguration of such matters, as may be deemed beneficial to the Royal Craft.

The principal recommendation I feel it to be my duty to offer is the revision of the Constitution. My worthy Predecessor strongly urged this at the last Convocation of Grand Chapter. A Committee for this special purpose should be appointed, unless you think proper to leave it to your Principals. In either case a report should be prepared, embodying a more perfect and extended code of Laws, not dependent upon Craft Masonry as they are now; such report to be sent for consideration to each subordinate chapter, at least three months before the Annual Convocation in 1865, and be then submitted, with all other suggested alterations, for final adoption.

Our Subordinate Chapters are, I have reason to believe, working harmoniously and successfully, but the reports of the several Grand Superintendents will give full information on this head. I have to report one additional Chapter, viz; *The Mount Horeb*, held at Montreal. The petition came from certain Companions belonging to the "Victoria" R. A. Chapter, on the Registry of England, and was accompanied by a formal surrender of their English Warrant. Under the circumstances, and after consulting the Grand Superintendent of the Montreal District, I looked upon it in the light of affiliation, and ordered a Canadian Warrant to be issued instead, free of fee except for registration, which action I request Grand Chapter to confirm.

Our relations with Sister Bodies are of a most amicable

nature, and their proceedings are duly received by the Grand Scribe, E. A report on foreign correspondence is desirable, for which a special Committee should be nominated.

It is my duty to submit a letter received from the Grand Chapter of Ireland, relating to one of her subordinates, No. 209, holden at London, C. W., and the delivering up of some property said to be improperly retained by one of our Chapters. This should receive early attention, and be fairly and justly arranged.

I have granted several Dispensations during the year, sanctioning special elections of Principals, and thereby enabling the Chapters interested to continue their labors. It is extremely difficult, under the existing restrictive law, to avoid having recourse to the dispensing power.

Your Treasurer and Grand Scribe E, will report on the financial condition of the subordinate Chapters, and the general state of Grand Chapter funds. The latter were so far improved as to enable me to order the payment of a portion of the sum due to that very able and indefatigable officer, R. E. Comp., T. B. Harris.

Last year my predecessor took loyal notice of the auspicious marriage of the Prince and Princess of Wales. It is my pleasing privilege to make mention of the birth of a Prince, the first fruit of that union, and an event which has given comfort to our widowed Sovereign, diffused joy throughout the British Empire, and to the well known loyalty of the craft been a welcome source of congratulation. May the illustrious parents, the hope and pride of the nation, have continually increasing happiness, and may God save and bless the Queen.

The miserable civil war still exists in the neighboring States causing ruin and grief throughout the land; but Freemasonry, though it cannot prevent, has there proved its beneficent power to mitigate suffering and distress; and our order will ever be found side by side with mercy and humanity, provided its numerous members are only true to its attributes and themselves. Peace reigns within our borders, for which we should be deeply

grateful to the Most High. May He continue to regard favorably our common country, one destined, it would clearly seem, to a brilliant future, and may His Blessing be and remain upon us and all belonging to us, and our present proceedings.

The Grand Scribe E. read the report of the Grand Superintendent for the Montreal District :

### REPORT.

*To the Most Excellent the Grand Council and Companions of the Grand Royal Arch Chapter of Canada.*

In the month of September, 1863, a number of Companions, then members of "Victoria" Royal Arch Chapter of this City, under the Registry of England, forwarded an application to the Most Excellent Grand Z of Canada, for a Dispensation to open a new Chapter here, under the name of "St. Lawrence" Royal Arch Chapter. Previous to that time, there was in existence, in Montreal, only one Chapter under Canadian jurisdiction, viz :— the "Carnarvon," No. 21. The most Excellent Grand Z, in issuing the Dispensation referred to, was pleased to appoint me to the office of Grand Superintendent for the District of Montreal.

Shortly before I received my Commission, and the Dispensation for the new Chapter, it was brought to my knowledge, that a disposition existed among the remaining members of "Victoria" Chapter to give up their Warrant, and take one instead from the Grand Chapter of Canada, an arrangement, which I am happy to say, was ultimately carried out in a spirit of harmony and fraternal good-feeling, highly creditable to the Companions of that Chapter. Later in the year, the old Warrant was surrendered to me, for transmission to England, together with an application for a new Warrant under Canada. I forwarded the Warrant, and the documents connected with it, to the Most Excellent the Grand Z., who was pleased to comply with the request of the Companions, and to grant a Warrant authorizing the formation of a new Chapter, under the name of the "Mount Horeb" R. A. Chapter, No. 25, and I had the pleasure of constituting the Chapter, and installing the Charter Officers, at the regular Convocation in January, 1864. In April, a new election took place, and I had also the pleasure of installing the officers elect, at the next regular convocation.

The Chapter is now in a flourishing condition, and may be expected to receive large accessions to its membership.

Carnarvon Chapter, No. 21, has prospered greatly during the year, and its prospects for usefulness are exceedingly bright. It has now a membership of about forty, and in every respect, it may be said to be in an excellent position.

These Chapters are the only two in the District, working under the Grand Chapter of Canada.

The "St. Paul's" Royal Arch Chapter attached to the "St. Paul's" Lodge Montreal, continues its work under the jurisdiction of England. A considerable number of the members of that Chapter, have taken the intermediate degrees of Mark, Past, and Most Excellent Master, in the Carnarvon Chapter, C. R., and I have now to call the earnest attention of the Grand Chapter to the necessity of providing them with proper Certificates in order to enable them to visit Mark Lodges in England, and the Royal Arch Chapters in the United States.

I regret exceedingly that a severe attack of illness will prevent my being present at this Convocation of Grand Chapter, and I therefore take this opportunity of expressing the deep obligations under which I am laid to the Most Excellent Grand Z., for the kindness he has always manifested towards me, in the discharge of my duty, and for the promptitude displayed by him in affording the fullest information, on any point referred for his opinion or advice. I have also to express my acknowledgement to R. E. Companion H. Luke Robinson, of Waterloo, and to R. E. Companion George T. Morehouse, of "St. John's," for the valuable services they have at various times rendered the Companions of this District.

It has not yet adopted the recognized ritual of this Grand Chapter, but works correctly, I believe, according to that of the United States.

"Bedford District," has never yet conferred the Royal Arch Degree, nor has it met for more than two years, it has therefore rendered itself subject to erasure, and it becomes my duty to recommend that it should be done. I regret it much, for it possesses much abundant material for a good working Chapter, and its connection with "Prevost" Lodge, and its nearness to "Stanbridge" and "Nelson" Lodges, ought to make it the most prosperous Chapter in the District; "Dorchester," over which I have the honor to preside, continues to add slowly, but steadily to its numbers, and I am happy to say, that its members manifest much interest in the cause of Royal Arch Masonry.

In Septembér last, I had the honor, for the third time, of installing the Officers of Carnarvon Chapter, Montreal.

Since then, there has been a Grand Superintendent appointed

### R E P O R T .

*To the Most Excellent the Grand Council, Officers, and Companions of the Grand Chapter of Royal Arch Masons of Canada :*

In accordance with the constitutional requirements of Grand Chapter, I have much pleasure in submitting my report on the condition of Royal Arch Masonry in the Hamilton District, over which I have had the honor to preside during the past year.

There are three Chapters in the District, all of which are progressing satisfactorily under the charge of zealous, well-skilled officers. "The Hiram" Chapter No. 2, Hamilton, (the oldest but one in the Province) is ably and efficiently presided over by V.E. Comp. James M. Rogerson. "St. John's," No. 6, of the same city, is equally fortunate in having at its head V. E. Comp. T. McCracken; and "Mount Moriah," No. 19, St. Catharines, is not less so in E. Comp. C. P. Camp. Each Chapter is well attended at Regular and Emergent Convocations, thus showing that the Companions are not unmindful of their duty in this respect. The work proceeds regularly and is well done.—The instruction imparted to each candidate being impressively delivered, and in accordance with the Ritual of this Grand Chapter; and all the material submitted for the building of our sacred temple is well-tried before use, and proved to be true and trusty. There have been periods when the number of applicants for admission within our portals has surpassed the present one; but never has the quality of those accepted been excelled, which speaks well for the care exercised in judiciously selecting none but the best. Let this circumspection continue, and the result

will amply repay each Chapter, in the superior quality and other essentials to a good, active, working membership, that may in consequence be relied on.

Owing to ill health, I have not been able to visit the Hamilton Chapters as frequently as I would desire ; but where the true spirit of the Royal Craft is so admirably inculcated by officers and observed by the Companions, official visits from the Grand Superintendent are not absolutely necessary, unless for the purpose of cementing together those fraternal ties which occasional comingling is so well calculated to foster and strengthen. My own Chapter, however, I have visited regularly ; and in noticing its prosperity, I feel it a pleasurable duty to bear testimony to the zeal which has influenced its officers in working and managing its affairs. Its minutes are accurately kept ; records carefully preserved ; finances well husbanded ; and returns to Grand Chapter promptly forwarded.

The healthy vigor pervading Capitular Masonry in this District may lead to the establishment of one or more additional Chapters during the coming year. Indeed, several Companions at Grimsby are desirous of organising one at an early day ; and should it appear that sufficient material can be relied on to justify the Companions in their laudable aspirations, I would cheerfully recommend their claims to favorable consideration.

I regret to add, that during the year several worthy Companions have been called to the Grand Chapter above ; but I can only give the name of one—not having been furnished with those of the others—Comp. A. W. HENDERSON, of Mount Moriah Chapter, who died December 9, 1863. A pattern of Masonic vigilance and integrity, ever ready to relieve the distressed, and universally esteemed for his many excellent qualities as a man and Mason. His memory will ever be held dear by his Companions, who sincerely sympathise with his bereaved widow and children in the irreparable loss they have suffered.

Your Committee on Audit and Finance having examined the books, accounts, and vouchers of the Grand Scribe E., and Grand Treasurer, beg leave to report, that the same are found to be correct.

Your Committee have had laid before them the following accounts, which they have examined, and recommend that the same be paid, viz ;

Your Committee find that there has been received during the year on account of Grand Chapter the sum of \$360 60, which with the balance in the Grand Treasurer's hand of \$77 09, making a total of \$437 69, and that the disbursements for the same period



of time, have been \$417 95, leaving a balance in Grand Treasurer's hands of \$19 74.

Your Committee regret to observe that two Chapters have not made returns to Grand Chapter since 1862, that four have not made returns since January 1863, and they further regret to see, that the "Bedford District" Chapter has made no returns since 1859, the date of its formation; your Committee would therefore recommend that the Grand Scribe E, be instructed to address a communication to the last-named Chapter, requiring its returns to be immediately made up and forwarded to him within six months, failing to do so within that time, that the officers of the Chapter be summoned to appear at the next annual convocation of this Grand Chapter, to show cause why their Warrant should not be cancelled and its number erased from the registry of the Grand Chapter.

Your Committee also find that in the aggregate the amount owing by the various Chapters to be \$224 95, and would respectfully recommend that the Grand Scribe E, use his best endeavours to collect the above amount.

#### R E P O R T .

*To the Most Excellent Council and Companions  
of the G.R.A. Chapter of Canada.*

Your Committee to whom was referred the reports of the Grand Superintendents of Districts, beg leave to state:

That the first report before them is that from the Grand

Grand Superintendent of the Hamilton District, from the purport of which we learn with great satisfaction and much pleasure the flourishing position of Chapters in this district, numbering at present, three, with every probability of a fourth going into operation immediately. This augurs favorably, and is flattering alike to the presiding officers of their several Chapters, as well as to their Grand Superintendent for their careful and judicious management.

By the report of the Grand Superintendent for the Montreal District, we note with pleasure the healthy and prosperous state of the Royal Craft in this district. It is highly satisfactory to mark the kindly relations between "Caernarvon" Chapter, under Canada, and "St. Paul's" Chapter, under England. May these amicable feelings long prevail. In reference to the proper certificates for the Companions of "St. Paul's" Chapter joining "Caernarvon" Chapter, enabling them to visit Mark Lodges in England, and Royal Arch Chapters in the United States, your Committee are given to understand that these measures will be cared for under another head.

Next under consideration is the report of the Grand Superintendent for the Eastern Townships District. While we learn with pleasure the prosperity of "Golden Rule" and "Dorchester" Chapters, we deeply regret the non-advancement of "Bedford District" Chapter; and, if deemed desirable by the M. E. Z., would join with the Grand Superintendent in recommending its erasure from the Grand Chapter roll. Your Committee would respectfully suggest, in regard to "Golden Rule" Chapter, that they adopt the recognized ritual of this Grand Chapter in their working as soon as possible, since a uniformity of work in our subordinate Chapters is much to be desired.

We are happy to learn from the report of the Grand Superintendent of the Quebec District, that the success and prosperity of "Stadacona" Chapter is unabated, and that its successful working is complete.

Your Committee regret much that the gentle reproofs recorded by their predecessors in last year's report has not had

the desired effect in drawing from the Grand Superintendents of the several Districts the cap-stone of their labors, we conceive where this is the case there may be no labors to report ; we hope, otherwise, however, and trust the Grand Superintendents, non-reported this session will in future crown their labors with a report, so that subsequently any remonstrance such as the present may be deemed unnecessary.

The special Committee to whom was referred the address of the M. E. Z., submitted the following

#### R E P O R T .

Your Committee have much pleasure in entertaining the hope, so happily expressed in the address of the Most Excellent Grand Z., that the present and first convocation of Grand Chapter in the renowned and historical city of Quebec, may result in the more firmly cementing of those friendly relations of amity and good-will which now so happily characterize each annual re-union of the members of the craft.

Your Committee feel that we have reason to be more than usually thankful to the Great I AM, for the numerous mercies bestowed upon us during the past year, and more especially for His exceeding goodness in sparing us for the privilege of assembling together on this the occasion of the seventh annual convocation of Grand Chapter.

It is with extreme pain and regret that your Committee have learnt that the Most Excellent Grand Z. has suffered, and still

suffers, from a severe attack of illness, induced chiefly by an excess of Masonic labor during the oppressive heat which prevailed during the past month, and which has rendered him unable to enter more fully into the various subjects of interest appertaining to Capitular Freemasonry, and which he had wished to submit to the consideration of Grand Chapter.

Your Committee sincerely trust that the Most Excellent Grand Z., will be speedily restored to his usual health and vigor, and that under the blessings of the All-Merciful Ruler of the universe, he may be long spared to continue his self-imposed labor of dispensing light and instruction to all his Brethren and Companions in the different orders of Freemasonry.

Your Committee heartily concur with the Grand Z. in the advisability of providing for a revision of the Constitution so as to render the Grand Chapter independent of the laws of Craft Masonry ; and for this purpose your Committee would respectfully recommend that the three Grand Principals be authorized and empowered to revise the Constitution, and that the Grand Superintendents of Districts do assist them by transmitting them such suggestions as the Chapters in their respective Districts may have to offer respecting the same, and that a draft of such revision be sent for consideration to each Subordinate Chapter, at least three months before the annual convocation of Grand Chapter in the ensuing year, and be then submitted with all other suggested amendments for final adoption.

Your Committee are pleased to learn that all the subordinate Chapters are working harmoniously and successfully ; and your Committee, in view of the peculiar circumstances of the case, recommend that Grand Chapter do confirm the Warrant issued free of charge, excepting the fee for registration of members, by the Grand 1st Principal, to "Mount Horeb" Chapter, at Montreal.

Your Committee are happy to learn that our relations with the Sister Bodies are of the most amicable nature, and that they continue to send us copies of their proceedings, and recommend the nomination of a Committee on Foreign Correspondence.

The letter from the Grand Chapter of Ireland, referred to in the address of the Grand Z., having been, by a resolution of Grand Chapter, referred to him for final action thereon, requires no further comment from your Committee.

Your Committee feel that under the existing restrictive law, it is impossible to avoid having recourse to the exercise of the dispensing power sanctioning the special elections of principals.

Your Committee are pleased to learn that the funds of the Grand Chapter are in such a condition as to have enabled the Grand Z., to pay that excellent and indefatigable officer, the Grand Scribe E., a portion of the arrears of salary due him.

It is with extreme pleasure that your Committee re-echo the sentiments of loyalty and attachment to our noble and illustrious widowed Queen, so ably and eloquently expressed in the address of the Grand Z., and the pride, and gratification which the auspicious event of the birth of a Prince in the Royal household of England, has diffused throughout the length and breadth of one of the greatest empires of the earth; and the joy and gladness it has occasioned in the hearts of the members of the Craft in Canada, who with pride look up to the ancestors of the infant Prince as the bright luminaries of their order, and hope that he will in some future time, look upon the Royal Craft and people of this Province as among the most loyal of his subjects, and upon Canada as the brightest jewel in his Crown.

While Your Committee have to deplore the continuance of the disastrous and deadly civil strife which still exists across our border, yet it is with renewed assurance of the beneficent attributes of Masonry that they feel that its horrors may be mitigated by the diffusion of the benign and merciful precepts of the order; and it is with a deep sense of gratitude to the Most High, that your Committee have to thank Him for his mercy in preserving to us the blessings of peace and plenty, and implore his divine mercy to allow us long to continue in our unchequered career of national prosperity; and grant that our Order may grow and extend with the increase and prosperity of the country, and

that all our deliberations and proceedings may meet with His divine favor and approbation.

That the usual fees be paid to the Grand Janitor for his attendance during this Convocation.

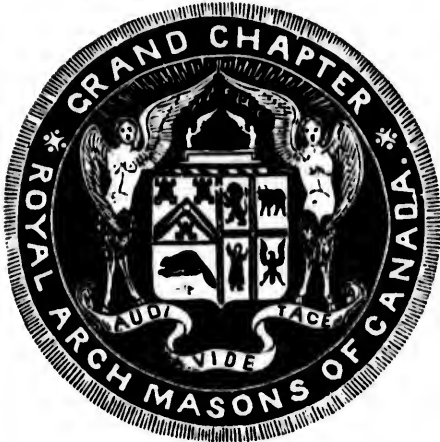

## REPORT ON FOREIGN CORRESPONDENCE.

YOUR COMMITTEE on Foreign Correspondence beg most respectfully to submit their review of the proceedings of Thirteen Grand Chapters, which have been placed in their hands by the Grand Scribe E., viz. :—

The Grand Chapters in fraternal correspondence with the Grand Chapter of Canada, whose proceedings have not been received, number twenty-five, as follows, viz.:—England, Ireland, Alabama, Arkansas, Connecticut, Florida, Georgia, Illinois, Kentucky, Louisiana, Michigan, Minnesota, Mississippi, New Hampshire, North Carolina, Ohio, Oregon, Pennsylvania, South Carolina, Tennessee, Texas, and Virginia. The Annual Convocations of several of these have in all likelihood not been held, owing to the lamentable fratricidal war still raging within their limits. But for the absence of reports from those not so afflicted, your Committee are at a loss to account, and miss them very much; as it would have been a most pleasing duty to peruse their transactions, and cull from them such extracts as would instruct and cheer all engaged in the noble task of building up that moral edifice which is pre-eminently the mission of Royal Arch Masonry.

On examining the proceedings furnished them, your Committee are pleased to find a healthy tone prevalent throughout, and that the progress of the Royal Craft continues to be steady and enduring. In a few instances, however, war's devastating influence has operated disastrously to the successful working of Chapters in disturbed States; but on the whole, evidence is not wanting that our United States Companions are alive to their duty in this respect, and will in due time, by closely adhering

to the exalted teachings of our Order, overcome these hindrances, which are but trials of their fidelity, to nerve them up to greater fervency and zeal. It is also cheering to observe an absence of that acrimonious spirit, in discussing their unfortunate troubles, which was at the outset so strongly apparent in some instances, and greatly to be deplored, as destructive of that Masonic charity and fraternal feeling which should always govern members of the same family in judging of each other's actions.

Without further digression, your Committee will at once report the result of their labors, which they have arranged in alphabetical order, except in the case of Scotland, which, being a mother Grand Chapter, is entitled to the first place.

#### SCOTLAND.

The proceedings of this Supreme Grand Chapter are from 31st March, 1863, to 31st March, 1864. They relate almost wholly to business affairs, and matters of local interest.

There are one hundred Chapters on the Roll; but of these twenty-nine are dormant, and the other six are in arrears and liable to be cancelled. Six new Chapters have been opened, three dormant ones revived, and a Provincial Grand Superintendent appointed for "Victoria," New South Wales.

A case of jurisprudence is reported, the heads of which it may be well to embody here. It appears that the Provincial Grand Superintendent of Bengal suspended all the Principals, Officers and Members of "Kilwinning-in-the-East" Chapter, No. 64, Calcutta, on the following charges: 1. "That they removed the place of meeting of the Chapter from the rooms formerly occupied, to a new one fitted up by the members, 'without the consent or order of the Grand Chapter of Scotland.'" 2. For refusing to obey the orders of the Provincial Grand Superintendent to call a special meeting of emergency." The aggrieved Companions appealed against this suspension, when the matter was referred to a special Committee of the Supreme Grand Chapter for investigation. In their report, this Committee "view with great regret the step taken by the Provincial Grand Superintendent in the present case, as suspension is a sentence which should not

be lightly passed upon any one ; and even where it is deserved, time should be allowed to the party accused to endeavour to remove, if possible, the cause of offence. However, sentence of suspension has been pronounced, and the Committee have now to consider whether sufficient grounds existed, or indeed any grounds at all, to warrant this sentence." After reciting the cause which led to removing the place of meeting—viz., "the danger that the working of the degrees might be heard outside," and justifying the action of the Chapter—the Committee report that "the first charge being groundless, the second is equally so, because the special emergent meeting was called by the Provincial Grand Superintendent *at the rooms vacated*, to confer degrees without giving proper notice before balloting," in which case "the E. Z. was justified in declining to comply with the Provincial Grand Superintendent's order." The Committee thus close their very interesting and able report :—

"A Provincial Grand Superintendent may order a meeting of any Chapter in his province to be called at its ordinary place of meeting whenever he pleases ; but, most certainly, he has no power to order the First Principal of a subordinate Chapter to call a meeting within a few hours, at a place other than the ordinary place of meeting of the Chapter, and to admit candidates of his selection. An interference with the rights of a subordinate Chapter, such as the present, the Committee have never seen, and they think it right to report the matter to the Supreme Chapter, in order that it may be considered whether the Provincial Grand Superintendent of Bengal has not totally disqualified himself for holding such an office, and whether his commission should not, therefore, be cancelled."

This report was adopted, when the suspensions were reversed and the Provincial Grand Superintendent's appointment cancelled, because he refused to reconsider his decision when requested to do so by the Committee.

One of the Companions (E. W. Pritchard, M.D.) expelled for complicity in organizing a surreptitious General Grand Chapter, in opposition to the supreme body, has been reinstated ; and several who signed a "deed of demission," for the purpose of uniting with the malcontents, have applied for healing.

The representative from the Grand Chapter of Canada, (R. E. Comp. A. J. Stewart,) and R. E. Comp. Wm. Hay, of Toronto, representing Scotland in Canada, were present at the Annual Festival held to celebrate the Vernal Equinox.

The obituary list contains the names of several illustrious and eminent Companions, amongst whom we may name: His Grace the Duke of Atholl, K.T., Past Grand J.; the Most Noble the Marquis of Huntly, Provincial Grand Superintendent of Aberdeenshire; Major-Gen T. R. Swinburne; J. H. E. Wemyss, M. P., P. H.; John Denchar, P. G. H. Addresses of condolence, couched in feeling terms, were presented to the relatives of each.

Most Excellent Companion J. Whyte Melville was re-elected G. Z., and Lindsay Mackersy, W. S., Grand Scribe E.

#### CALIFORNIA.

The Tenth Annual Convocation of the Grand Chapter of California was held at San Francisco on the 7th May, 1863, the M. E. Adolphus Hollub, Grand High Priest, presiding, and Lawrence C. Owen, Grand Secretary. In his annual address the Grand H. P. feelingly alludes, in the true spirit of Masonry, to the fratricidal strife now raging in the United States; but is cheered by the fact that the Holy Teachings of our Order have not been lost sight of in the fearful struggle. He also refers to official acts performed by him during the year; and announces in becoming terms the death of a distinguished Mason, the R. E. Comp. Samuel G. Risk, General Grand Secretary.

The report on Foreign Correspondence was presented by Comp. L. C. Owen. It contains a review of the proceedings of ten Grand Chapters, our own among the number. The correspondence between the Grand Chapter of England and that of Canada, on granting new charters in this Province, is given in full, and the Committee, in speaking of it, say:—

“The response of the Grand Z. of Canada, so completely demolishes the assumptions of the Mother Grand Chapter, and establishes the rights of his own, that we prefer to give it at length rather than summarise it.”

The finances of this Grand Chapter appear to be in a flourishing condition, the total receipts for the year being \$3,233, and the balance in the hands of the Treasurer \$587.

Thirty-two subordinate Chapters are reported, with a total membership of 1,147; average to each, 36.

The M. E. Ezra H. Van Decar, was elected Grand High Priest, and Lawrence C. Owen, Grand Secretary.

#### INDIANA.

The Annual Convocation of this Grand Chapter was held at Indianapolis, May 20th, 1863. The M. E. G. H. P., George W. Porter, read a very interesting address, which embraced a variety of subjects, including the proceedings of twenty-one Grand Chapters—our own being one of them. His report on Foreign Correspondence is able and comprehensive. In referring to Canada he says, "I notice that some differences have hitherto existed between Canada and the Mother Country, upon the subject of granting charters; but this trouble, by the discreet exercise of the proper virtues of Masons, can and ought to be, and I trust will be ere long, if it has not already been, amicably adjusted to mutual satisfaction." He concludes his lengthy address with an earnest appeal against the policy of severing their connexion with the General Grand Chapter of the United States, a policy which is discussed with much force by several Grand Chapters. He says "there are some important interests and advantages connected with the preservation of the Supreme Grand Chapter, as it is, or ought to be, our Great Central Light, and its decisions should, or ought to furnish, uniform rules of work and action throughout the United States, and thus prevent the many inconveniences which are likely to result from the jarring and conflicting rules of different Grand Chapters having no common centre;" and he considers that this should be a sufficient reason for its continued existence.

There are forty-six subordinate Chapters in this State, with a membership of 1,474; average to each, 32.

Erastus W. H. Ellis was elected Grand High Priest, and Francis King, Grand Secretary.

## IOWA.

The Ninth Annual Convocation of this Grand Chapter was held at Iowa City, on the 30th May, 1863, the M. E. G. K., L. S. Swafford, presiding as G. H. P., and R. E. Comp. William B. Langridge, Grand Secretary.

A letter was read from the M. E. G. H. P., Caleb Lamb, explaining that "his absence was occasioned by having joined the army of his country, and commending the Chapter to the care of the Grand High Priest of the Universe."

The Committee on Foreign Correspondence report upon the proceedings of twelve Grand Chapters, our own not among the number. The report is well written, but possesses no points of peculiar importance to the craft in Canada. The Grand Secretary reports twenty-eight subordinate Chapters, with a membership of 560; average to each, 20.

M. E. Comp. W. E. Woodward, was elected Grand High Priest, and R. E. Comp. W. B. Langridge, Grand Secretary.

## MAINE.

The Grand Royal Arch Chapter of Maine assembled in Annual Convocation at the Masonic Hall, in Portland, on Monday, May 4th, 1863. Thirteen subordinate Chapters were represented. The M. E. G. H. P., in his address, which was a most able one, touched upon the influence the civil war had in some Masonic jurisdictions less fortunate than their own. He also alluded to a special Convention called on the 24th June, 1863, for the purpose of celebrating the 100th anniversary of the introduction of Masonry into Maine, and other topics of a local nature.

The Committee on Foreign Correspondence reviewed the proceedings of fifteen Grand Chapters; our own, however, was not among the number. R. E. Comp. Cyril Pearl, still continues to act as Chairman of this Committee.

The thirteen Chapters in this jurisdiction have an aggregate membership of 789; average to each, 60.

M. E. Comp. John J. Bell, was elected Grand High Priest; R. E. Comp. Ira Berry, Grand Secretary.

## MARYLAND AND DISTRICT OF COLUMBIA.

The proceedings of this Grand Chapter are dated 9th November, 1863. The M. E. G. H. P., Comp. J. N. McJilton, presided. In his opening address he says :--

“Prosperity in the Masonic family does not consist in the great increase of its members, nor in the wealth of its membership, but in the worthiness of character and usefulness of the co-laborers in the important work of building up a vast Moral Temple, the area of whose foundations extends over the globe, the elevation of which is to be wrought through time, and its duration commensurate with eternity. A single imperfect Ashlar detracts from the security and perfection of the edifice we are engaged in erecting, and once laid upon the walls, it cannot be removed, but must remain as an evidence of the weakness and indiscretion of the builders. Let it be the study and labor of the true and faithful craftsman to prevent such material from being placed among the well-trying, true and trusty Ashlars of our great Masonic Temple.”

He also states “that notwithstanding the confusion and uncertainty occasioned by the war, the Chapters are now working with an energy that indicates a speedy and prosperous issue.” He gives an account of visits to subordinate Chapters in his jurisdiction during the year, and closes his able and eloquent address by an earnest exhortation to the Companions ever to remember their responsibilities to the Great I AM, and their imperative duties to each other.

The report on Foreign Correspondence embraces the proceedings of twelve Grand Chapters. Canada does not appear amongst them, our last proceedings not being received in time.

There are ten Chapters under this jurisdiction, with an aggregate membership of 604; average to each, 60.

M. E. Comp. John L. Yeates, was elected G. H. P., and R. E. Comp. W. Morris Smith, Grand Secretary.



## MASSACHUSETTS.

The Annual Convocation of this Grand Chapter commenced September 8th, 1863, at the Masonic Hall, Boston; M. E. Comp. Solon Thornton, G. H. P., presiding, and Thos. Waterman, Grand Secretary.

No address was delivered by the G. H. P., but a minute detail of proceedings at a series of Convocations held during the year, is given in its stead. There is also an interesting record of the names of all Companions who have held Grand Offices since the establishment of this Grand body in 1798.

The Committee on Foreign Correspondence review the proceedings of eleven Grand Chapters. The report is very elaborate, lengthy extracts being given from the proceedings of all the Chapters noticed. Canada is not included in the number.

There are twenty-four subordinate Chapters under this jurisdiction, and four under Dispensation, with a total membership of 2,135. The number of exaltations during the year was 289, or an average of 12 to each.

M. E. Comp. Solon Thornton, was re-elected G. H. P., and R. E. Comp. Thomas Waterman, Grand Secretary.

## MISSOURI.

The proceedings of this Grand Chapter, for the years 1863-64, possess much interest. Both Convocations were held in the City of St. Louis, the first on May 20, 1863, when twelve Chapters were represented, and the second on May 18, 1864, with the same subordinate representation. At the former, the M. E. G. H. P., (James Carr,) delivered a very business-like address, which, after reviewing his official acts during the year, he concludes by stating that "A few of the subordinate Chapters have been doing a very flourishing business in the way of exalting new members, but the majority, however, have been hard run to keep the necessary meetings to prevent a forfeiture of their Charters." We hope the leaven working amongst the *few* will infuse its revivifying influence into the *many*, whereby all the Chapters in the State will resume their wonted vitality.



The address of the succeeding M. E. G. H. P. (James N. Burnes,) read at the Convocation held in May last, while equally practical, contains some valuable strictures on irregularities prevailing within his jurisdiction, and deplures in merited terms the "almost unintelligible manner in which certain degrees are conferred," by which "they are frequently made to appear senseless and ridiculous." To remedy this evil, a well-skilled Grand Lecturer has been authorized to visit all subordinates, for the purpose of instruction and to insure uniformity in work.

A very interesting report on Foreign Correspondence, from the able pen of R. E. Comp. A. O'Sullivan, accompanies each year's proceedings, in which the deliberations of fifteen Grand Chapters are lucidly reviewed, those of our own Grand Chapter being amongst the number.

Twenty-eight Chapters appear on the roll of this State, possessing a total membership of 994; average to each, 36.

M. E. Comp. Jas. A. H. Lampton, St. Louis, was elected G. H. P., and R. E. Comp. A. O'Sullivan, St. Louis, Grand Secretary.

#### NEW JERSEY.

The Seventh Annual Convocation of this Grand Chapter was held in the Masonic Hall, Trenton, on the 9th day of September, 1863. Twelve Chapters, (being the entire number in the State,) possessing an aggregate membership of 445 were represented.

The address of the M. E. G. H. P. is admirably written, and imparts much valuable information on the condition of the Royal Craft within that jurisdiction. Having officially visited every subordinate Chapter in his State, the M. E. G. H. P. bears testimony to the excellence of the work done in each, and its close conformity to the standard ritual, "the acquirement of which has been accomplished by all the officers without the services of a Grand Lecturer." He also uses the following pertinent observations on apathy in the discharge of duty shown by too many Companions, and which may be profitably embodied in this Report: "A more frequent visitation among the Chapters would, I believe, tend to cement that unity of feeling so desirous, and

create an emulation, inspiring that fraternal regard and esteem which is the true stamp of masonry. With but few exceptions and it is a matter of regret that they are so few, the general presence of members is not so numerous as is consistent with the benefits to be derived from attending the regular convocations of Royal Arch Chapters. This may arise from causes beyond the control of companions, but I fear it is an evidence of that want of fervency and zeal evinced by many of the Craft, through a misconception of their duties, and from unproficiency in the art, from which latter cause they lose much of its esoteric beauties."

Another subject referred to in this excellent address is that of seeking Dispensations to confer Degrees in a manner at variance with the landmarks of the order. The case in question is thus stated, and your Committee cordially endorse the sound wisdom of the M. E. G. H. P., in refusing to authorize such an innovation:—

"Application was made to me, for a Dispensation to confer the Degrees; there being some informalities, I instituted inquiries, which elicited the facts that the petition of the candidate was not at that time before the Chapter, and that the purpose was to make him a Royal Arch Mason *at large*; also, that he had been previously rejected in that Chapter. I refused to grant the request, upon the ground of irregularity, and also because a Dispensation would have been an infraction of that inalienable right accorded to every Mason in the exercise of the ballot."

The report on Foreign Correspondence, is from the able pen of Companion Wm. H. Jefferys, and is so well written, that we regret his intention to retire from the position of chairman of the Committee. He pays a high compliment to the Grand Chapter of Canada, and cordially re-echoes the sentiment contained in the address of M. E. Comp. J. C. Franck, that "the sublime precepts of our ancient and honorable institution may form the means of an amicable settlement of their unnatural and unfortunate difficulties."

M. E. Comp. John Sheville, was elected G. H. P., and R. E. Comp. J. Woolverton, Grand Secretary.

## NEW YORK.

The sixty-sixth Annual Convocation of this Grand Chapter was held in the Temple Hall, Albany, on the 3rd February, 1863, when eighty-three Chapters (out of one hundred and seventy-five on the roll) were represented, possessing an aggregate membership of 4,428; average to each, 26.

The address of M. E. Comp. G. H. Thacker, G. H. P., is an impressive and inspiring document, and in it he alludes most feelingly to the unhappy domestic troubles which afflict the republic, and tenders excellent advice to the Companions as to their duty as Royal Arch Masons. He also refers to the humanizing influence exerted by our Order on the battle-field, where the captive and the wounded have, on both sides, experienced at the hands of opposing Brethren, acts of kindness and alleviations of suffering which have served materially to assuage and mollify the horrors of war. Not only so, but through fraternal intercession, many comrades in arms, not members of the Order, have received the same consideration and beneficent treatment, though they knew not the cause. \* \* \* \* \*

Long after we have gone to our final home, our successors will point to these interesting facts as practical illustrations of the spirit and tenor of our teachings, and of the happy working of our Masonic system." He likewise suggests the publication of historic records from his Grand Chapter transactions, from 1798 to 1863, which will possess peculiar interest to the Craft at large, and which we are glad to observe has been approved, and a Committee authorised to superintend the printing. A decision is recorded, that "a Master Mason of five years' standing, who had lost his left arm by railroad accident, cannot be made a Royal Arch Mason." Also, that "a Companion suspended by vote of his Chapter for non-payment of dues, may be restored on paying arrears, without a fresh vote being required." This latter rule accords with the practice of the Grand Chapter of Canada, and we are glad to see New York adopt it.

The Committee on Foreign Correspondence ably and impartially reviews the proceedings of fourteen Grand Chapters—our own for the year 1862, included.

M. E. Comp. Darius A. Ogden, of Penn Yan., was elected G. H. P., and R. E. Comp. John O. Cole, Grand Secretary.

RHODE ISLAND.

The Annual Convocation of the M. E. Grand Royal Arch Chapter of the State of Rhode Island was held in the Masonic Hall, City of Providence, on Wednesday, March 11, 1863, at 10 o'clock, A. M. Five subordinate Chapters were represented, returning 530 members, and showing an average of 106 to each.

The M. E. G. H. P., in an interesting address, suggested the desirableness of a return of the "Old Work" and land-marks of Ancient Craft Masonry, by the abolition of the Chapter Degrees, and the restoration to the symbolic Lodges of all that originally belonged to them. He also stated his belief, "that gross fraud and imposition was successfully practiced by the Masonic innovators of the eighteenth century," and "that at some time during the last century there was a division of the Master's degree, and upon that division the innovators of those times built the Degree of the Royal Arch." The Rev. Dr. Oliver in an able paper treats of the same subject: but your Committee have grave doubts as to the possibility of making the change suggested by the M. E. G. H. P. of the Grand Chapter of Rhode Island, even if the change were desirable.

There was no report from the Committee on Foreign Correspondence.

M. E. Comp. Nathan H. Gould, was elected G. H. P., and E. Comp. Samuel B. Swan, of Providence, Grand Secretary.

VERMONT

The Grand Royal Arch Chapter of this State assembled at the Masonic Hall, in Bradford, on the first Wednesday of October, 1863. Eleven subordinate Chapters were represented.

The address of the G. H. P., M. E. Comp. Barzillai Davenport, which was well and feelingly written, contains nothing of particular interest to other jurisdictions.

The Committee on Foreign Correspondence reviewed the proceedings of eleven Grand Chapters—Canada not among the number.

There are thirteen Chapters in this jurisdiction, with a total membership of 844 ; average to each, 55.

M. E. Comp. Gamaliel Washburn, of Montpelier, was elected G. H. P., and R. E. Comp. John B. Hollenbeck, of Burlington, Grand Secretary.

### WISCONSIN.

The fifteenth Annual Convocation of this Grand body was held in the City of Milwaukee, on the 3rd of February, 1864. Twenty Chapters were represented out of twenty-two in the jurisdiction, which shows an aggregate membership of 834 ; average to each, 34.

The G. H. P., M. E. Comp. A. B. Alden, delivered a very interesting address, in which he states that, "with but few exceptions the Royal Arch Craft of this jurisdiction are in a highly prosperous condition, notwithstanding the unsettled state of our affairs, which tend so directly to retard its advancement." The remainder of the address is devoted to matters of local interest and well-timed reflections on Masonic duty in the troublous times through which they are passing. Companions are earnestly enjoined "not to let political feelings and prejudices interfere with their fraternal relations, which should be sacredly adhered to,"—a sentiment your Committee heartily endorse, and commend to general consideration. Though written for the meridian of Wisconsin, it is not without force in other jurisdictions, and its reproduction can do no harm.

The report on Foreign Correspondence, by Companion H. L. Palmer, is voluminous and well-written. The proceedings of fourteen Grand Chapters are reviewed, and appended thereto is a carefully prepared statistical table, showing that these Grand Bodies contained four hundred and eighty-seven subordinate Chapters ; have exalted 1888 candidates, and report an aggregate membership of 20,163. The Grand Chapter of Canada does not

appear amongst the number. Speaking of the omission, the writer says:—"We have not been gladdened this year by the appearance of the proceedings of our Companions of the Grand Chapter of Canada." We regret the non-receipt of our proceedings, which were regularly forwarded by our Grand Scribe E., and can only attribute the failure of their arrival to some postal defect.

M. E. Comp. Melvin L. Youngs, was elected G. H. P., and R. E. Comp. W. T. Palmer, Grand Secretary.

In bringing their labors to a close, your Committee would crave the indulgence of this Grand Chapter for the imperfect manner in which the important research committed to them has been performed; and at the same time beg to express their high sense of the valuable compilations prepared by the several Committees of sister Grand Chapters, the perusal of which has afforded them much information that they could not otherwise have obtained. Always well digested and entertaining and with but rare exceptions written in a truly Masonic spirit, there is no portion of the proceedings that they rise from reading with more genuine satisfaction than the Foreign Correspondence.

All which is most respectfully submitted.
